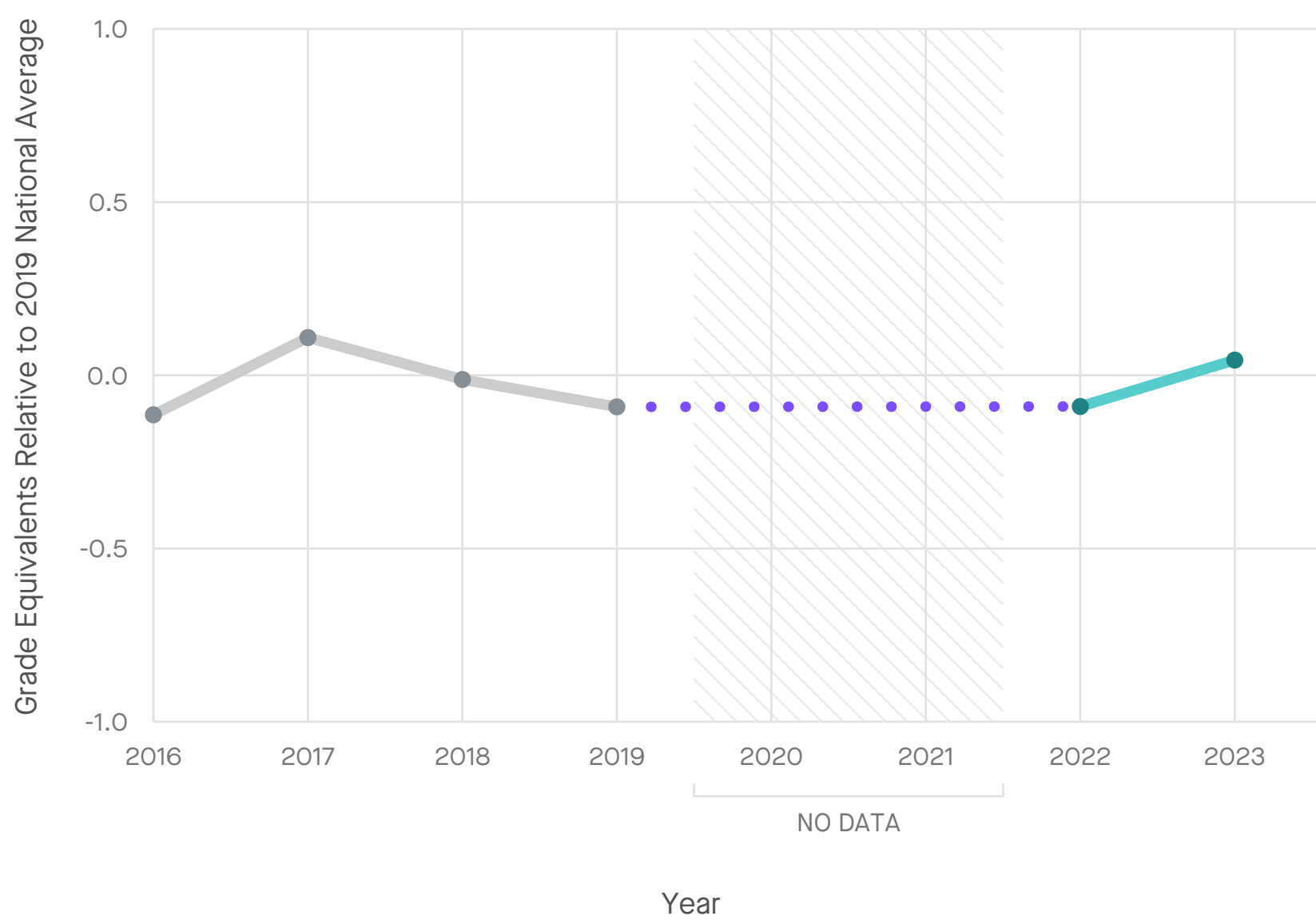

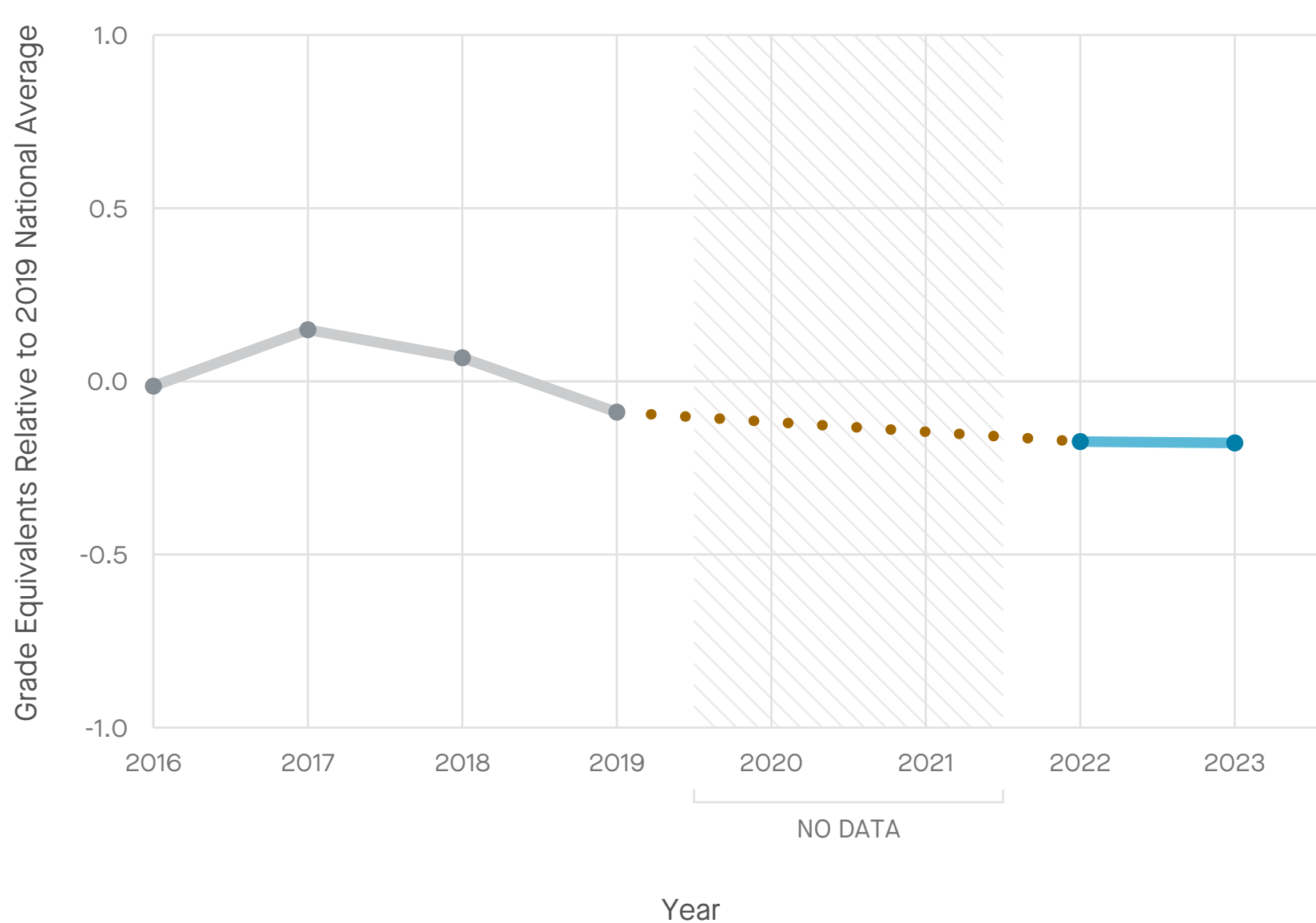

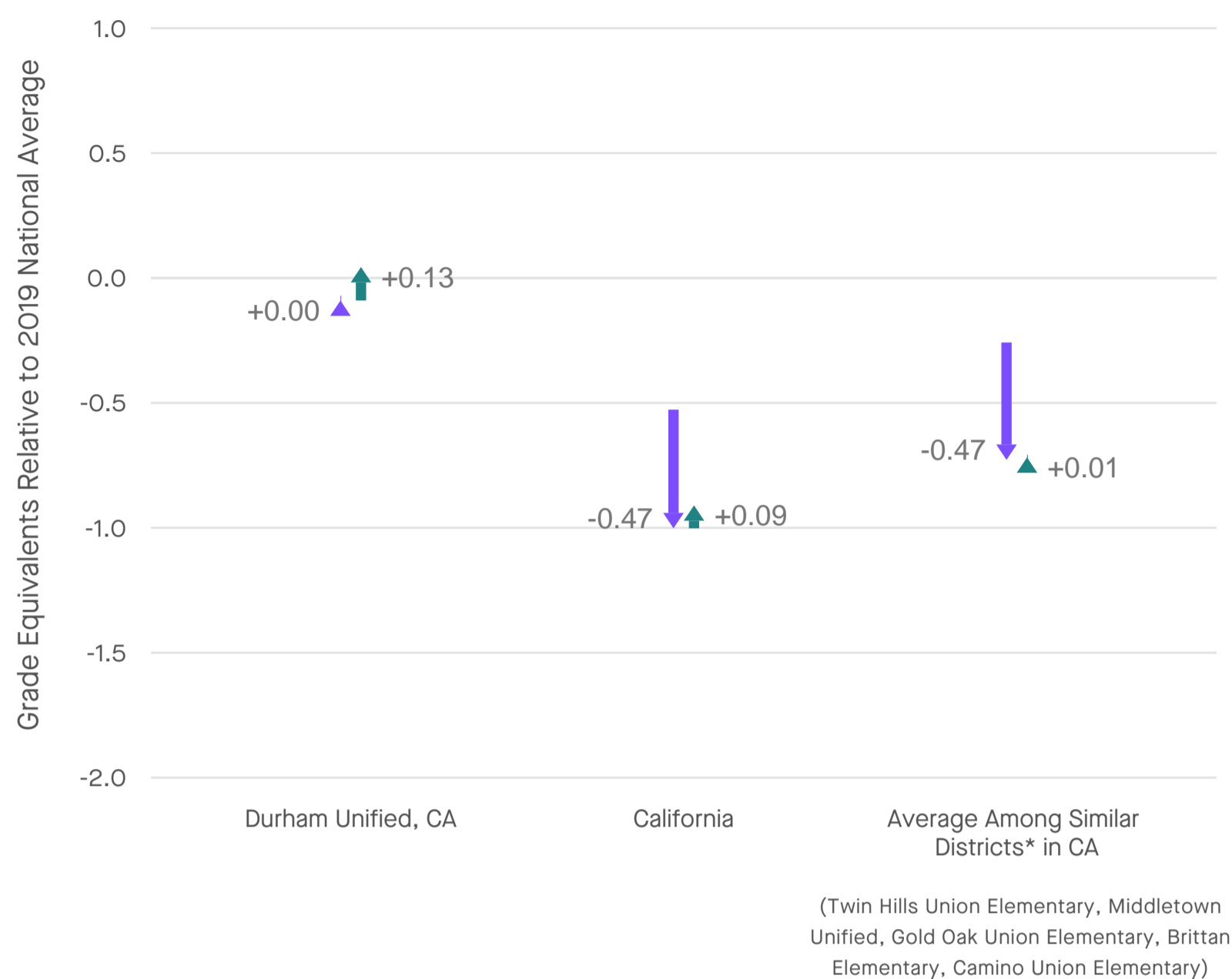

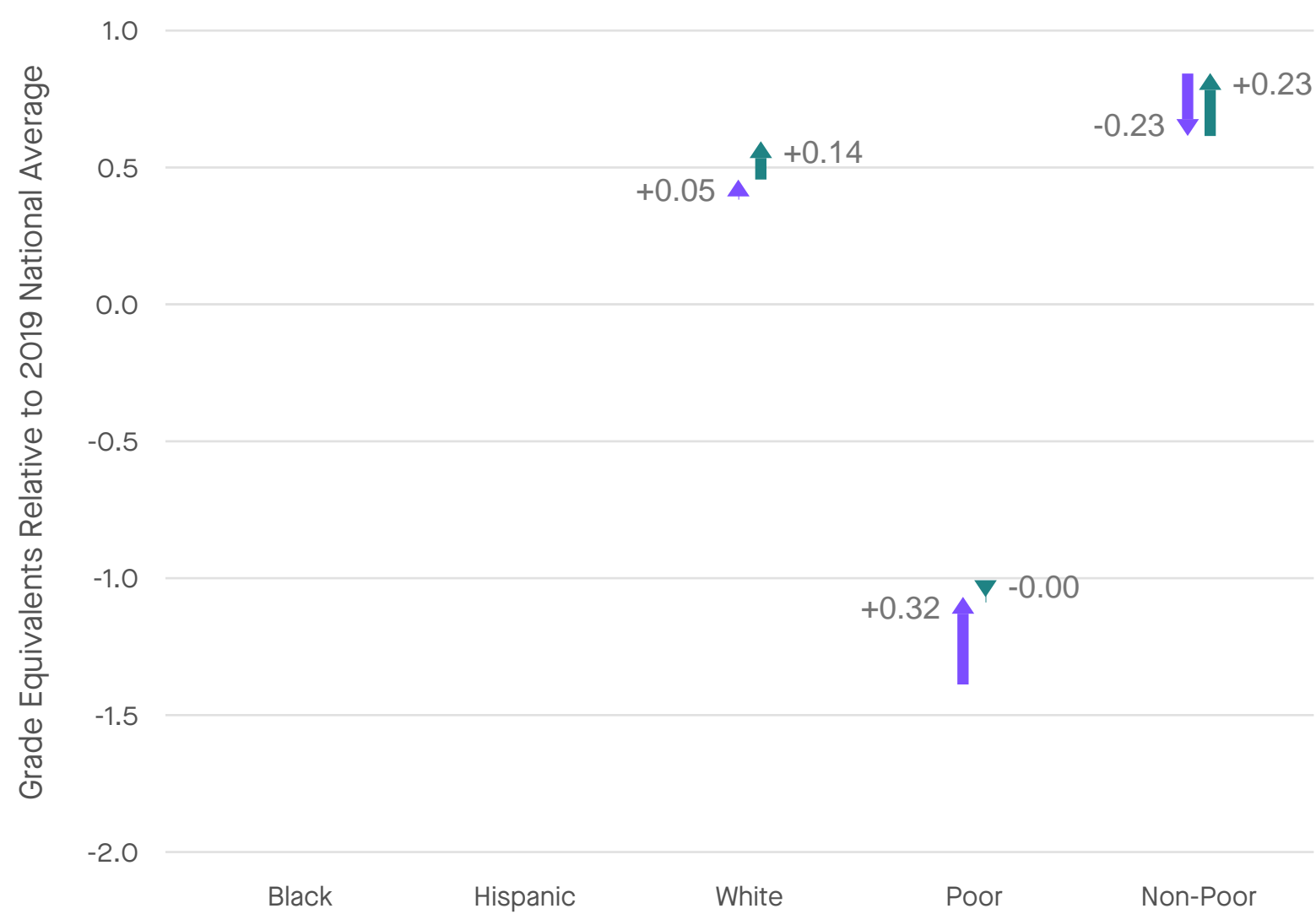

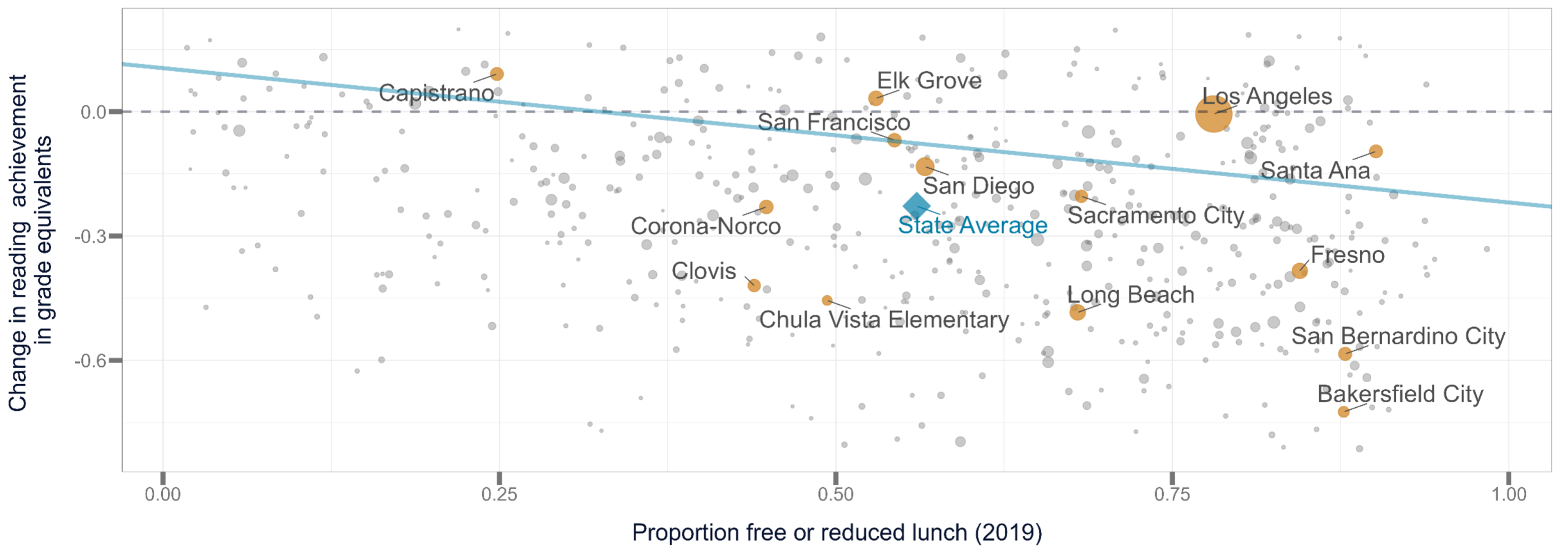
Change in Math Achievement 2019-2022 by proportion FRPL in California districts

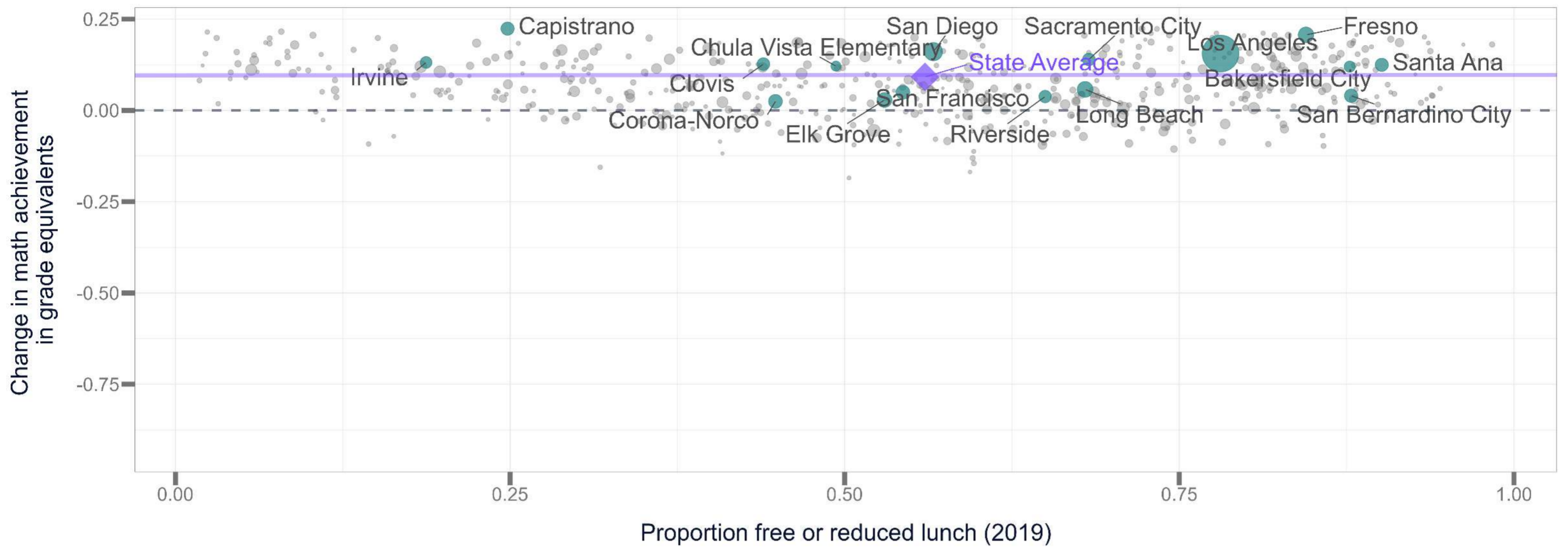
Change in Reading Achievement 2019-2022 by proportion FRPL in California districts

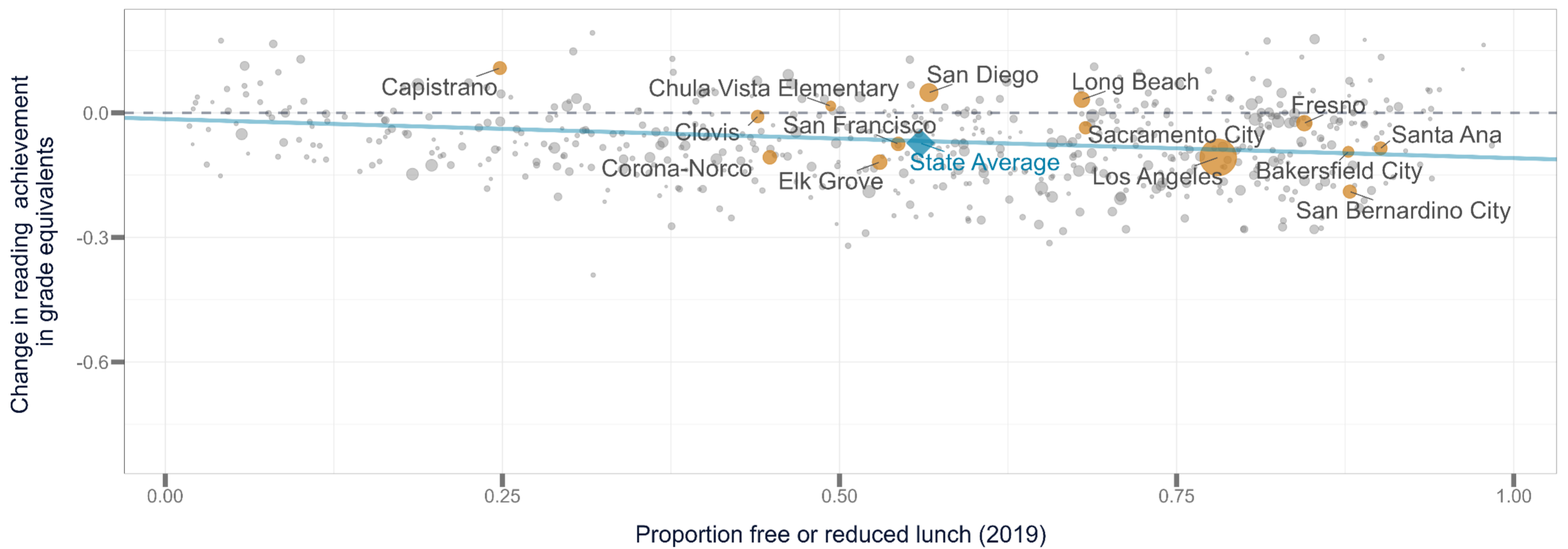
