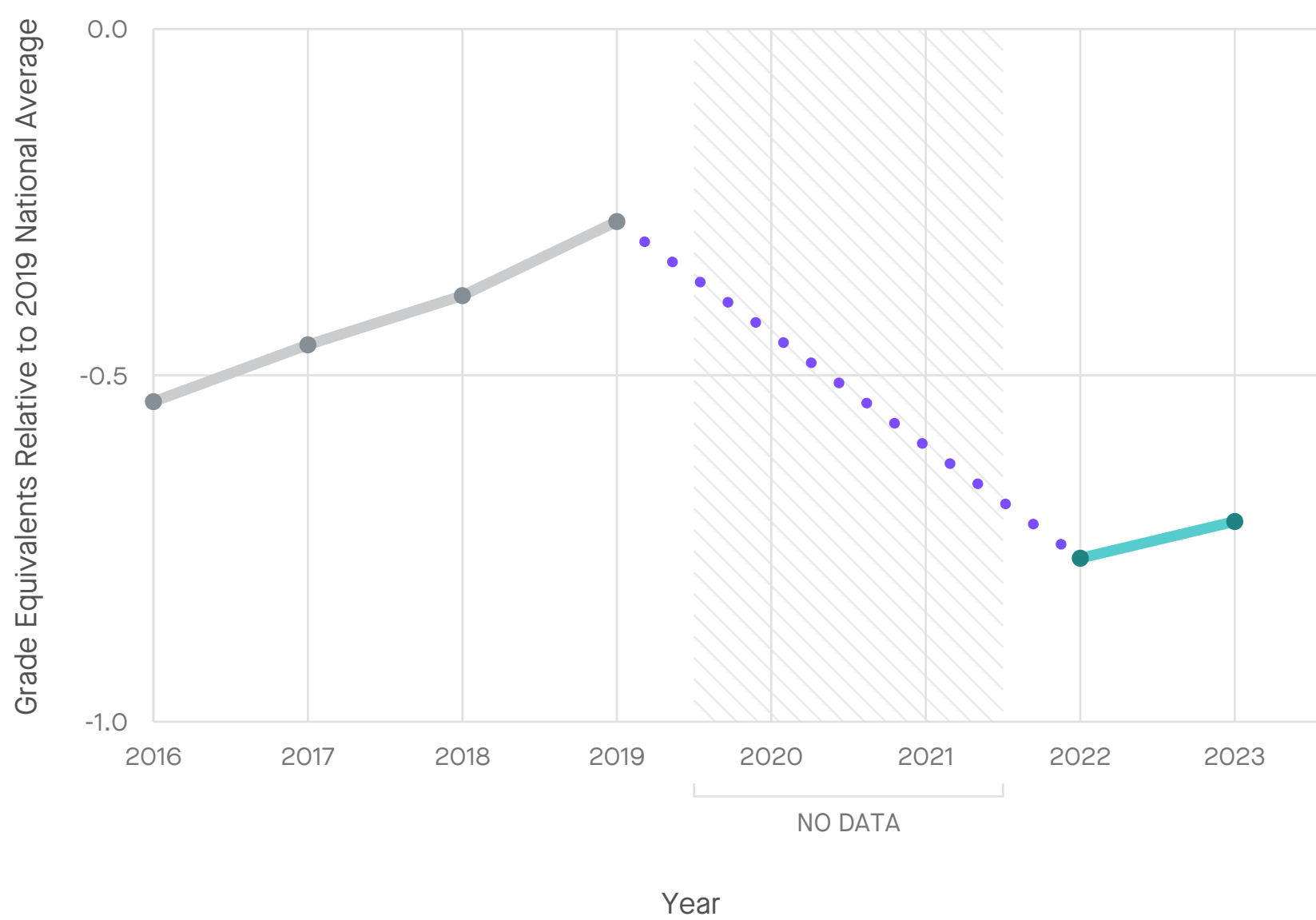

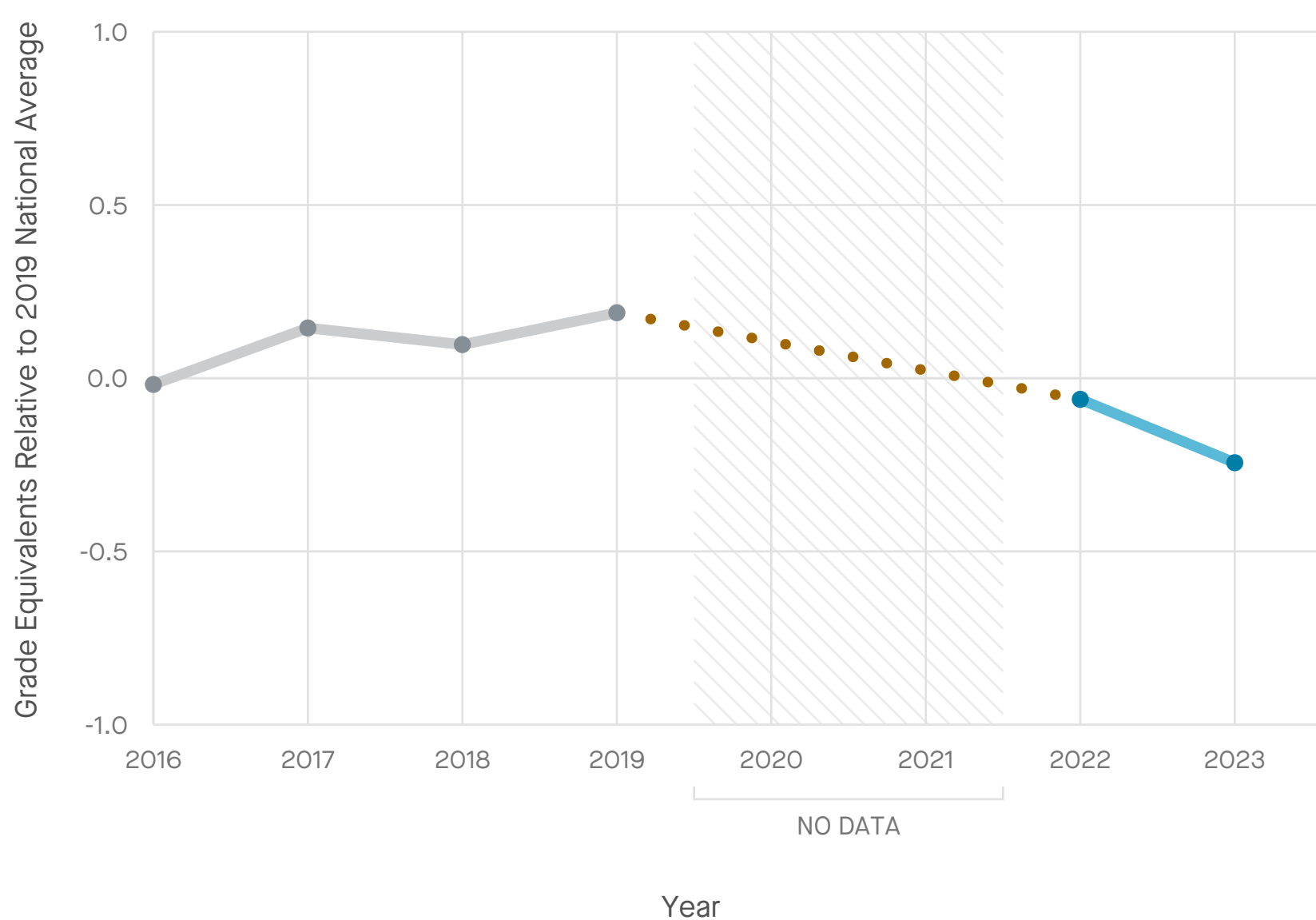

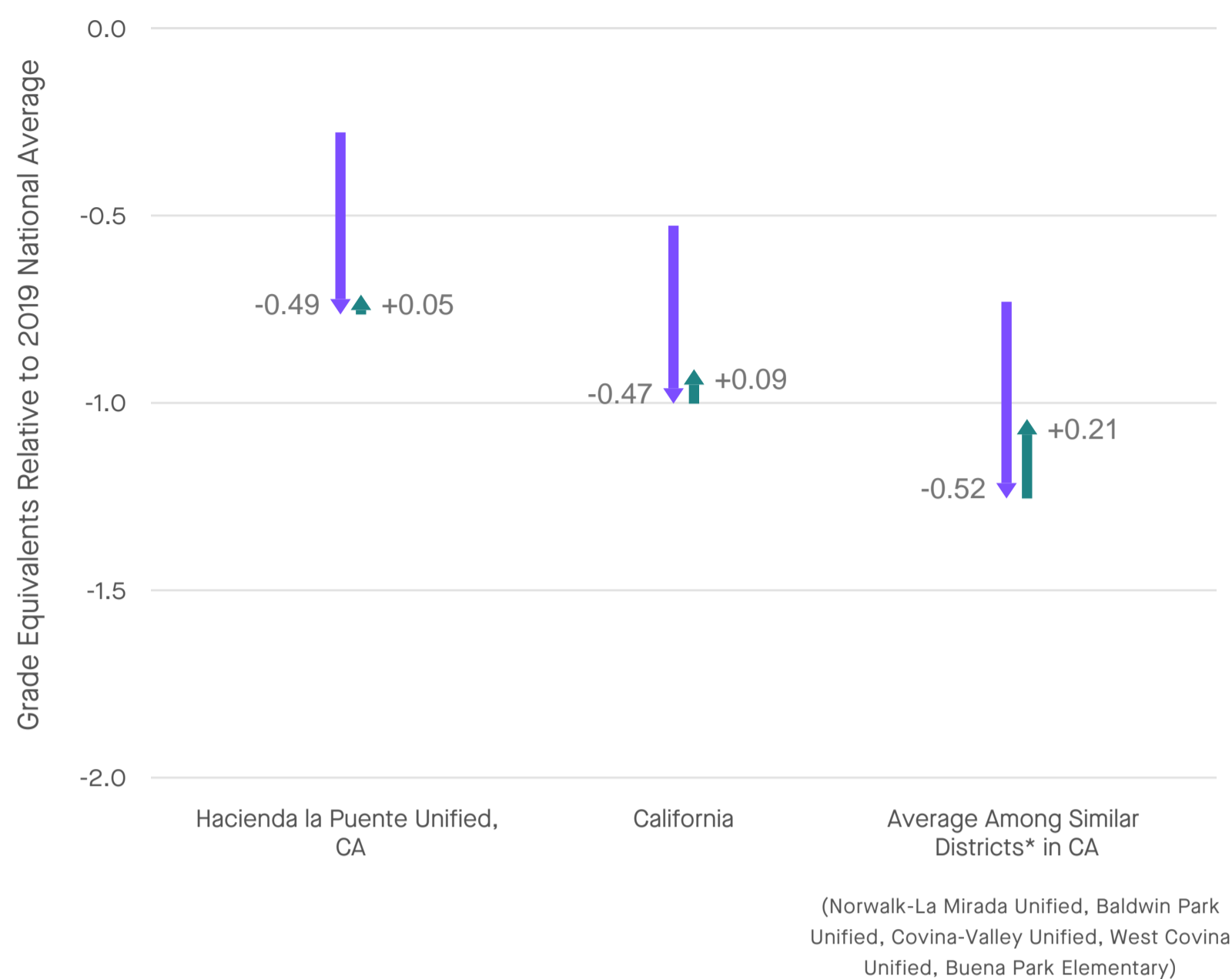

Math Performance in Hacienda la Puente Unified vs. California and Similar Districts, Grades 3-8, 2019-2023



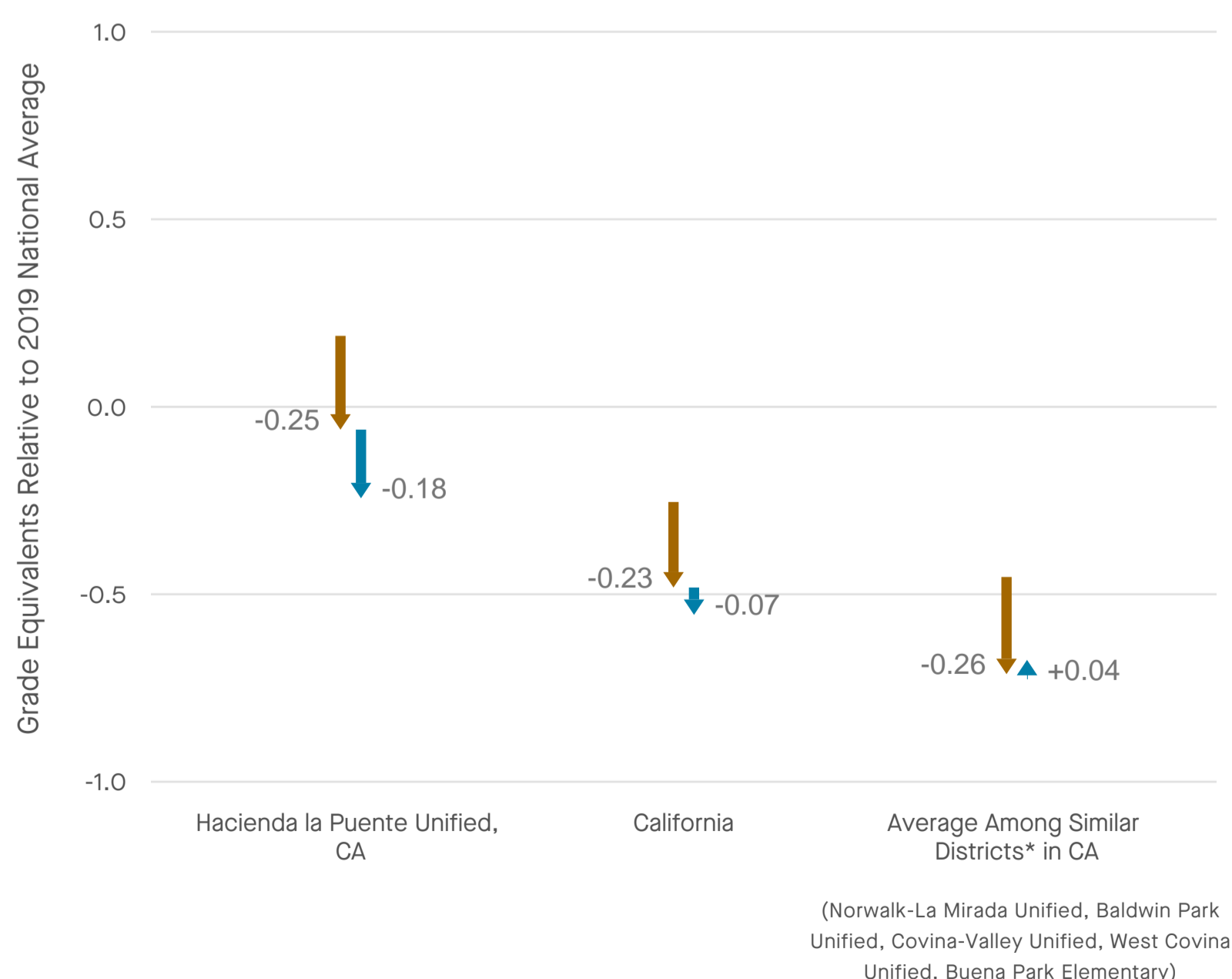

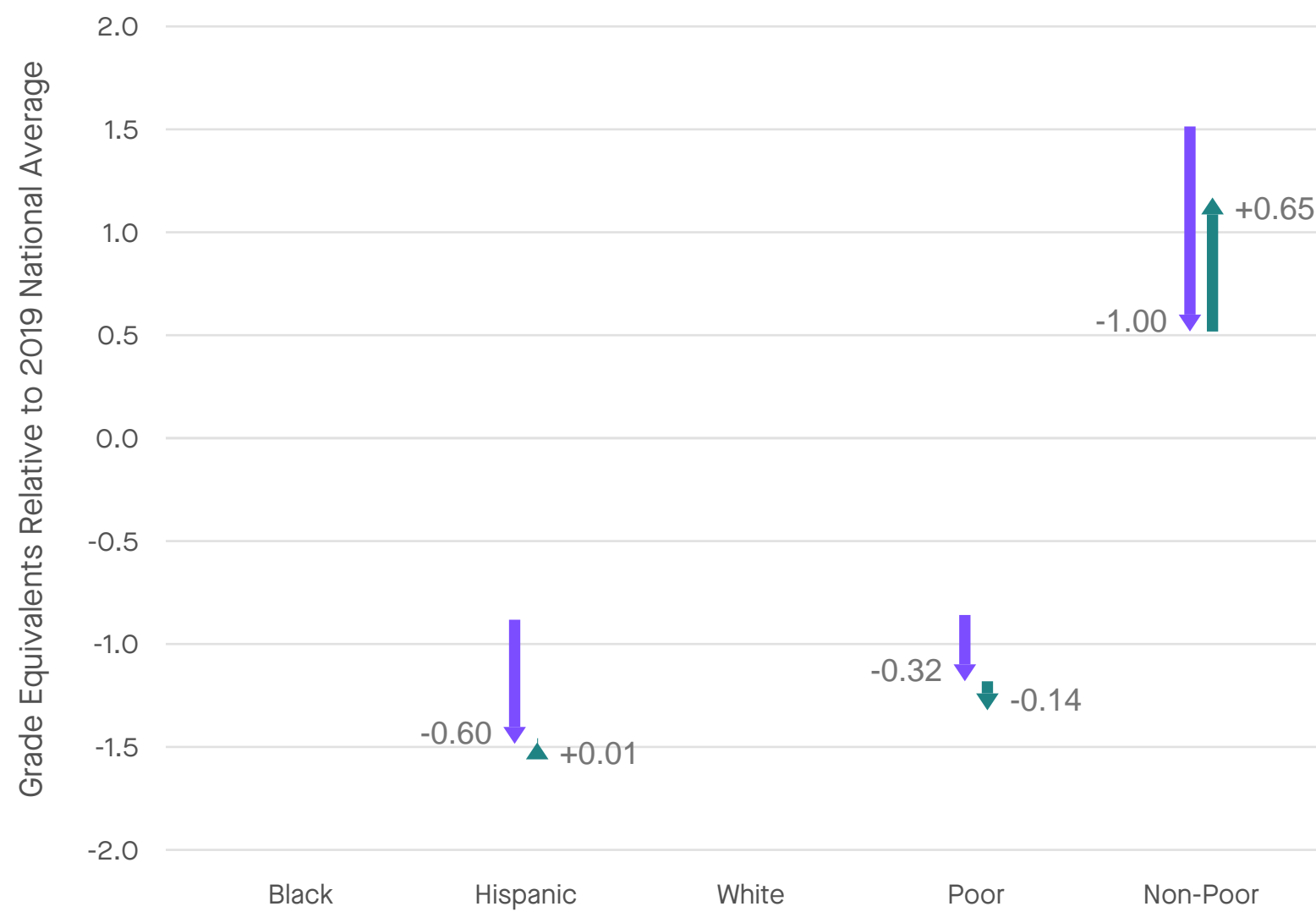

Math Performance by Subgroup, Grades 3-8, 2019-2023

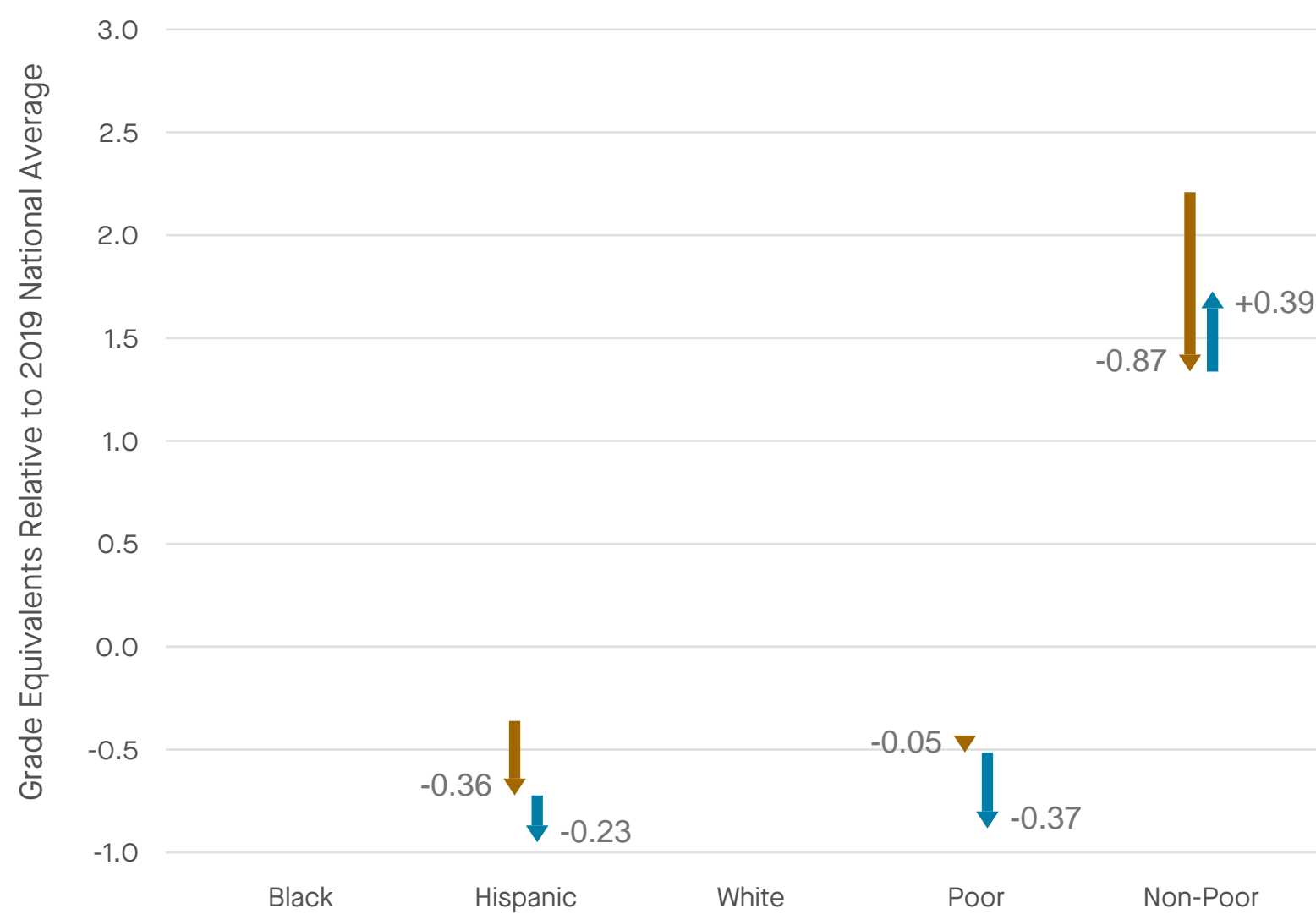

Change in Reading Achievement 2022-2023 by proportion FRPL in California districts



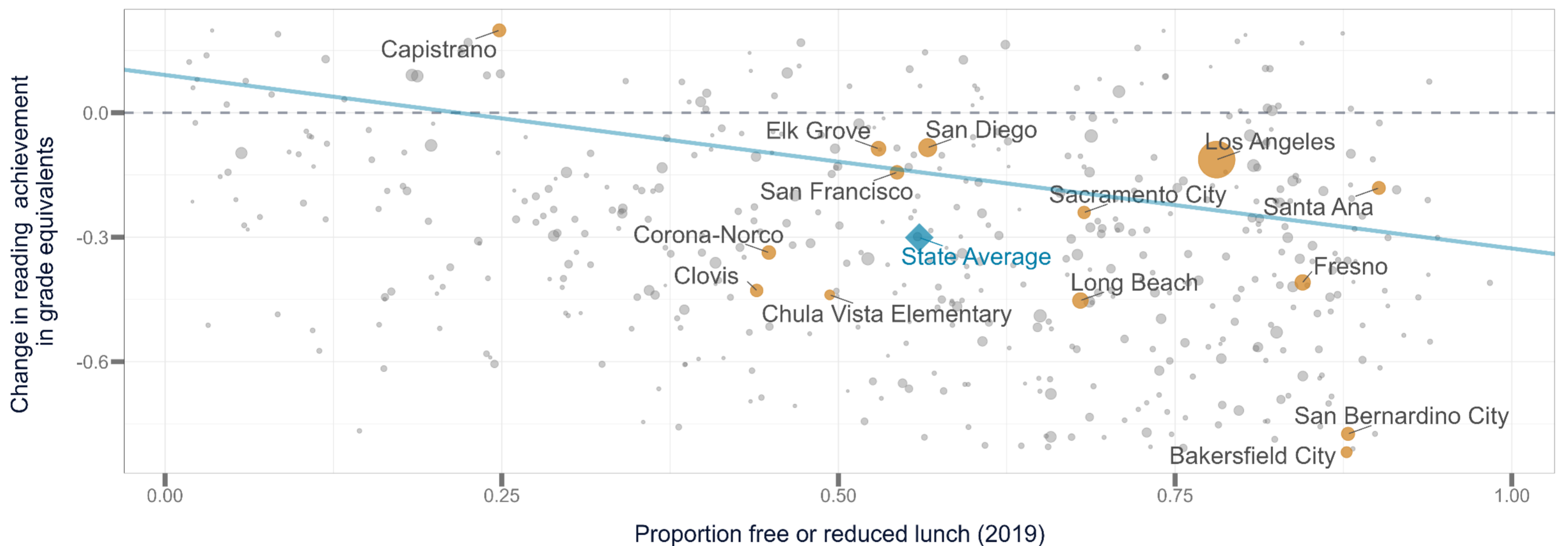

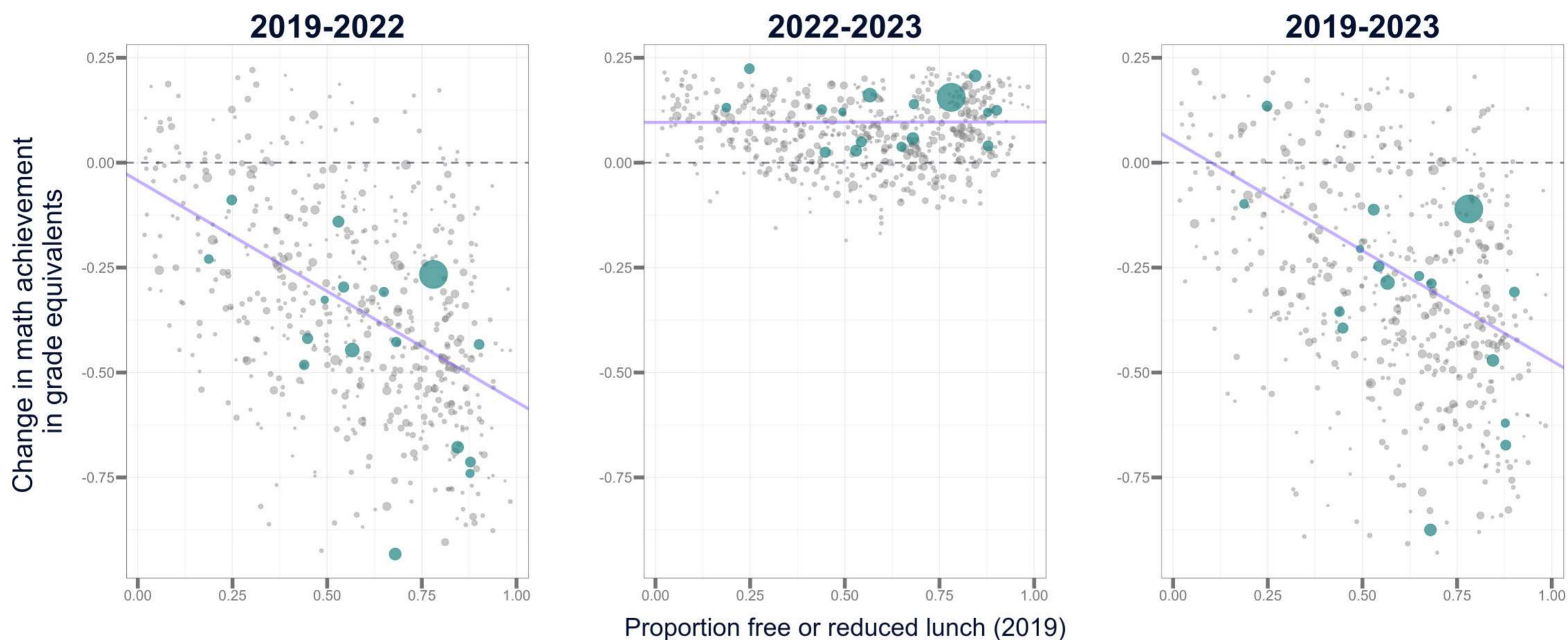
