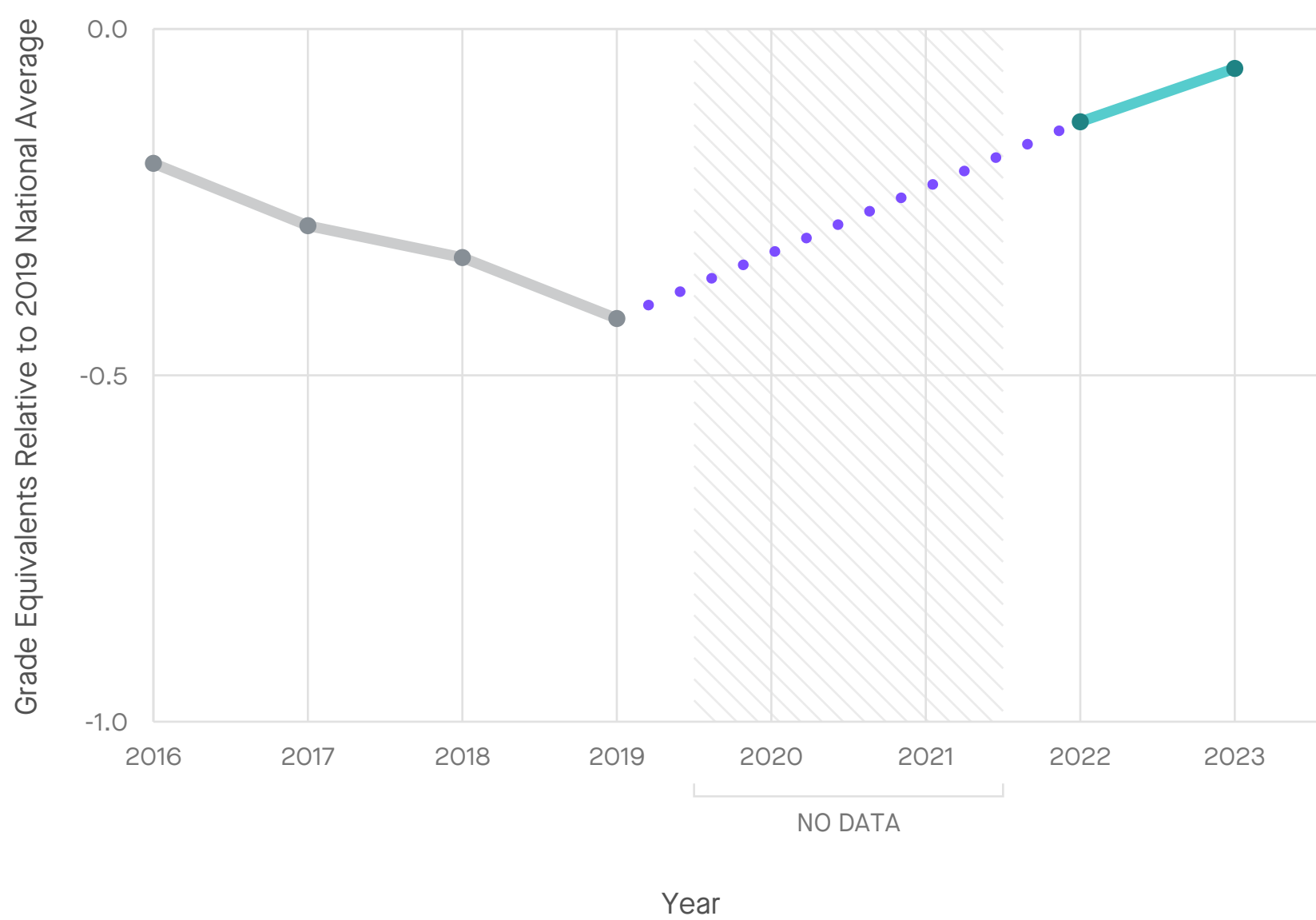

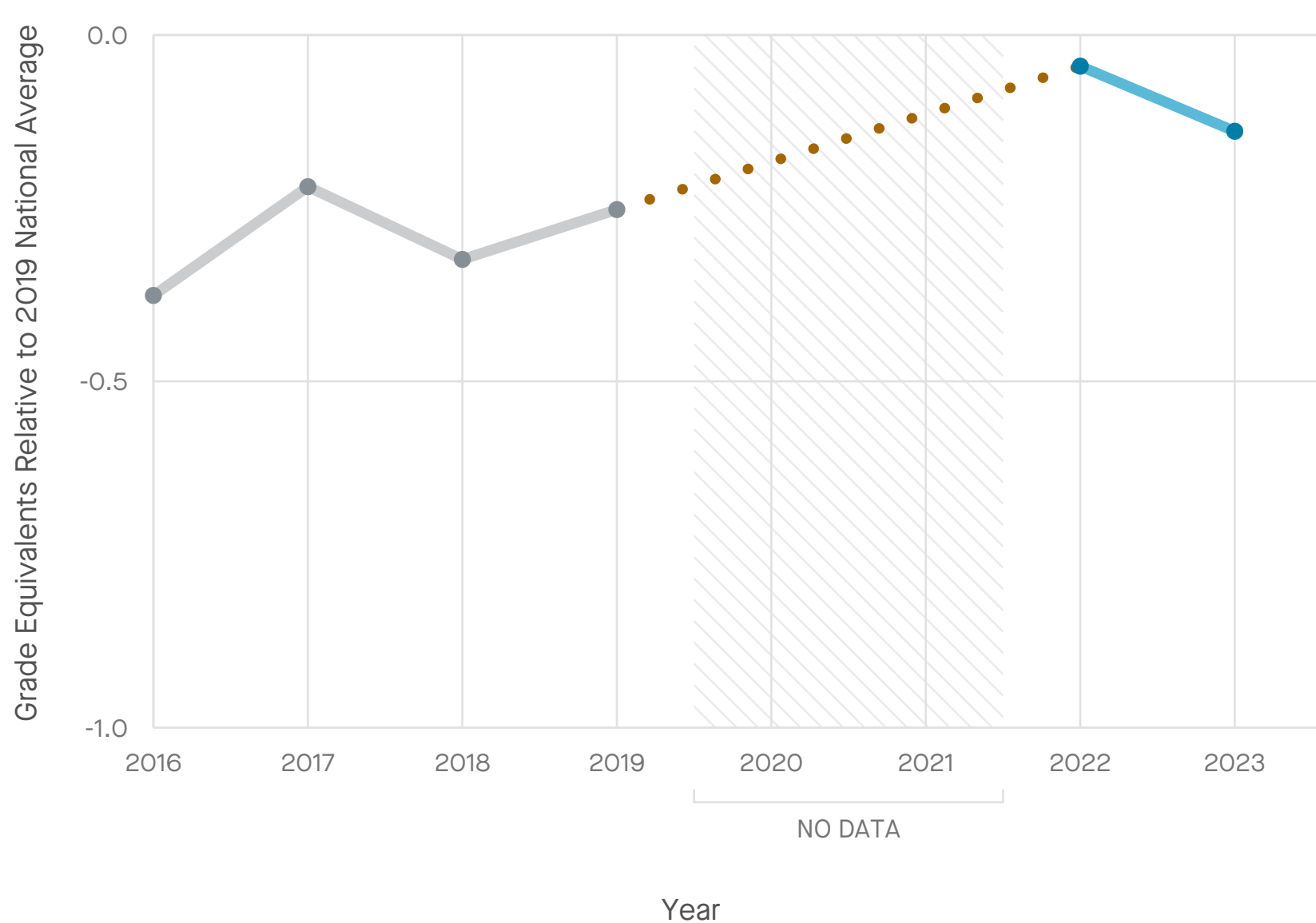

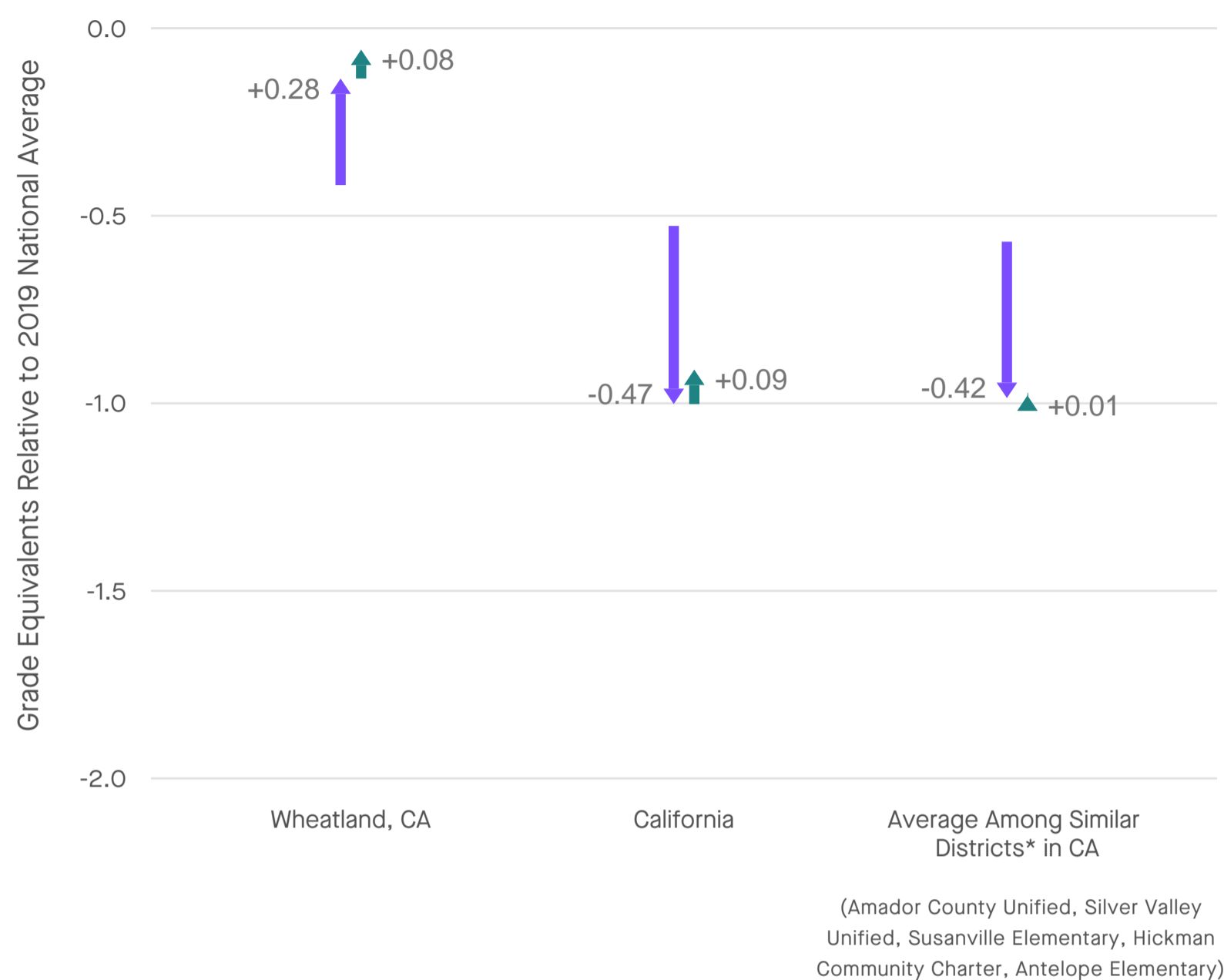

Math Performance in Wheatland vs. California and Similar Districts, Grades 3-8, 2019-2023



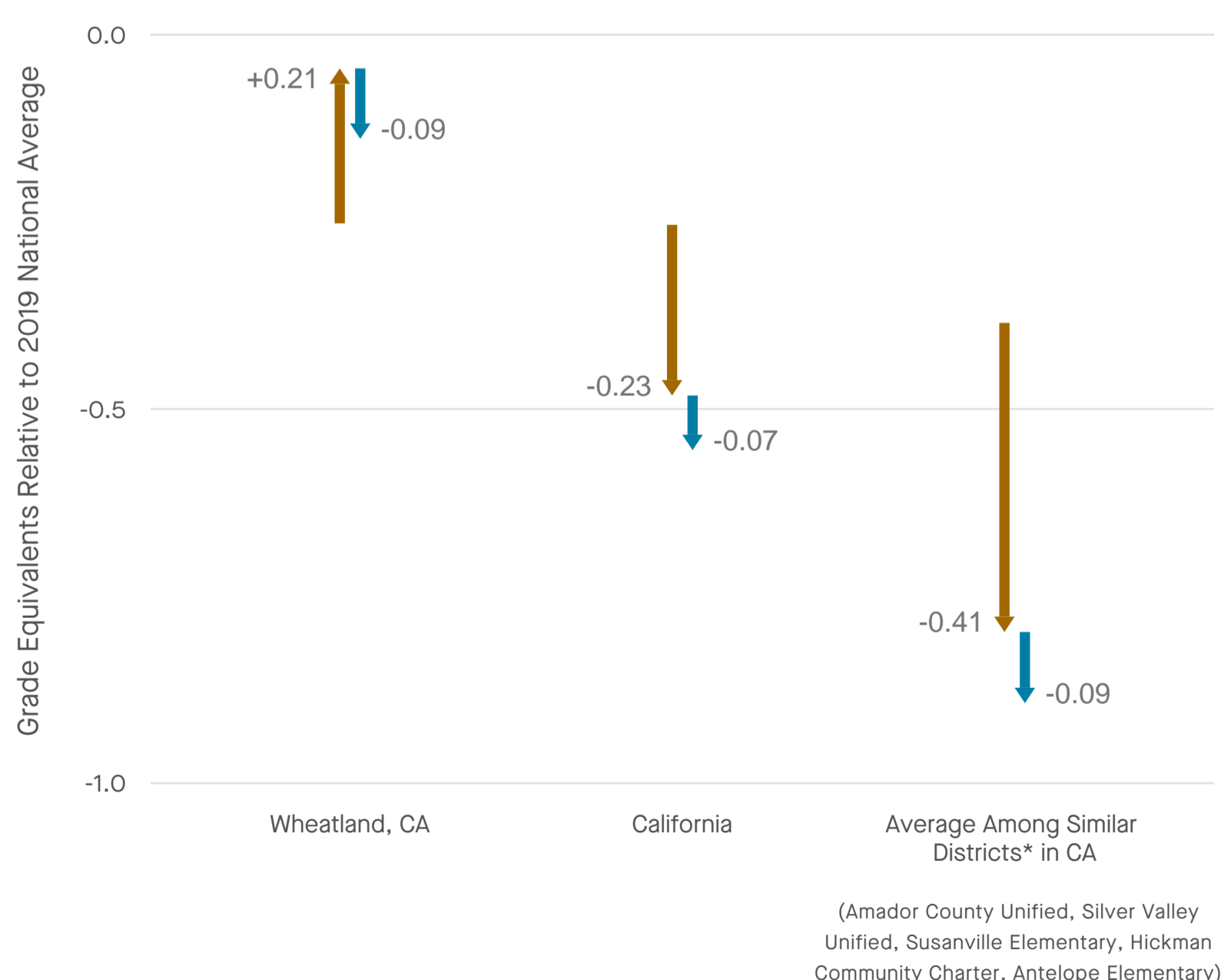

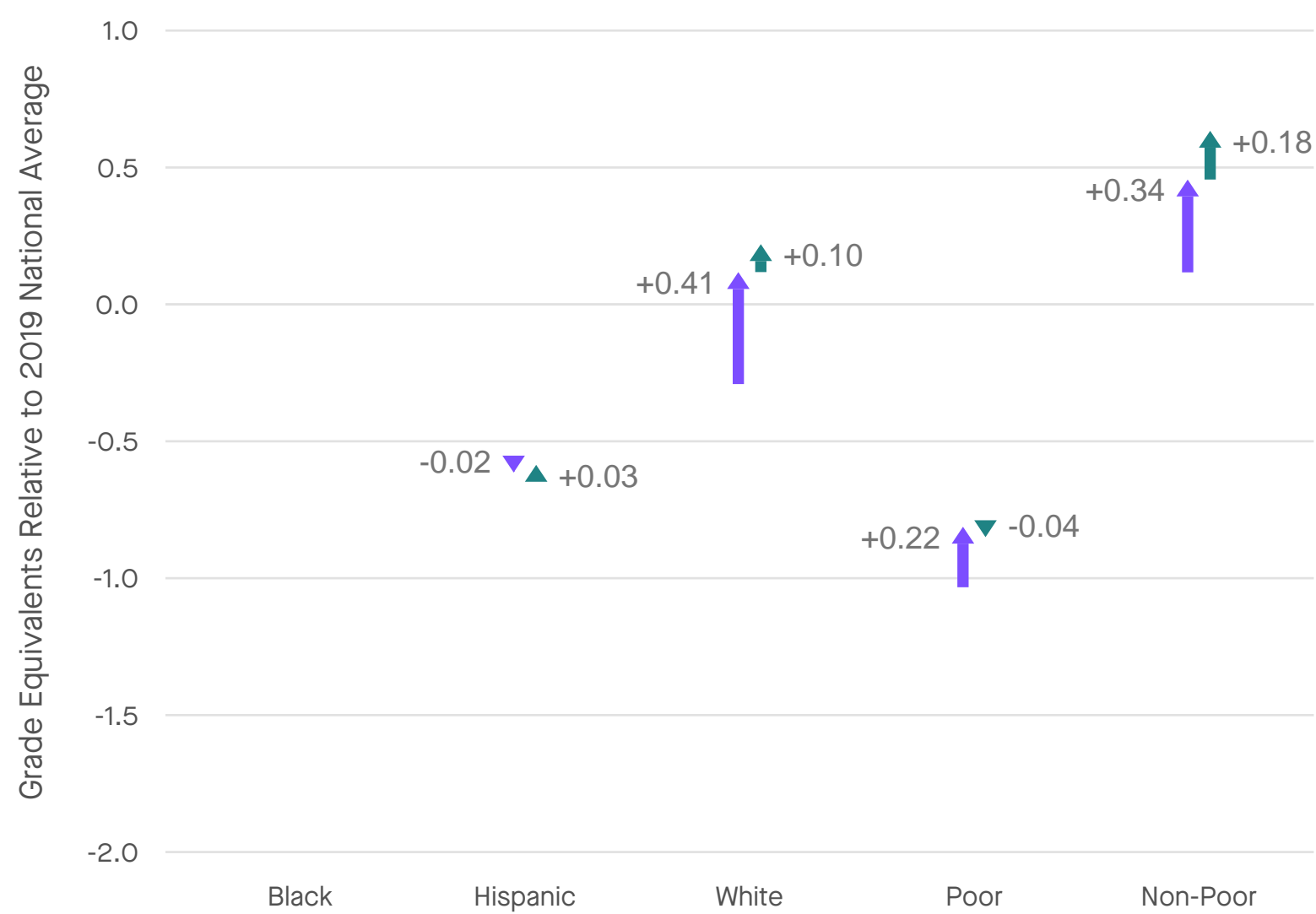
