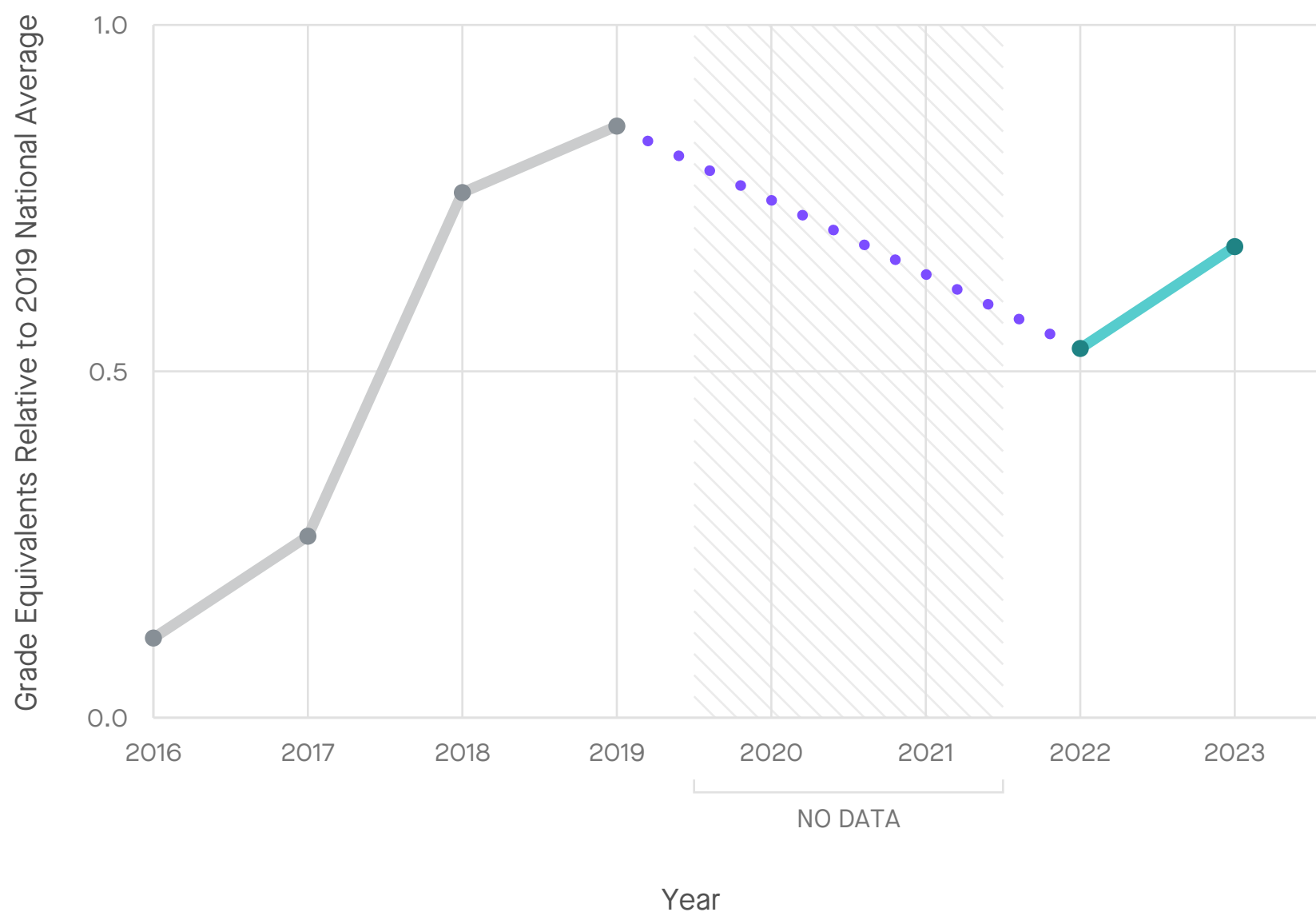

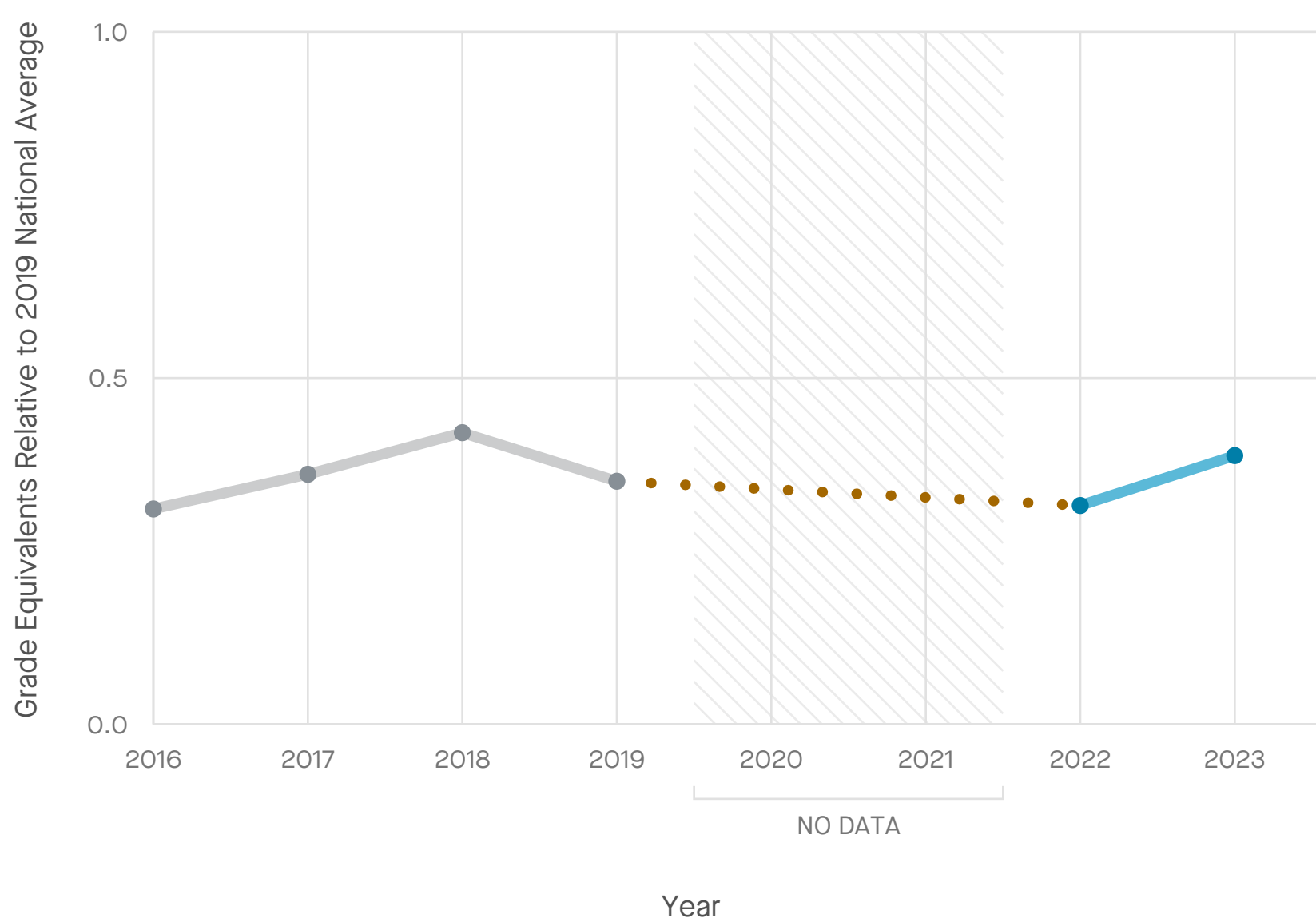

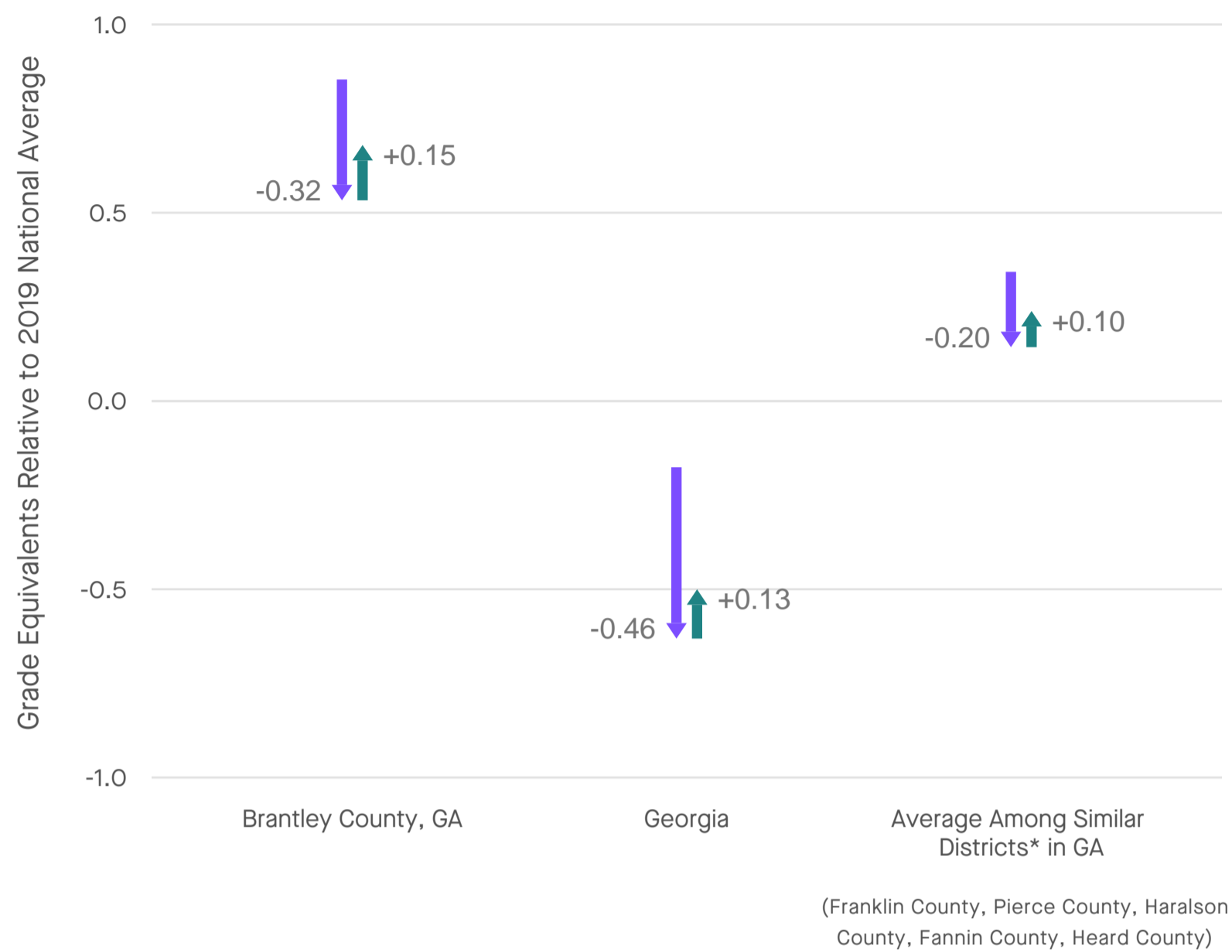

Change in Reading Achievement 2022-2023 by proportion FRPL in Georgia districts



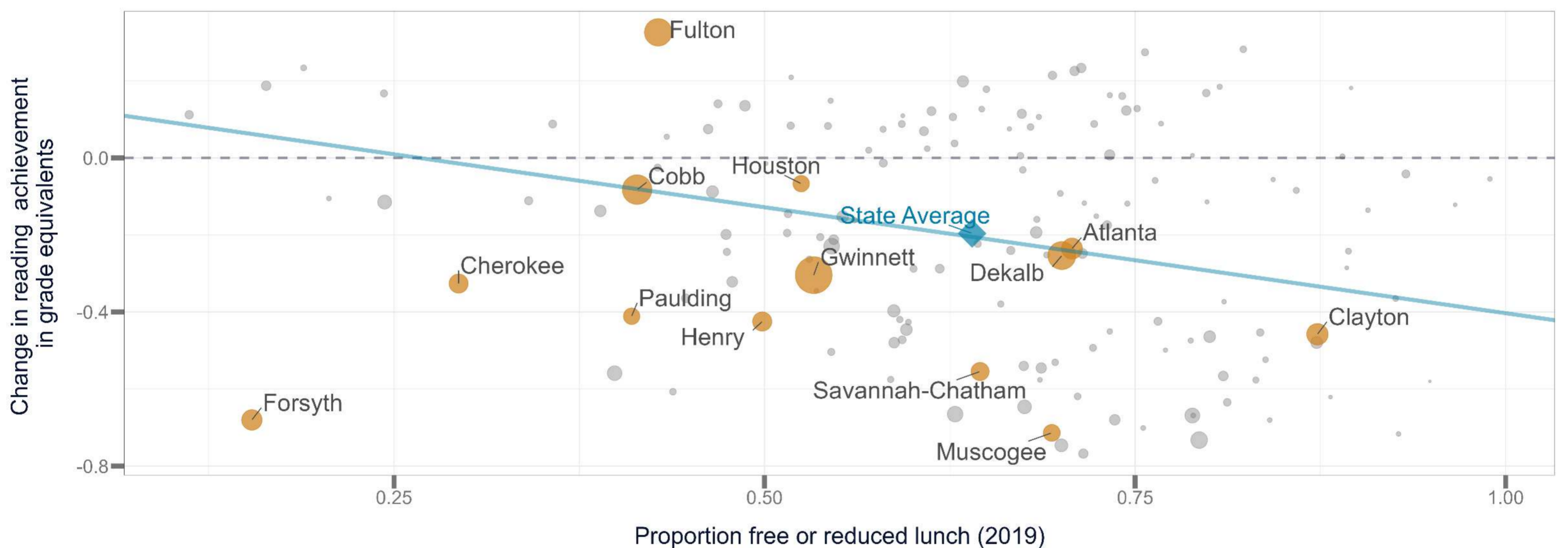

Change in Reading Achievement 2019-2023 by proportion FRPL in Georgia districts



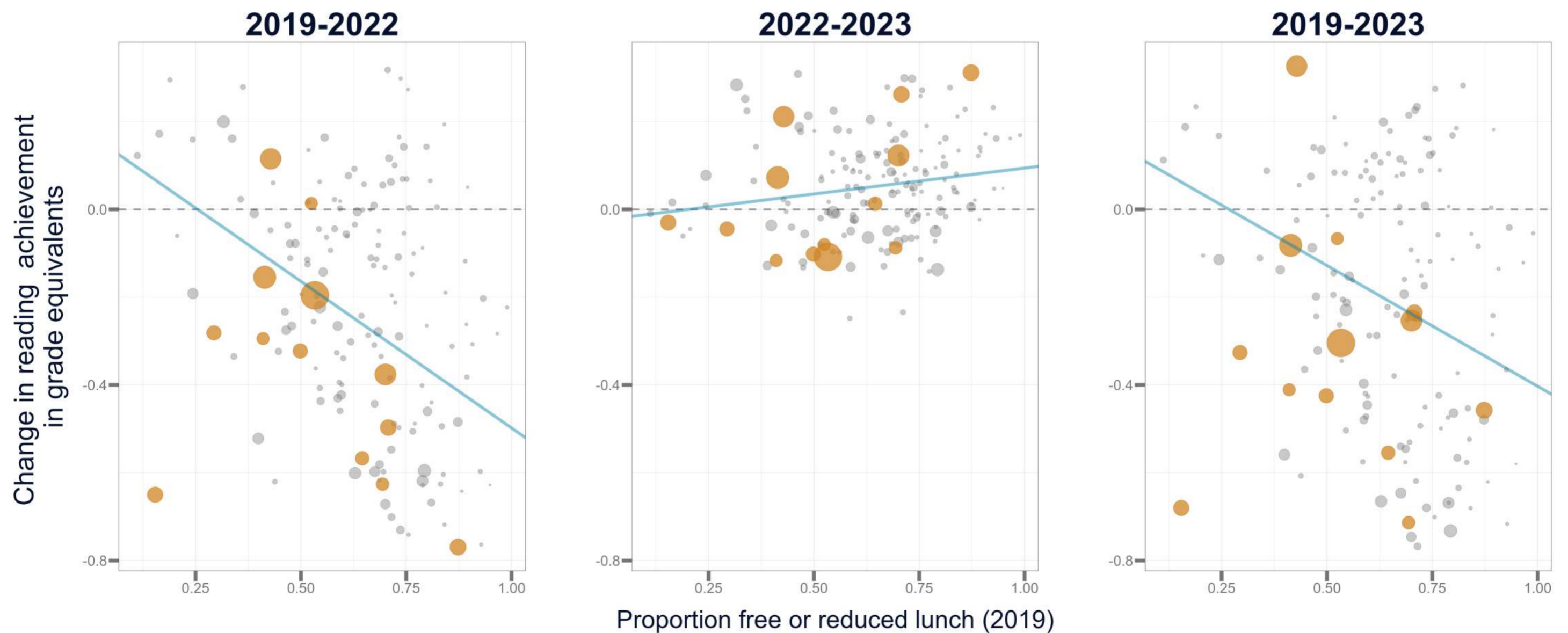
