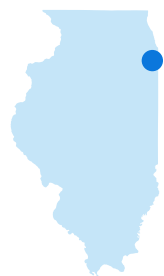
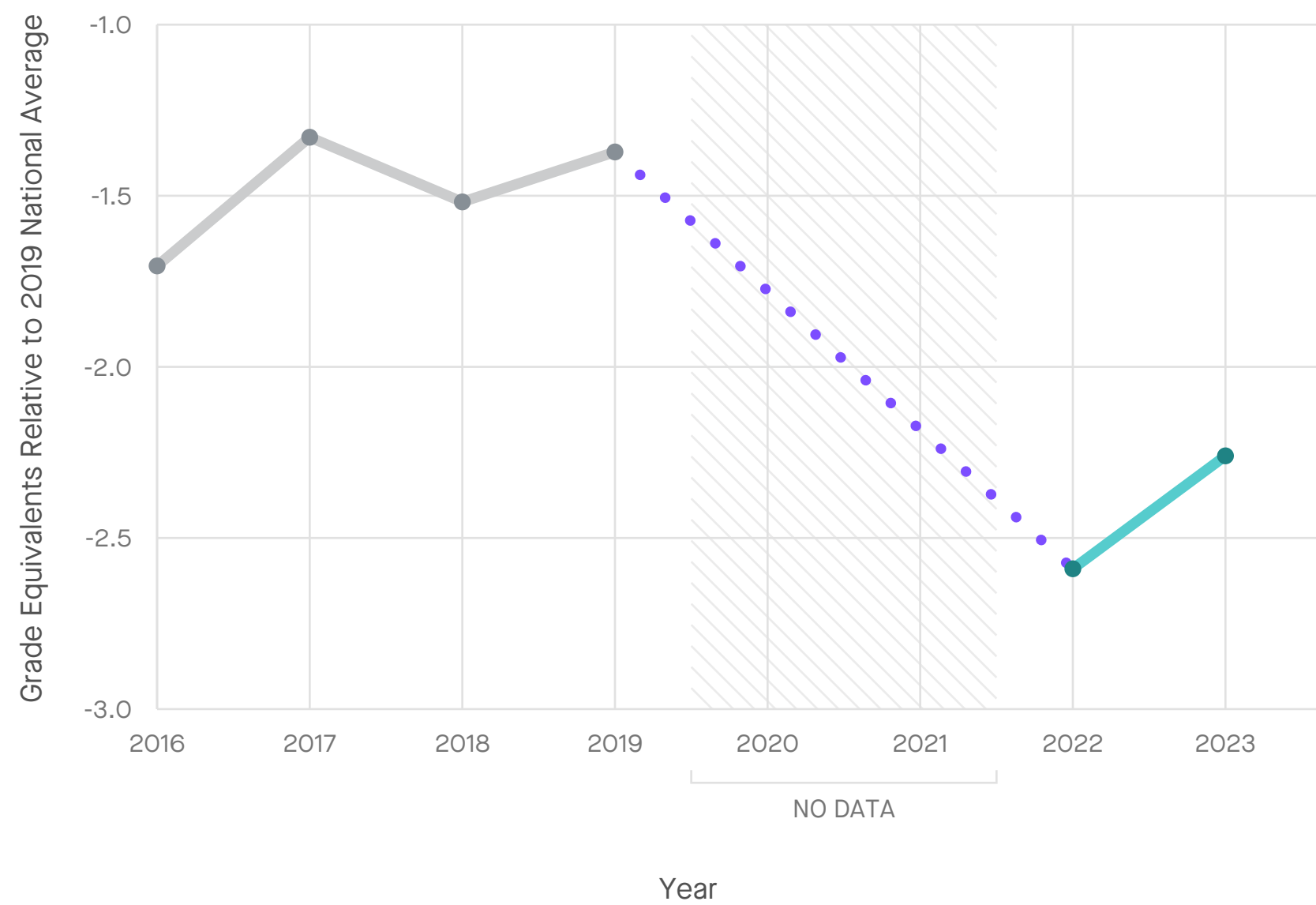

## Math Performance, Grades 3-8, 2016-2023

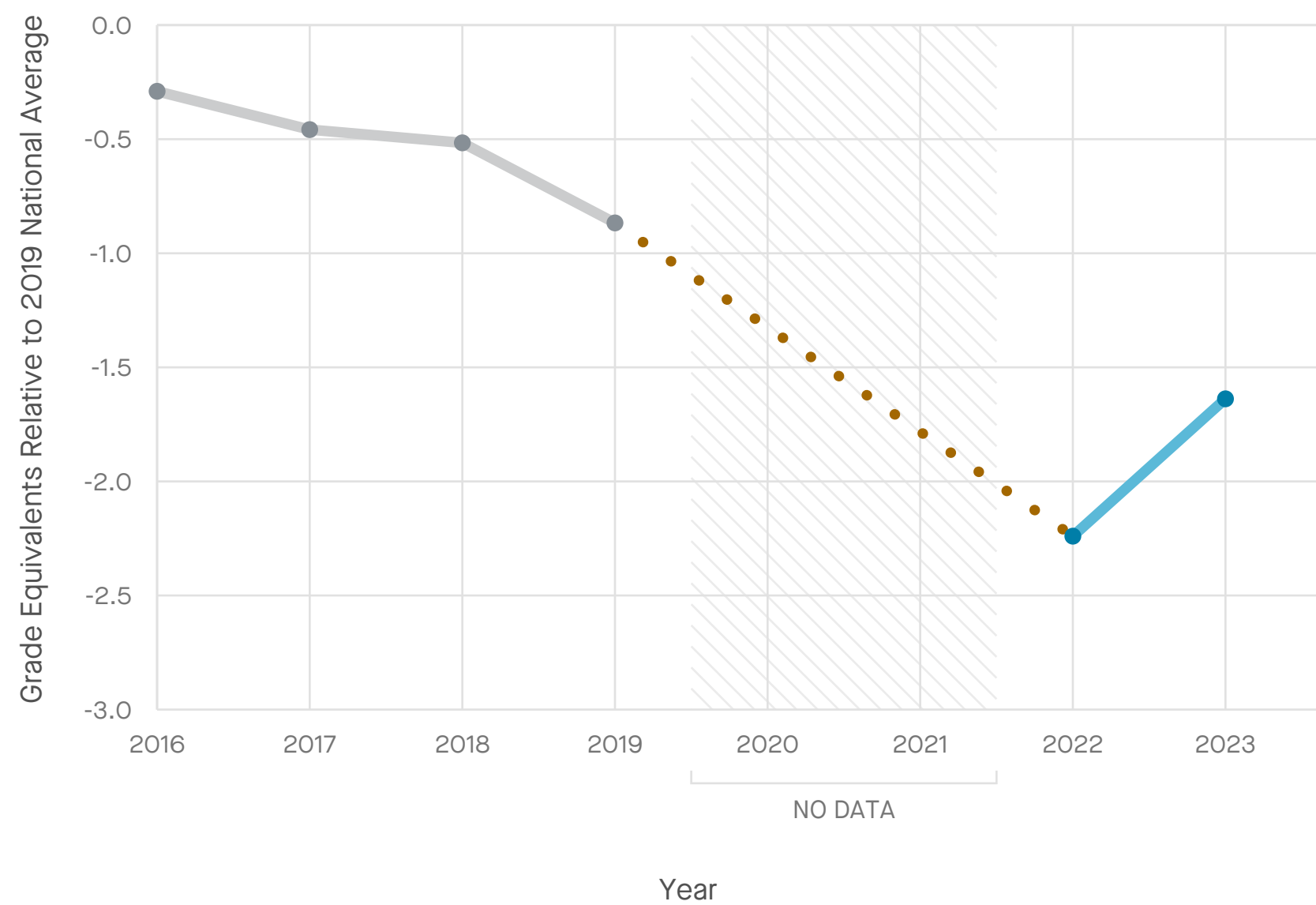

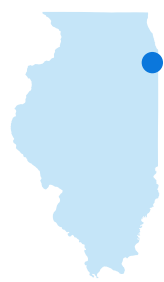

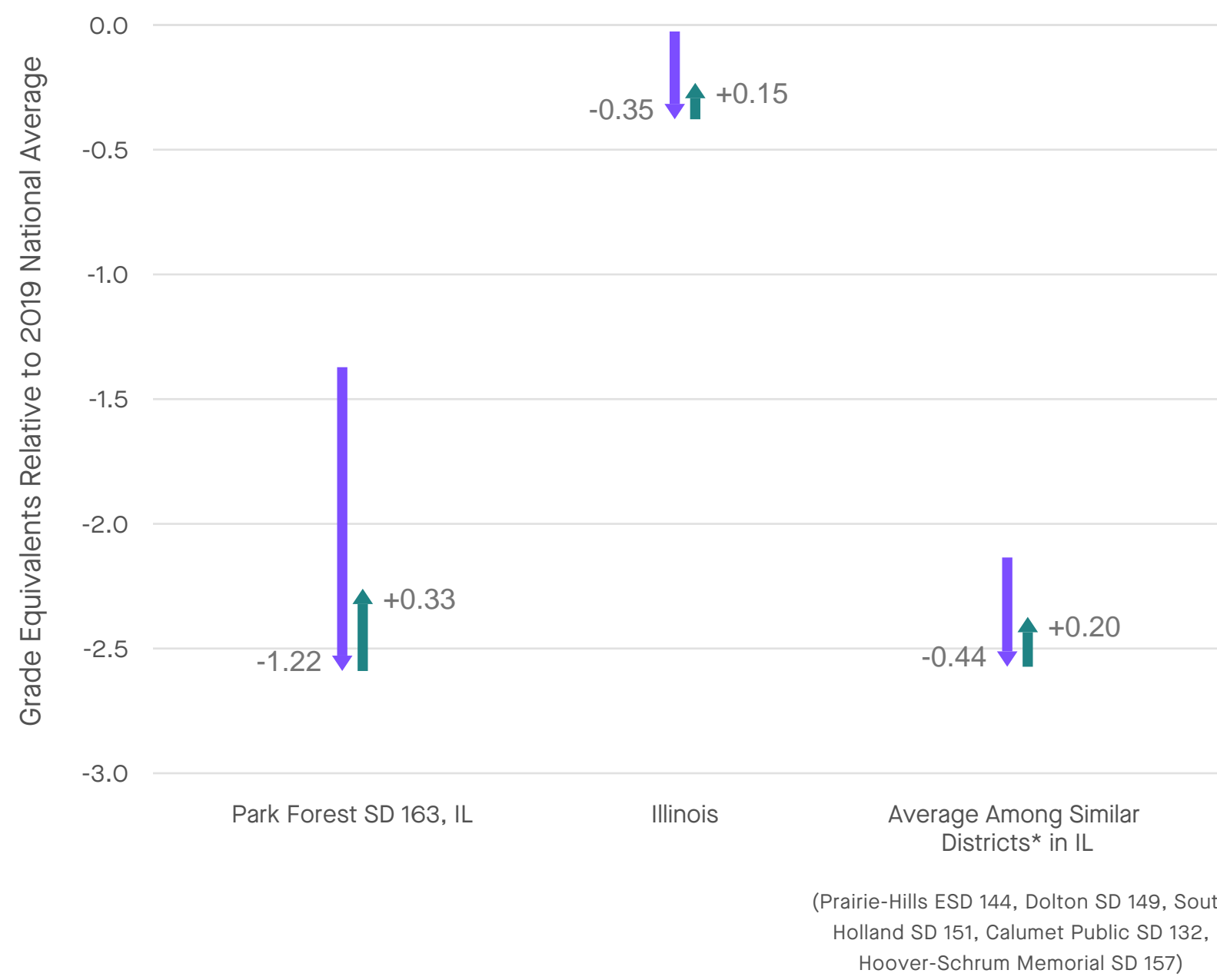

## Math Performance in Park Forest SD 163 vs. Illinois and Similar Districts, Grades 3-8, 2019-2023



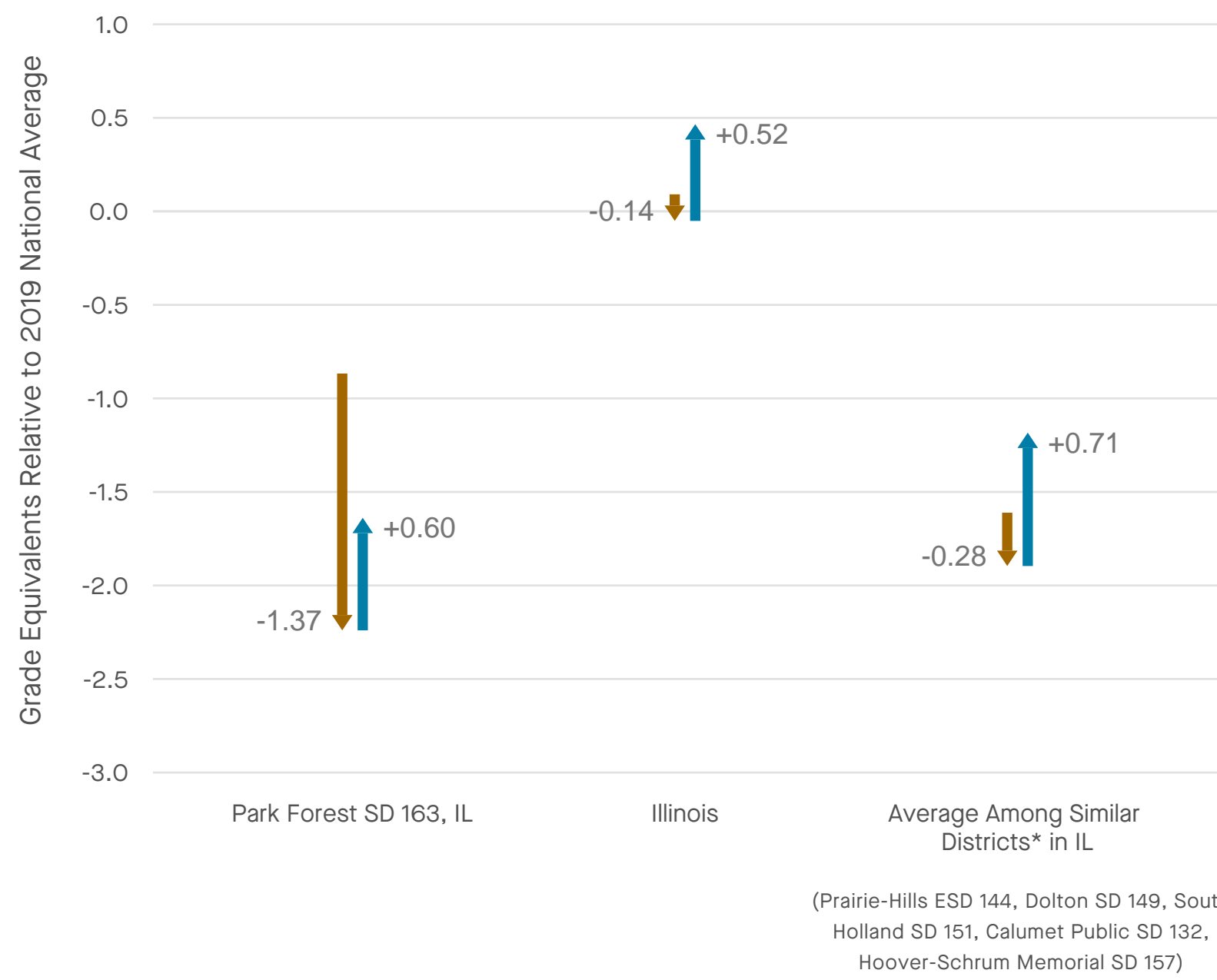

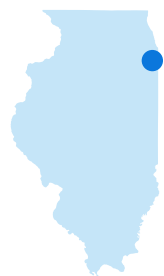

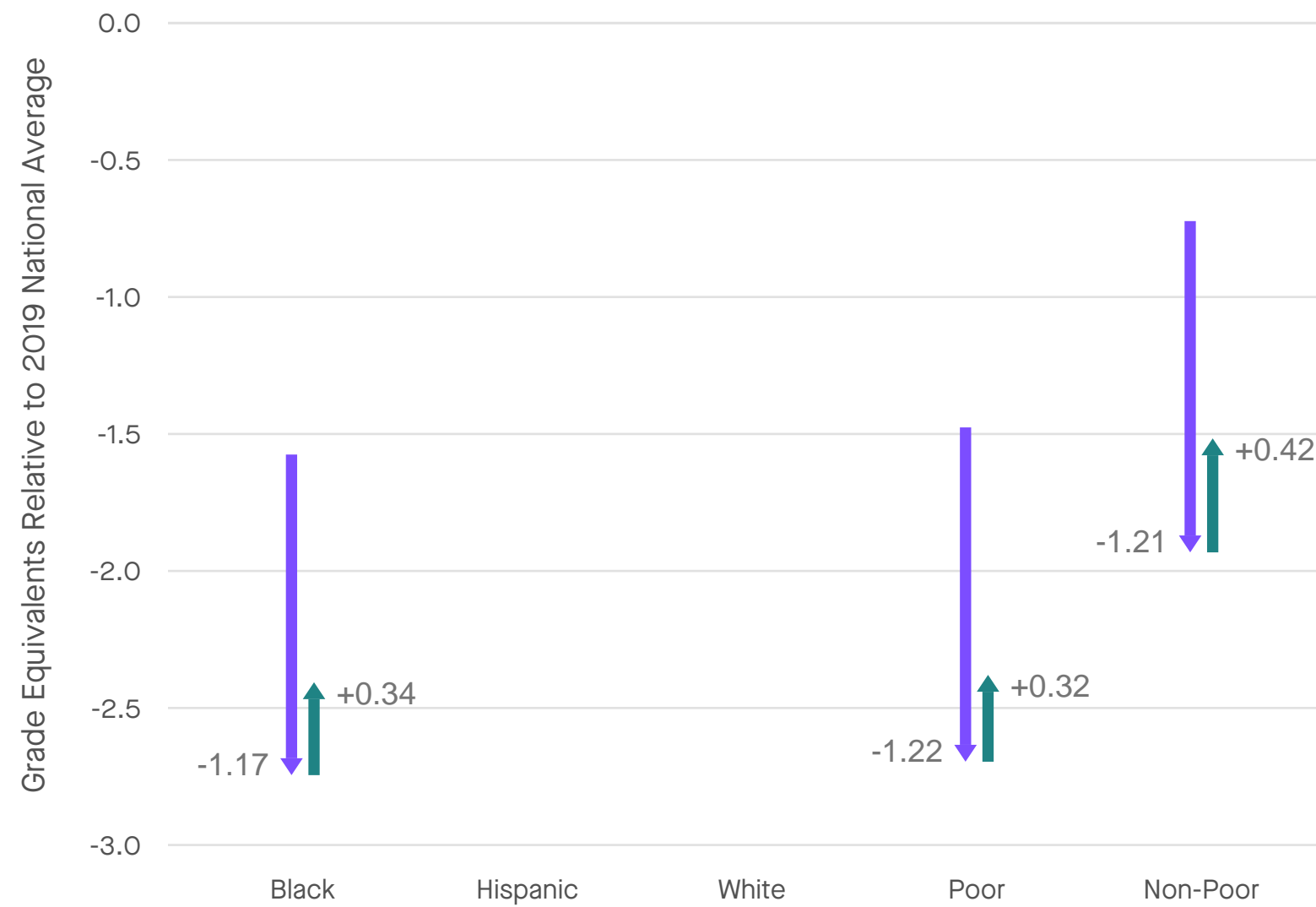

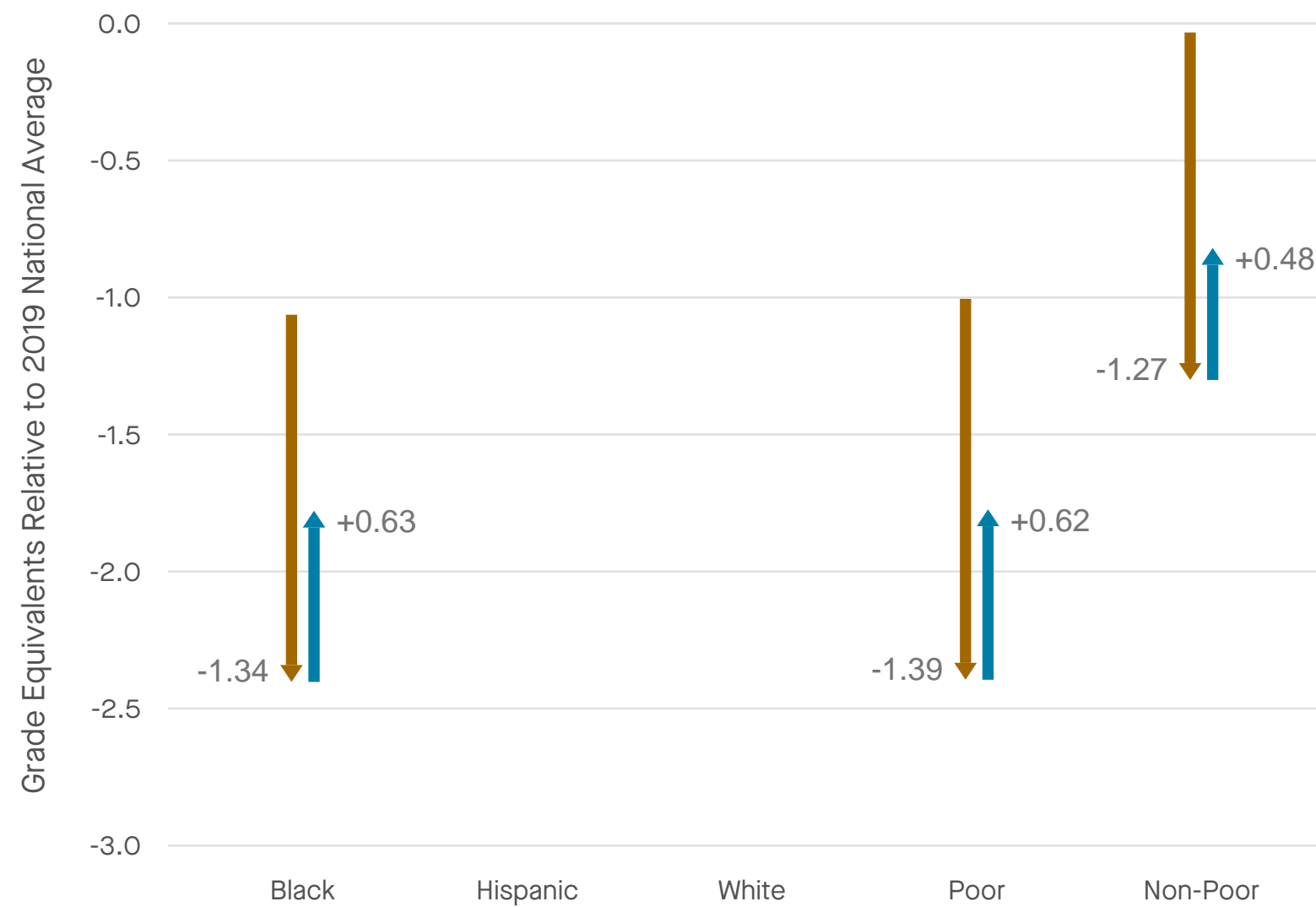

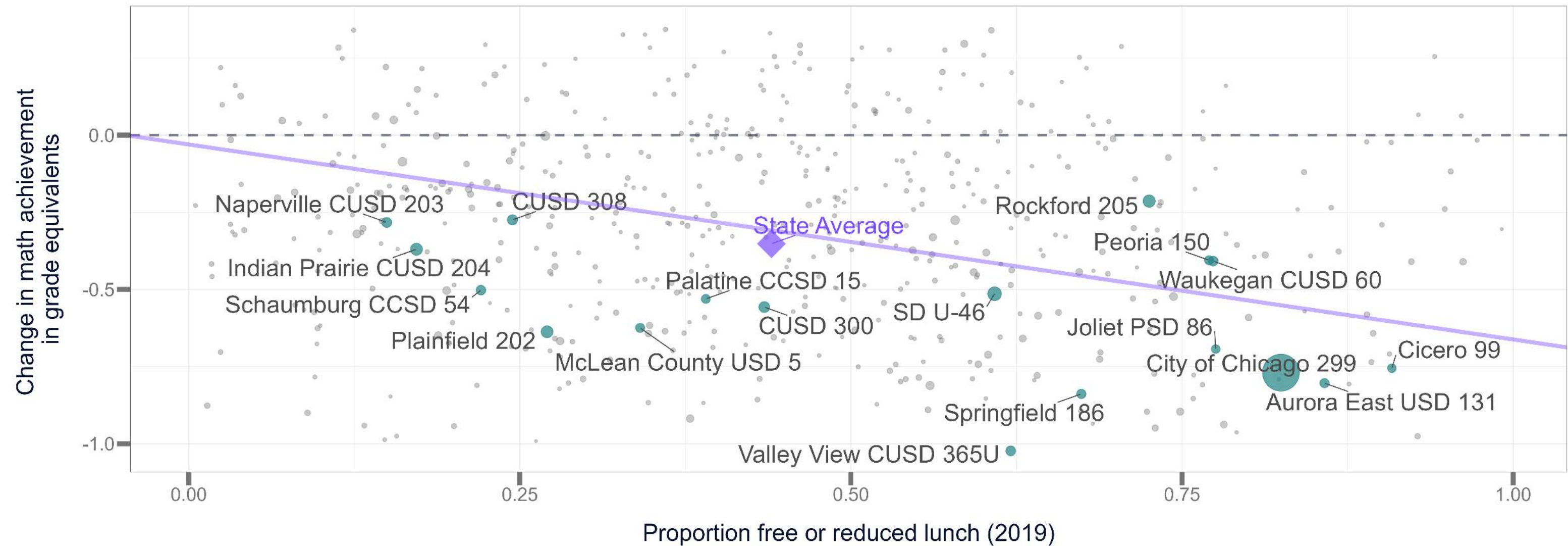

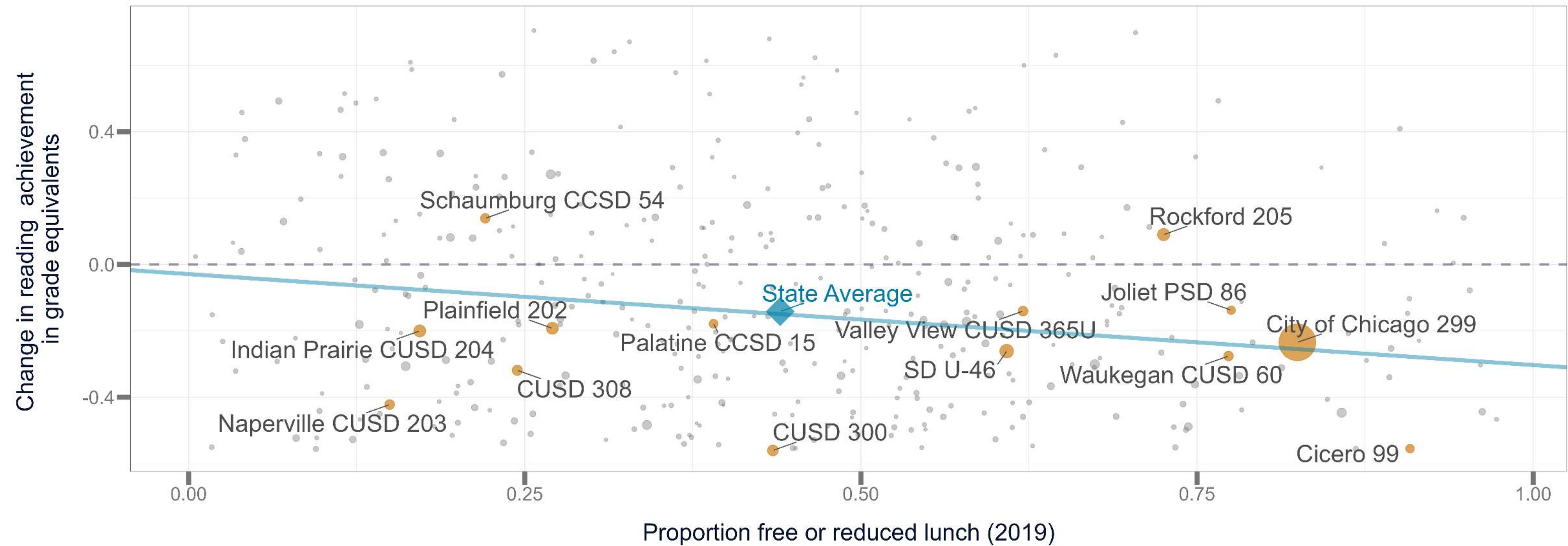

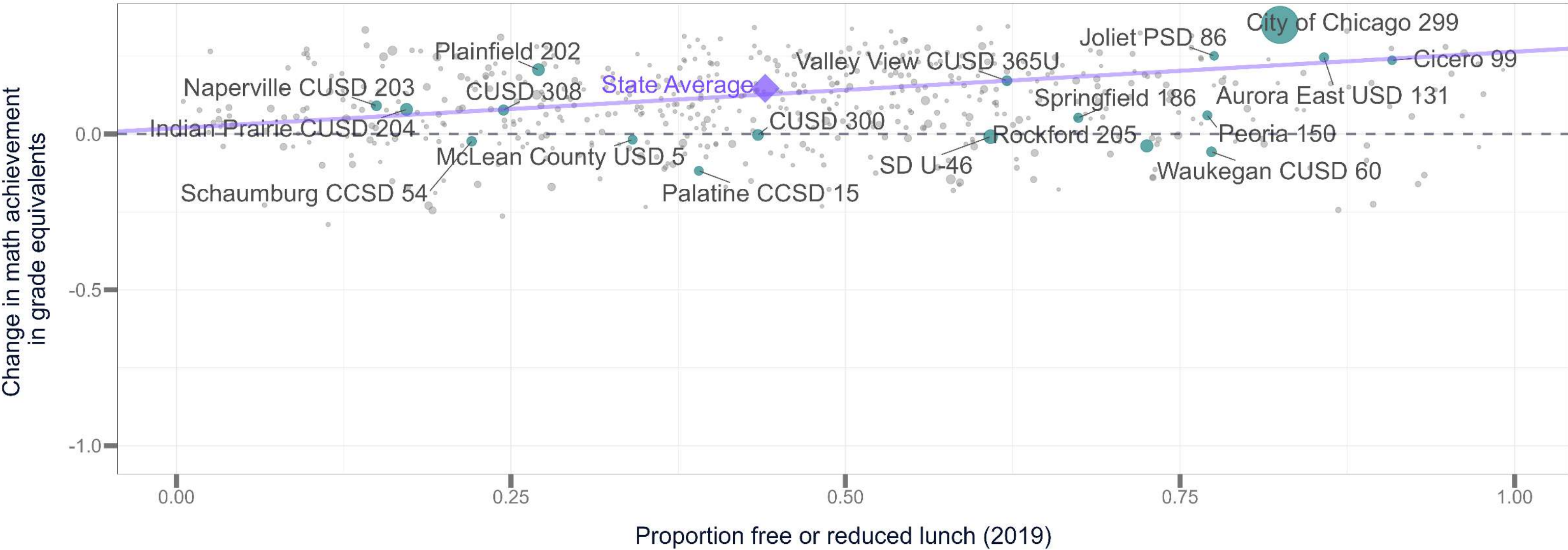
Change in Reading Achievement 2019-2022

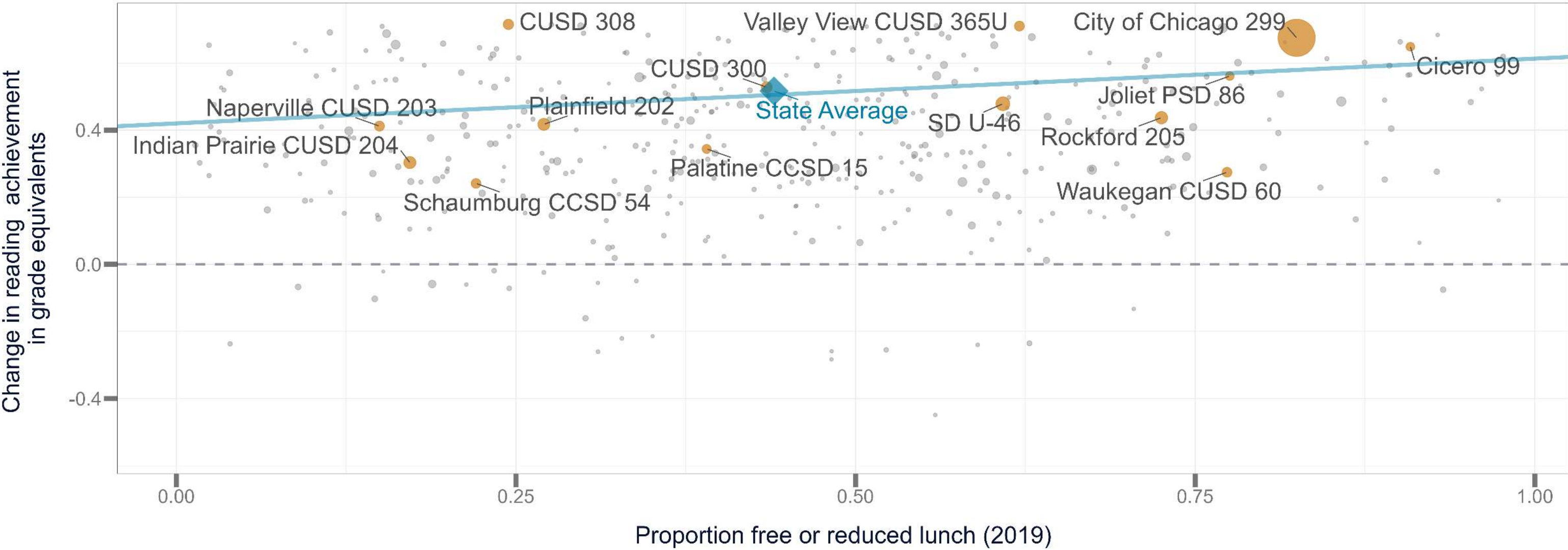


# Change in Math Achievement 2022-2023 by proportion FRPL in Illinois districts

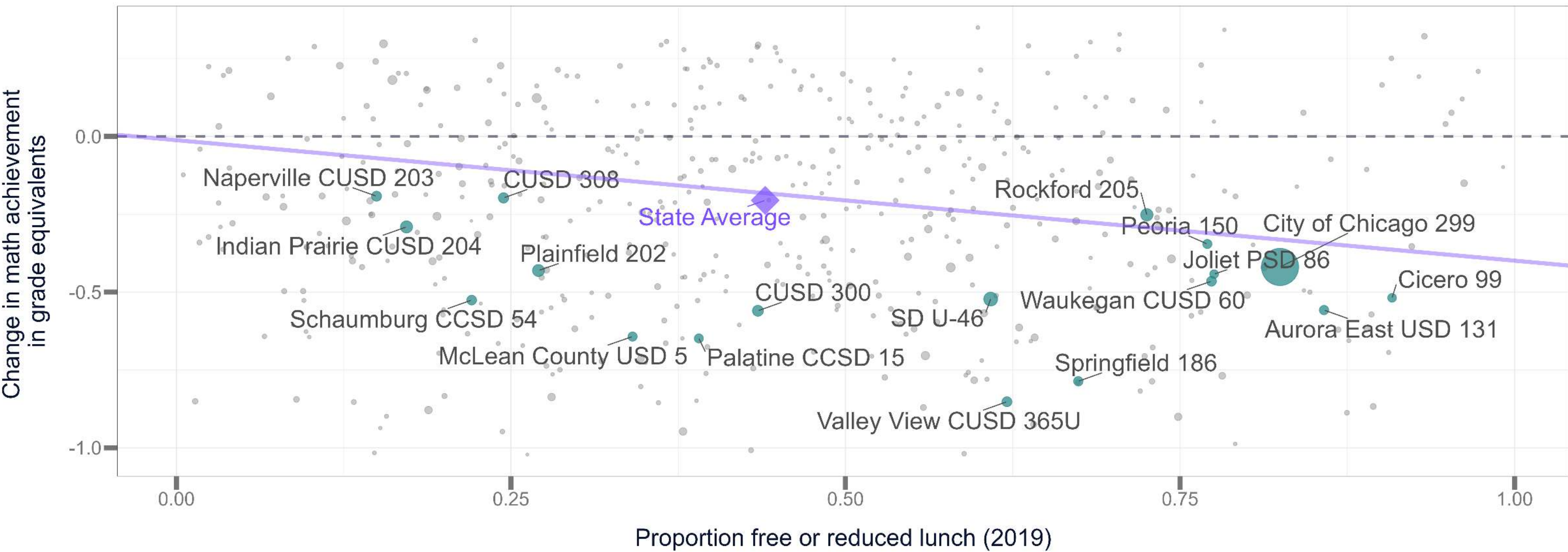

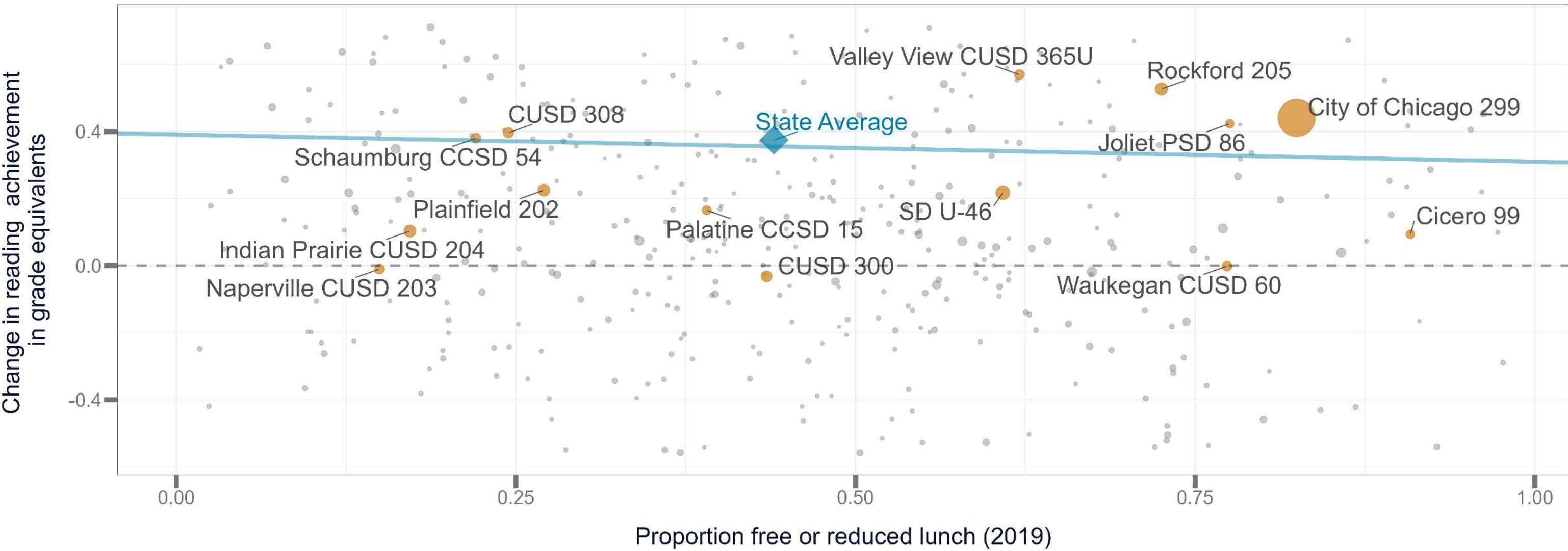


# Change in Math Achievement 2019-2023 by proportion FRPL in Illinois districts

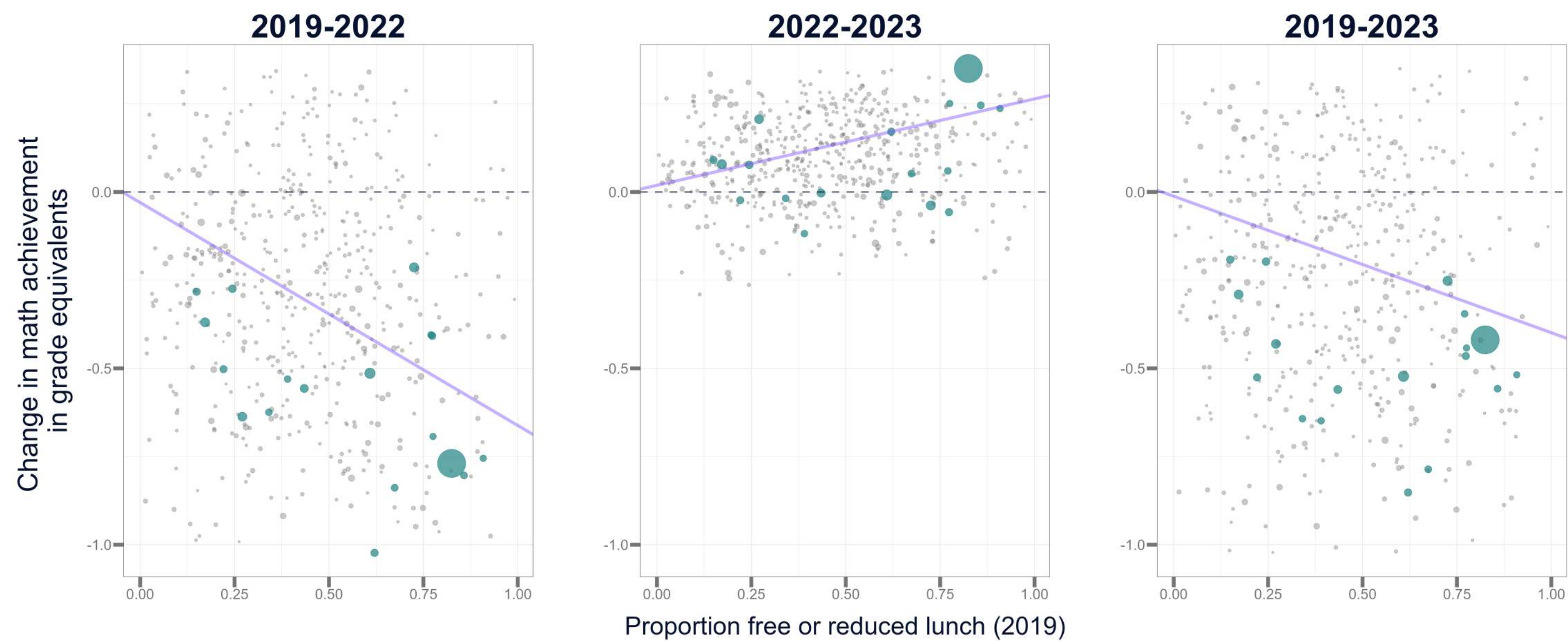

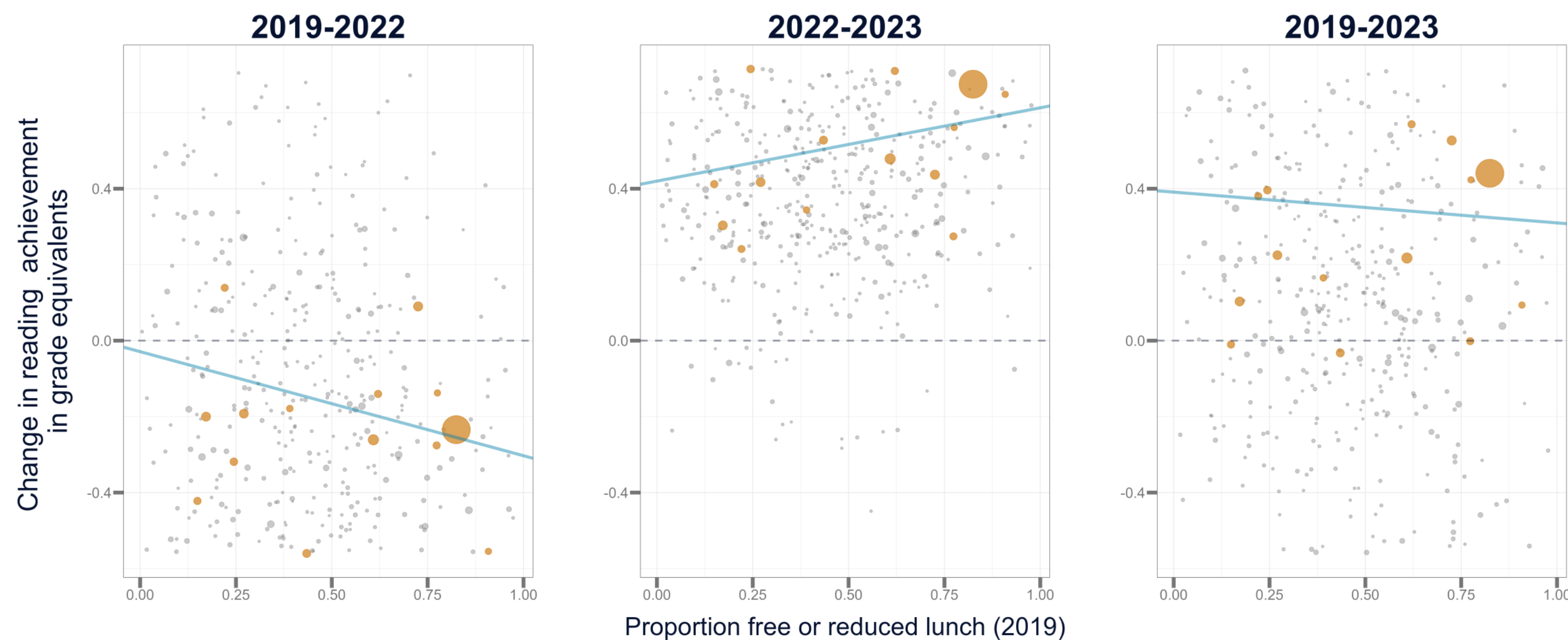

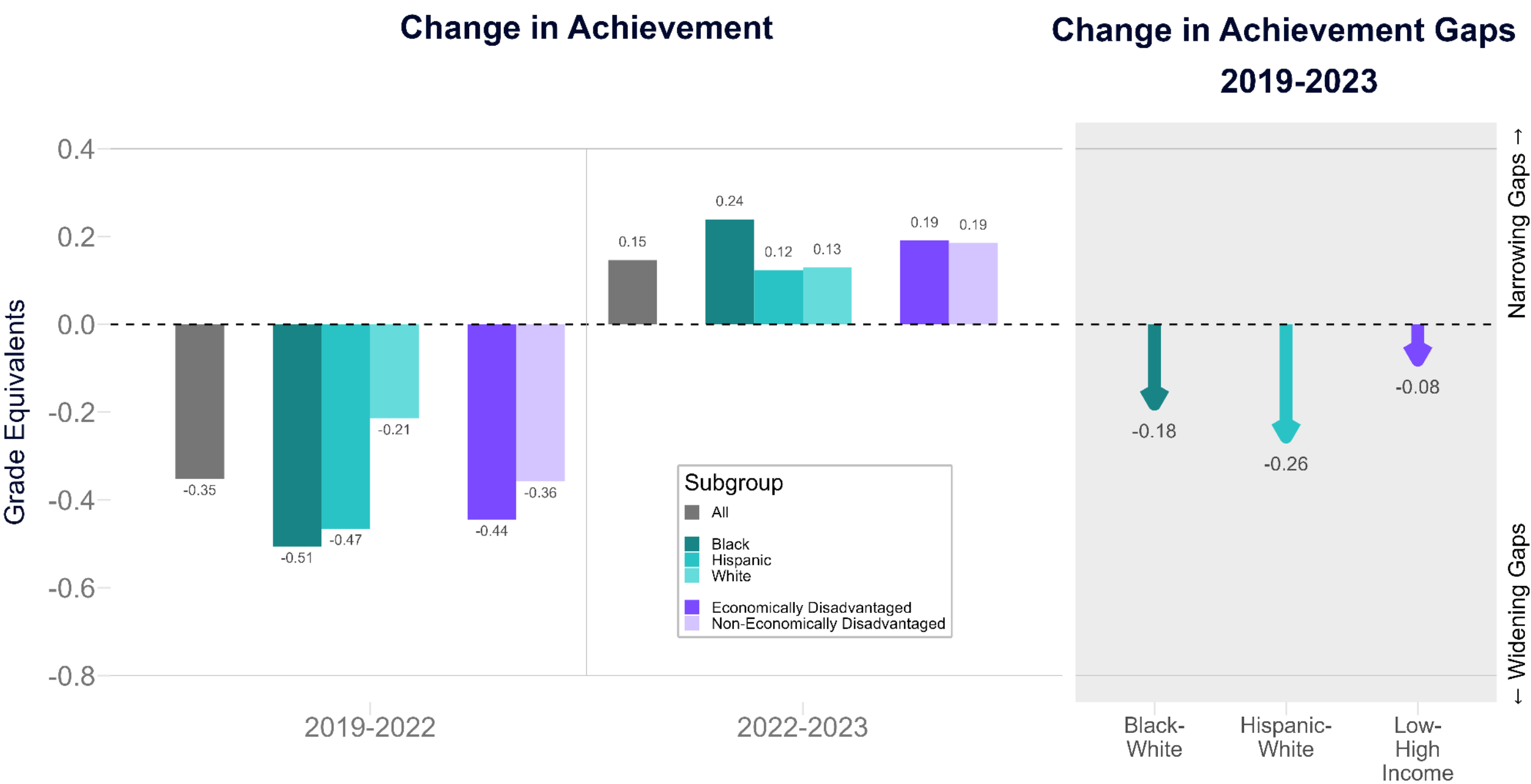

by proportion FRPL in Illinois districts



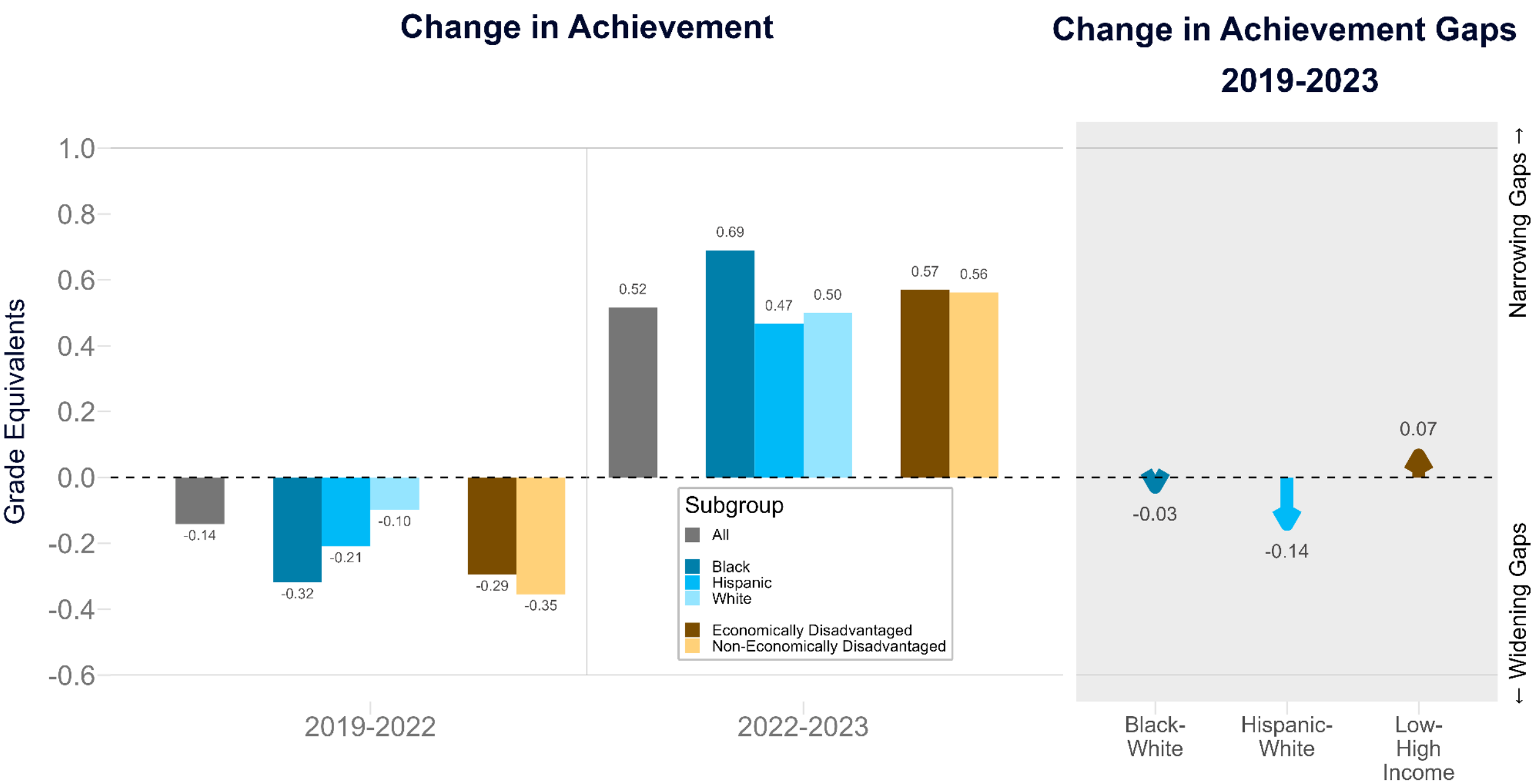
