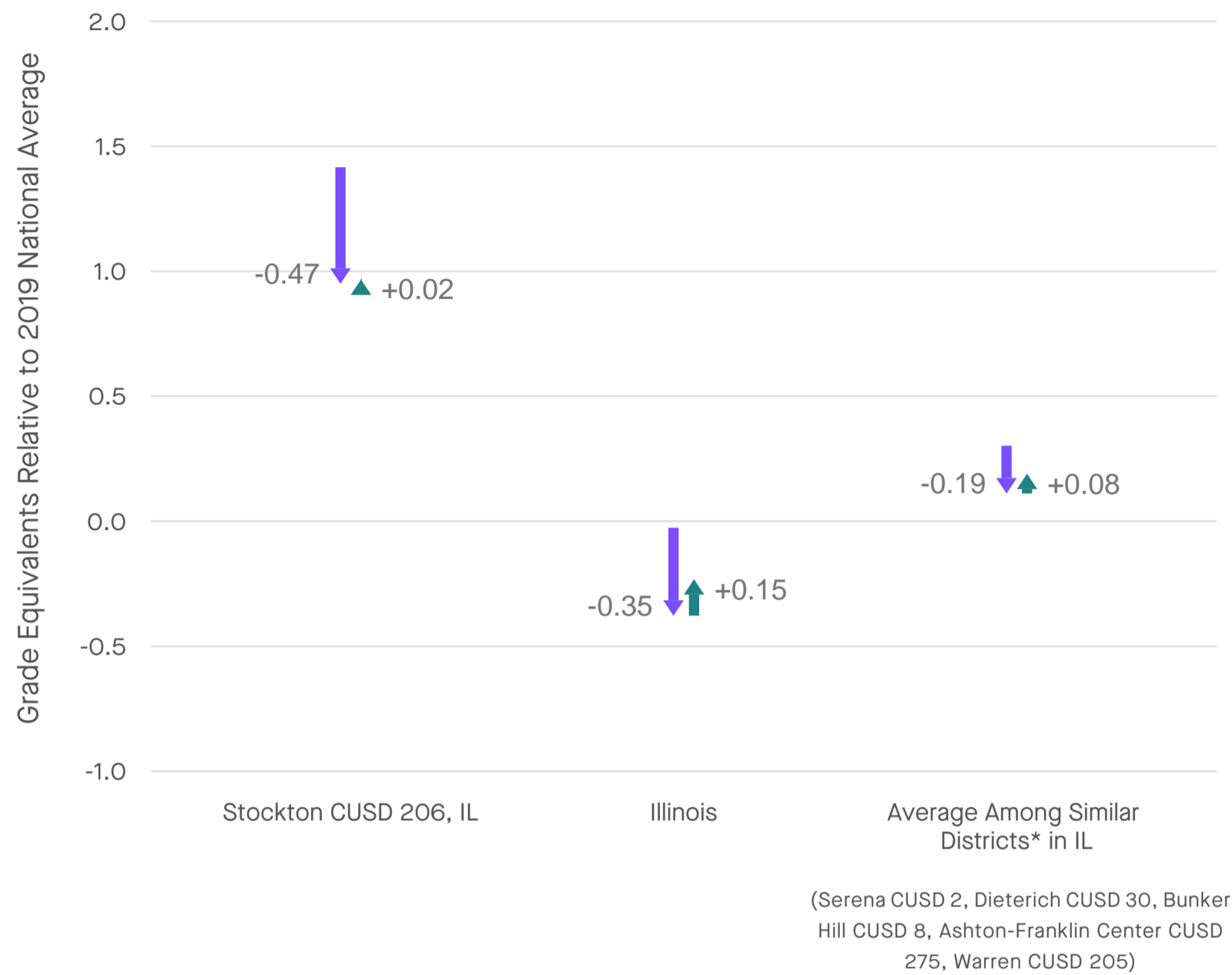

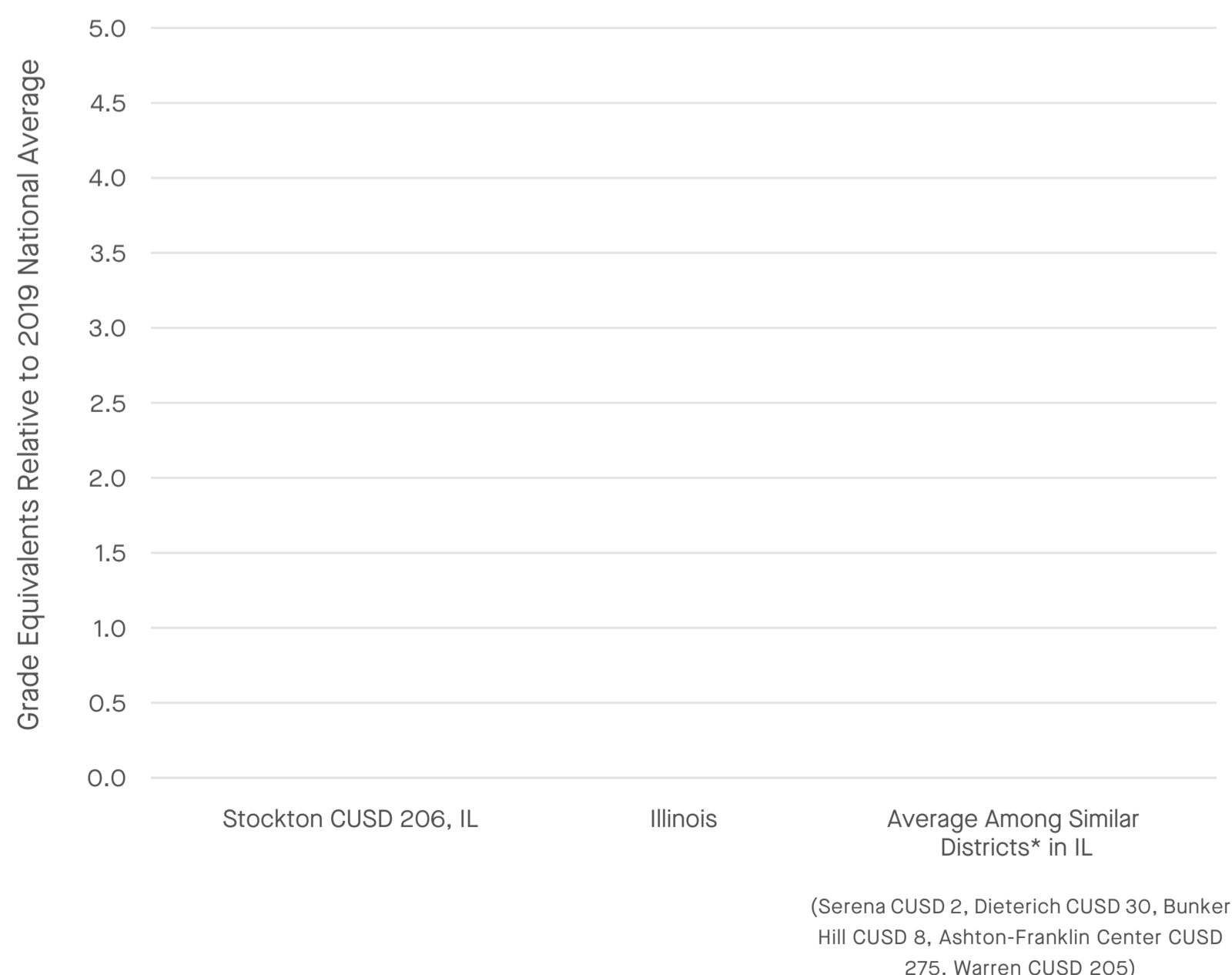

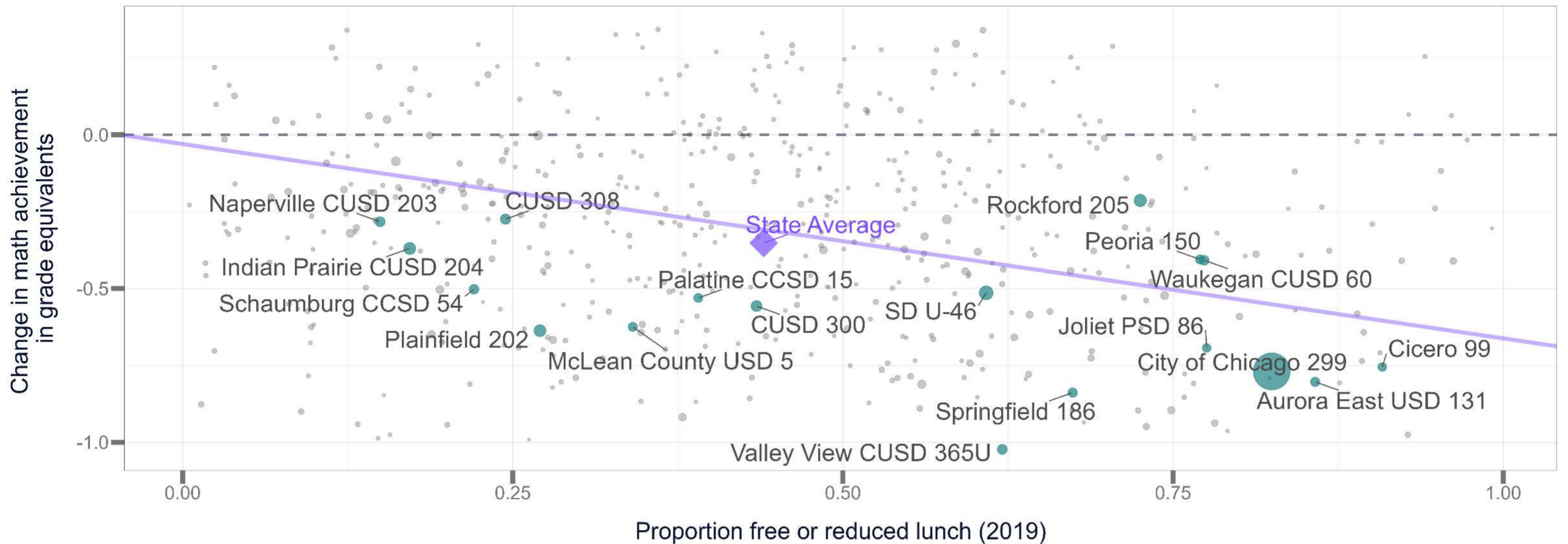

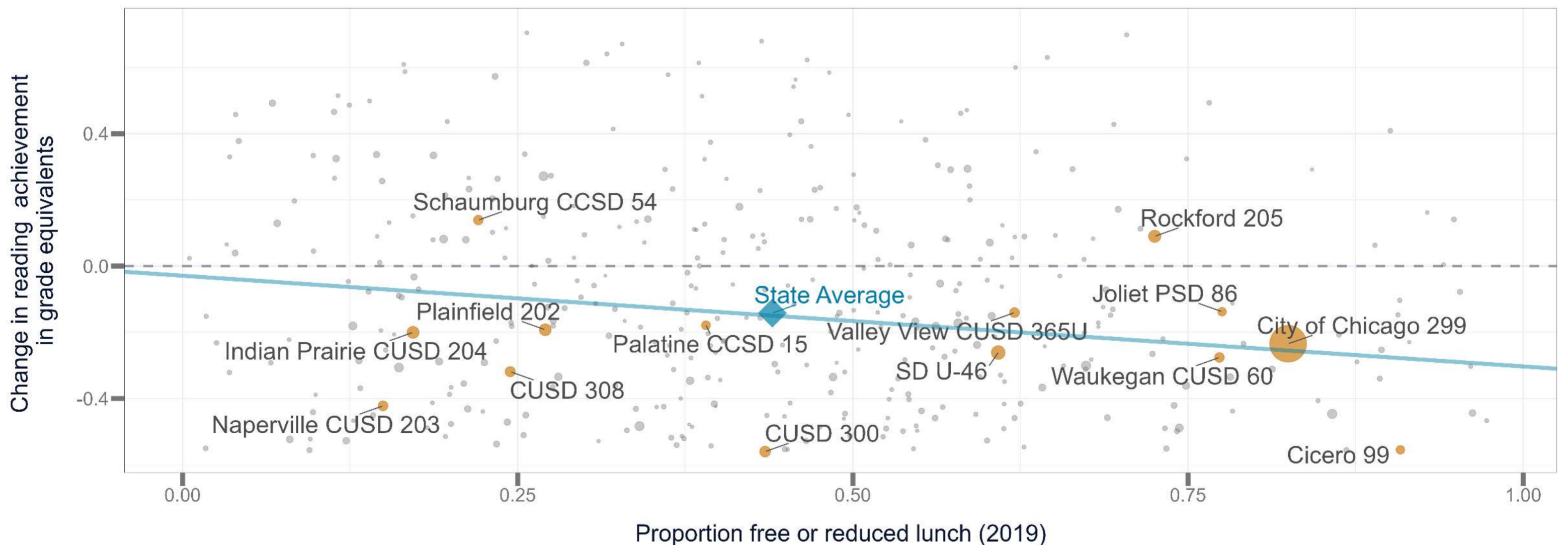
## Change in Math Achievement 2019-2022 by proportion FRPL in Illinois districts

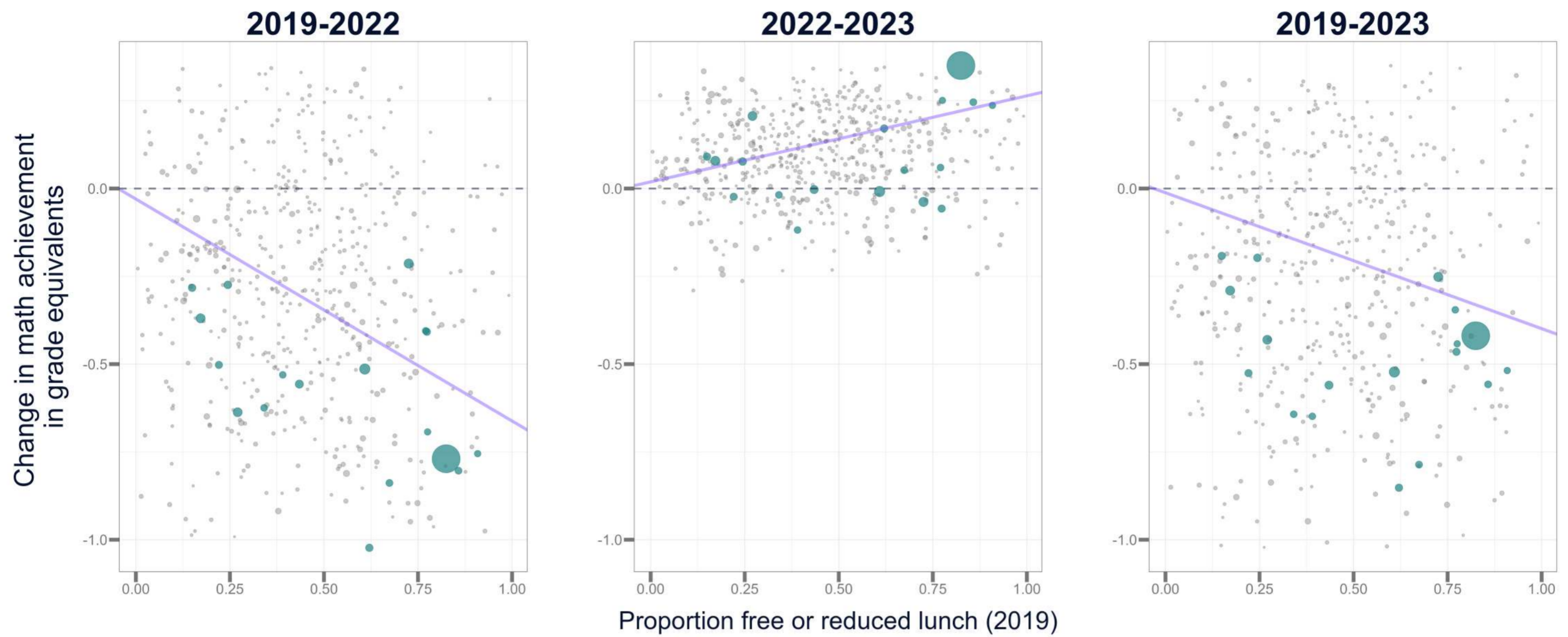

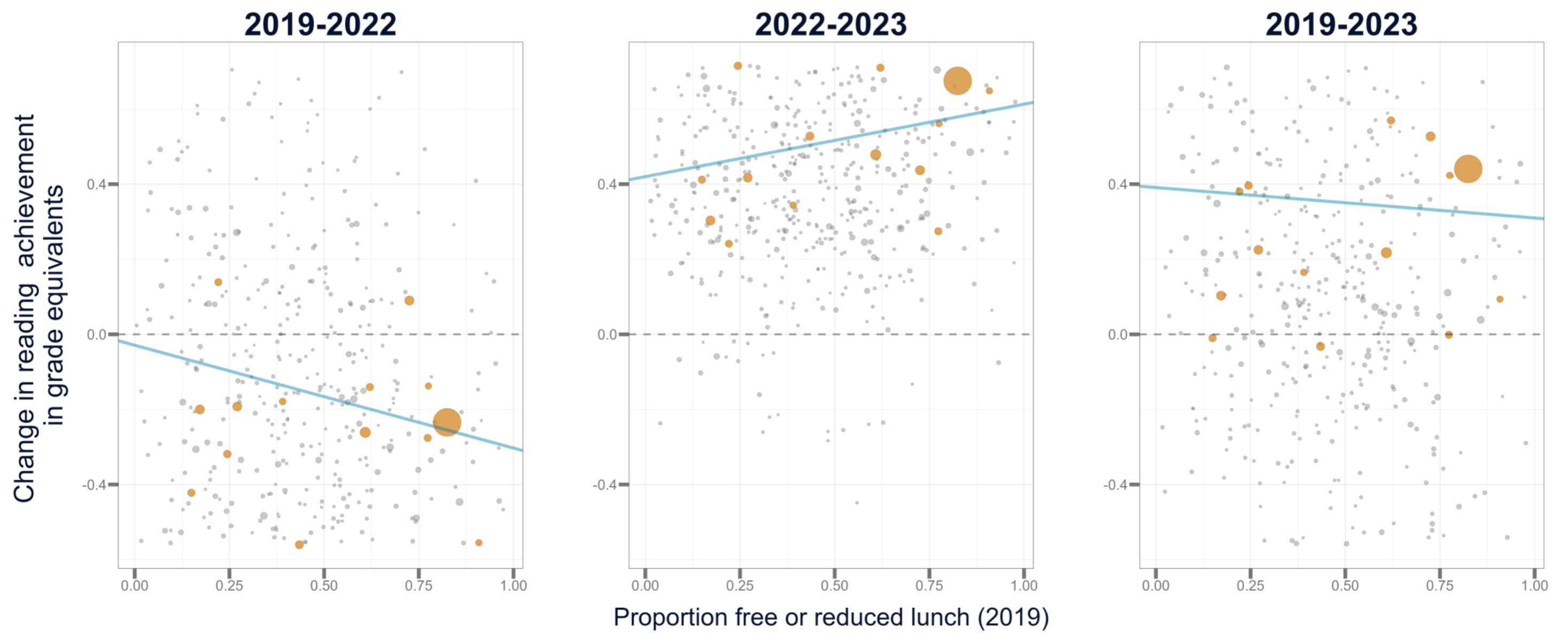
