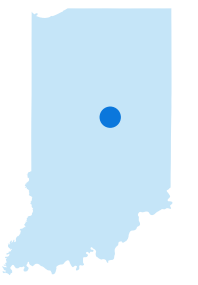
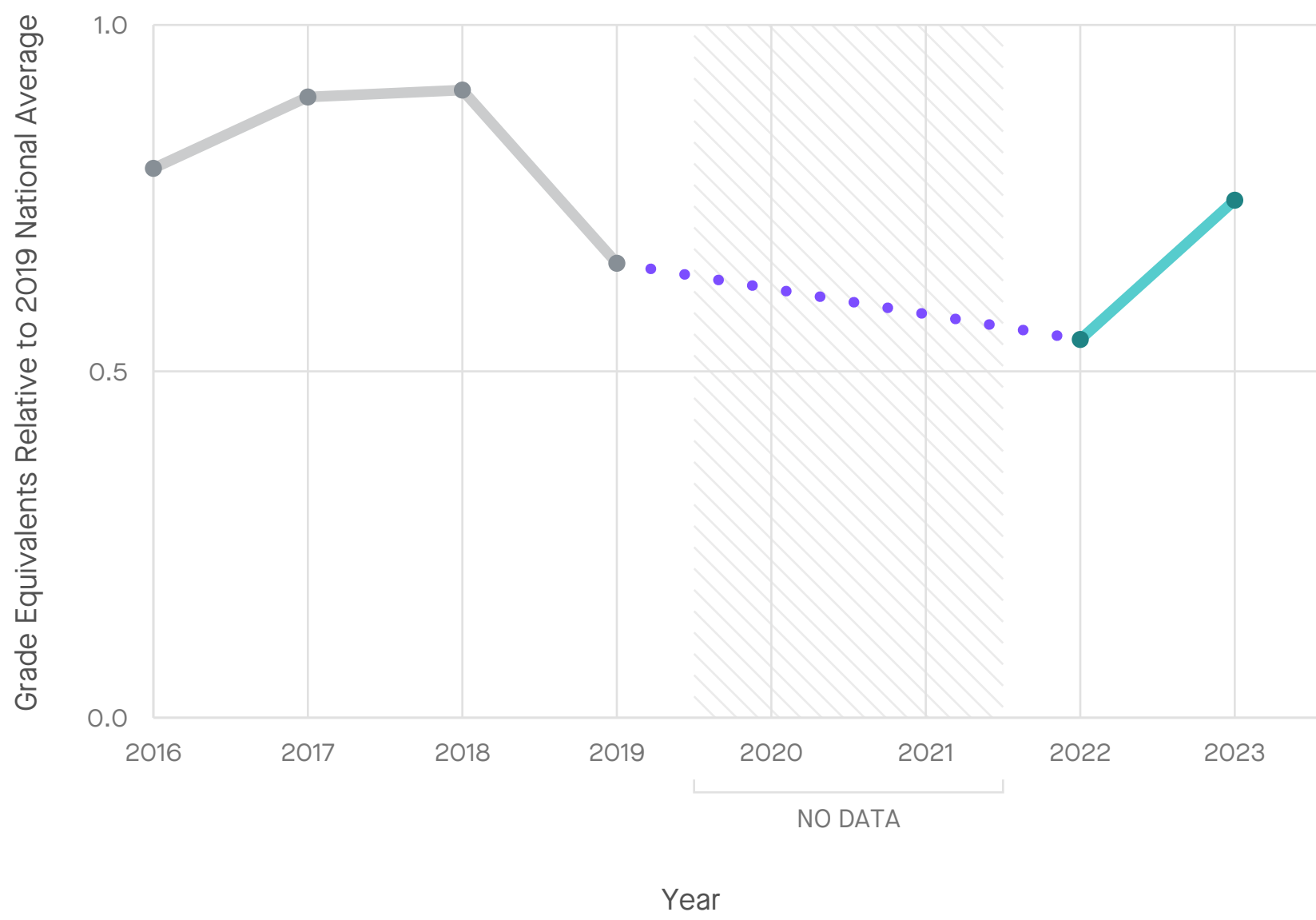

Math Performance, Grades 3-8, 2016-2023

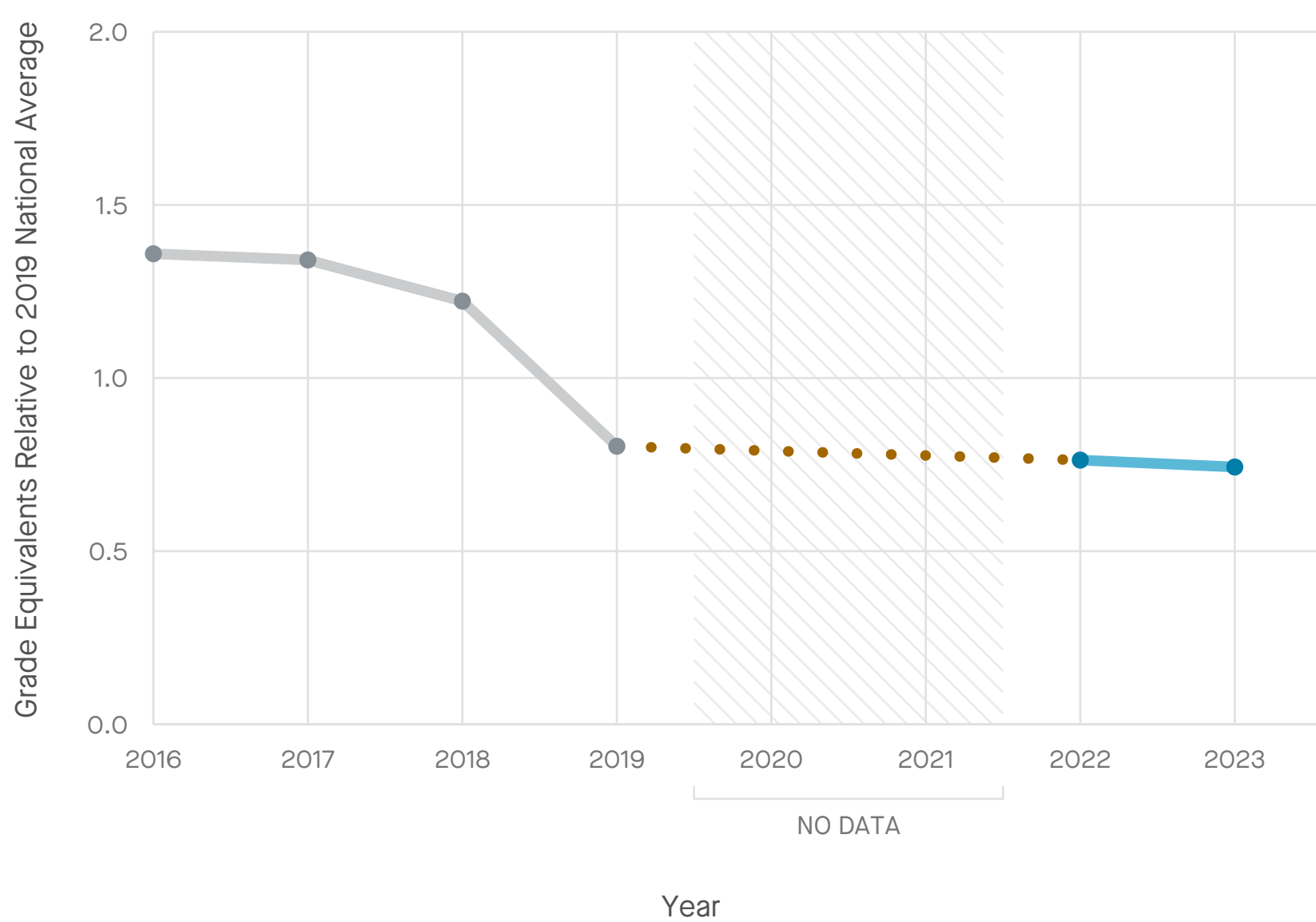

Reading Performance, Grades 3-8, 2016-2023



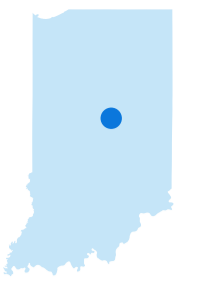

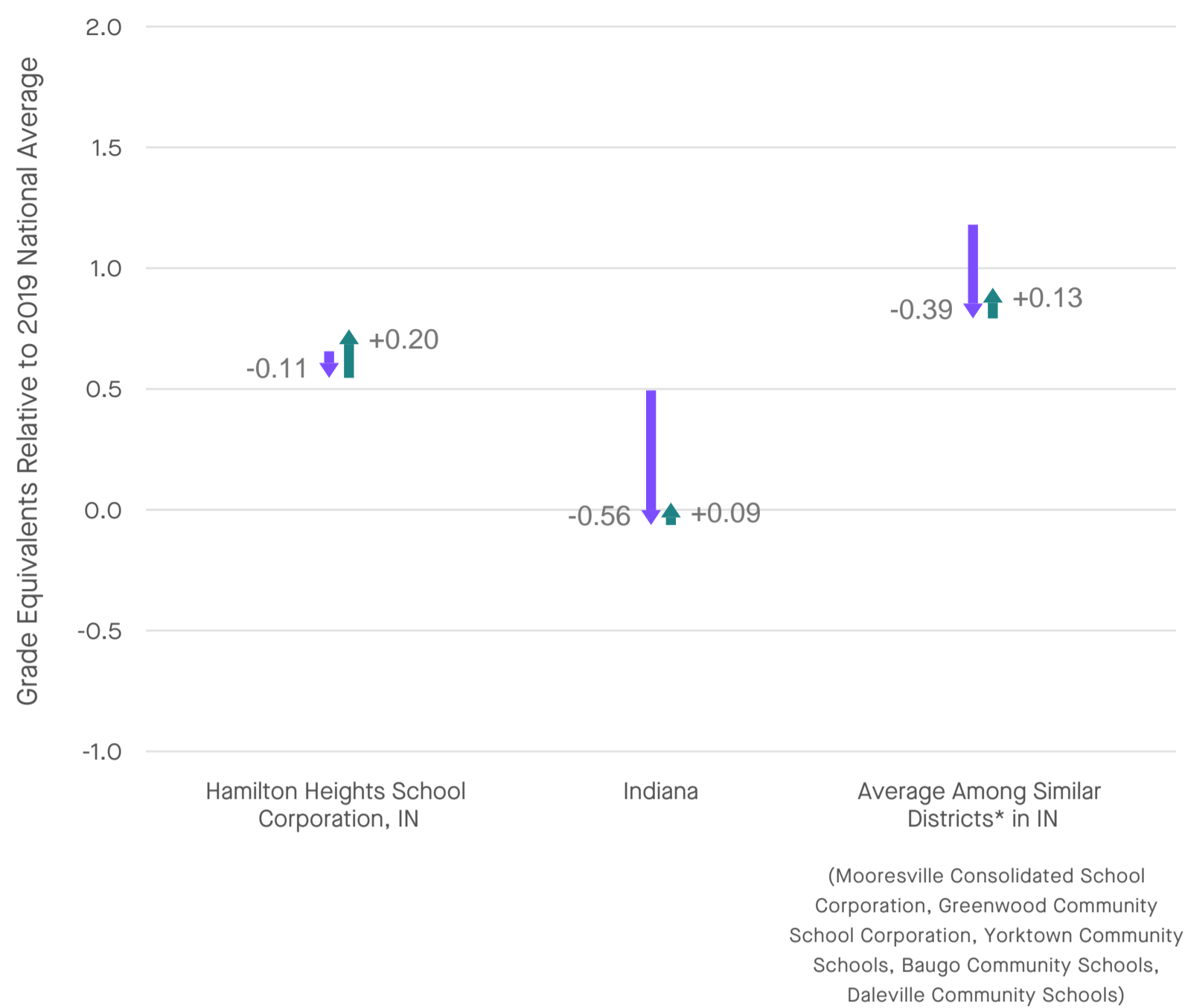

Math Performance in Hamilton Heights School Corporation vs. Indiana and Similar Districts, Grades 3-8, 2019-2023



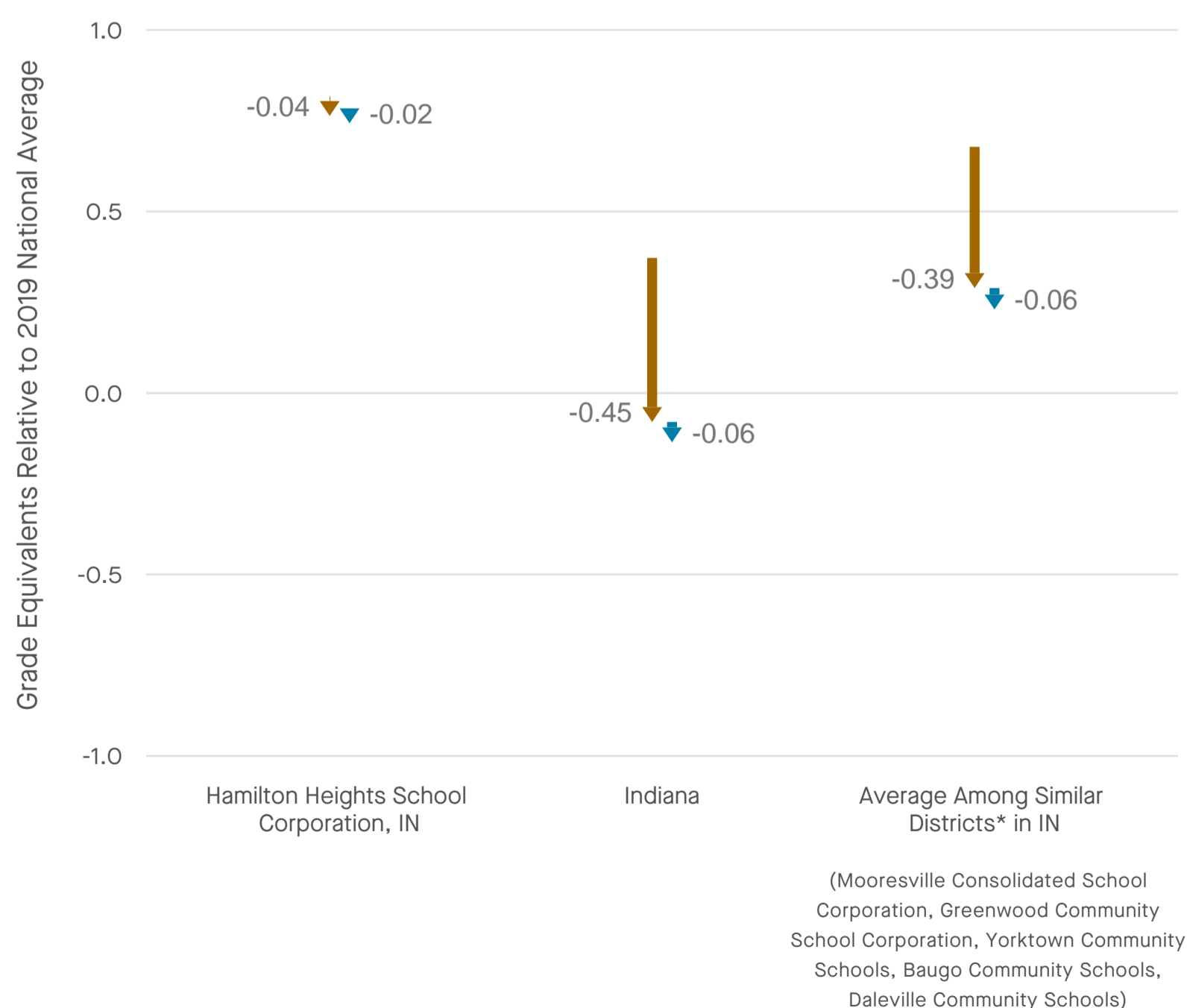
