





# Math Performance in Cumberland County vs. Kentucky and Similar Districts, Grades 3-8, 2019-2023









### Math Performance by Subgroup, Grades 3-8, 2019-2023







### Change in Math Achievement 2019-2022 by proportion FRPL in Kentucky districts











## Change in Math Achievement 2019-2023 by proportion FRPL in Kentucky districts









# Change in Math Achievement by proportion FRPL in Kentucky districts





# Change in Reading Achievement by proportion FRPL in Kentucky districts




