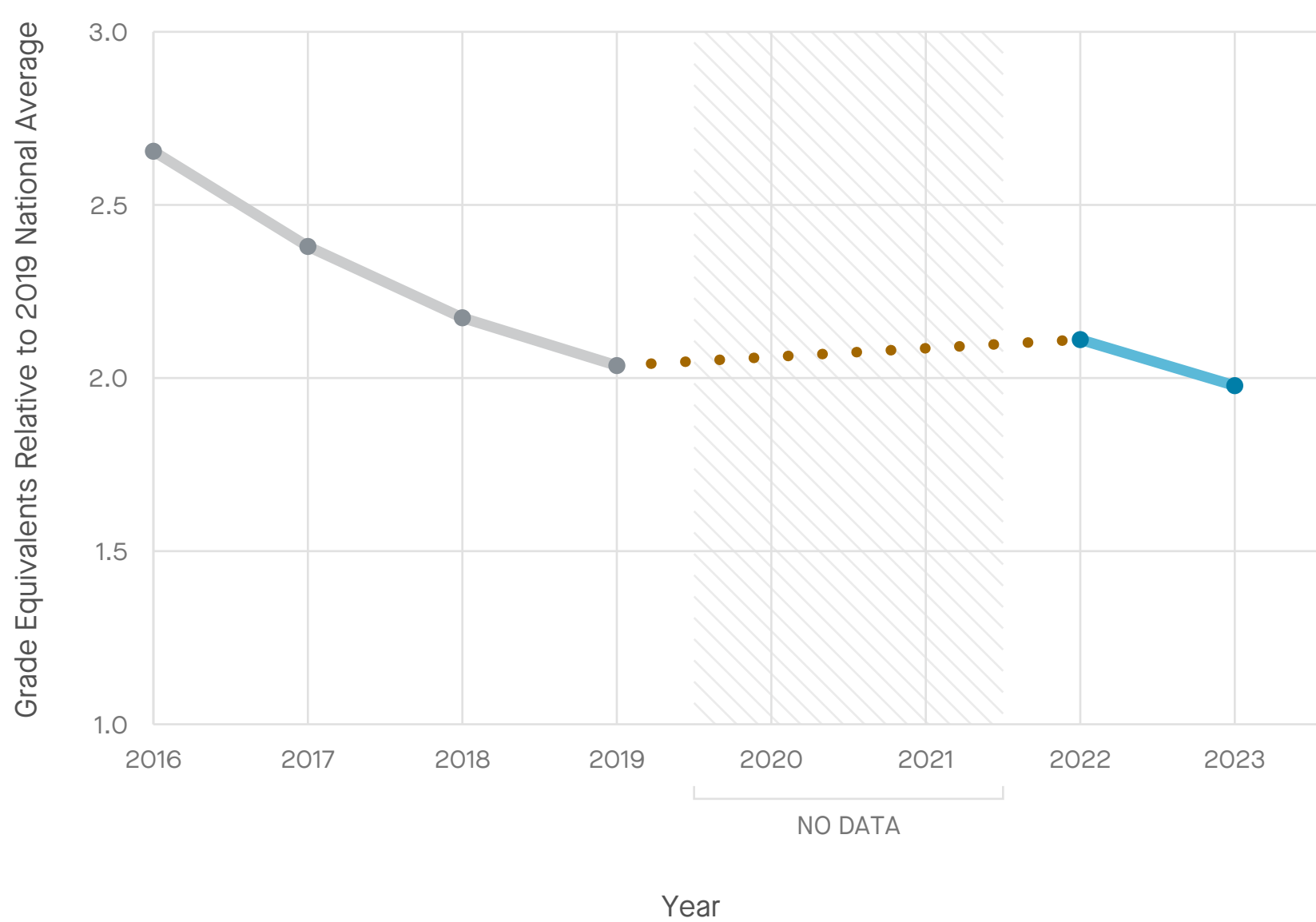

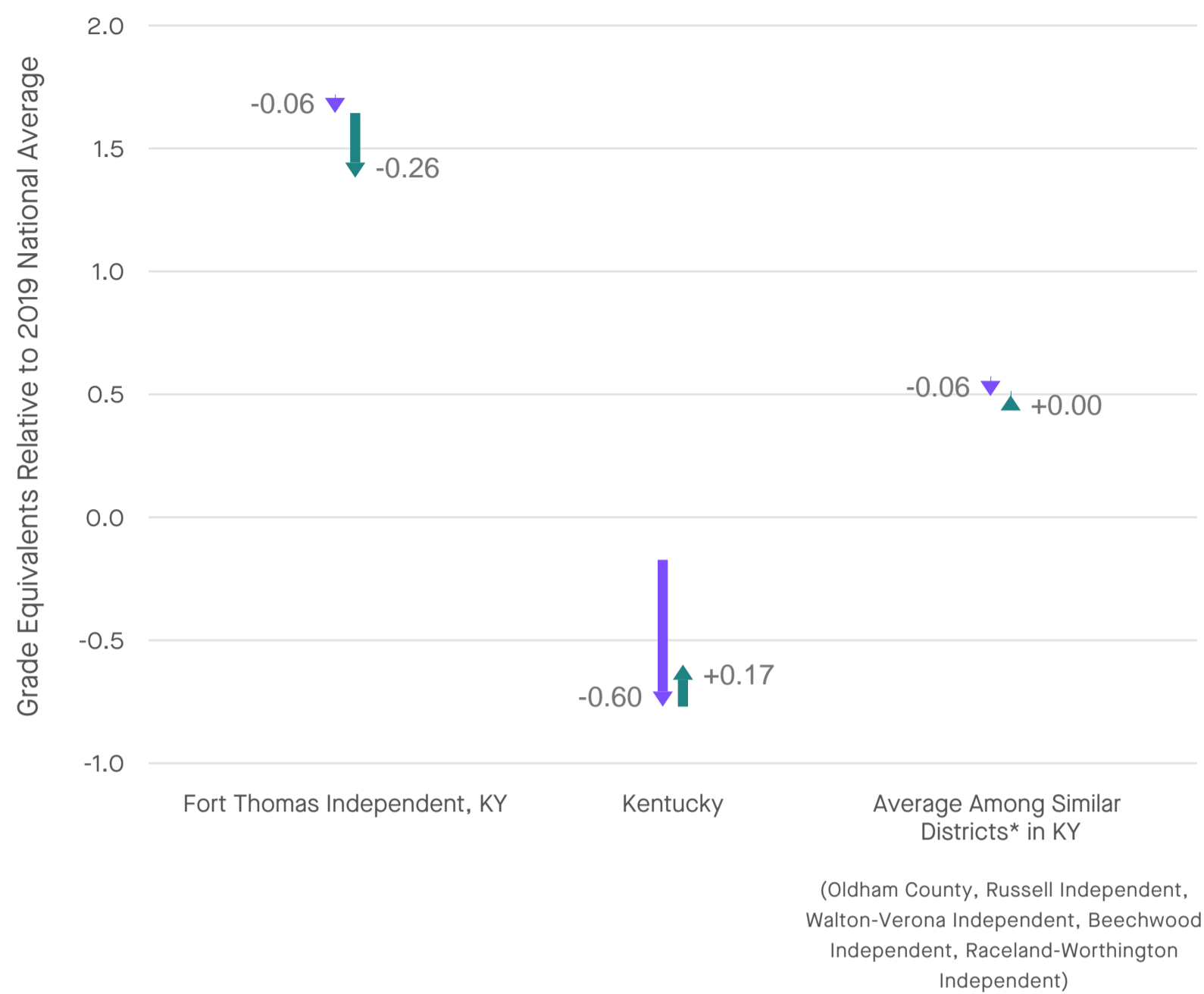

Math Performance in Fort Thomas Independent vs. Kentucky and Similar Districts, Grades 3-8, 2019-2023



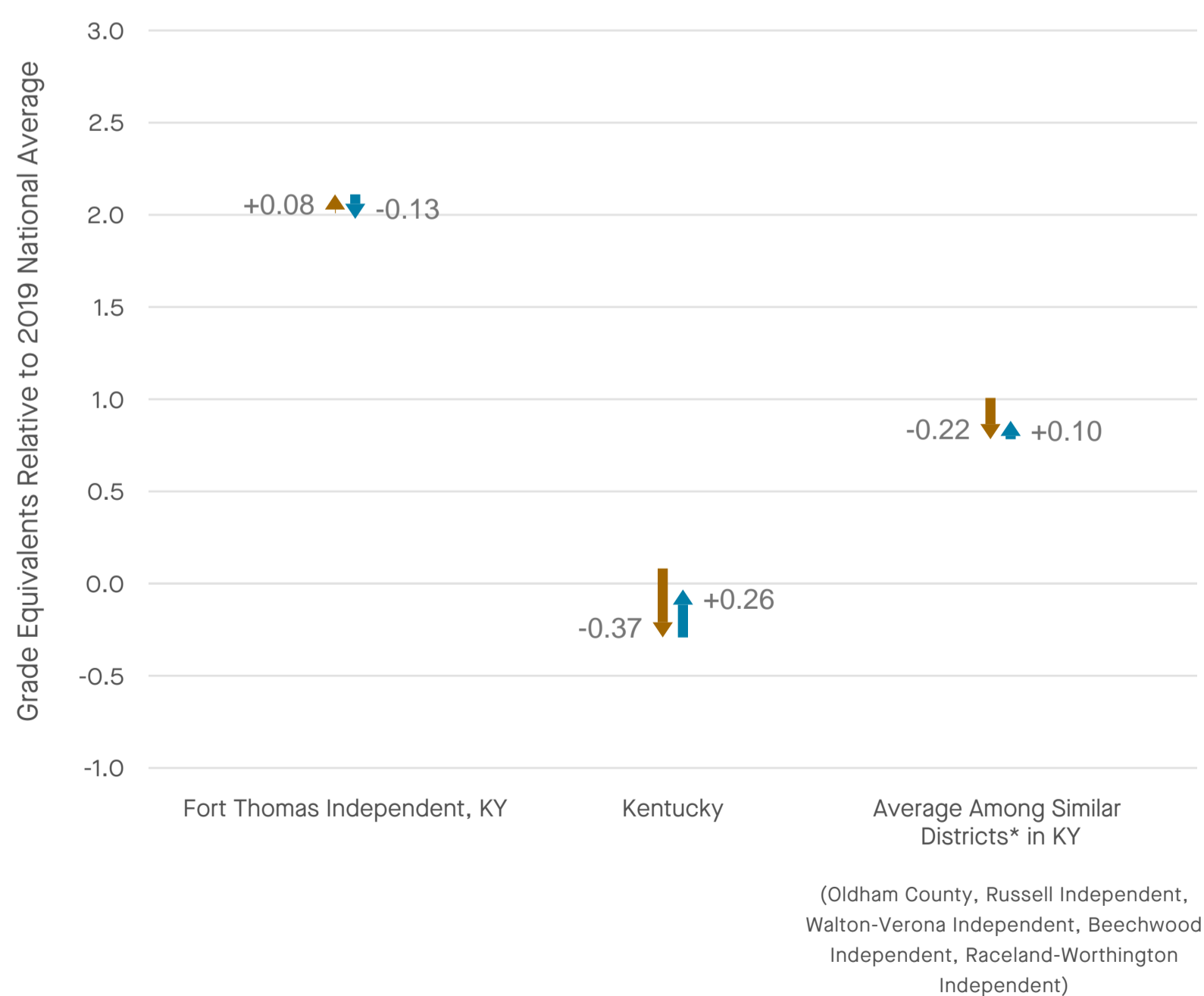

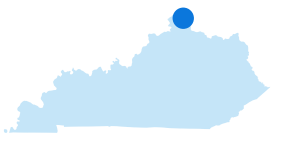

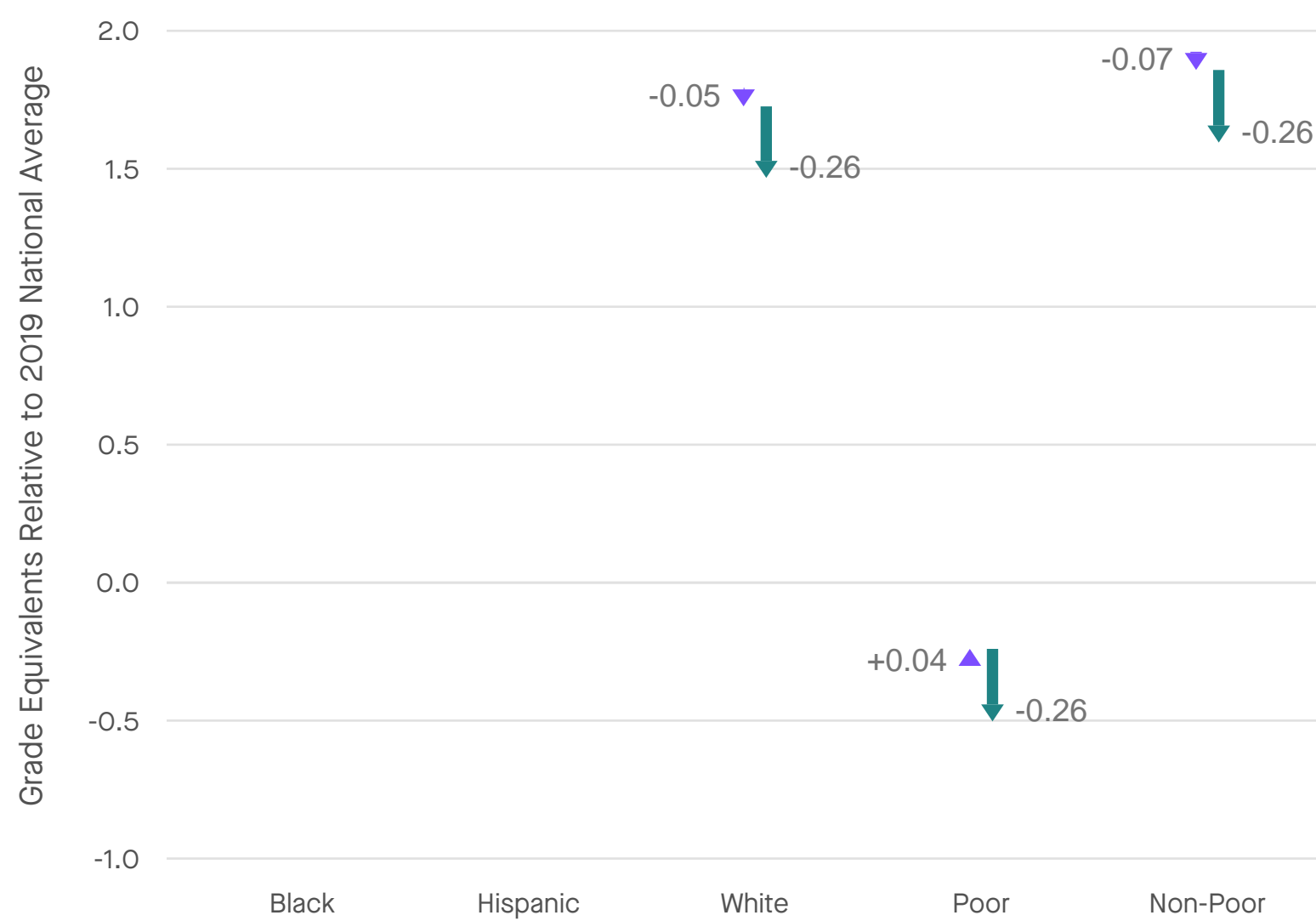

Math Performance by Subgroup, Grades 3-8, 2019-2023

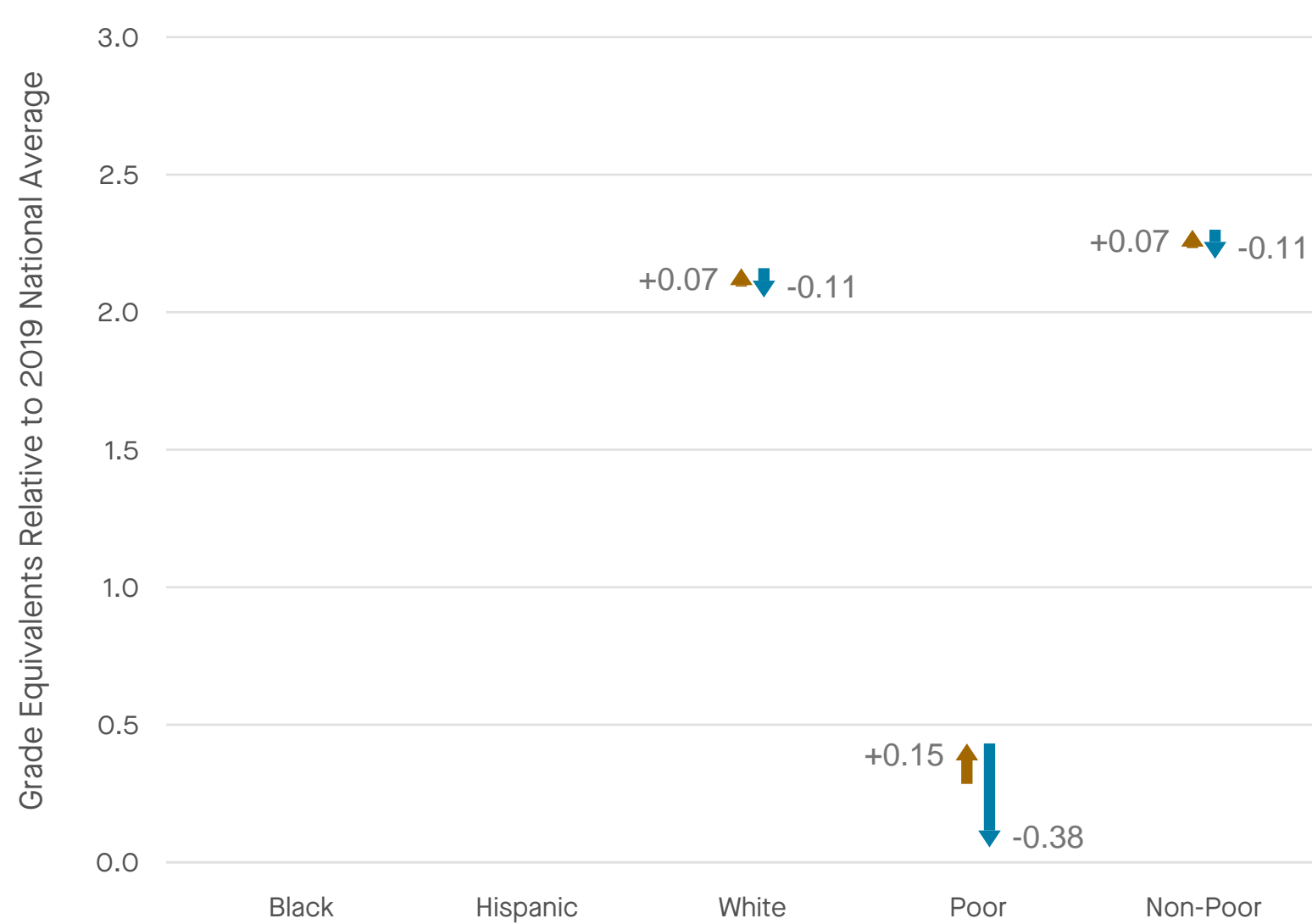

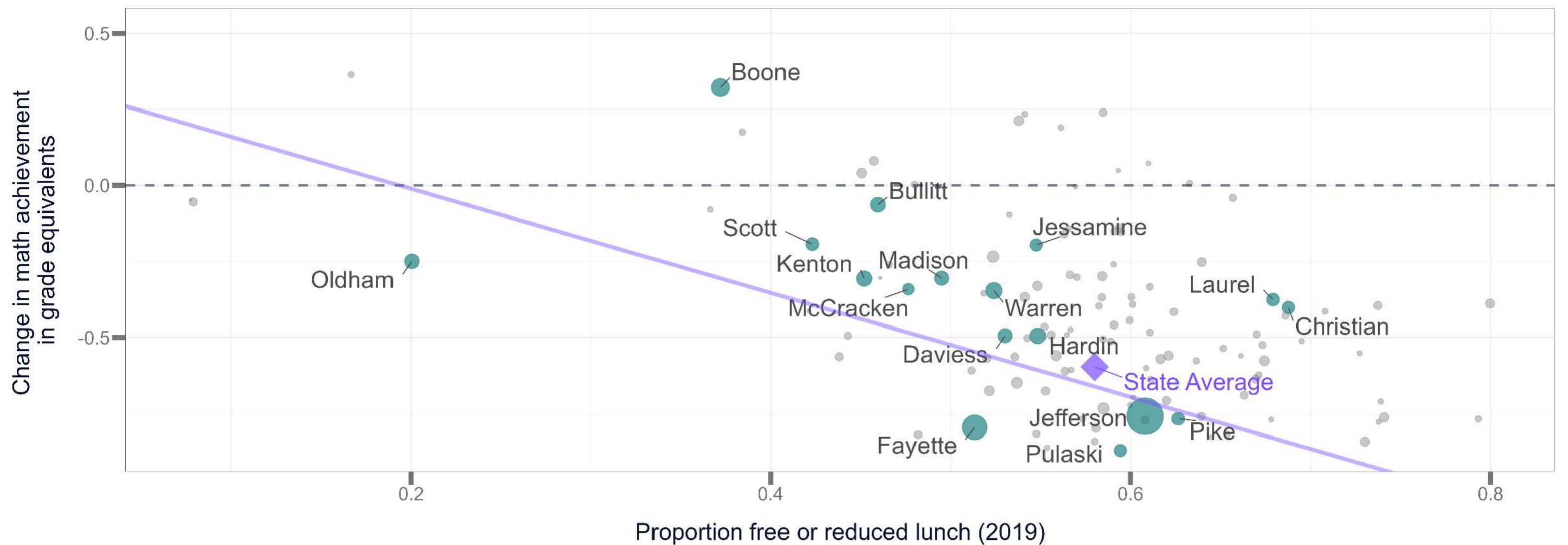

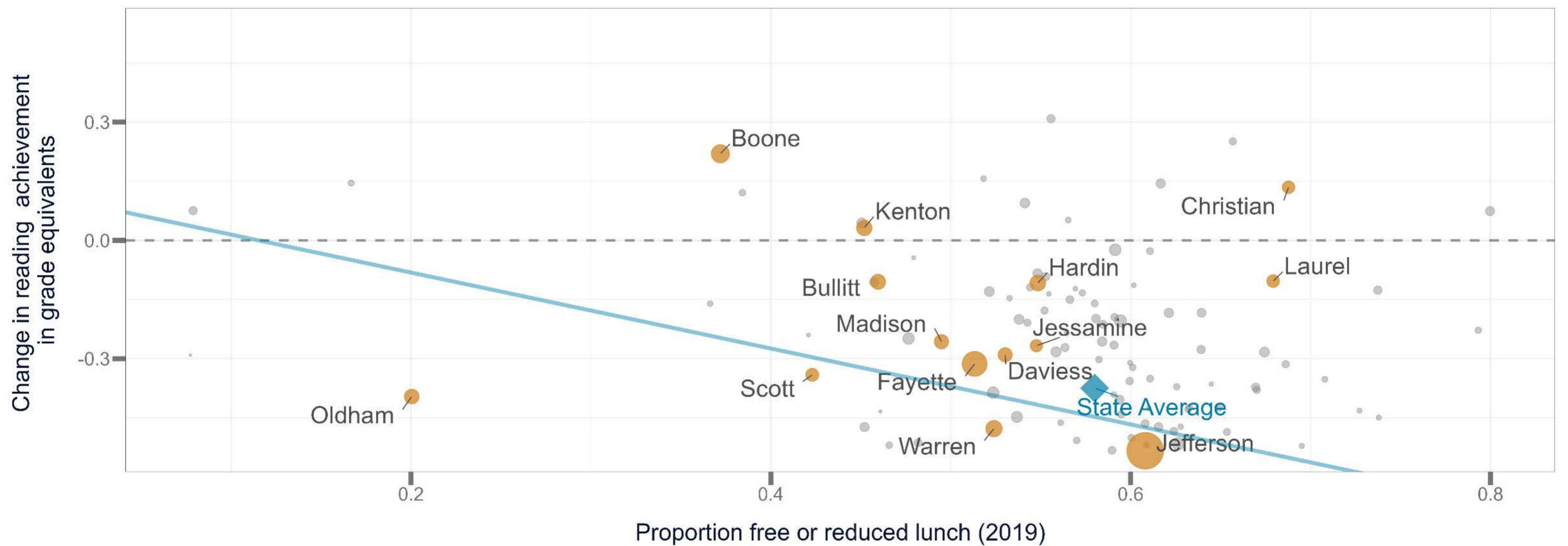
Change in Math Achievement 2019-2022 by proportion FRPL in Kentucky districts

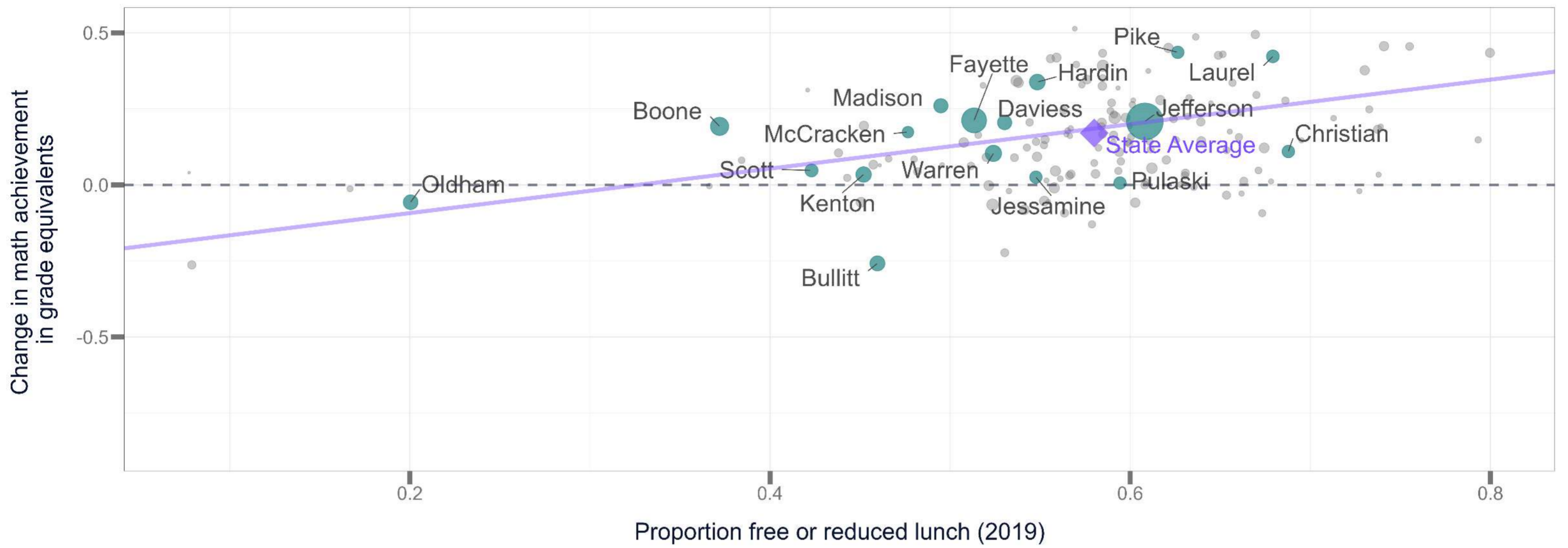
Change in Reading Achievement 2019-2022 by proportion FRPL in Kentucky districts

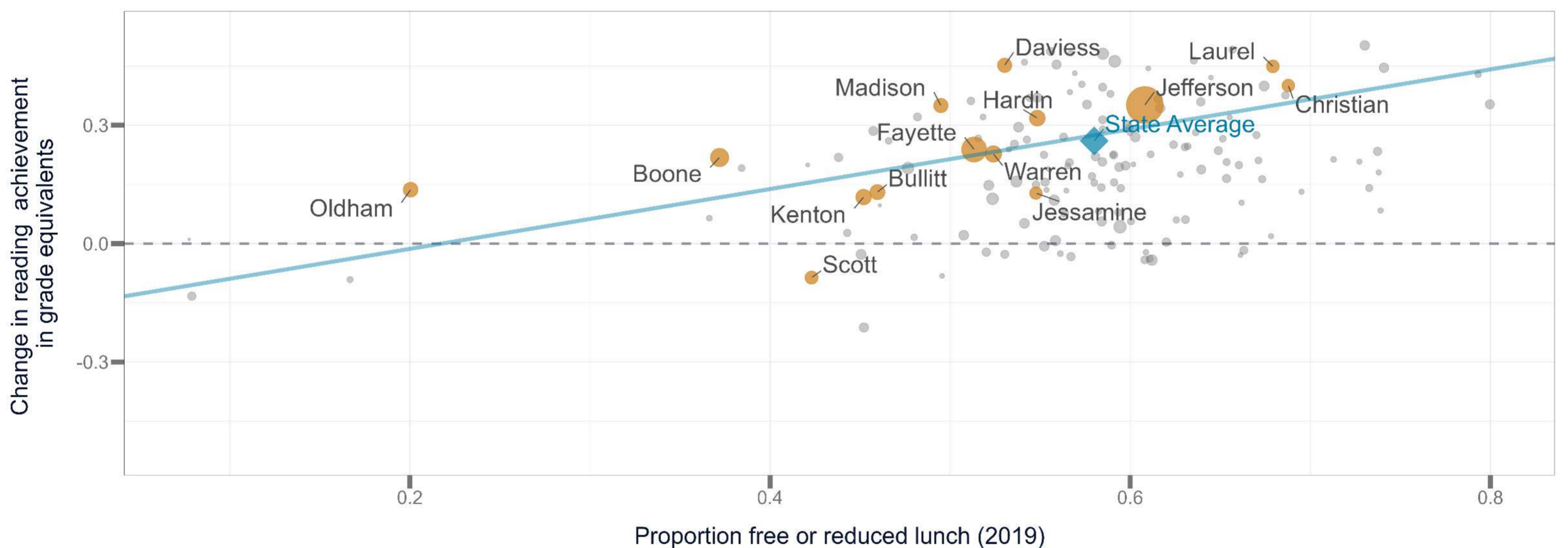

Change in Math Achievement 2022-2023 by proportion FRPL in Kentucky districts



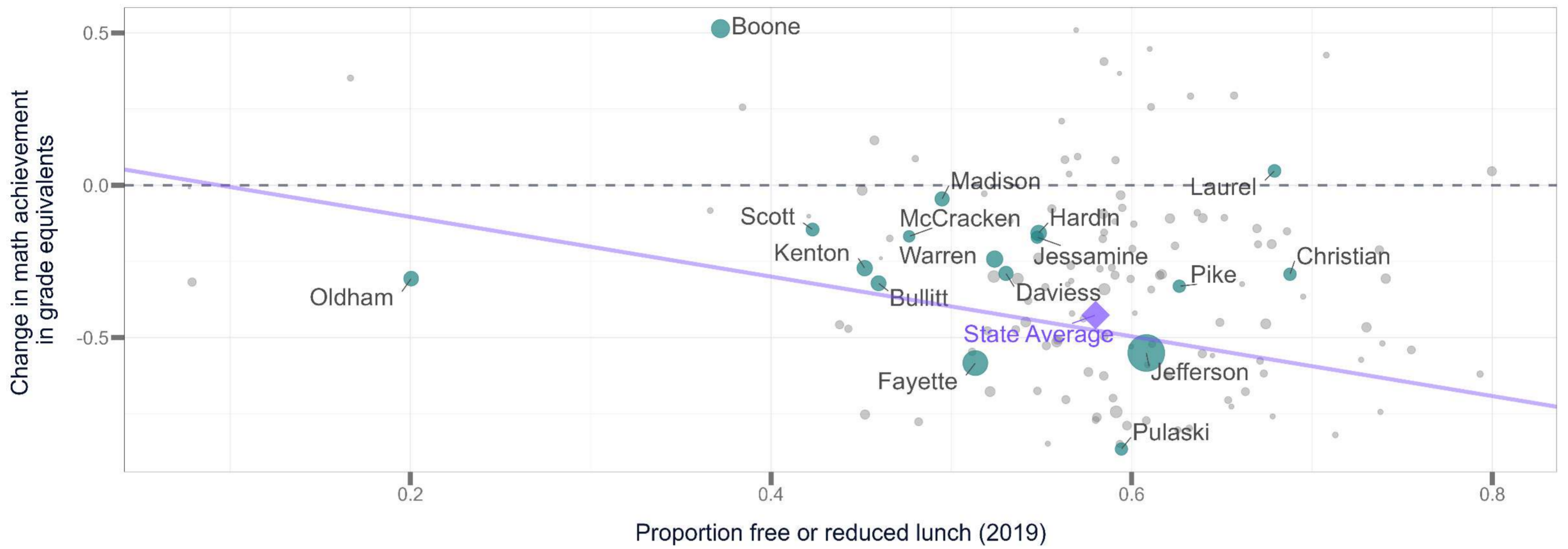

Change in Reading Achievement 2022-2023 by proportion FRPL in Kentucky districts



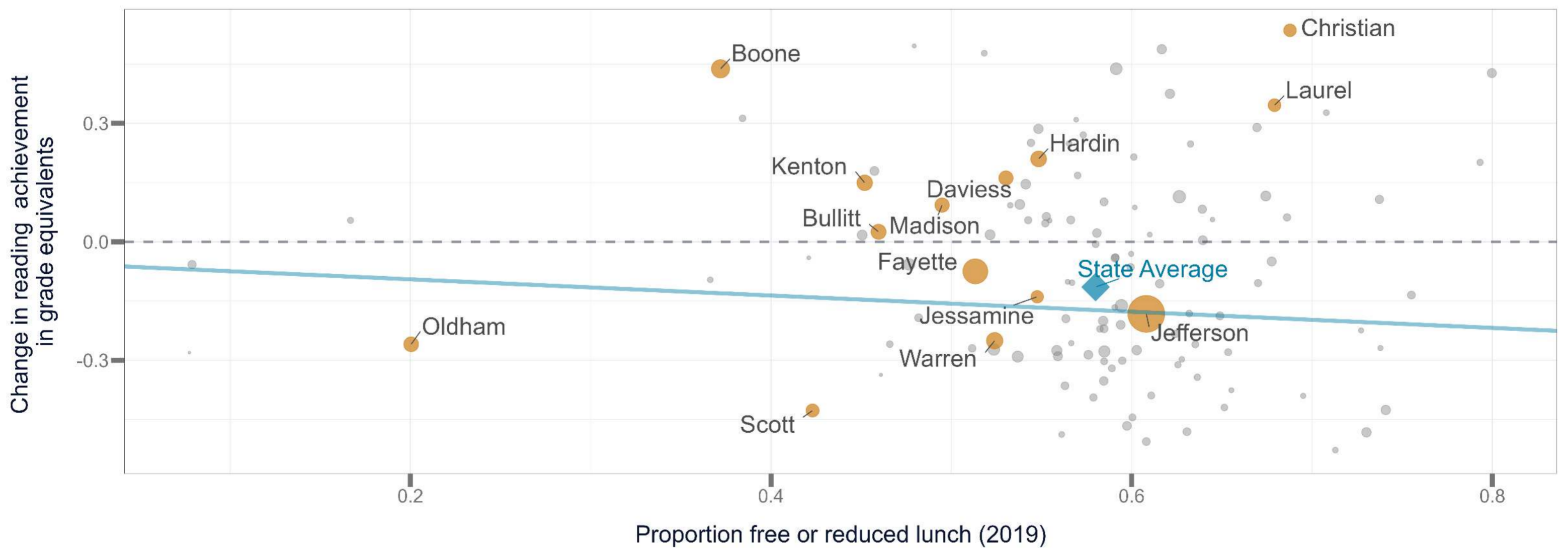

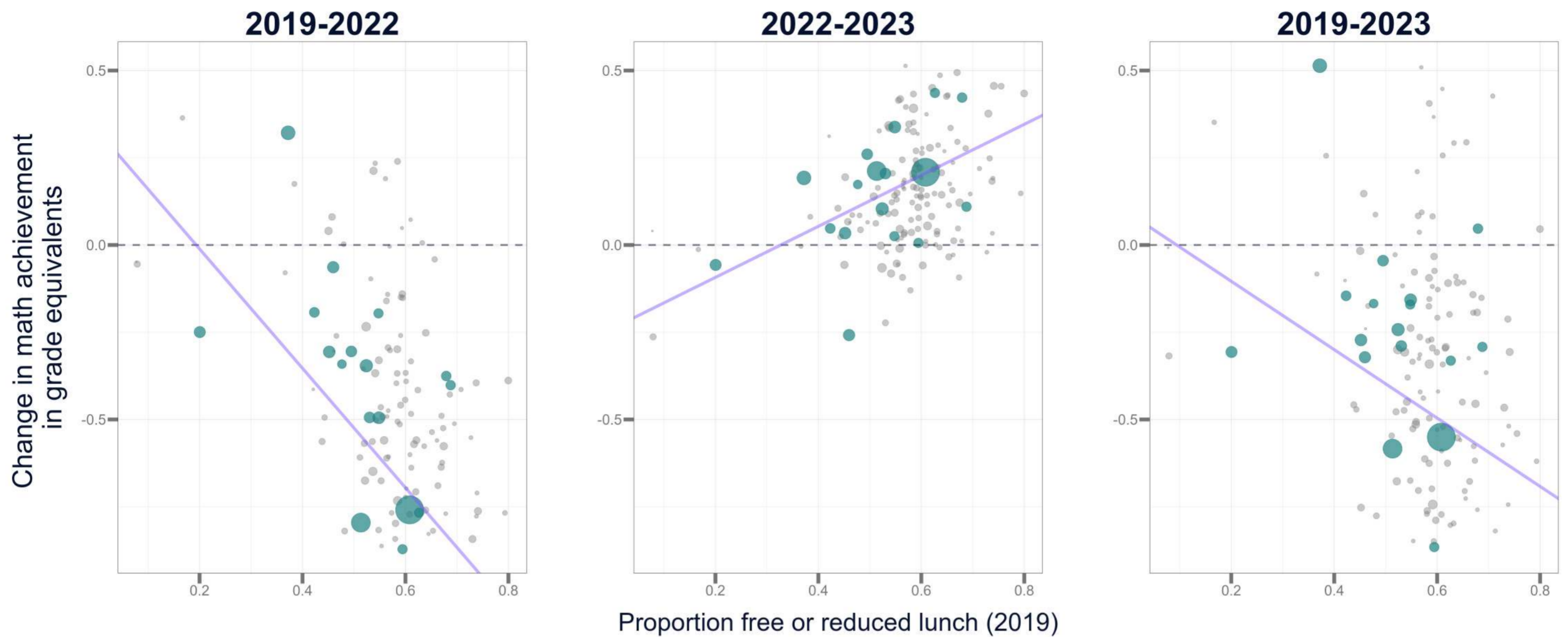
Change in Reading Achievement 2019-2023 by proportion FRPL in Kentucky districts

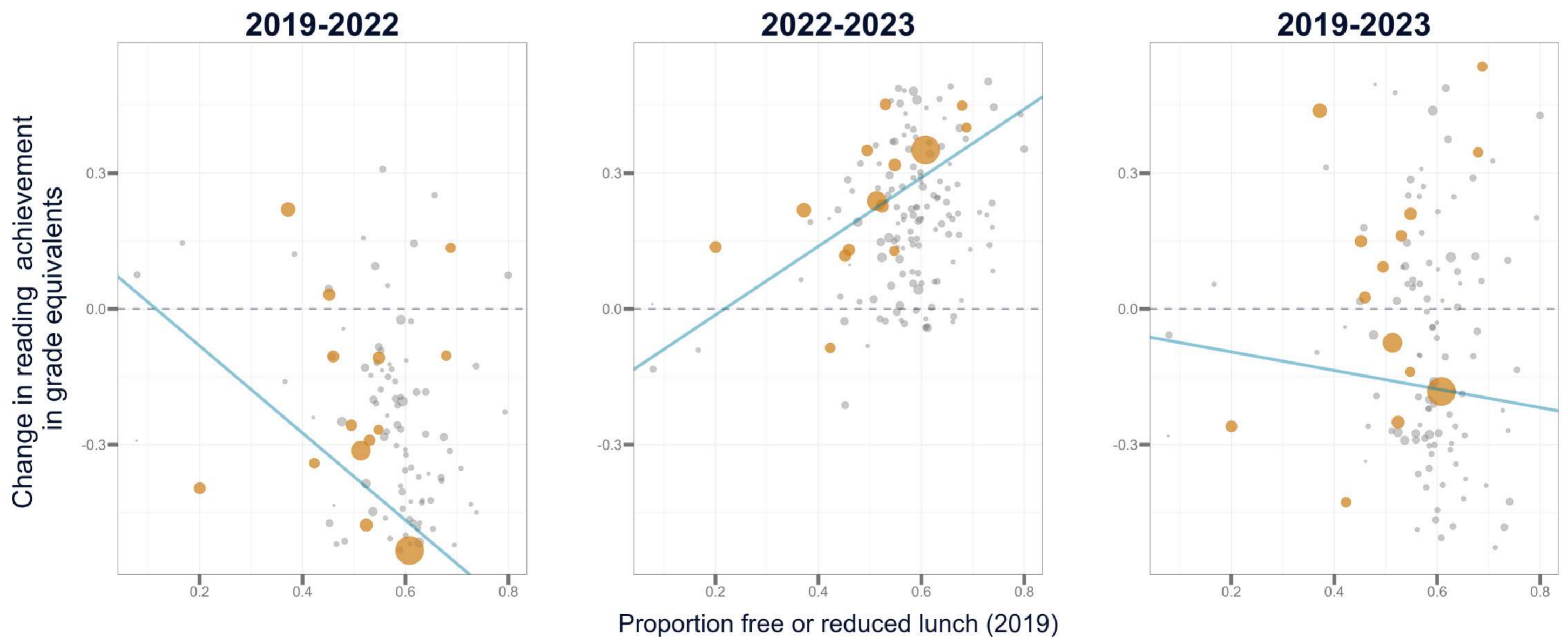
