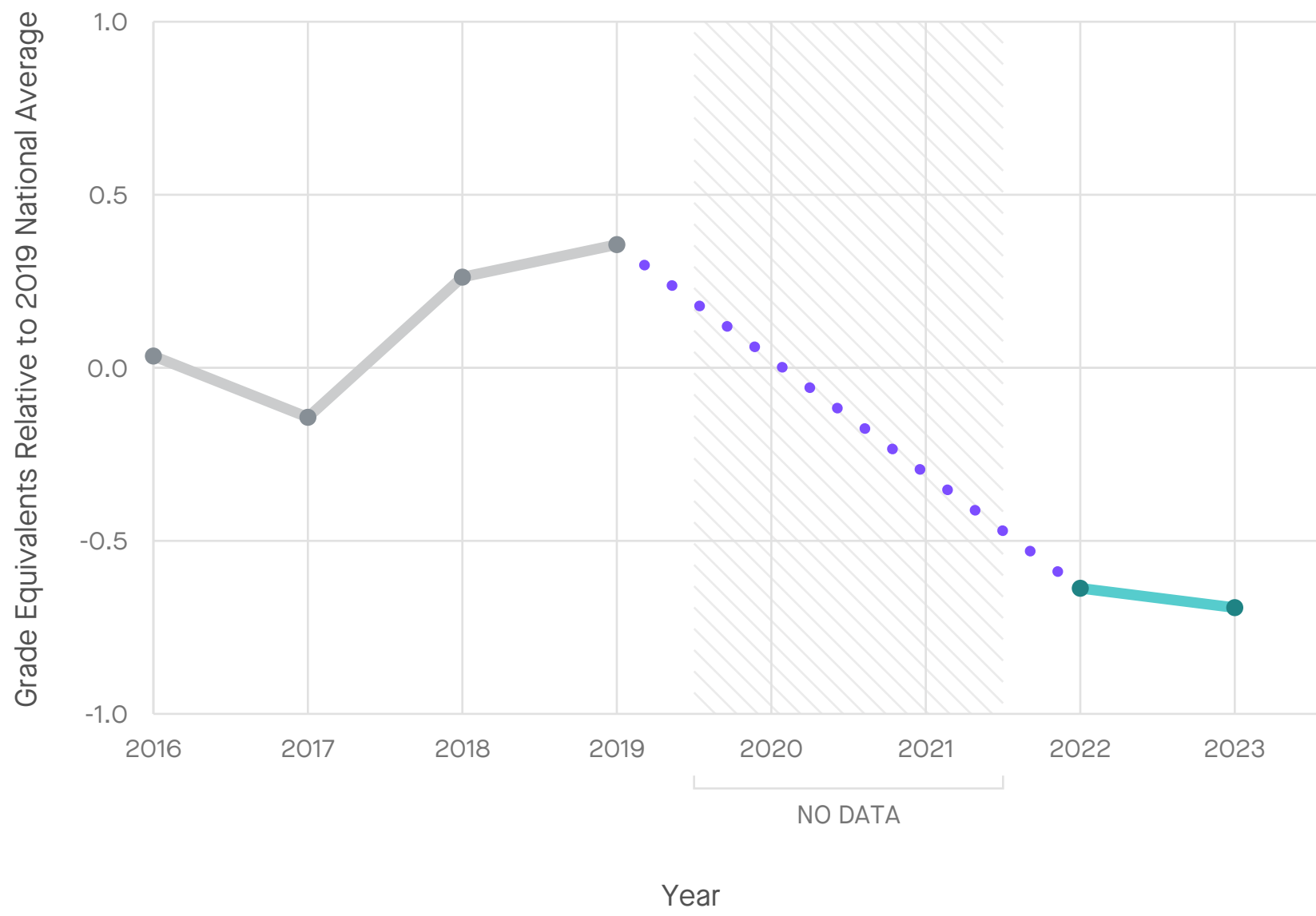

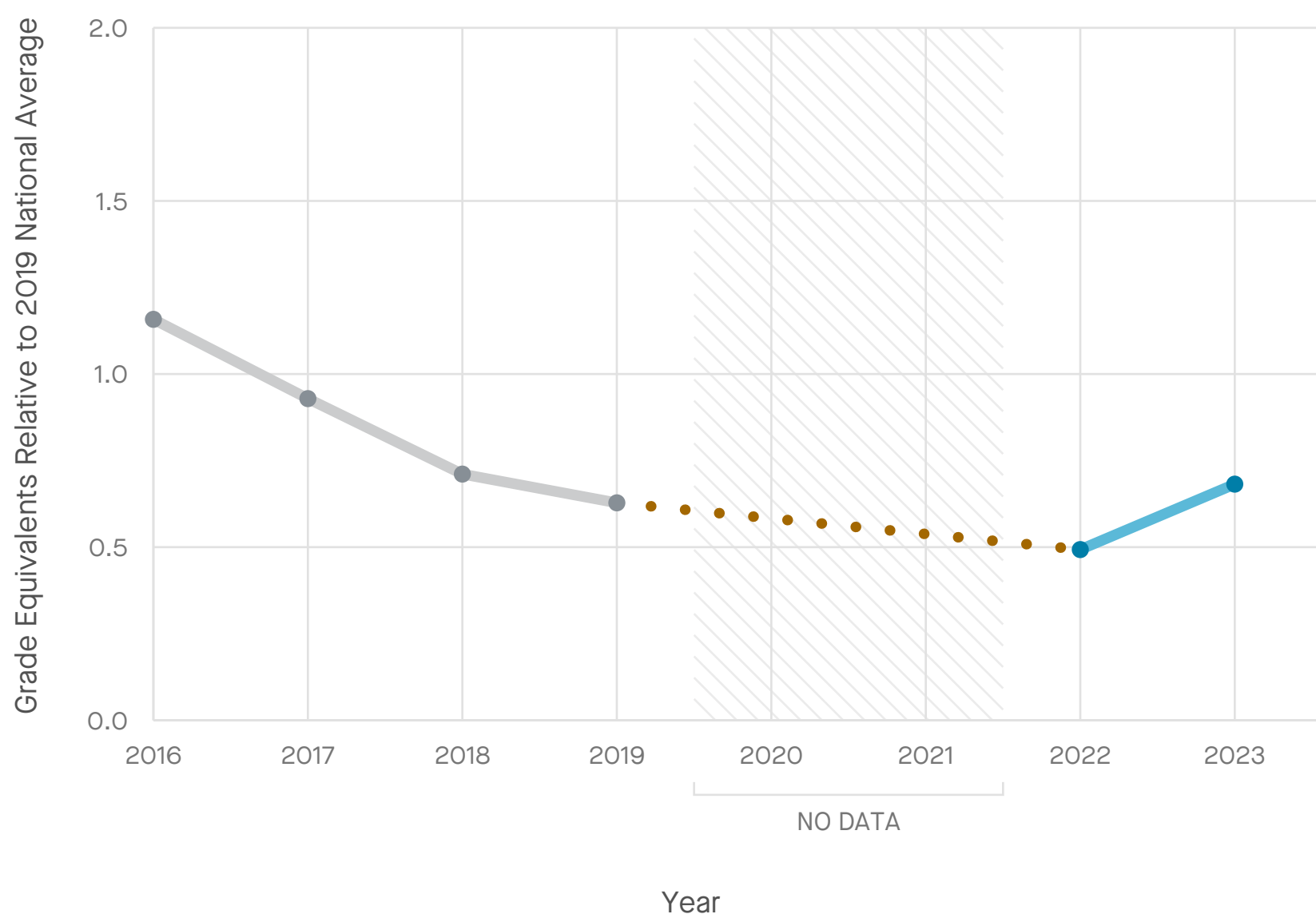

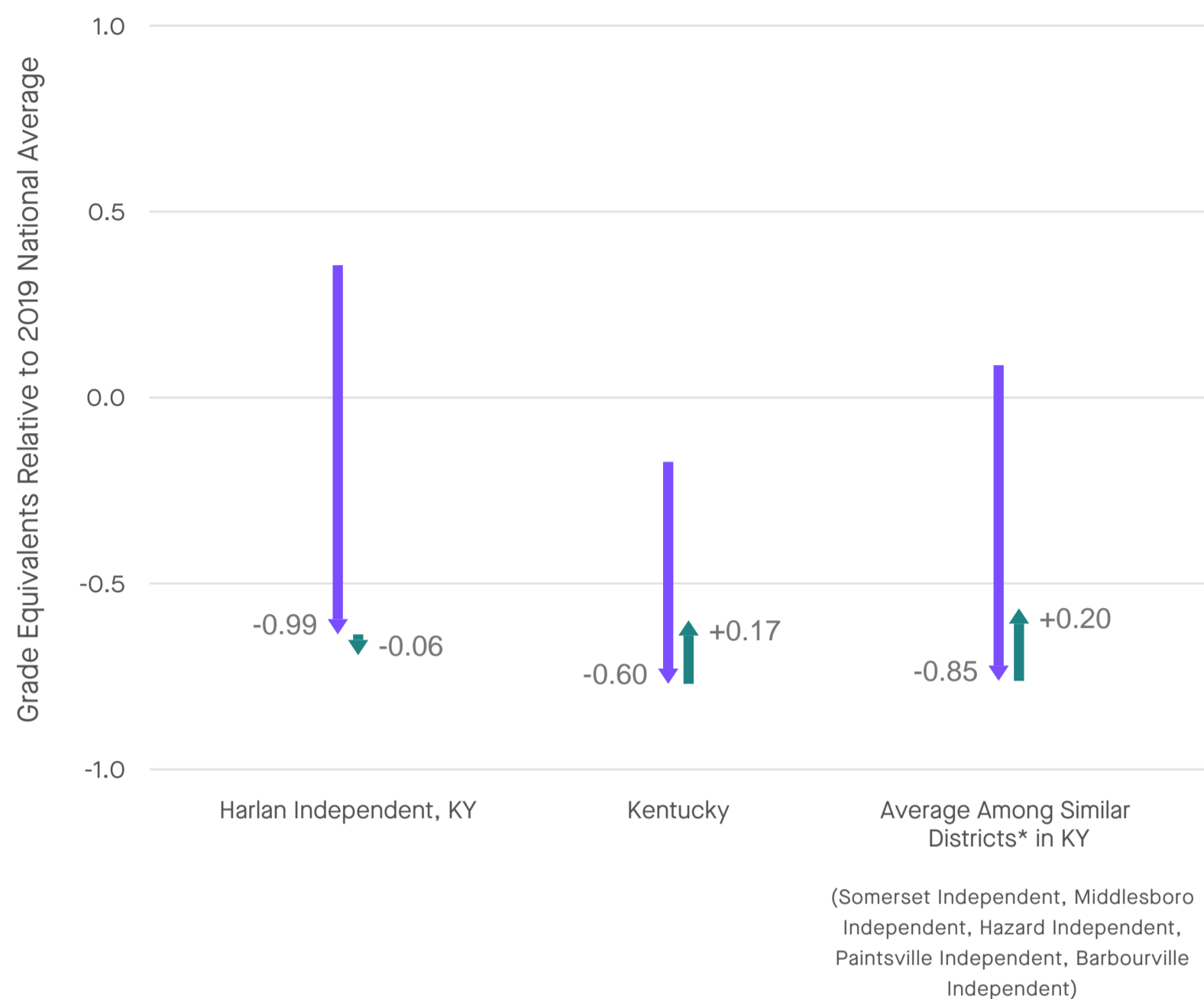

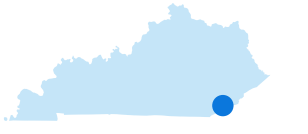

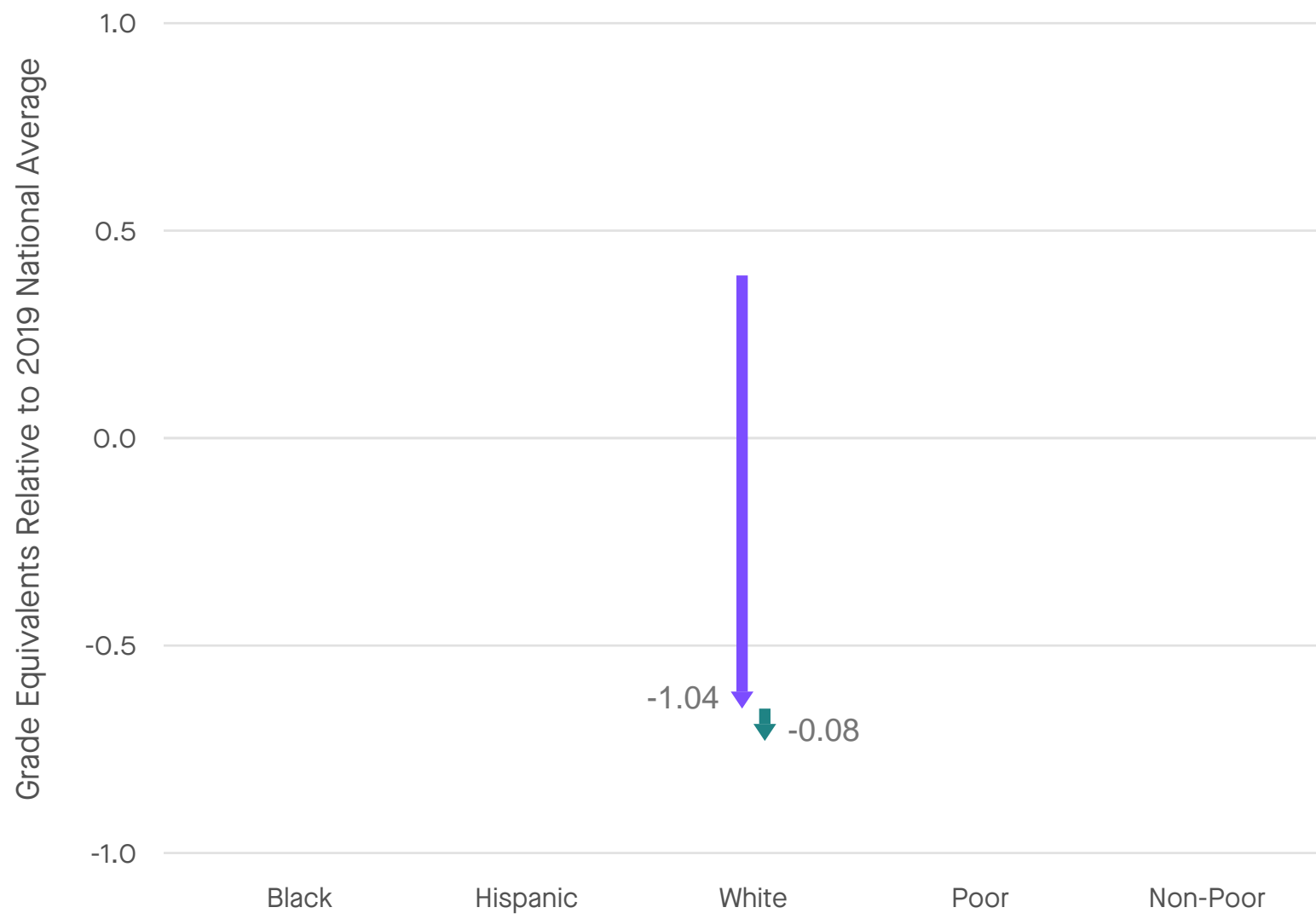

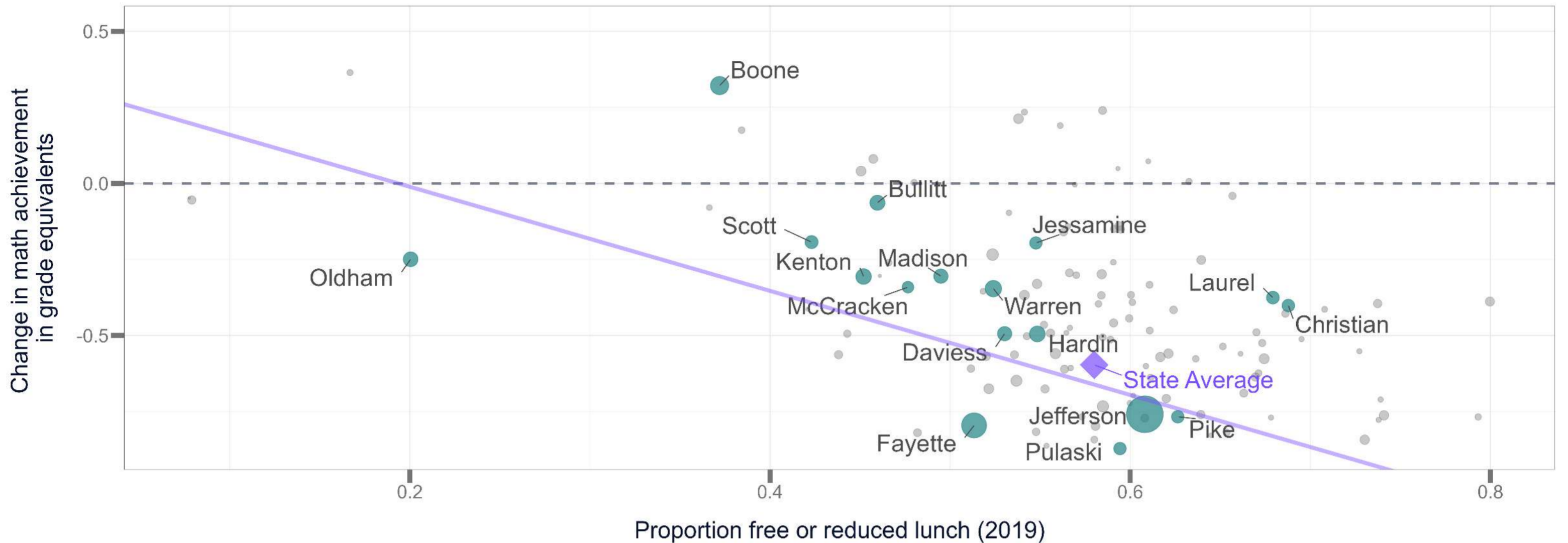

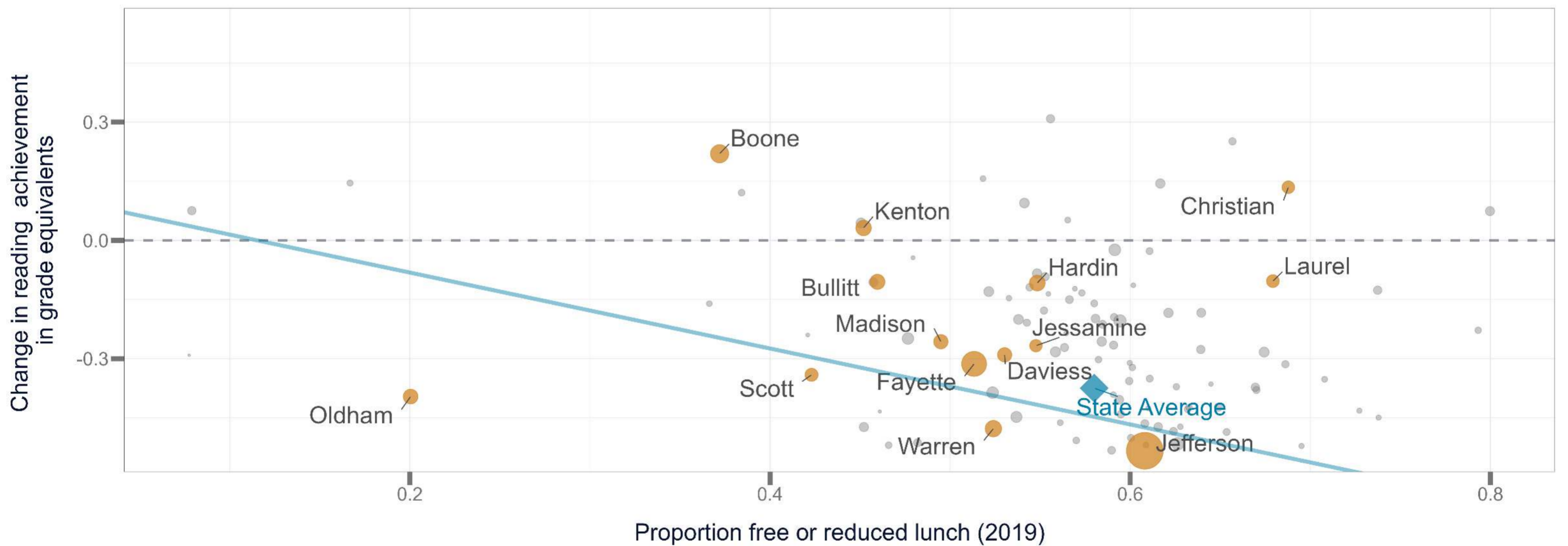

## Change in Math Achievement 2019-2022 by proportion FRPL in Kentucky districts



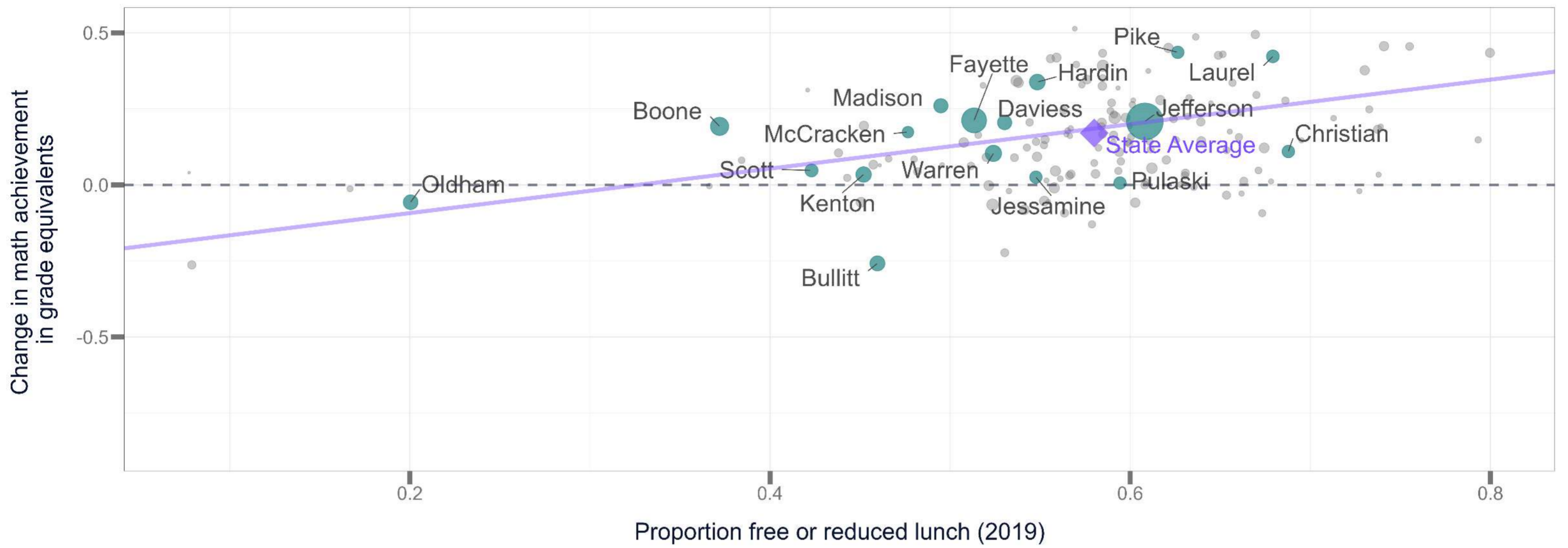

## Change in Reading Achievement 2019-2022 by proportion FRPL in Kentucky districts



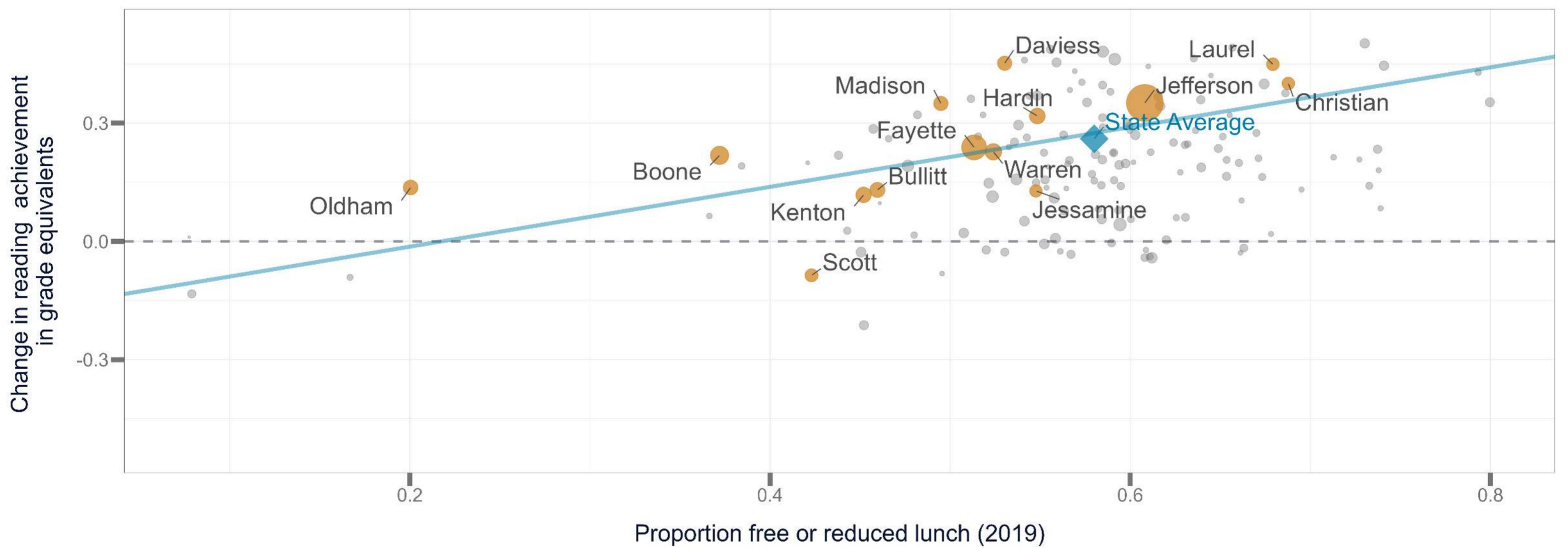
