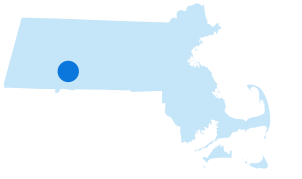
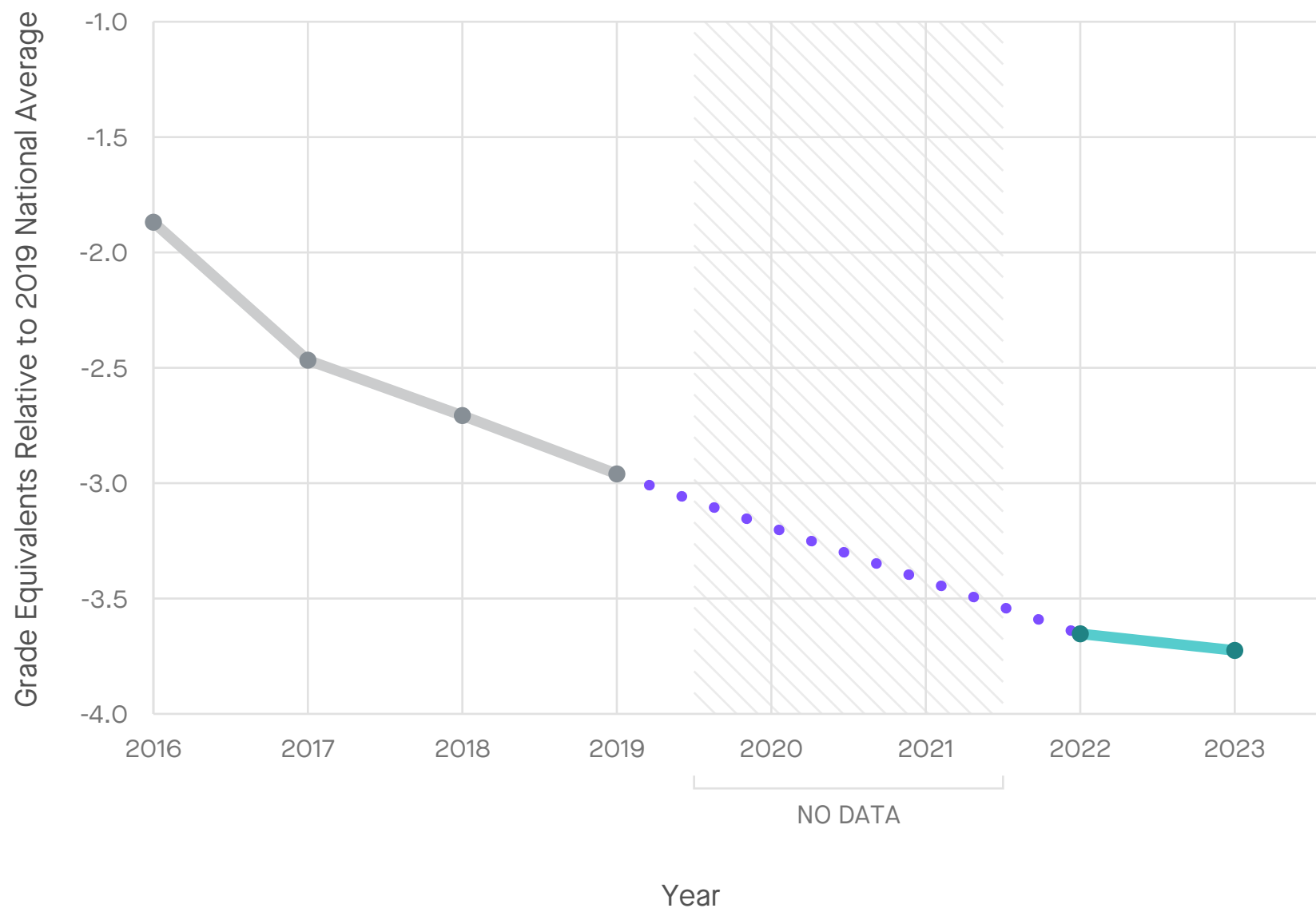

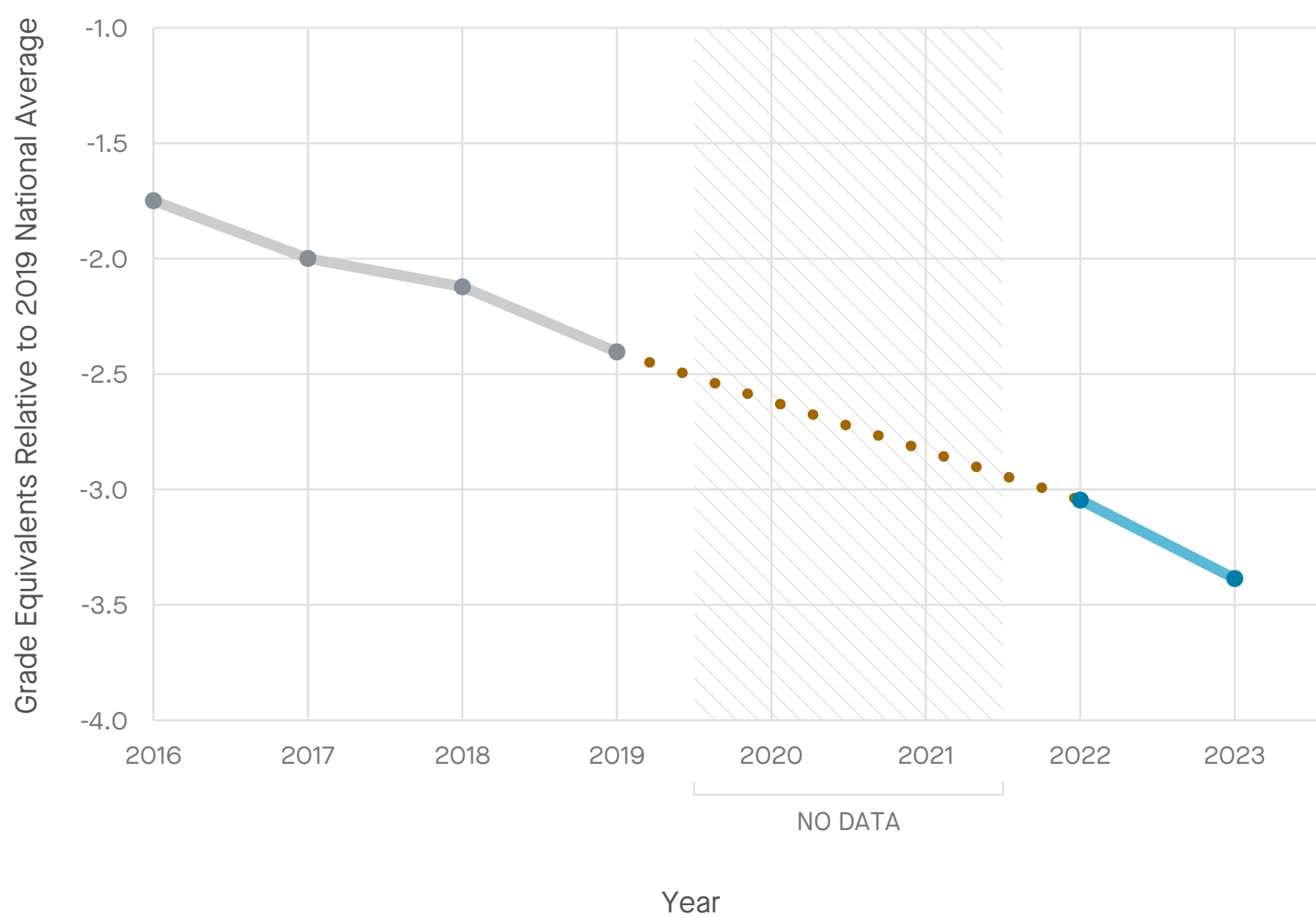

Reading Performance, Grades 3-8, 2016-2023



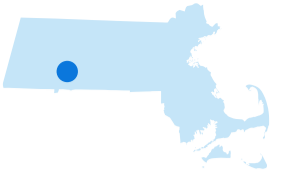

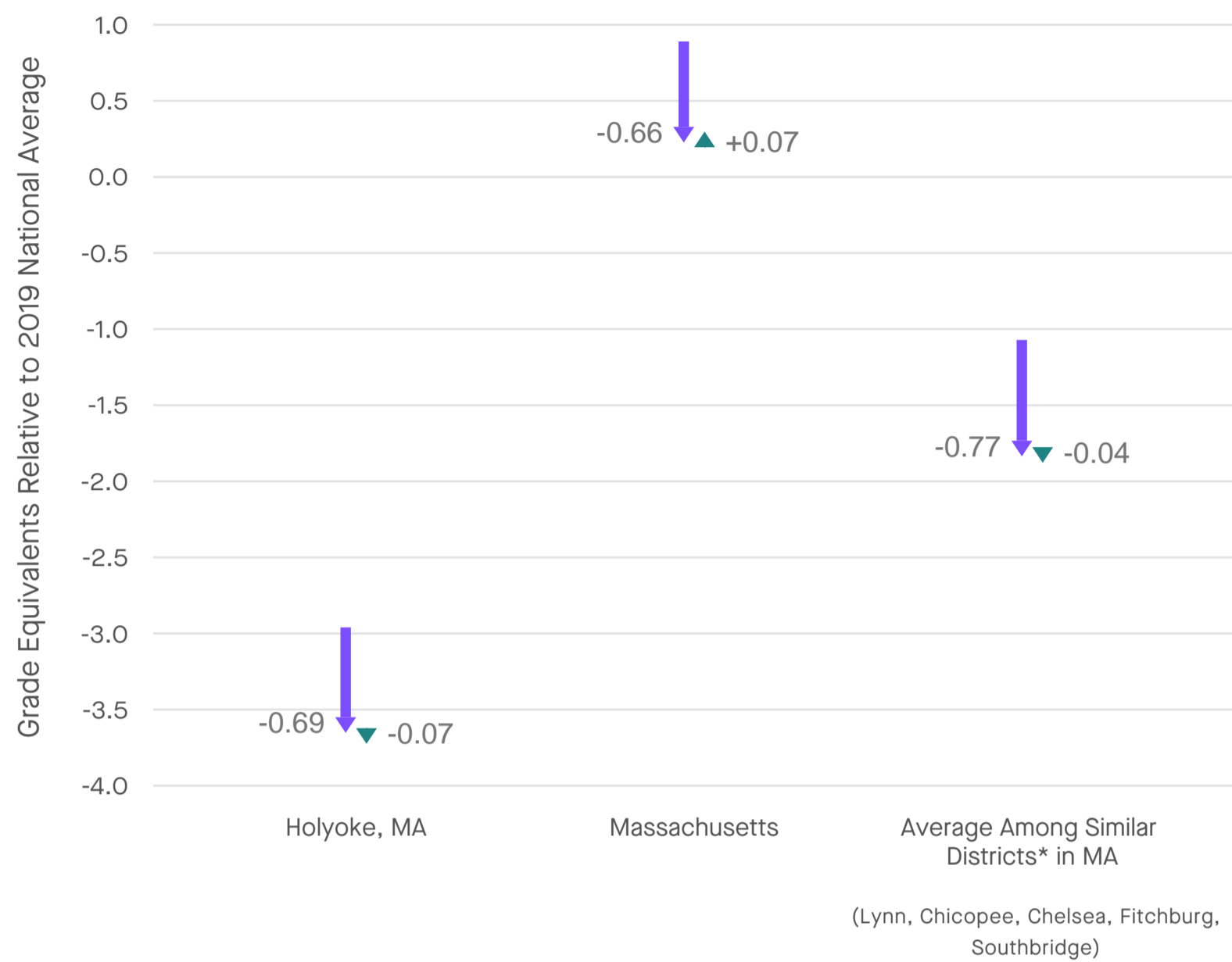

Math Performance in Holyoke vs. Massachusetts and Similar Districts, Grades 3-8, 2019-2023



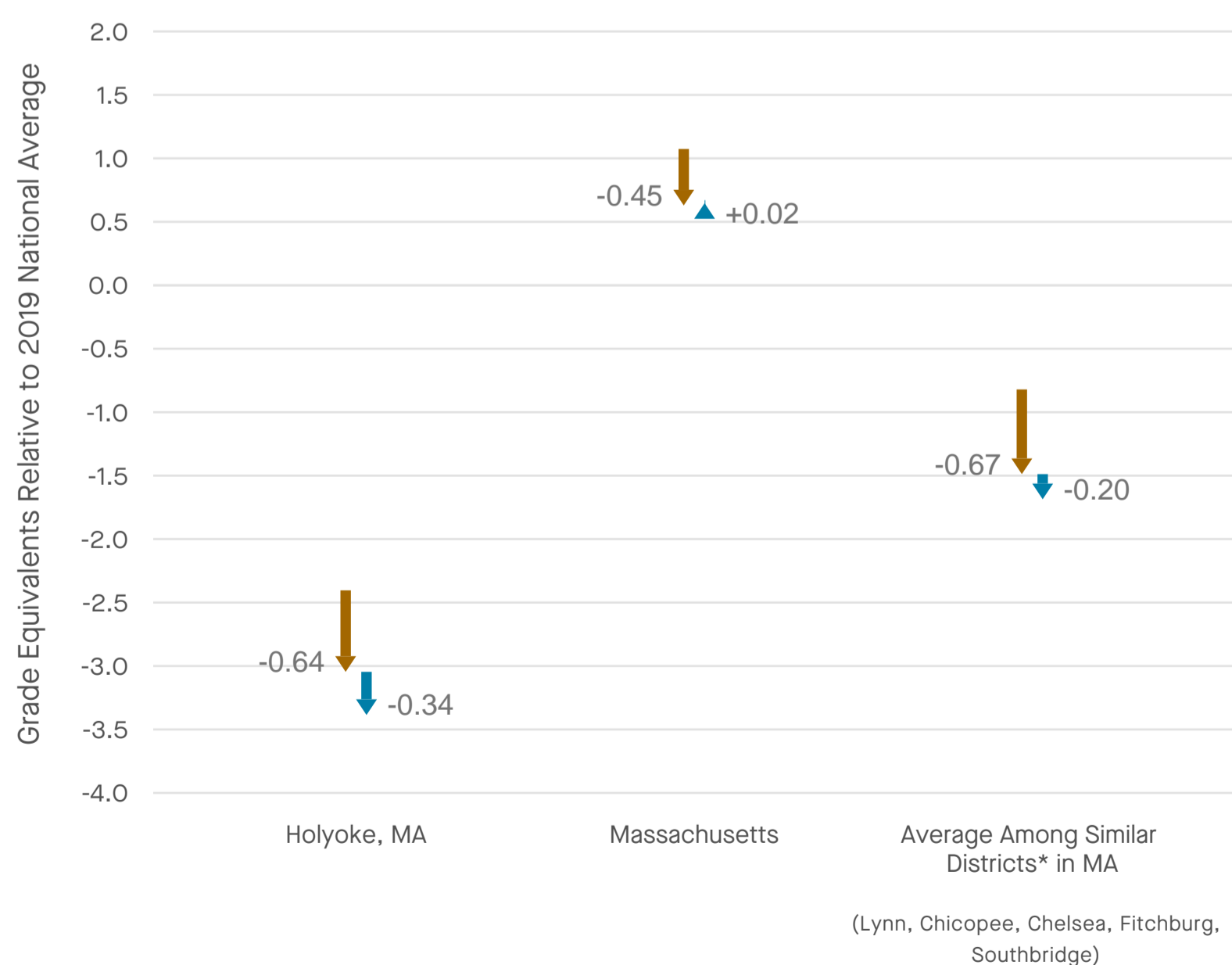

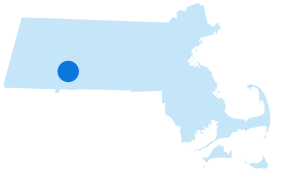

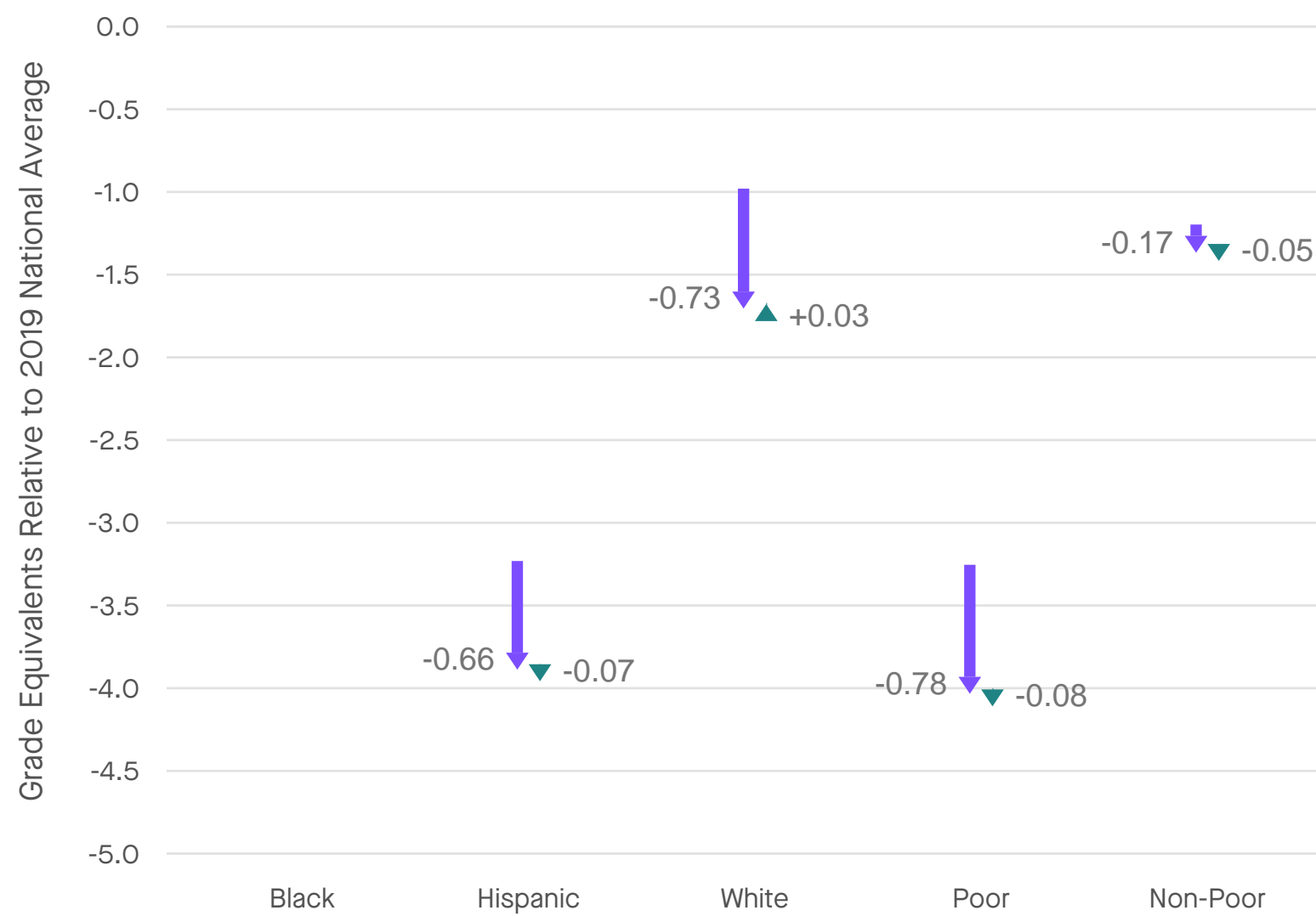

Math Performance by Subgroup, Grades 3-8, 2019-2023

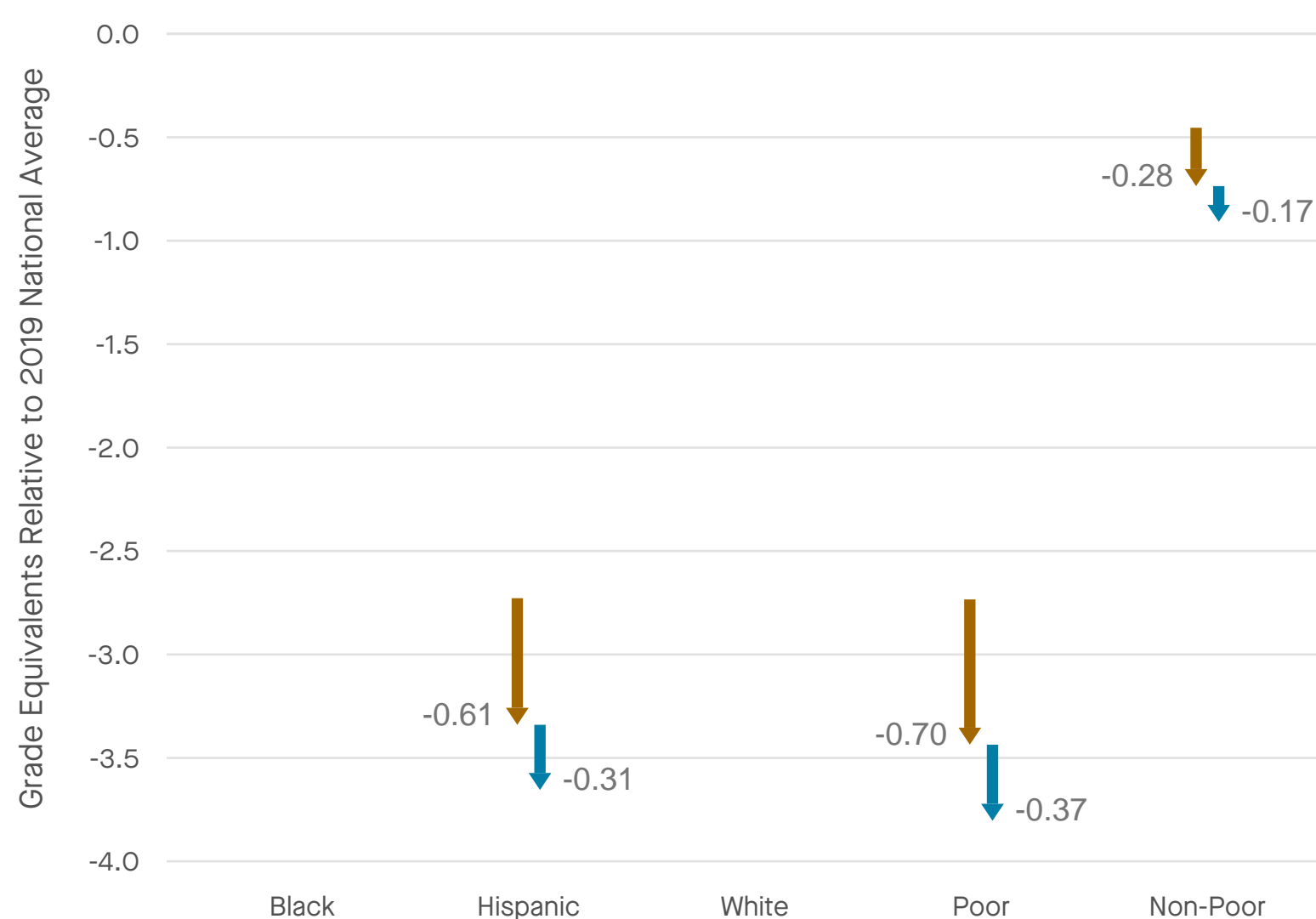

Change in Math Achievement 2019-2022 by proportion FRPL in Massachusetts districts



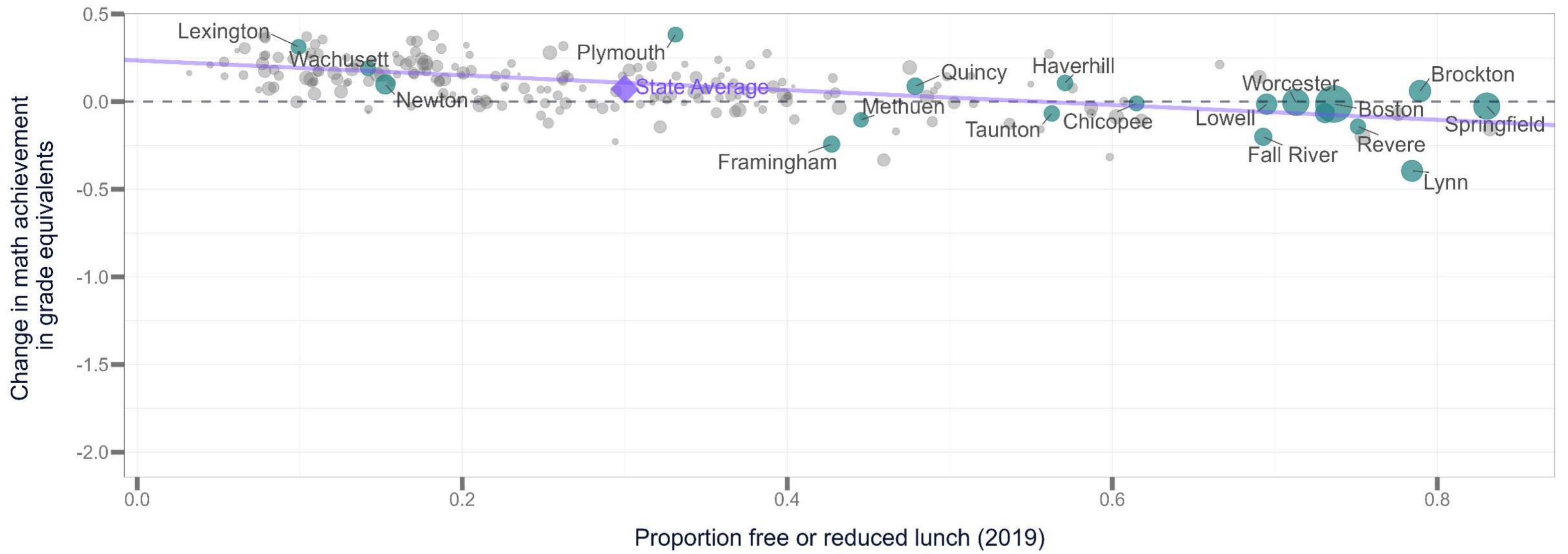

Change in Reading Achievement 2019-2022 by proportion FRPL in Massachusetts districts



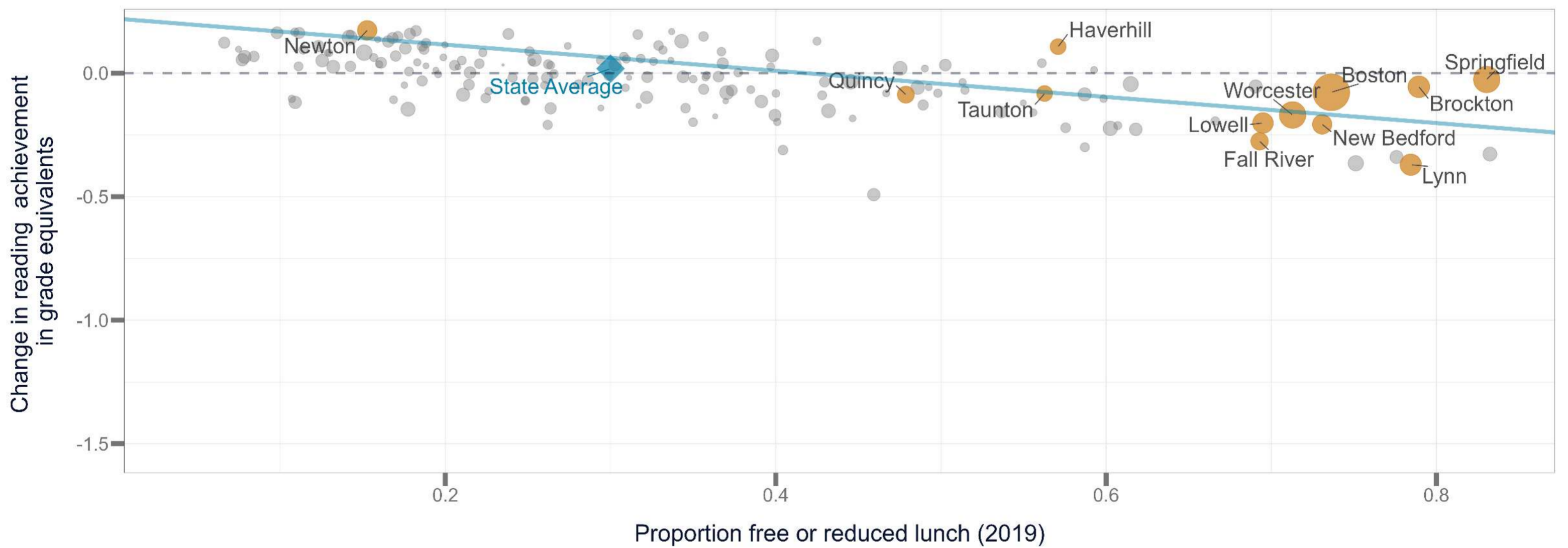

Change in Math Achievement 2022-2023 by proportion FRPL in Massachusetts districts



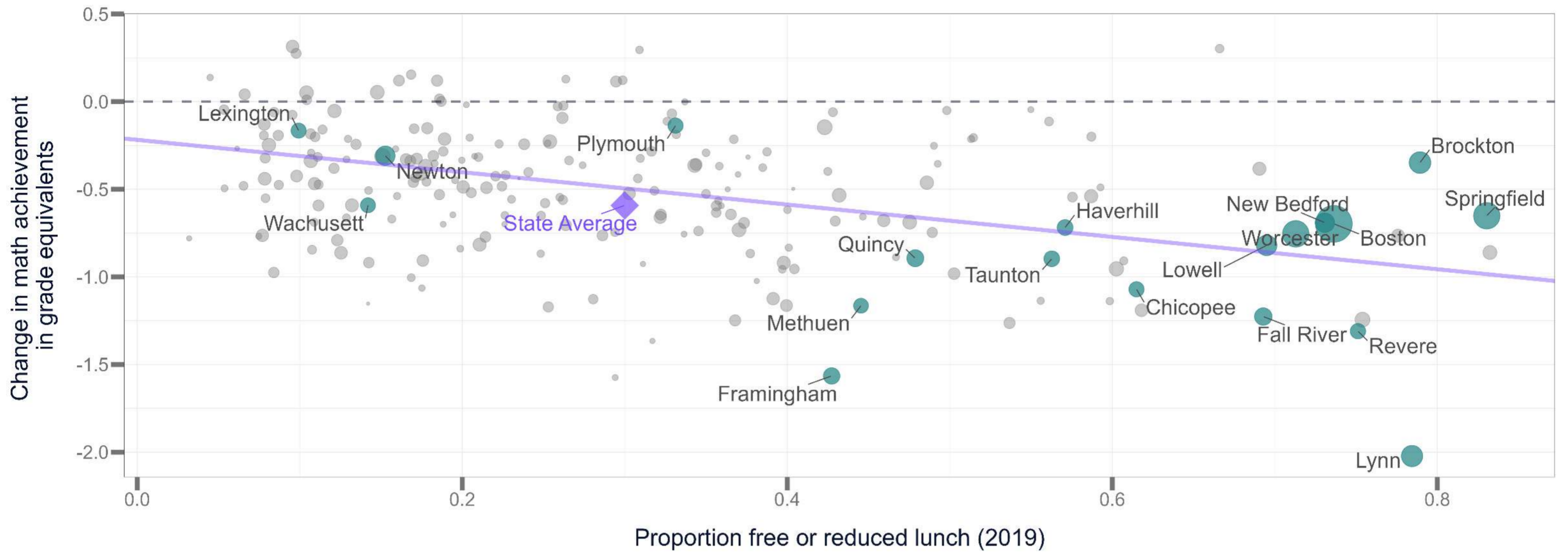

Change in Reading Achievement 2022-2023 by proportion FRPL in Massachusetts districts



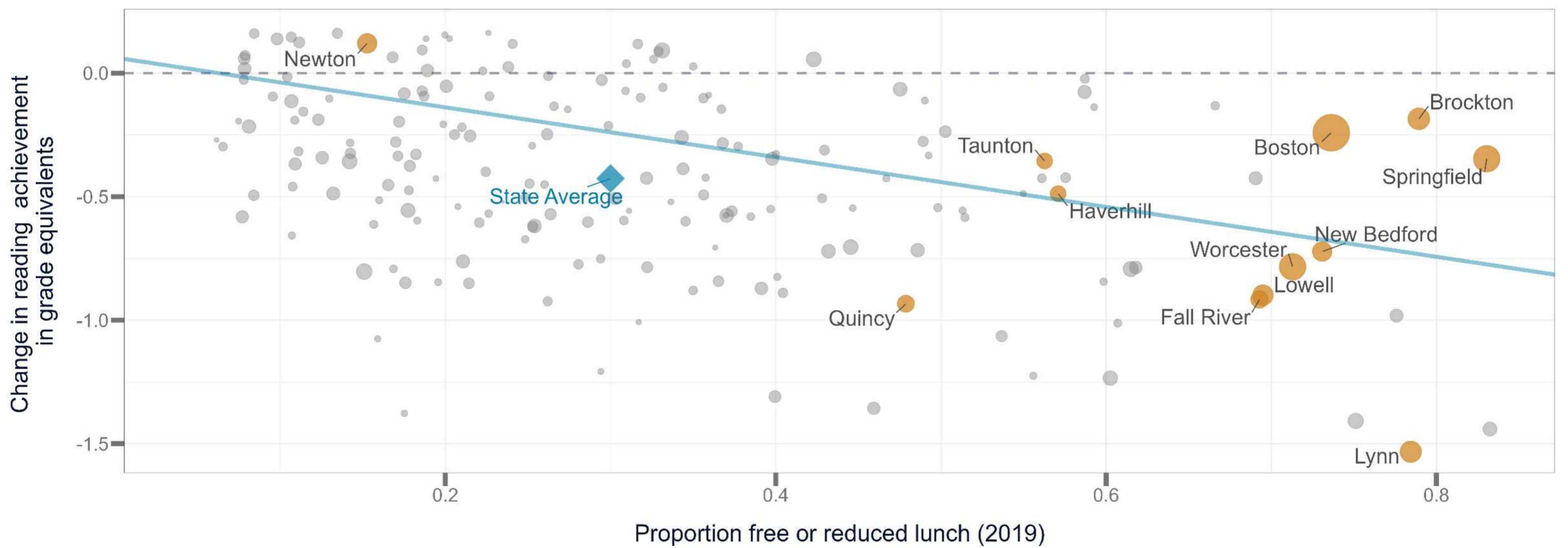
