





Math Performance in Brandon School District in the Counties of Oakland and Lapee vs. Michigan and Similar Districts, Grades 3-8, 2019-2023







Math Performance by Subgroup, Grades 3–8, 2019–2023





Change in Math Achievement 2019-2022 by proportion FRPL in Michigan districts





### Change in Reading Achievement 2019-2022 by proportion FRPL in Michigan districts








Change in Math Achievement 2022-2023

#### Change in Reading Achievement 2022-2023 by proportion FRPL in Michigan districts




Proportion free or reduced lunch (2019)




#### Change in Math Achievement 2019-2023 by proportion FRPL in Michigan districts







### Michigan Math Achievement By Race and Economic Status




