





Math Performance in Humphreys County School District vs. Mississippi and Similar Districts, Grades 3-8, 2019-2023








Change in Math Achievement 2019-2022

> Change in Reading Achievement 2019-2022 by proportion FRPL in Mississippi districts






### Change in Math Achievement 2022-2023 by proportion FRPL in Mississippi districts



### Change in Math Achievement 2019-2023 by proportion FRPL in Mississippi districts


Proportion free or reduced lunch (2019)




