








Change in Math Achievement 2019-2022

> Change in Reading Achievement 2019-2022 by proportion FRPL in Mississippi districts






Change in Math Achievement 2022-2023 by proportion FRPL in Mississippi districts



Change in Math Achievement 2019-2023 by proportion FRPL in Mississippi districts






