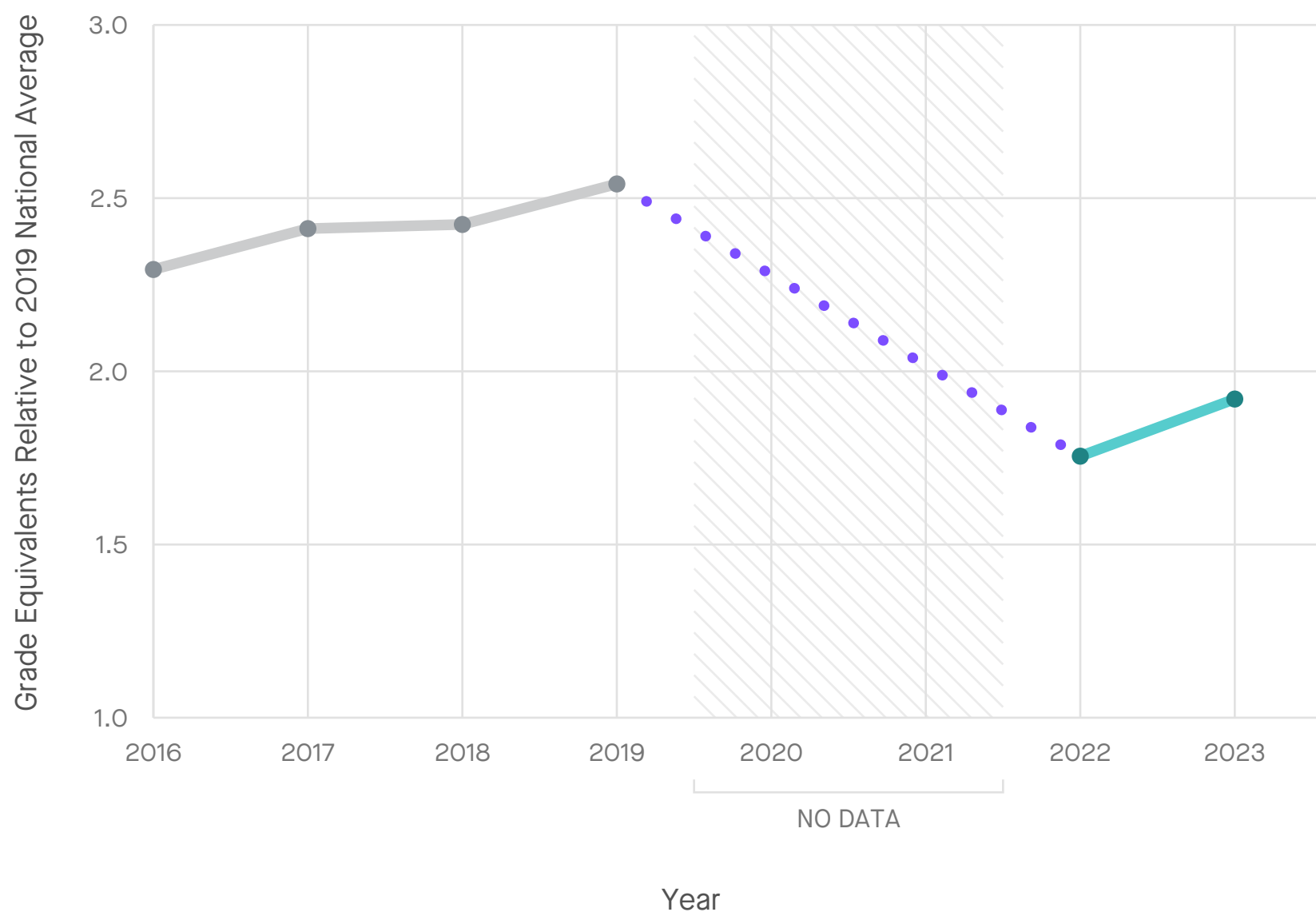

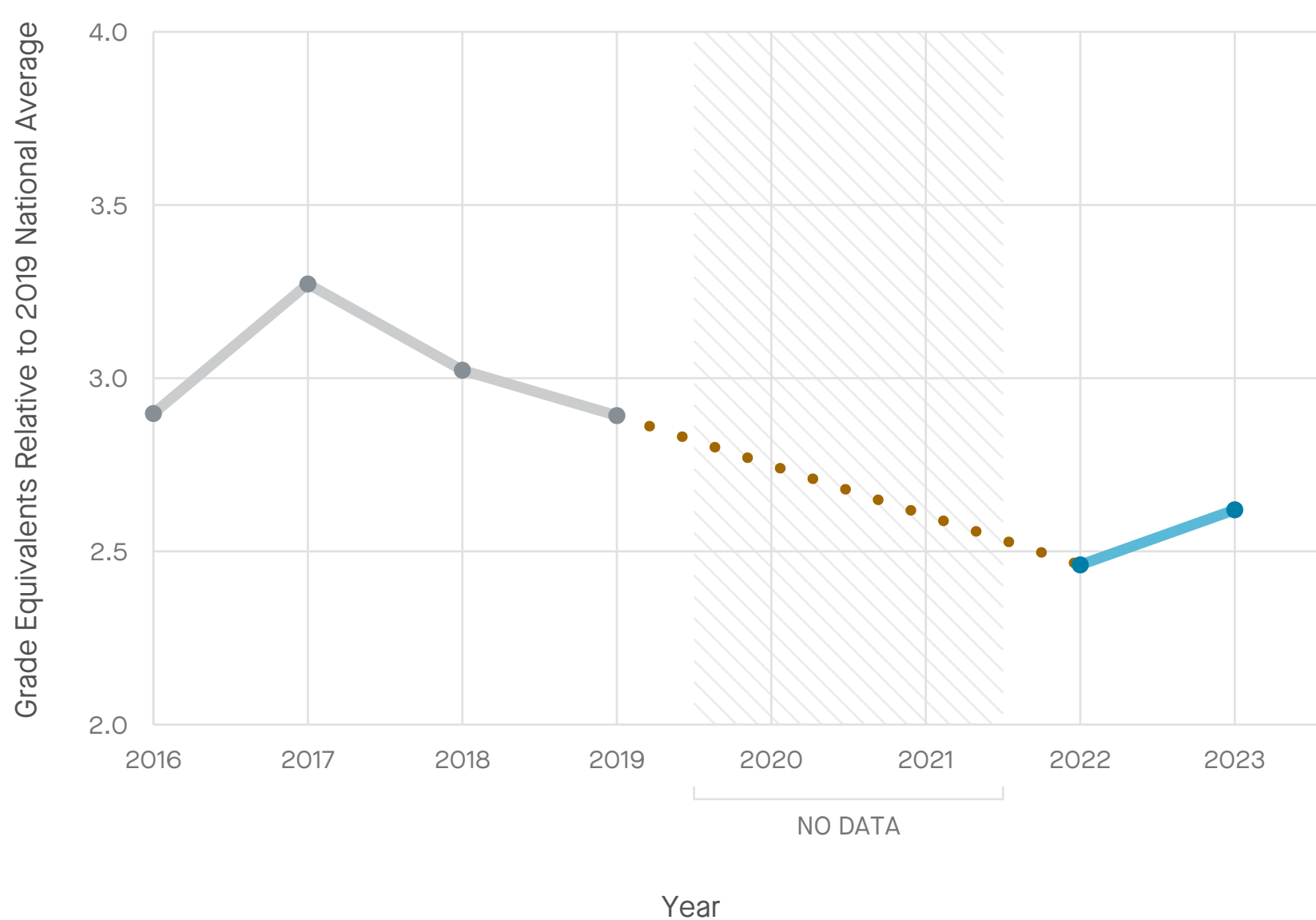

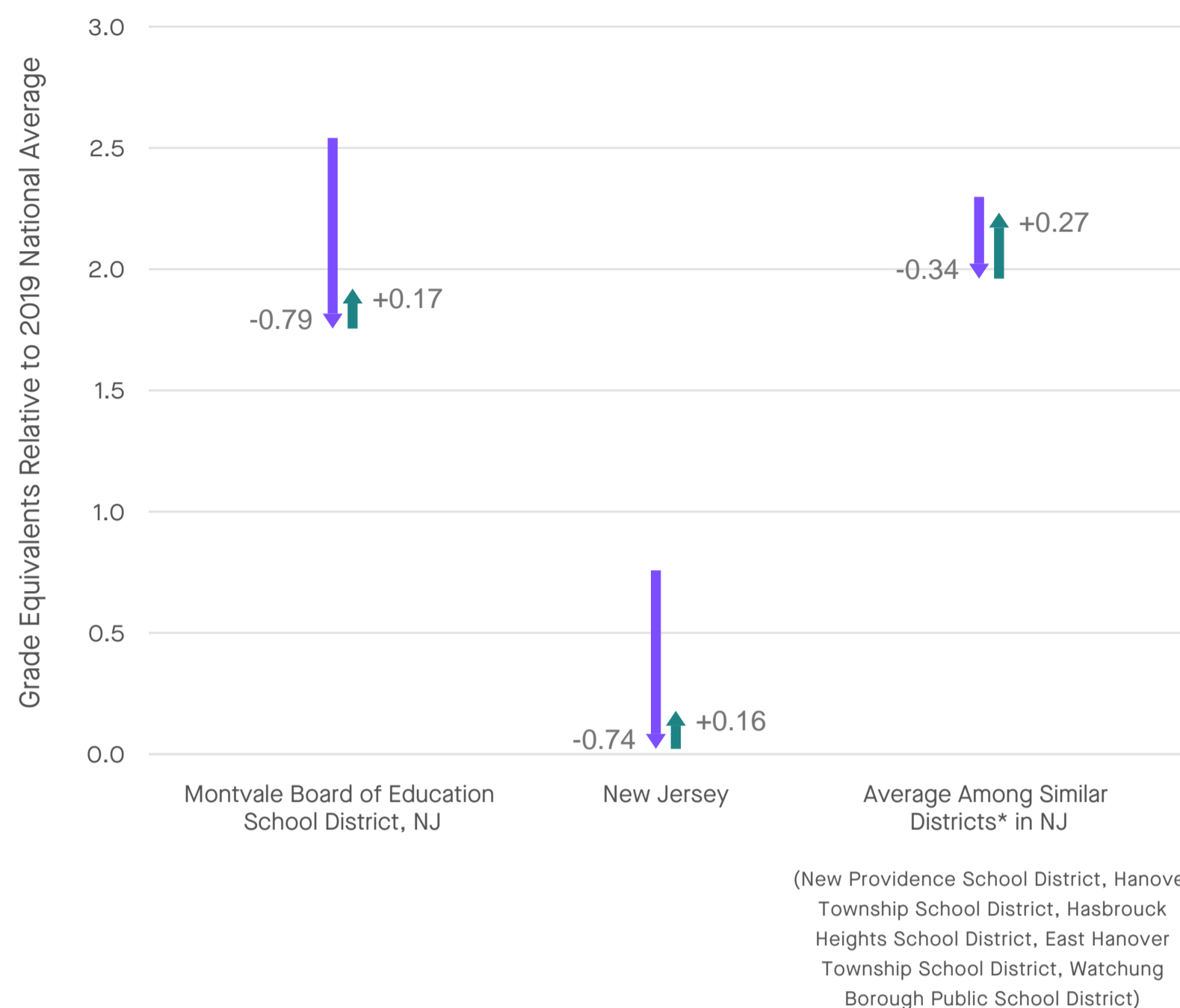

Math Performance in Montvale Board of Education School District vs. New Jersey and Similar Districts, Grades 3-8, 2019-2023



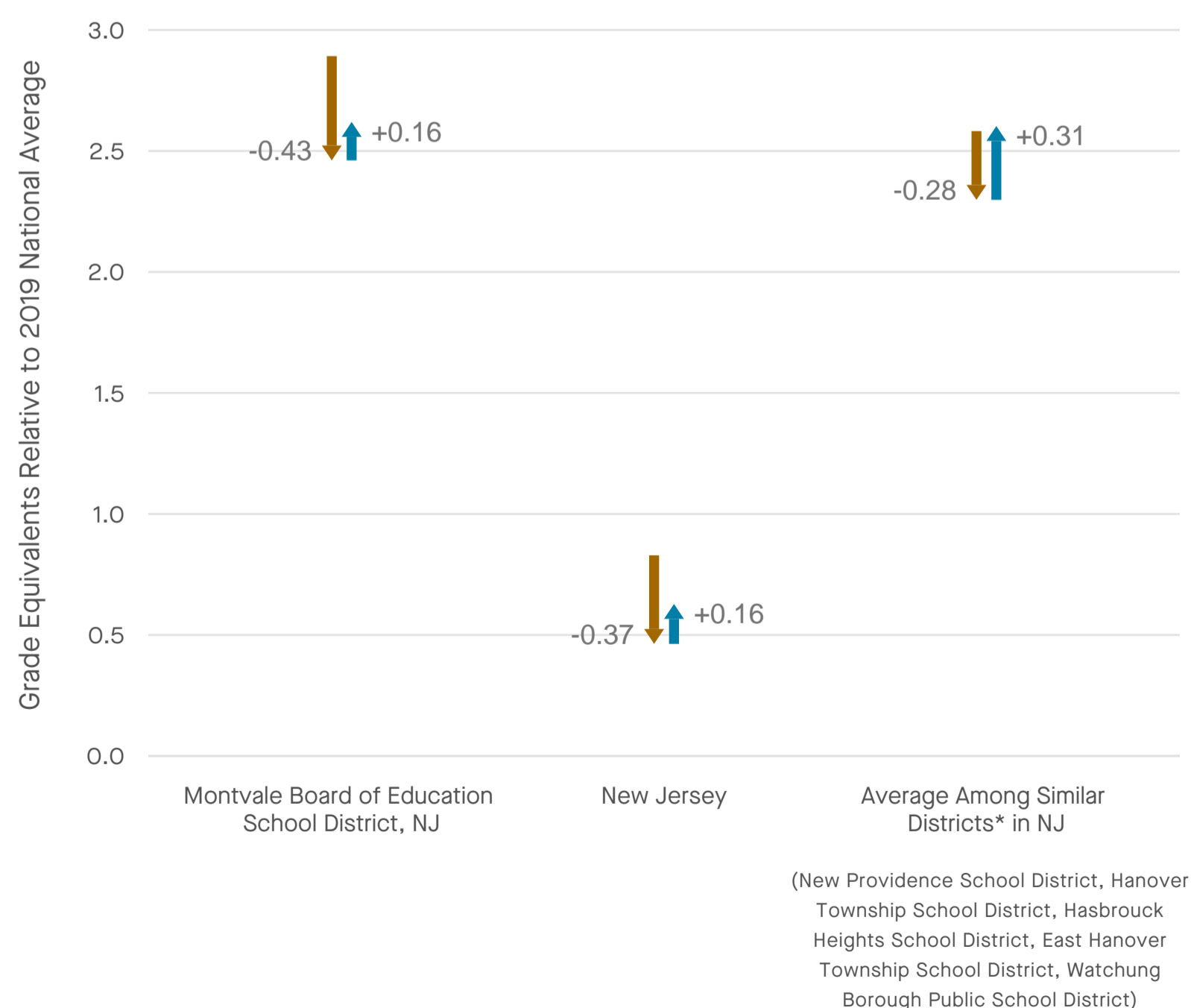

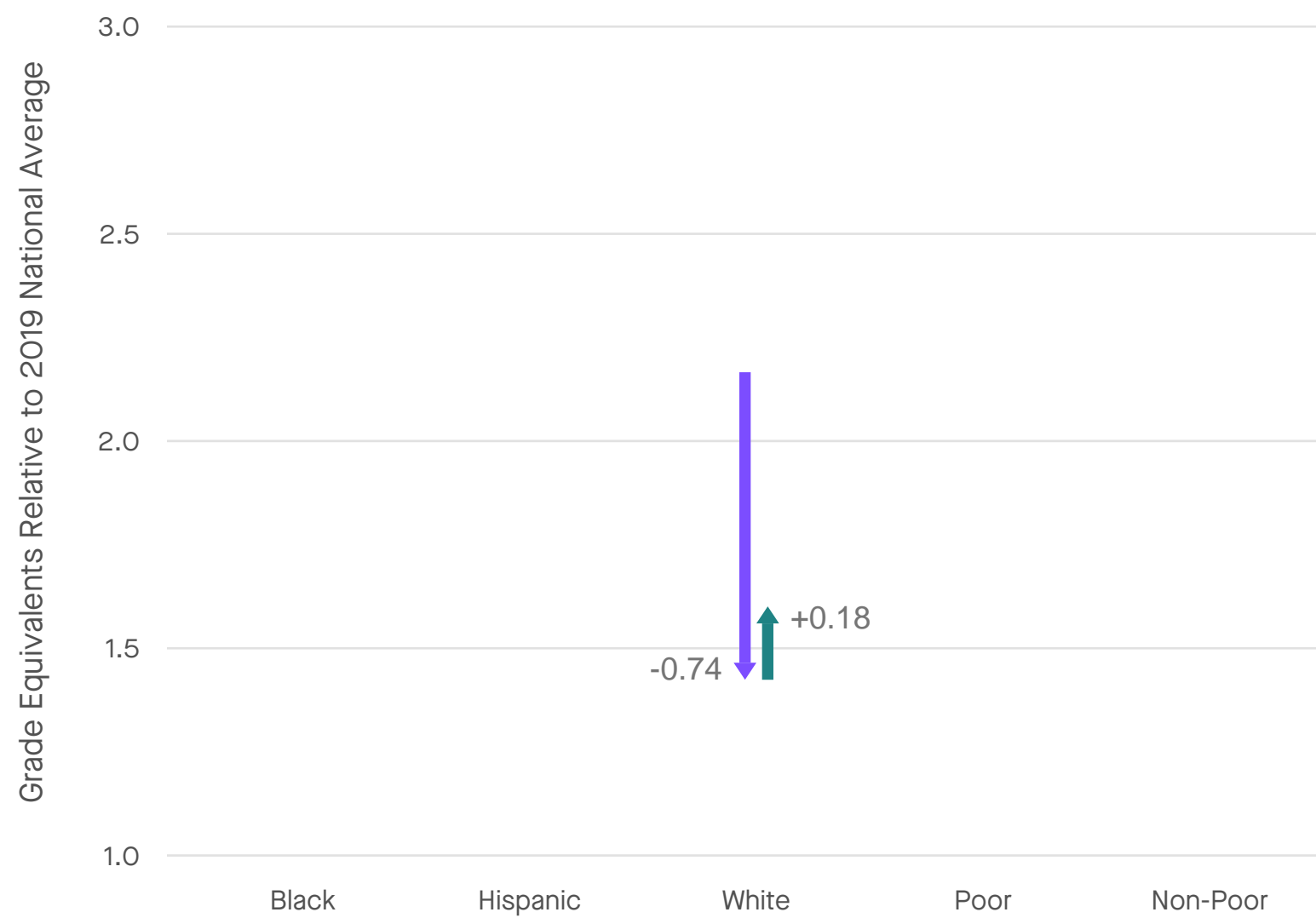

Math Performance by Subgroup, Grades 3-8, 2019-2023

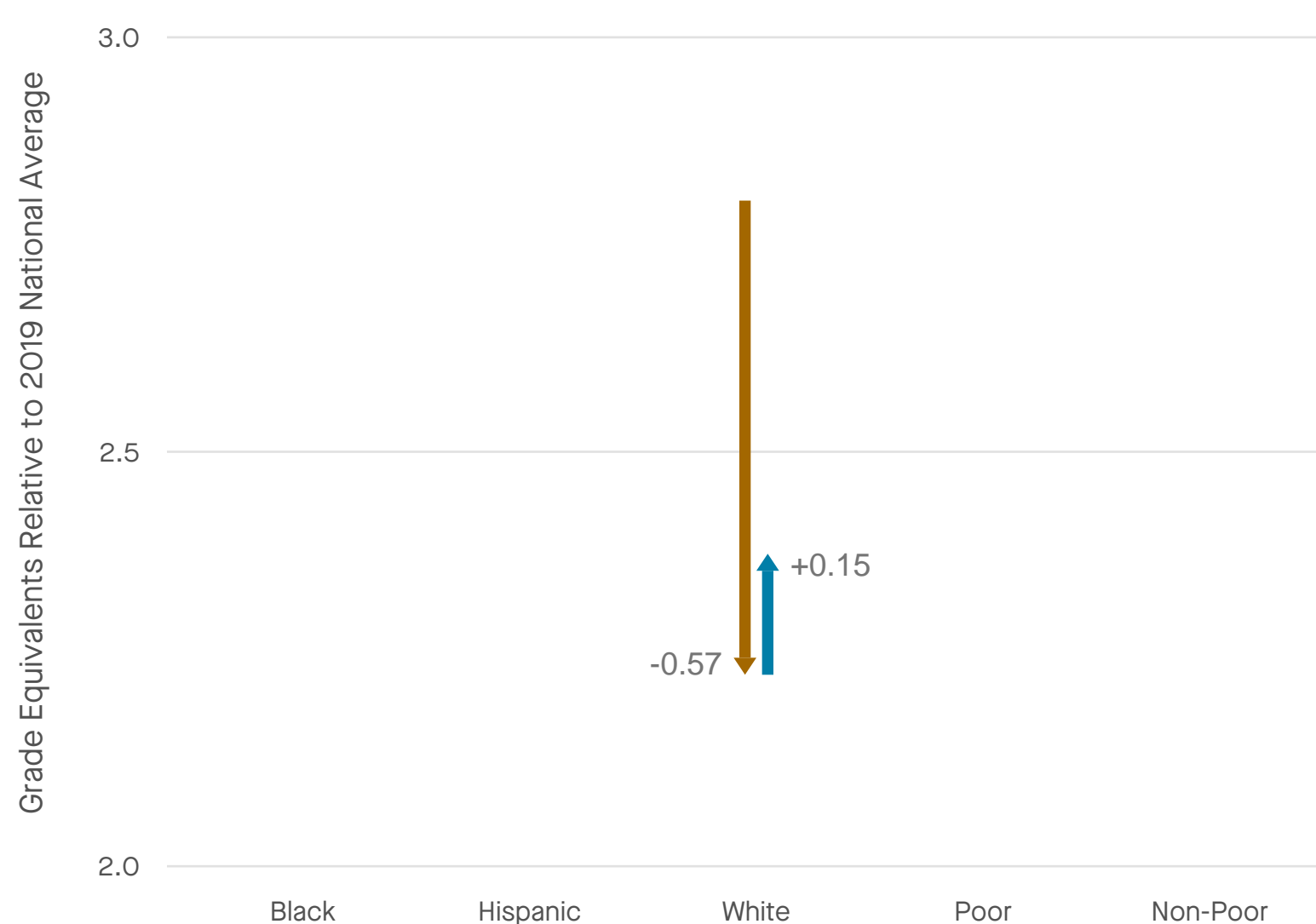
