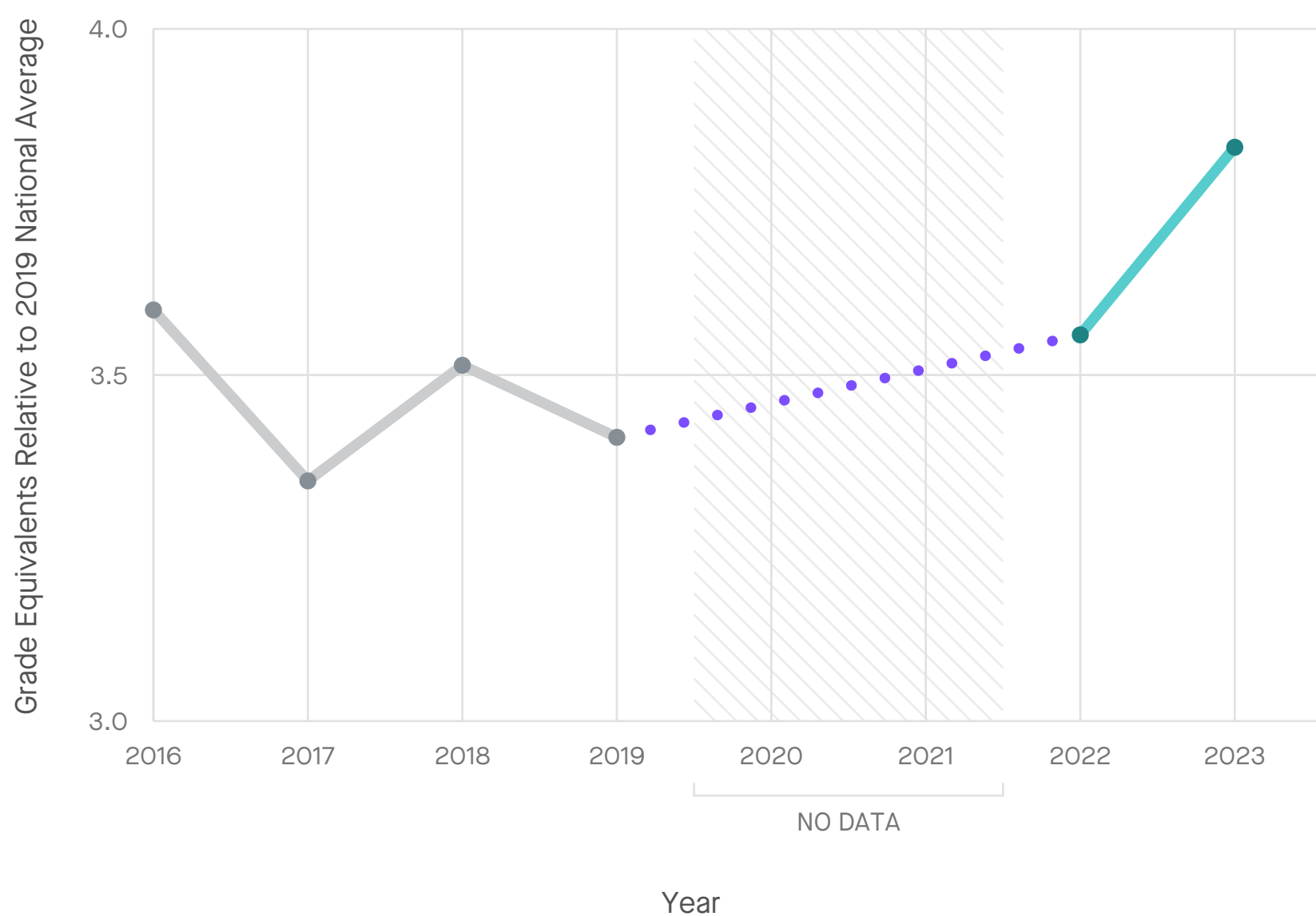

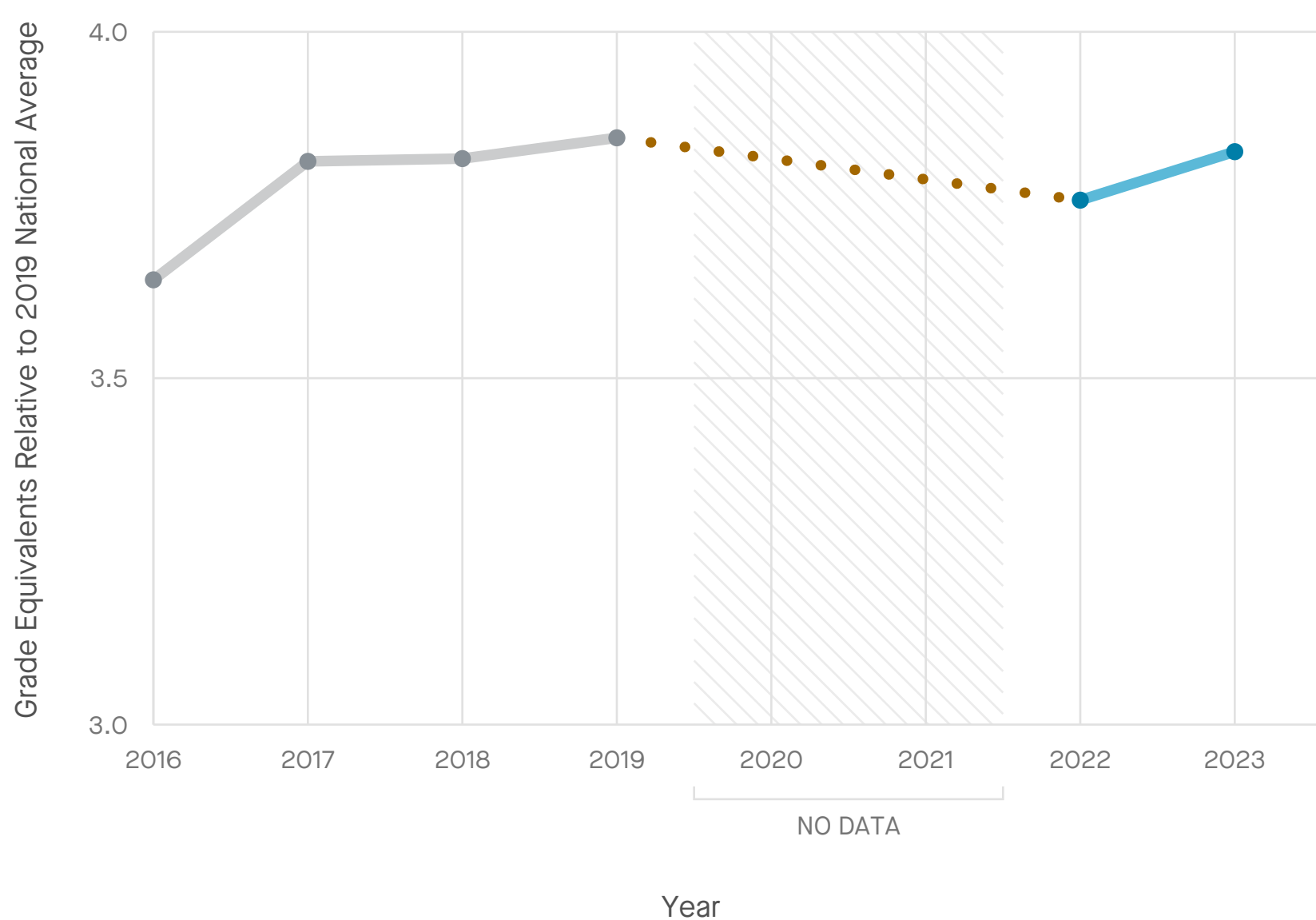

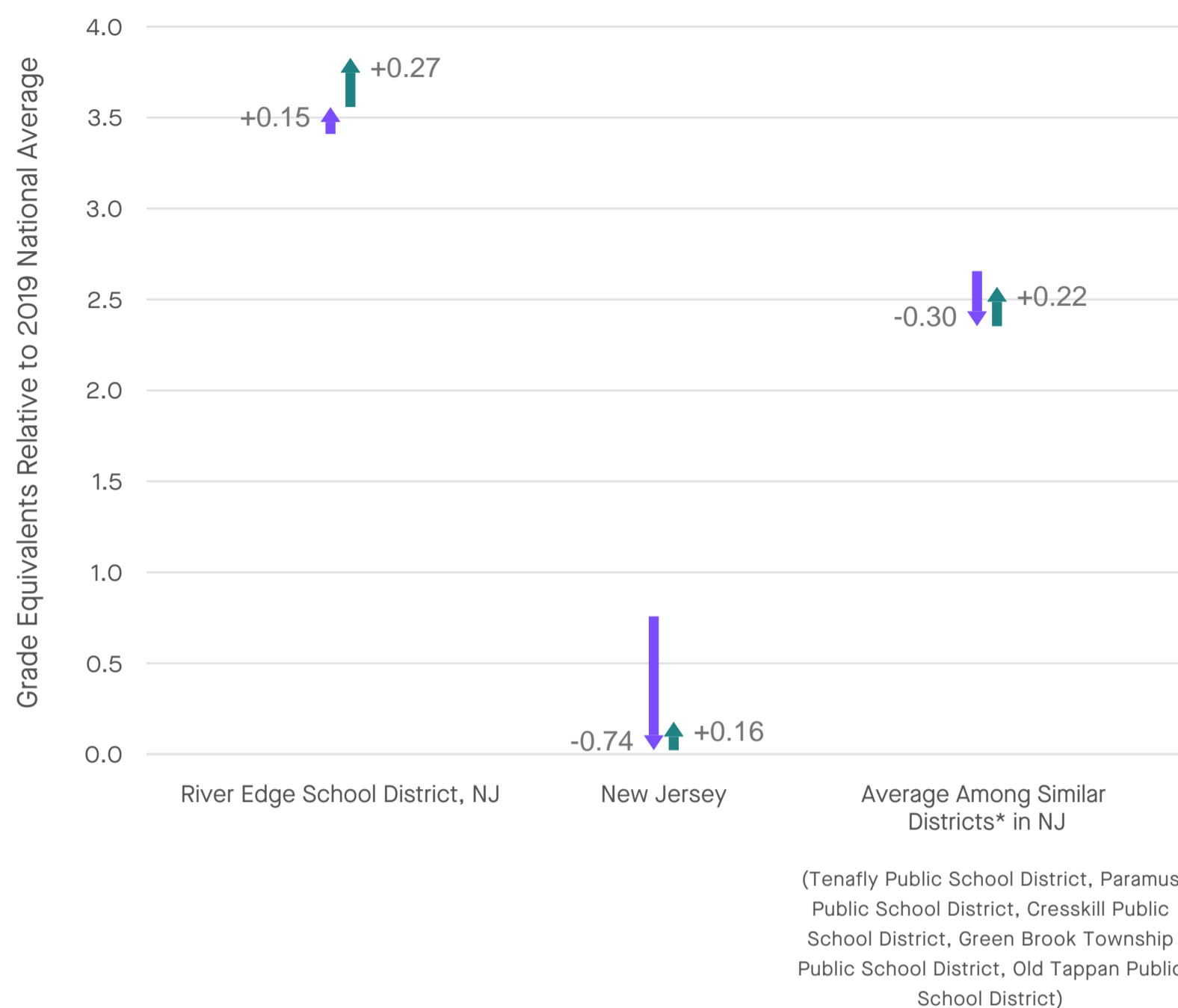

Math Performance in River Edge School District vs. New Jersey and Similar Districts, Grades 3-8, 2019-2023



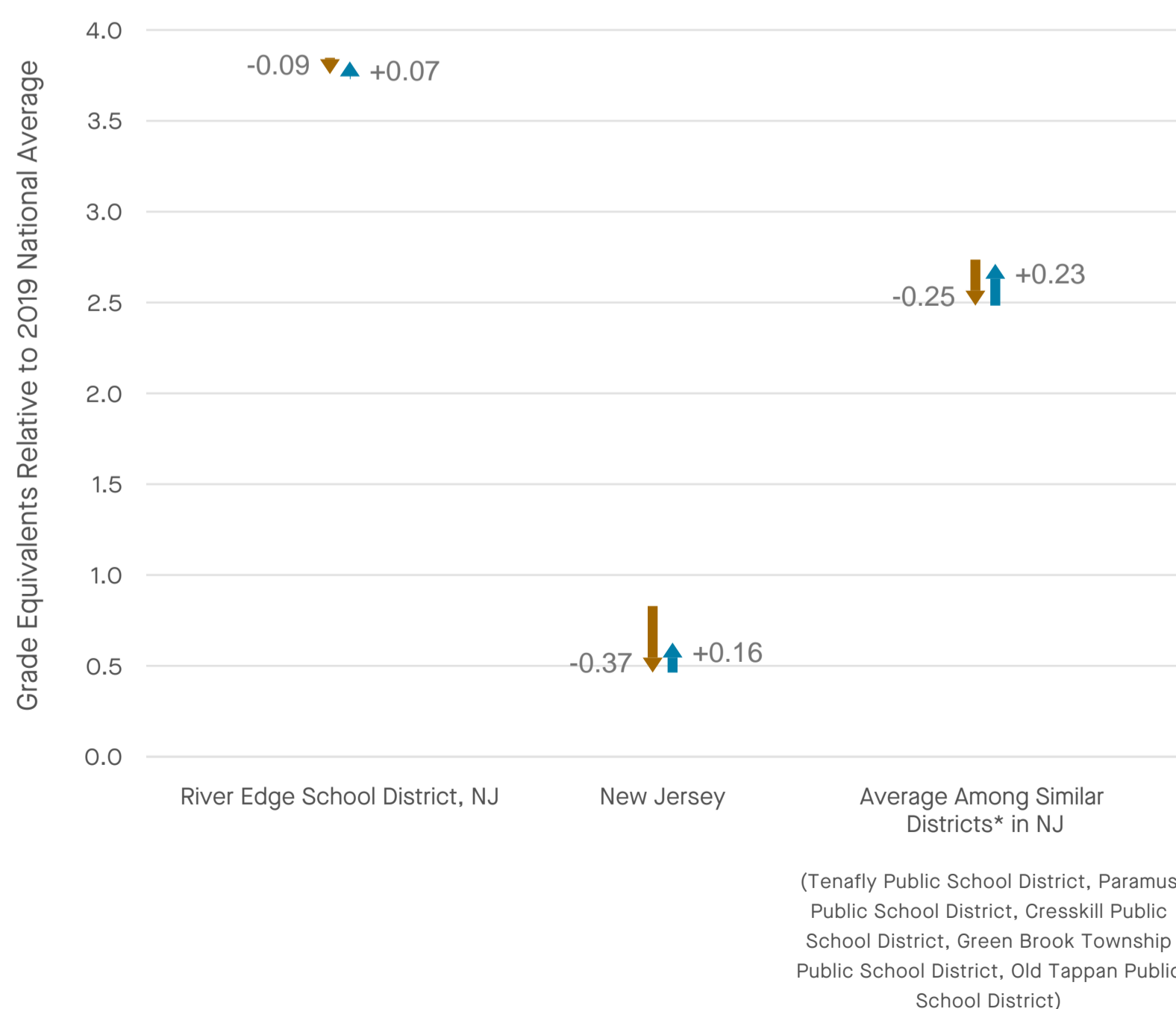

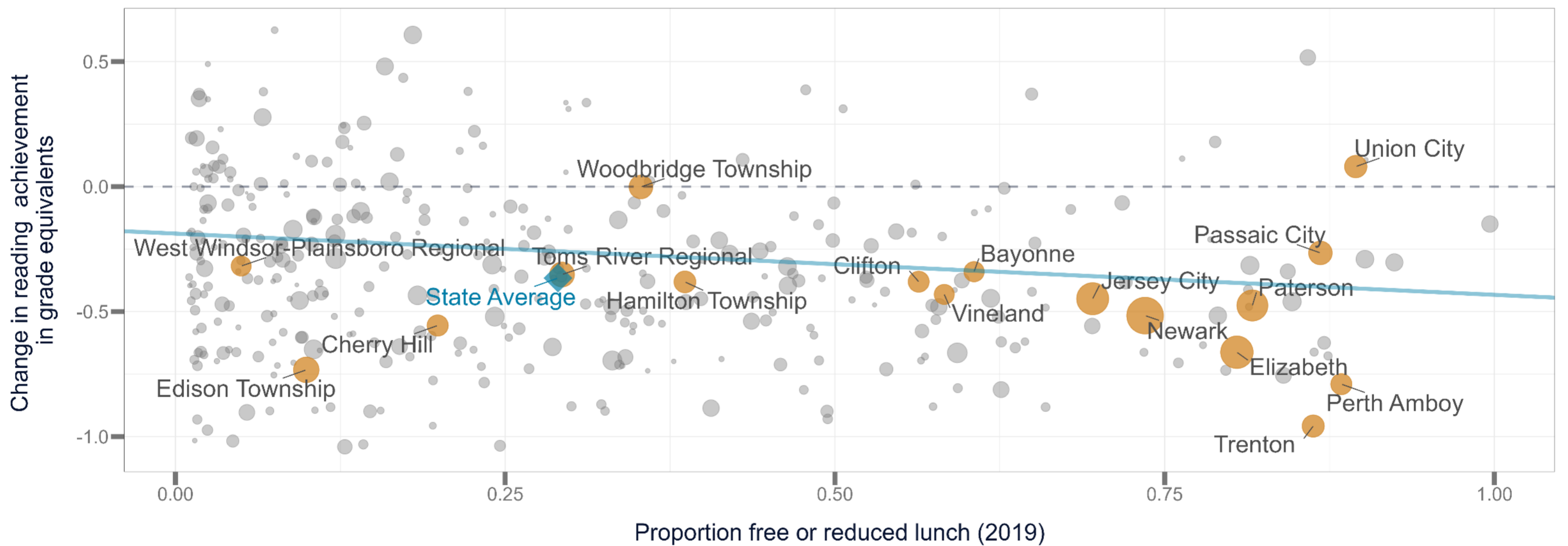
Change in Math Achievement 2019-2022 by proportion FRPL in New Jersey districts
