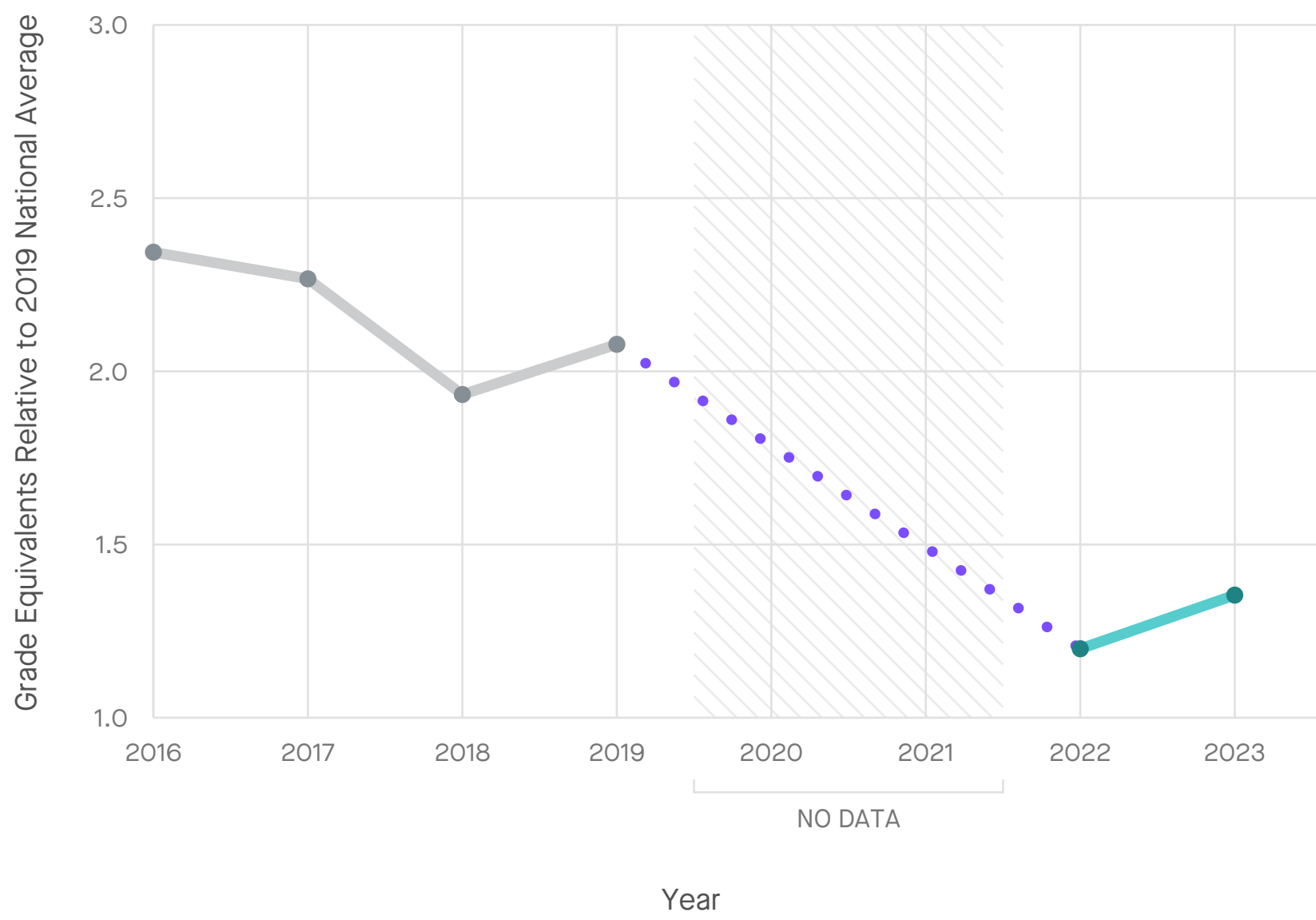

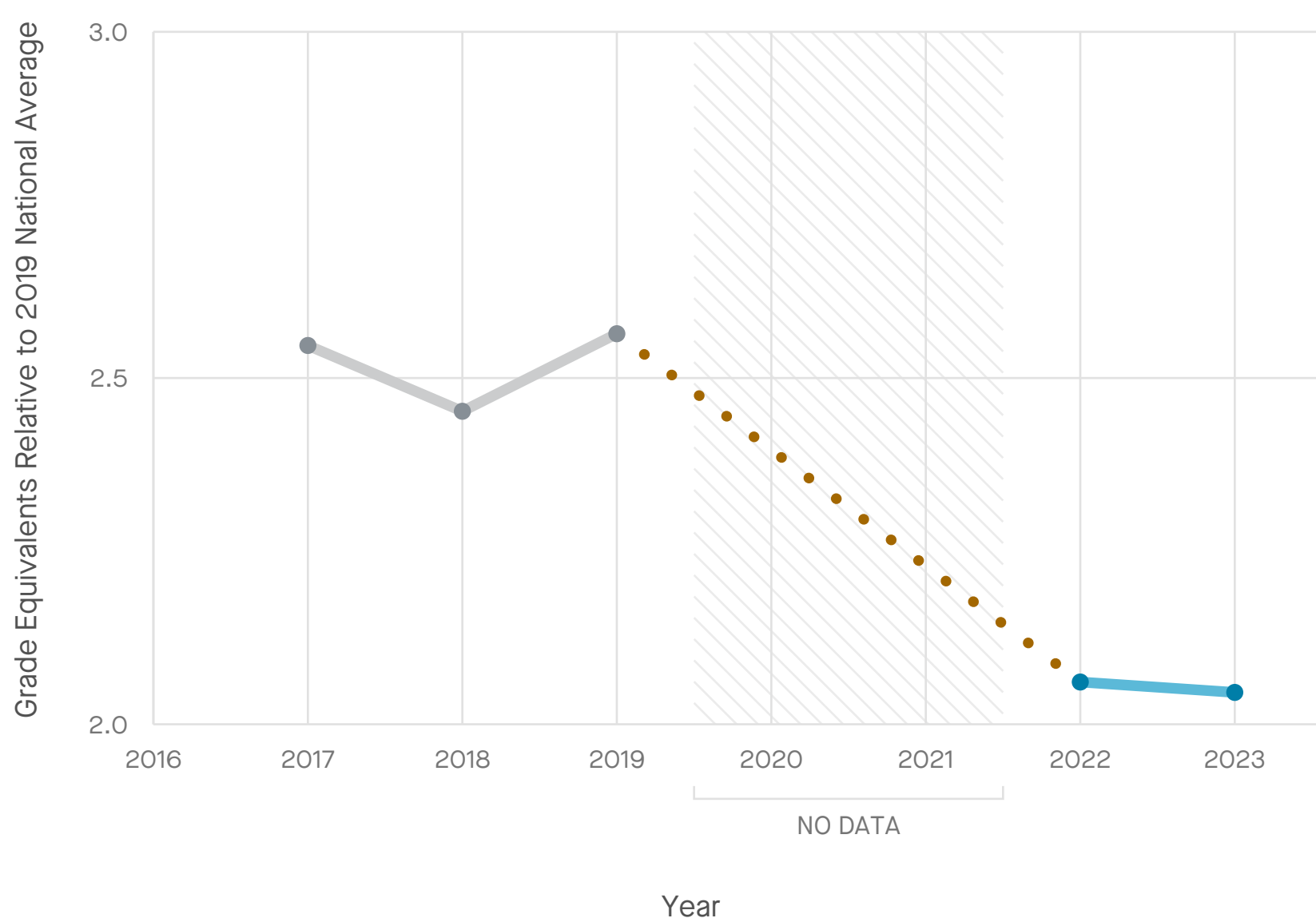

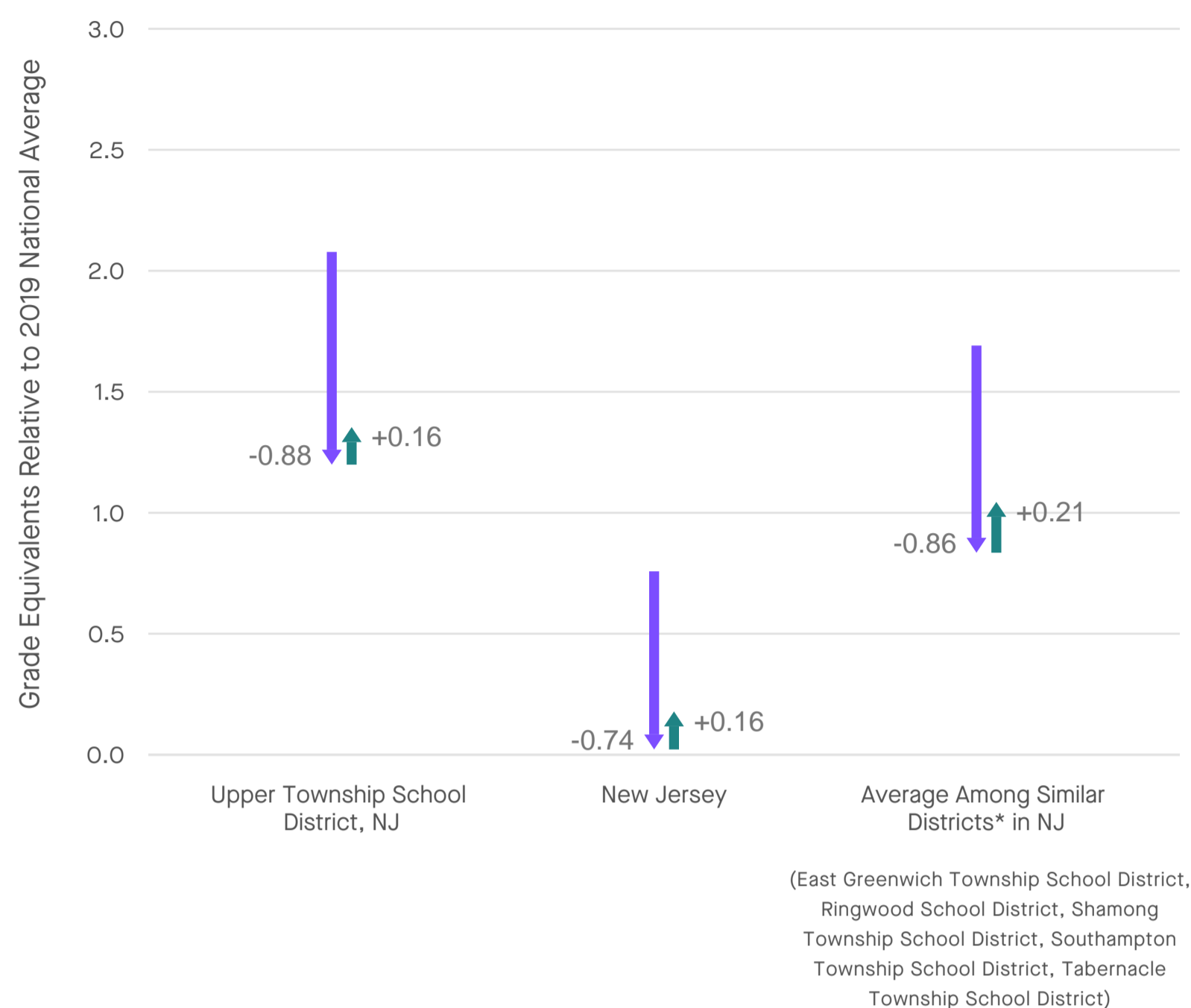

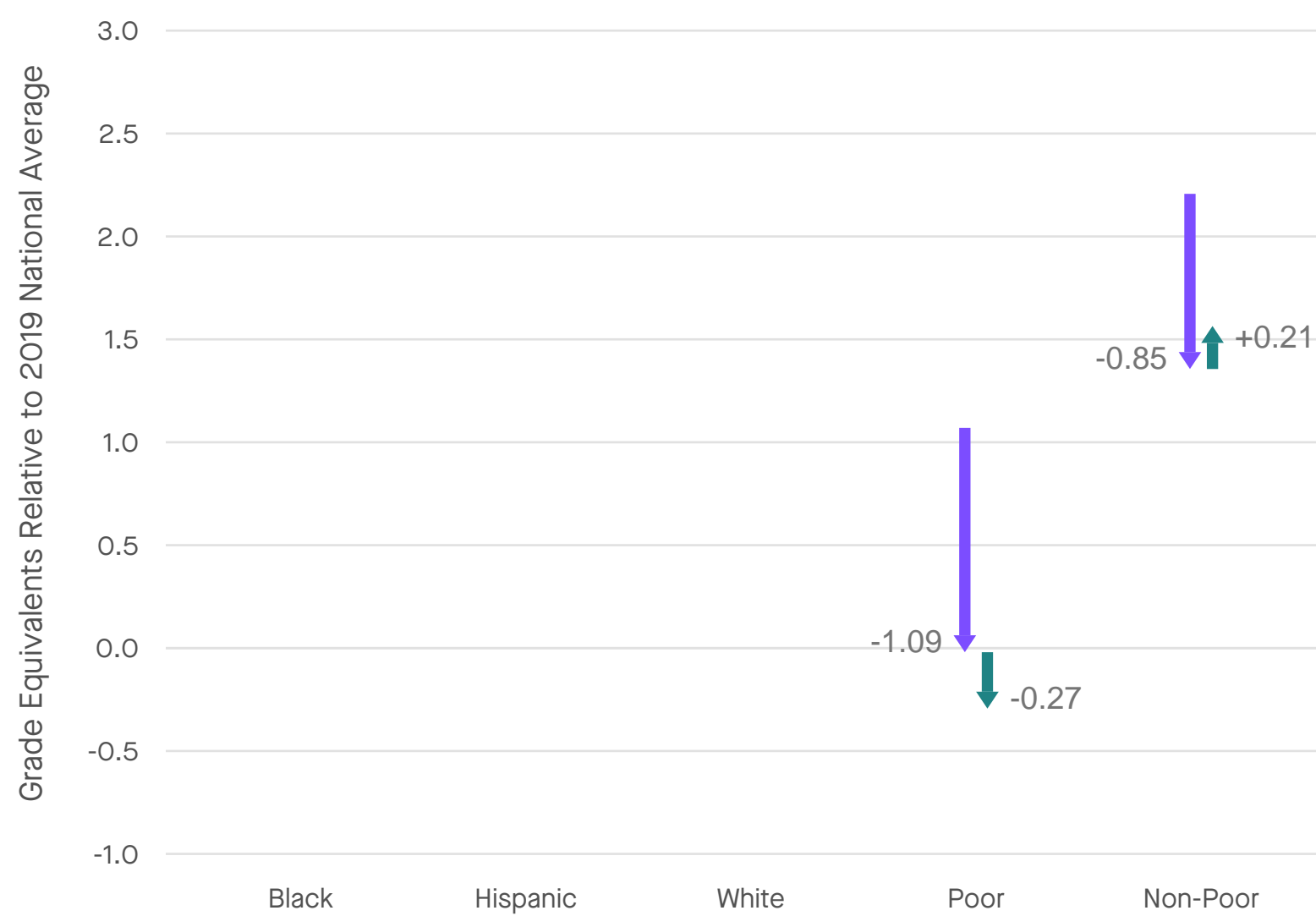

Math Performance by Subgroup, Grades 3-8, 2019-2023

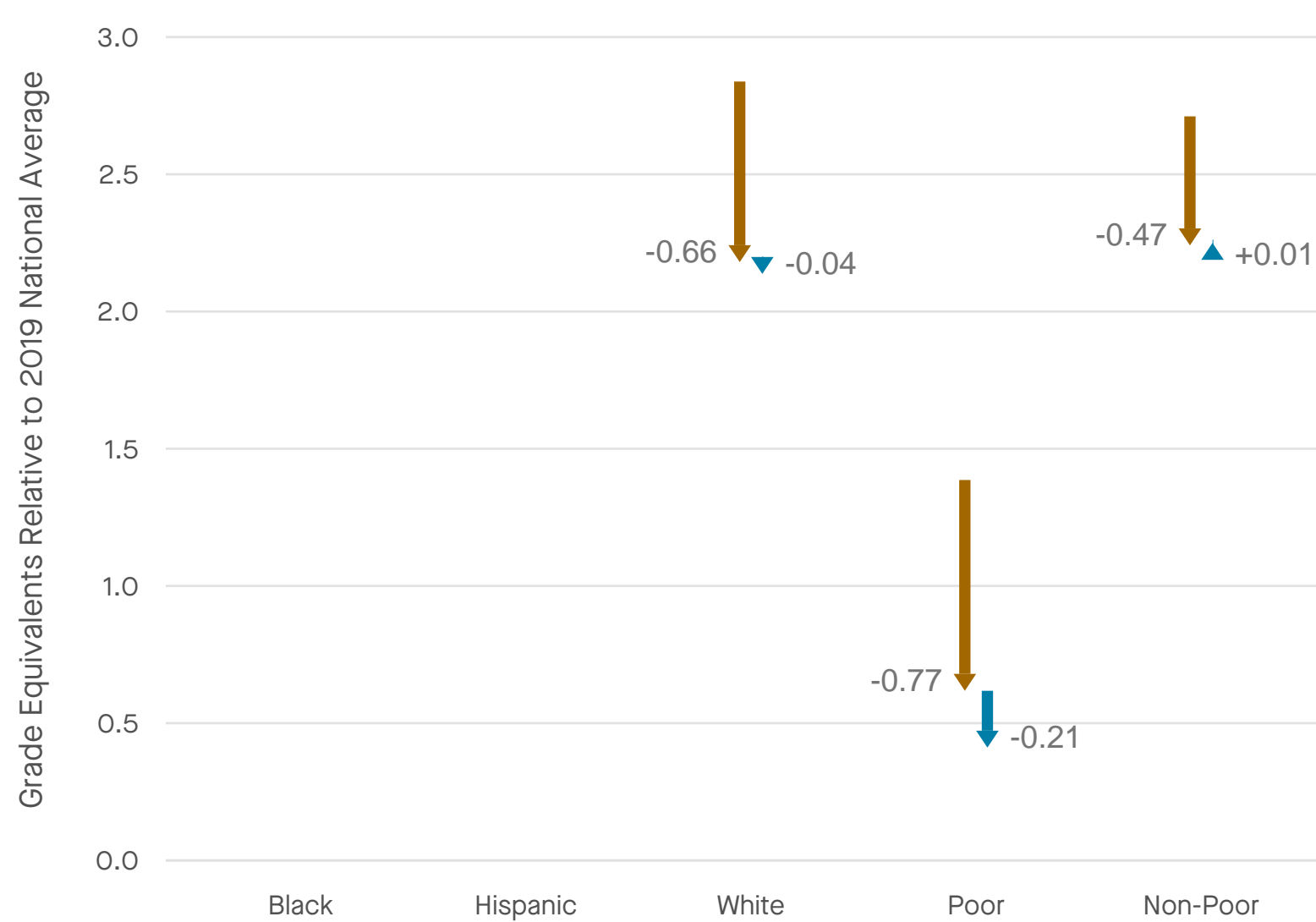

Change in Reading Achievement 2019-2022 by proportion FRPL in New Jersey districts



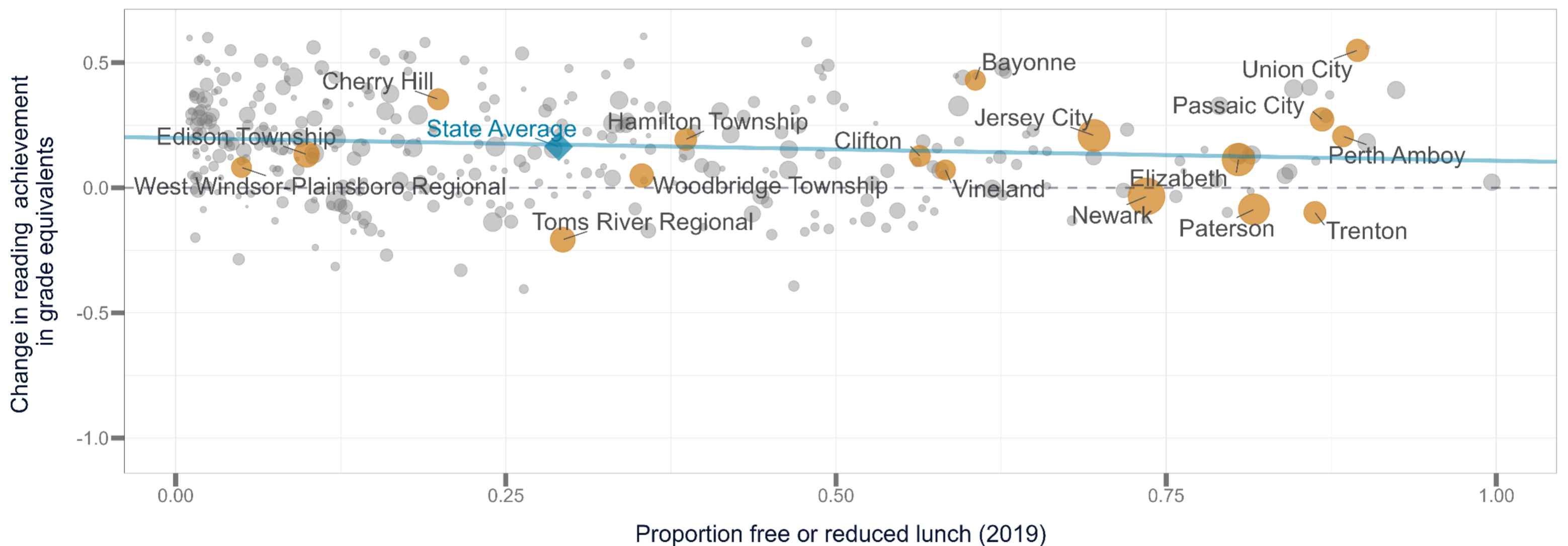
