









### Change in Reading Achievement 2019-2022 by proportion FRPL in Ohio districts





## Change in Math Achievement 2022-2023 by proportion FRPL in Ohio districts





## Change in Reading Achievement 2022-2023 by proportion FRPL in Ohio districts









# Change in Math Achievement by proportion FRPL in Ohio districts





#### Ohio Math Achievement By Race and Economic Status


