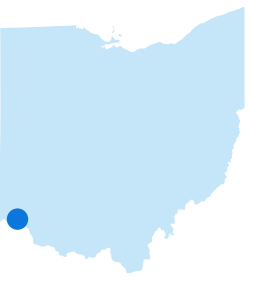
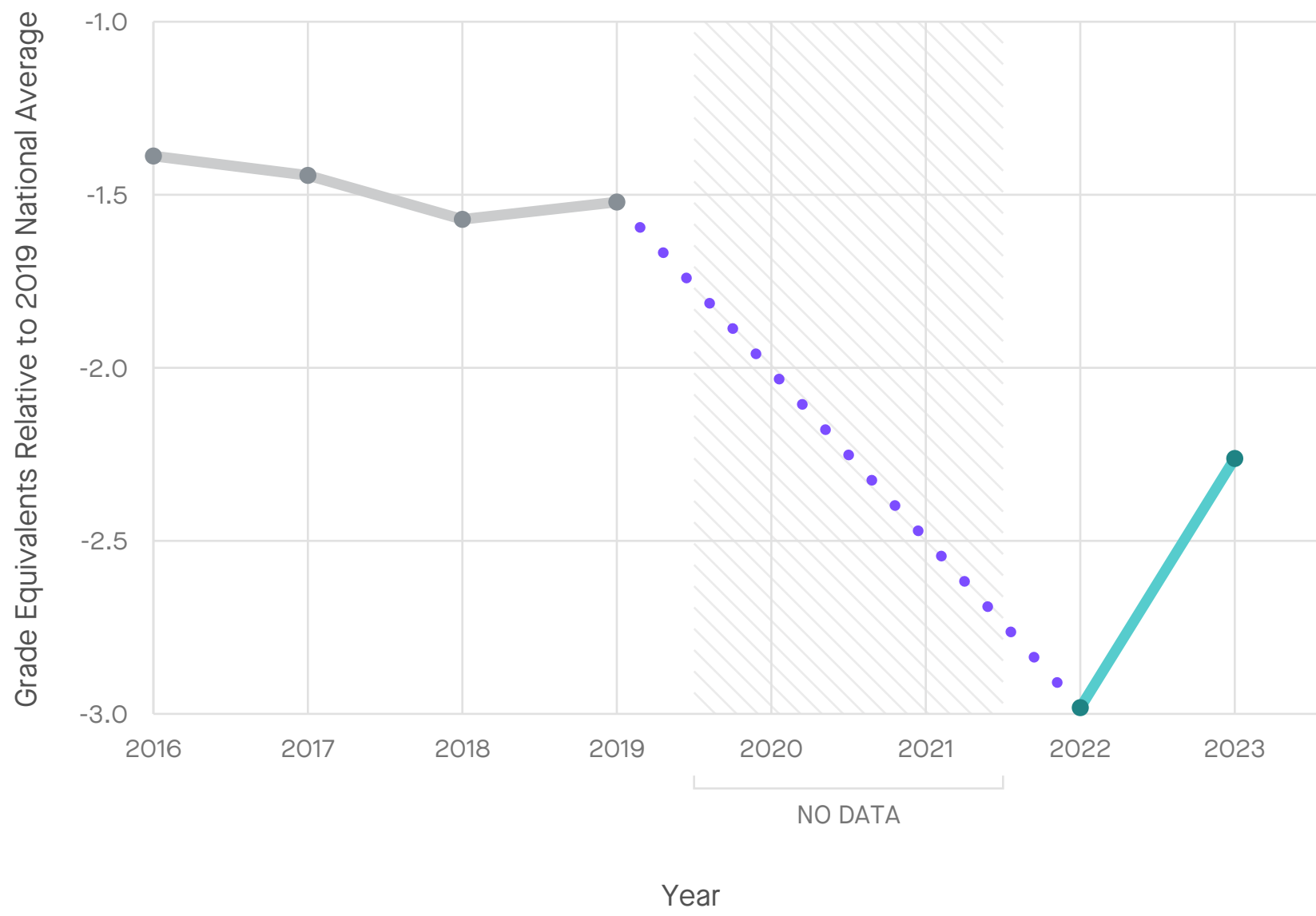

## Math Performance, Grades 3-8, 2016-2023

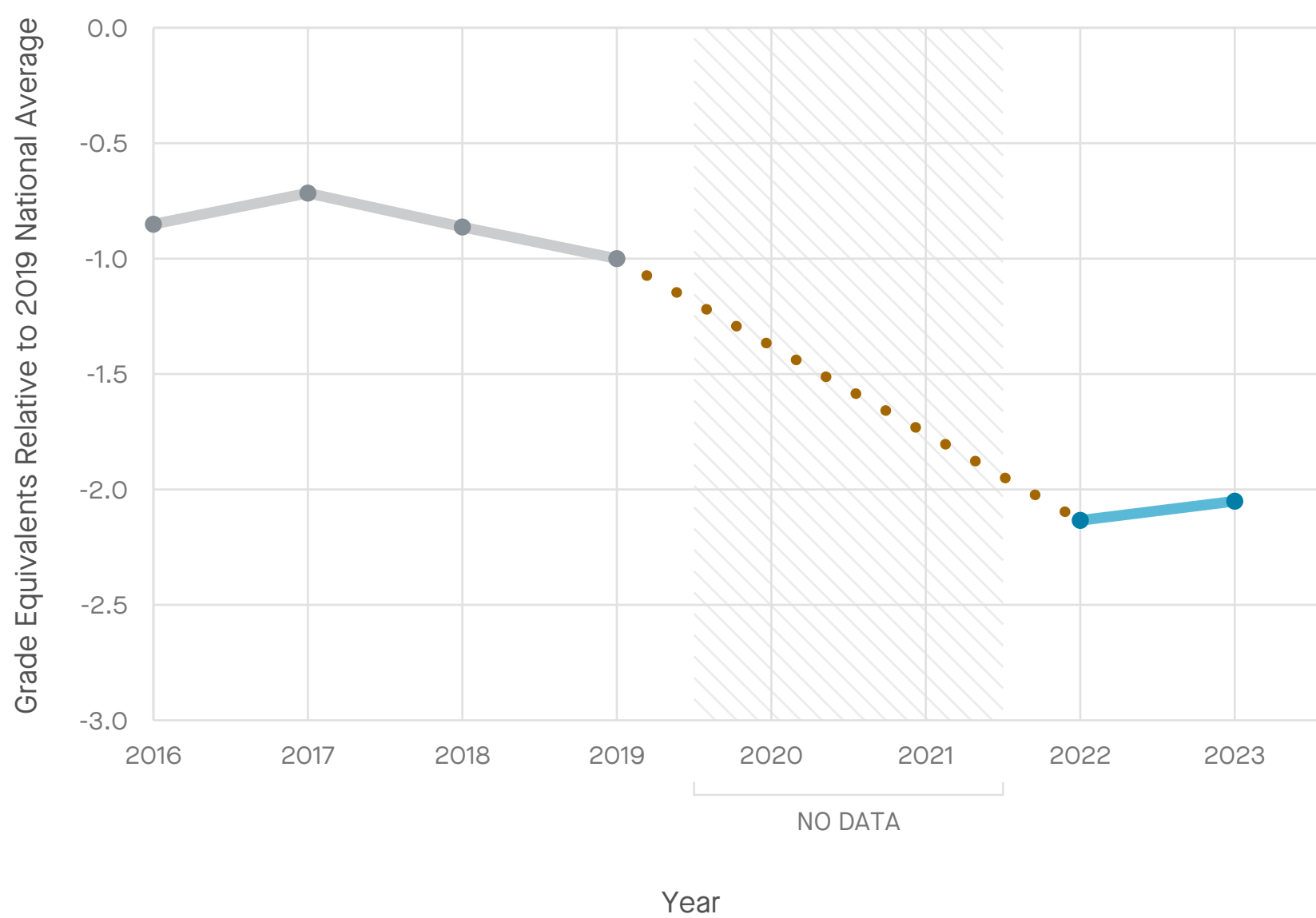

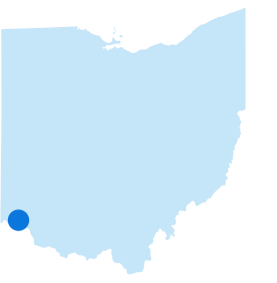

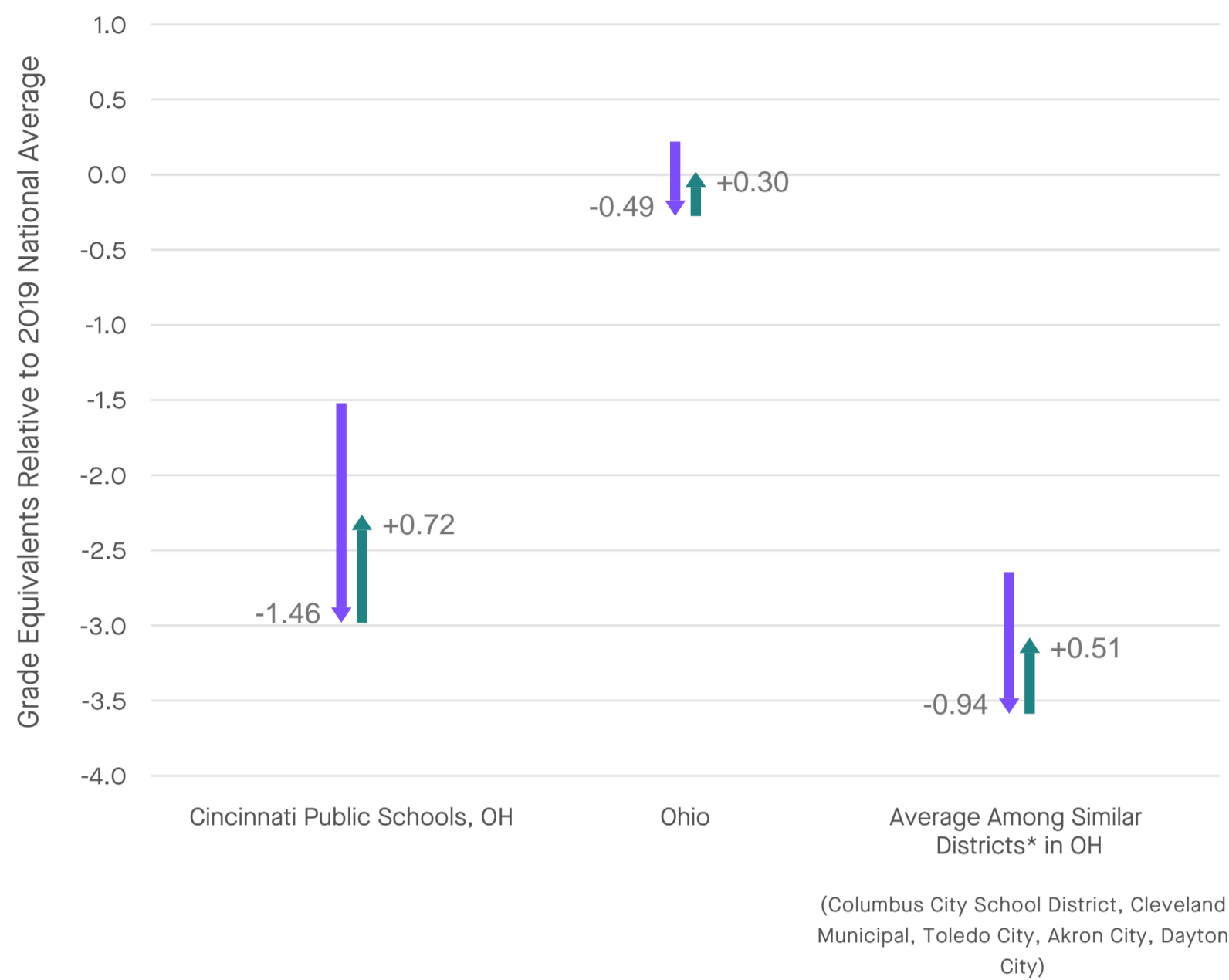

## Math Performance in Cincinnati Public Schools vs. Ohio and Similar Districts, Grades 3-8, 2019-2023



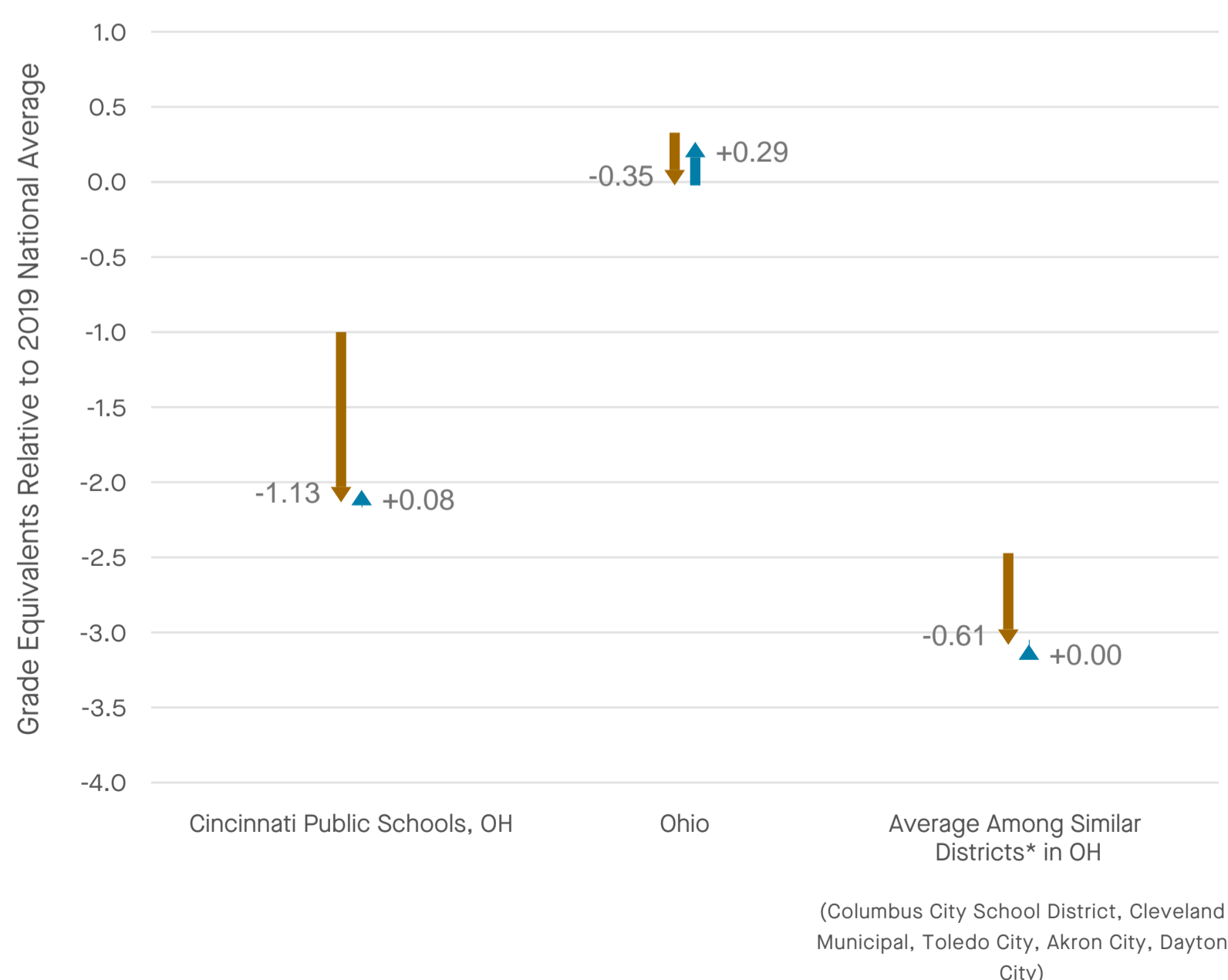

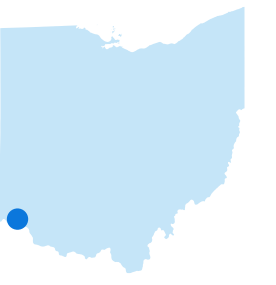

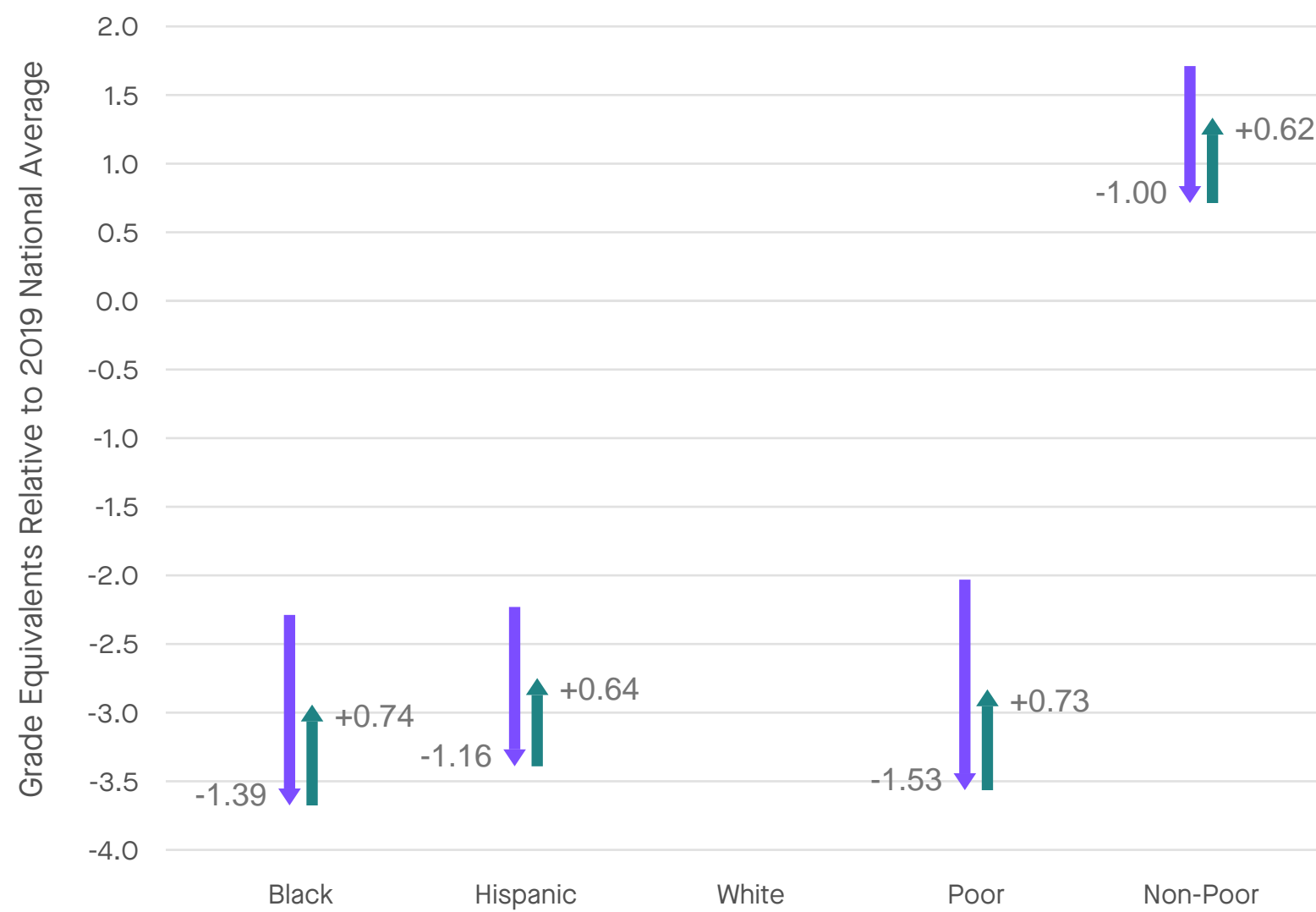

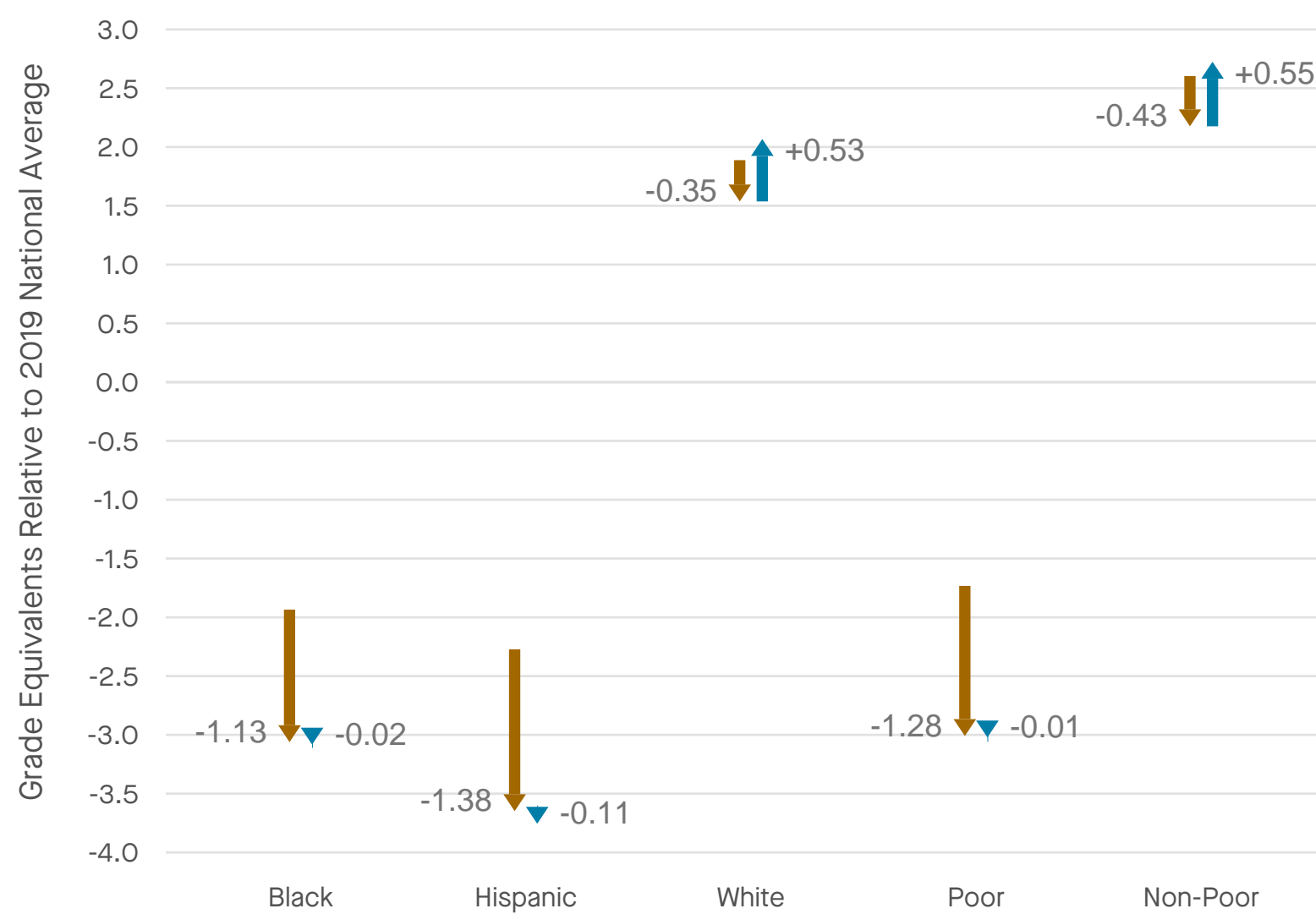
