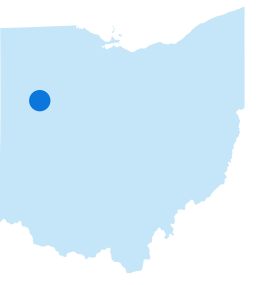
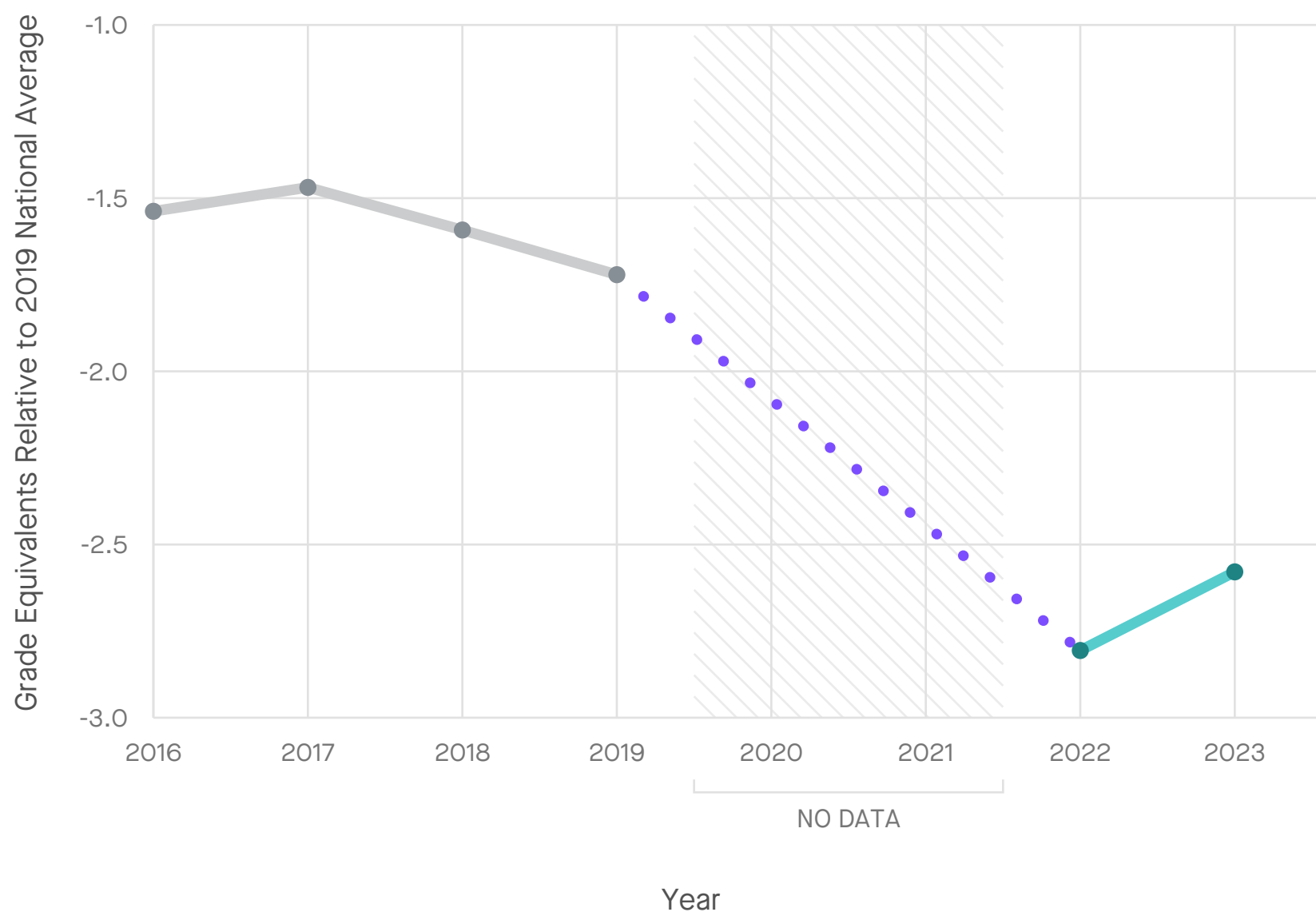

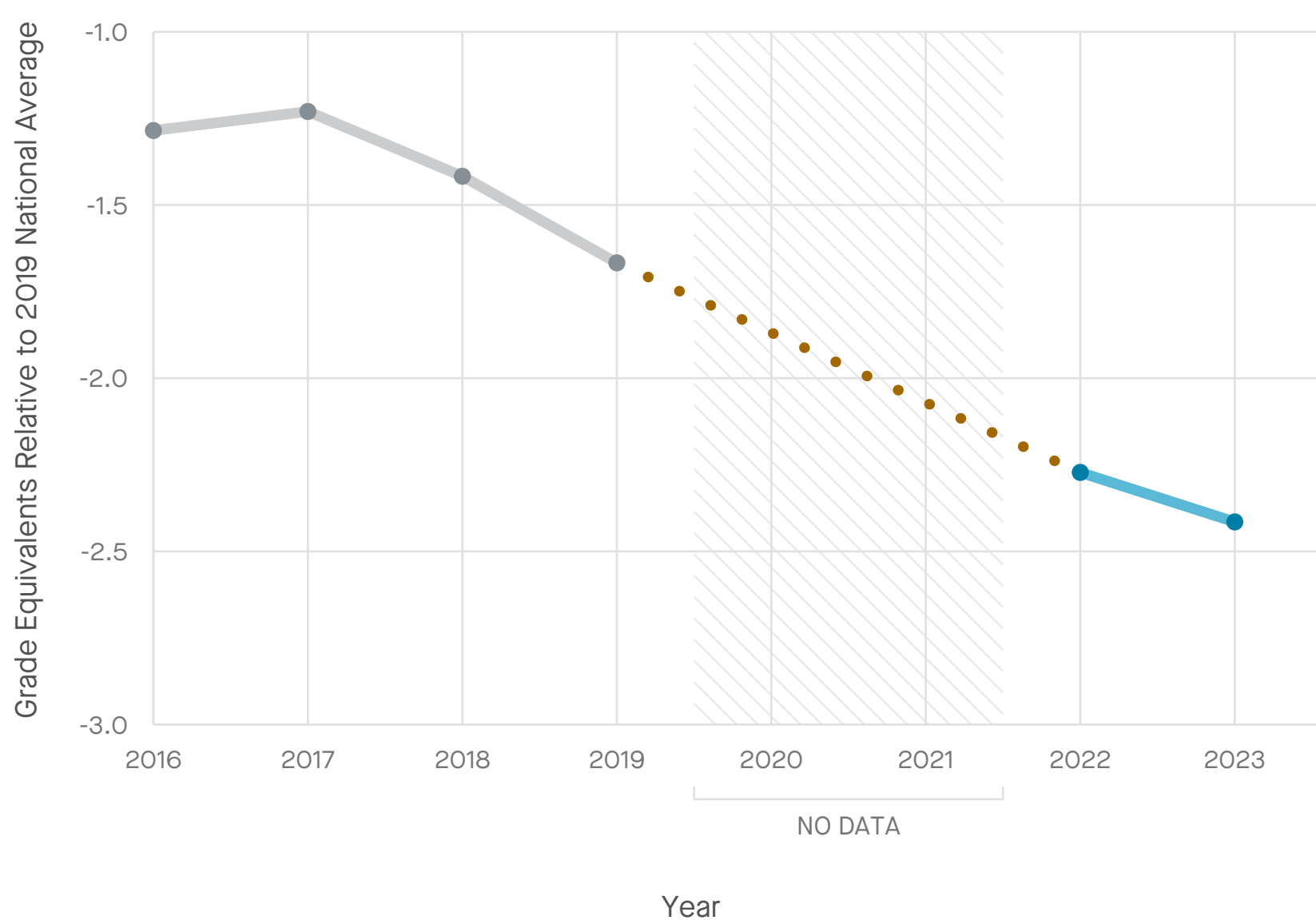

## Reading Performance, Grades 3-8, 2016-2023



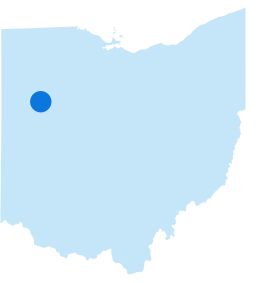

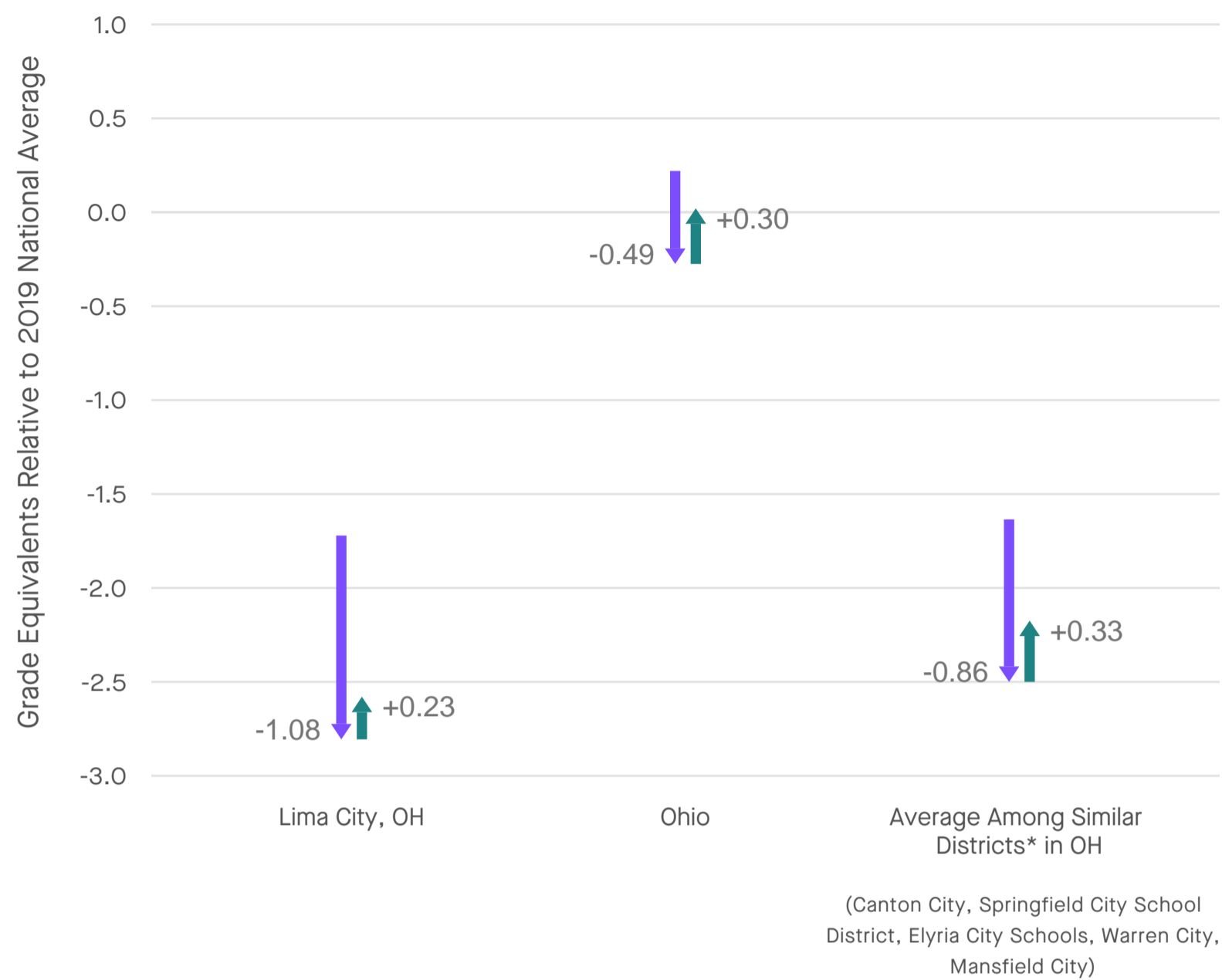

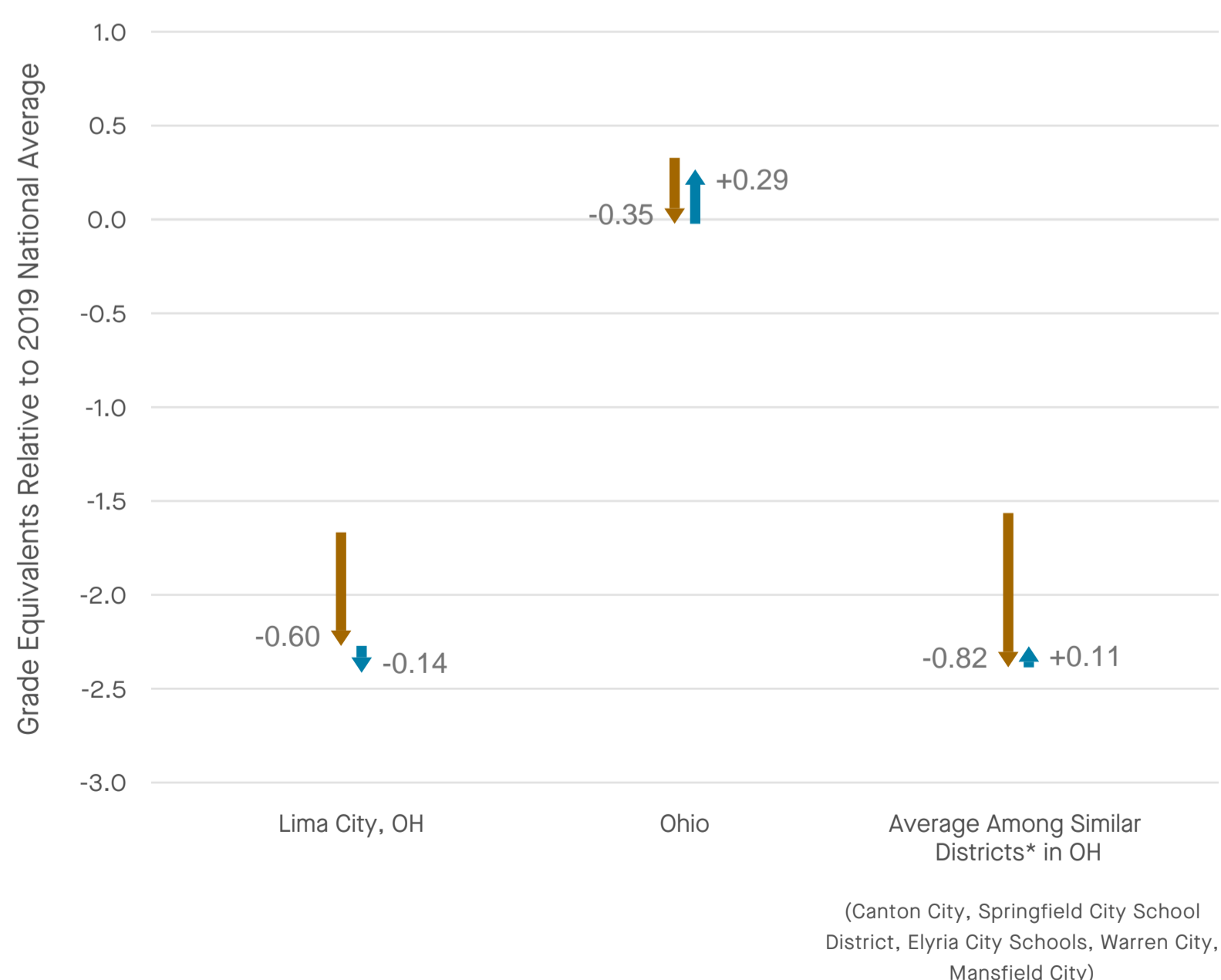

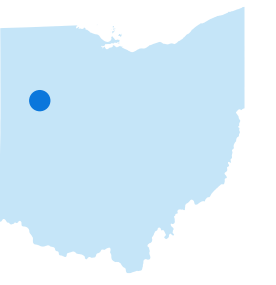

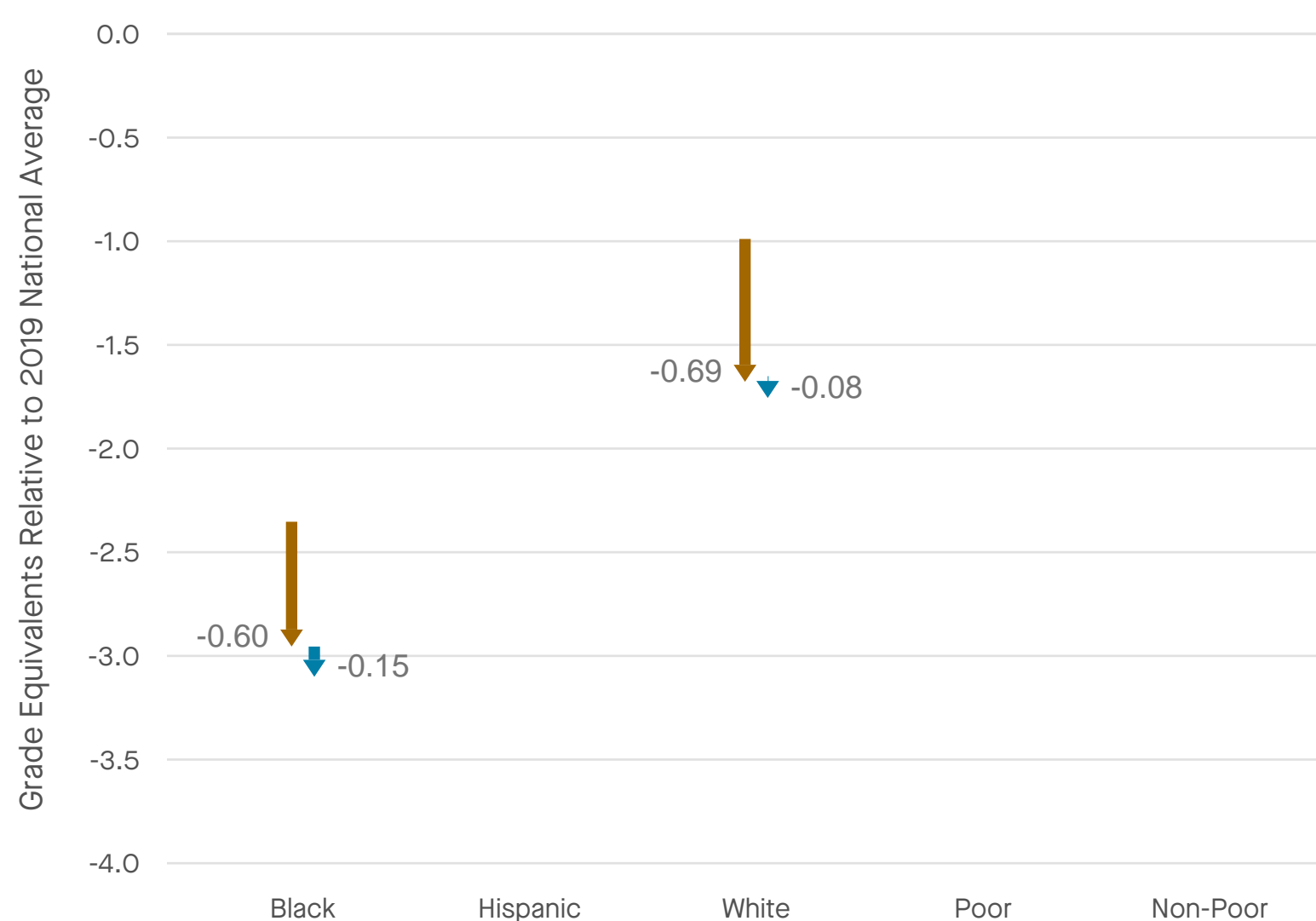
