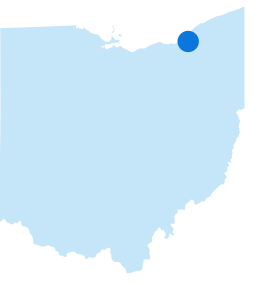
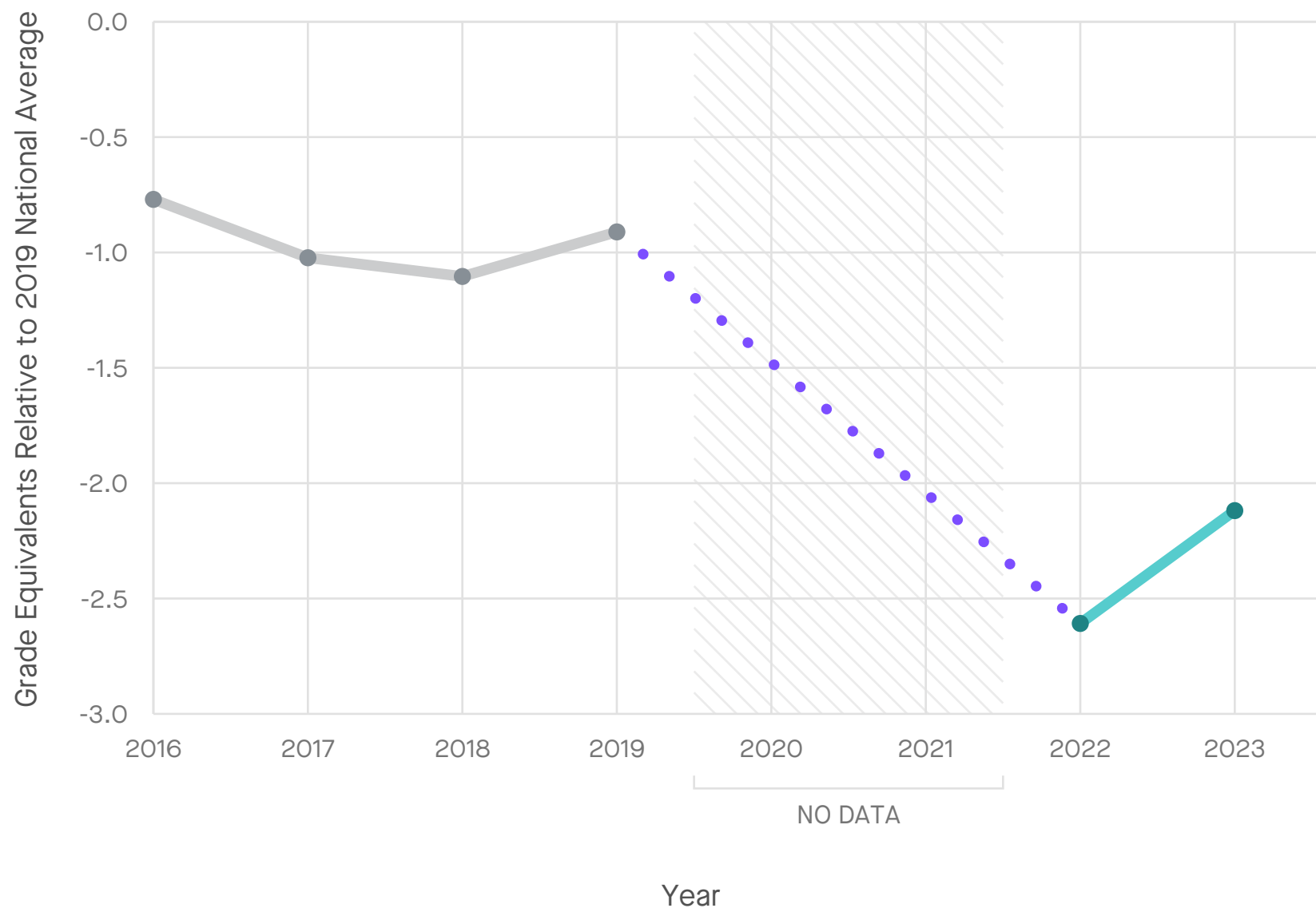

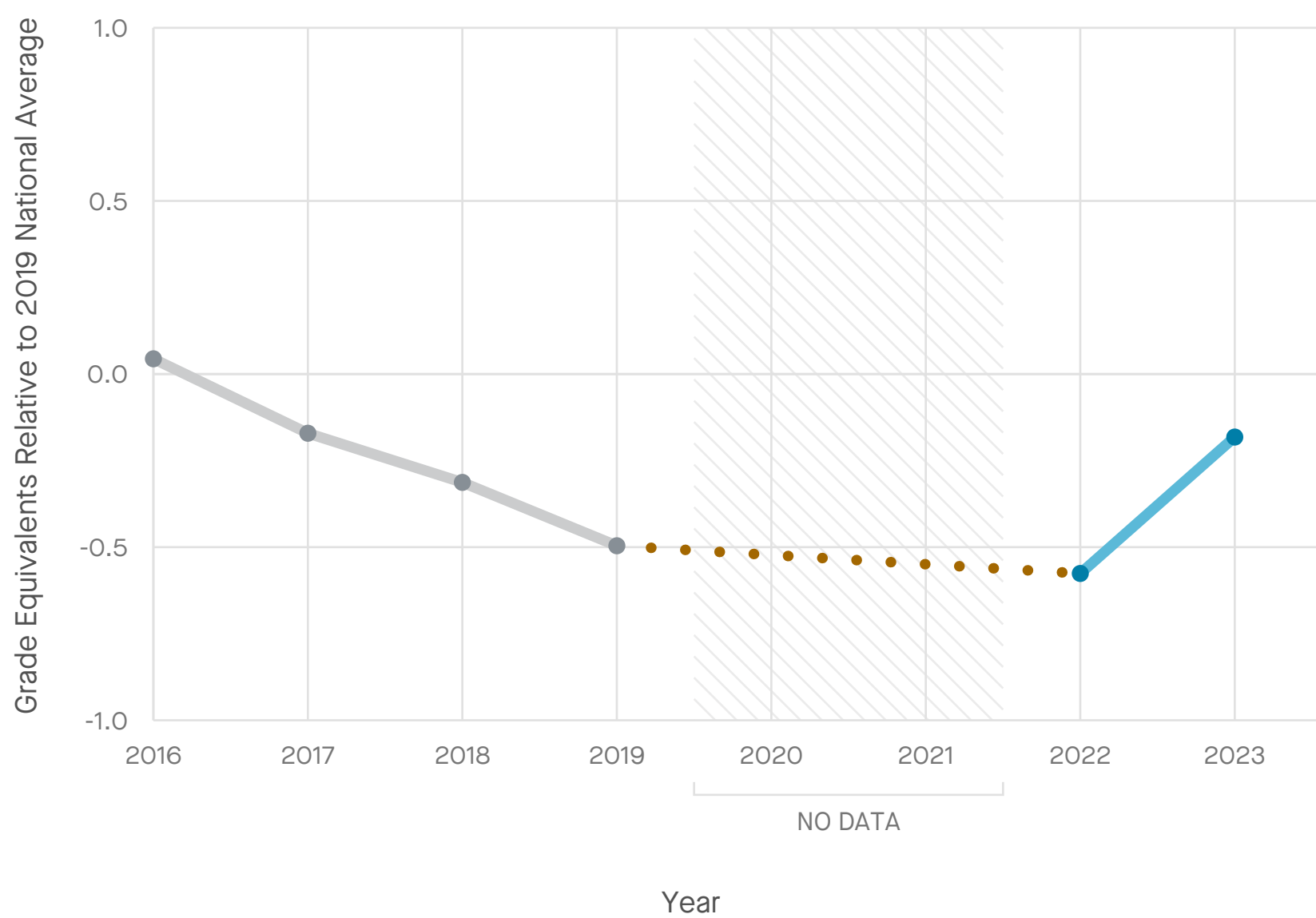

Reading Performance, Grades 3-8, 2016-2023



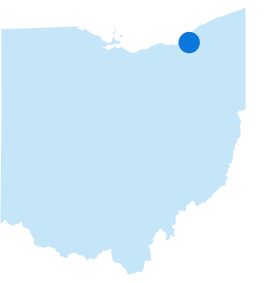

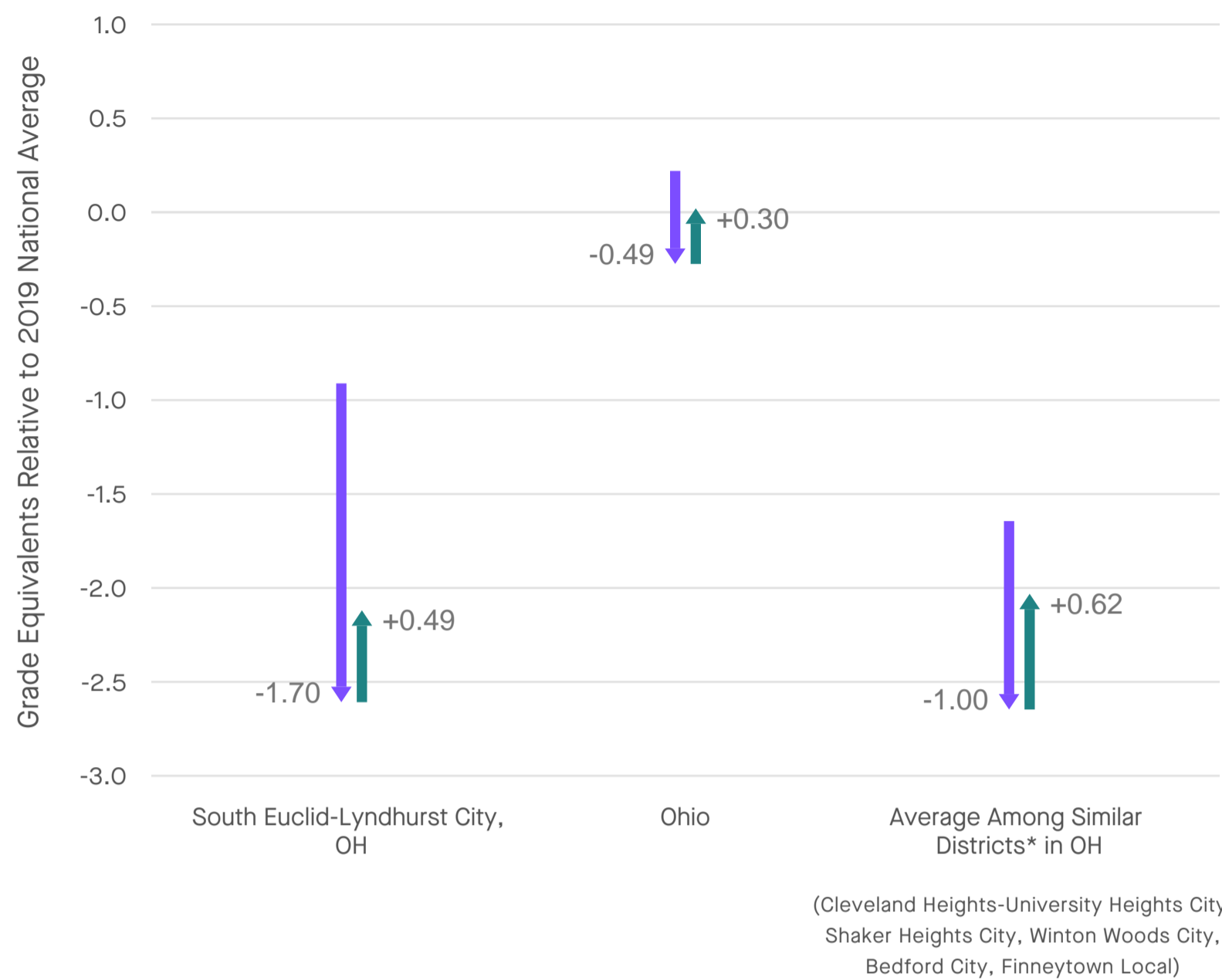

Math Performance in South Euclid-Lyndhurst City vs. Ohio and Similar Districts, Grades 3-8, 2019-2023



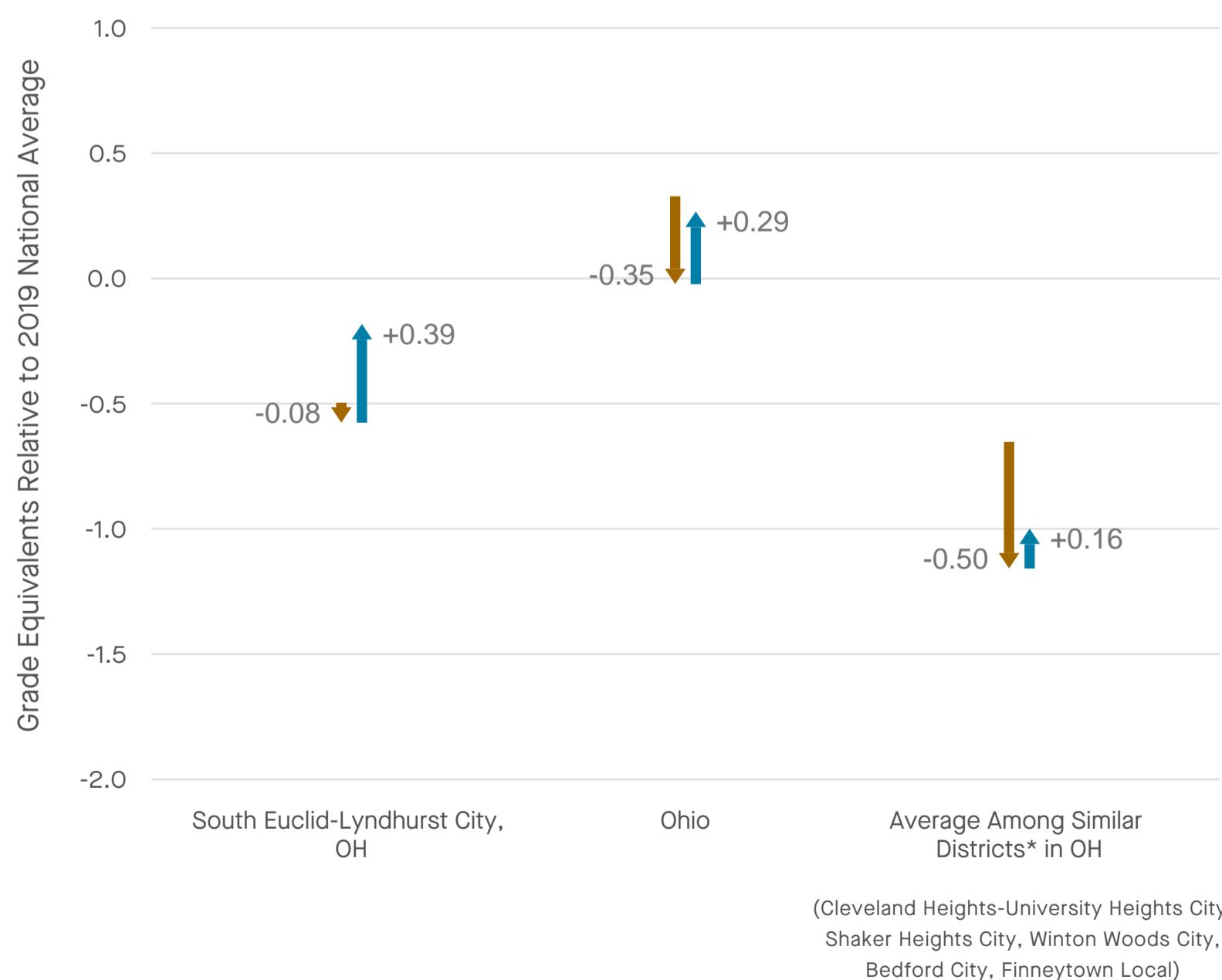

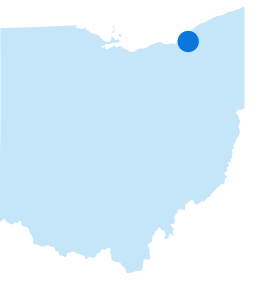

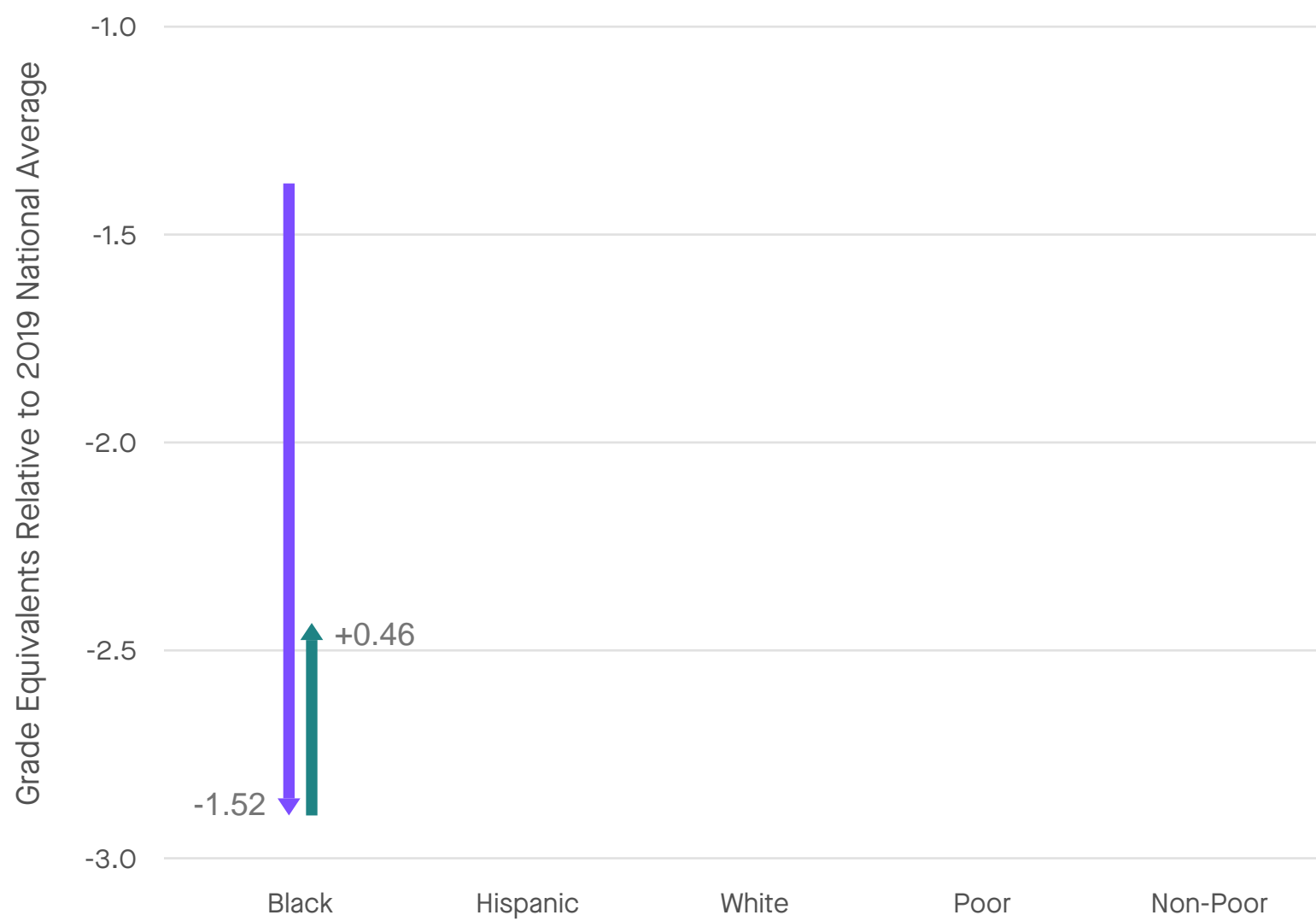

Math Performance by Subgroup, Grades 3-8, 2019-2023

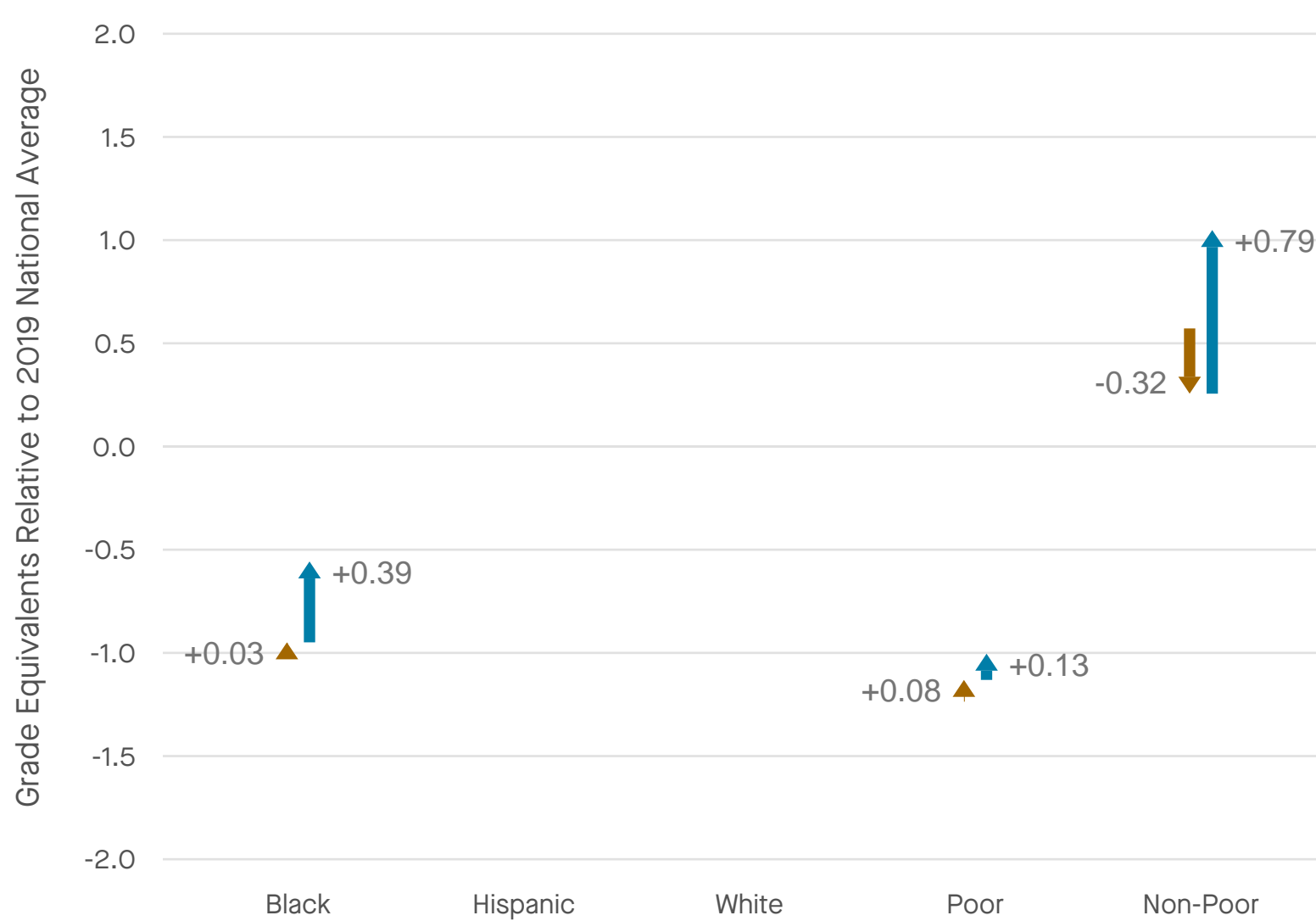

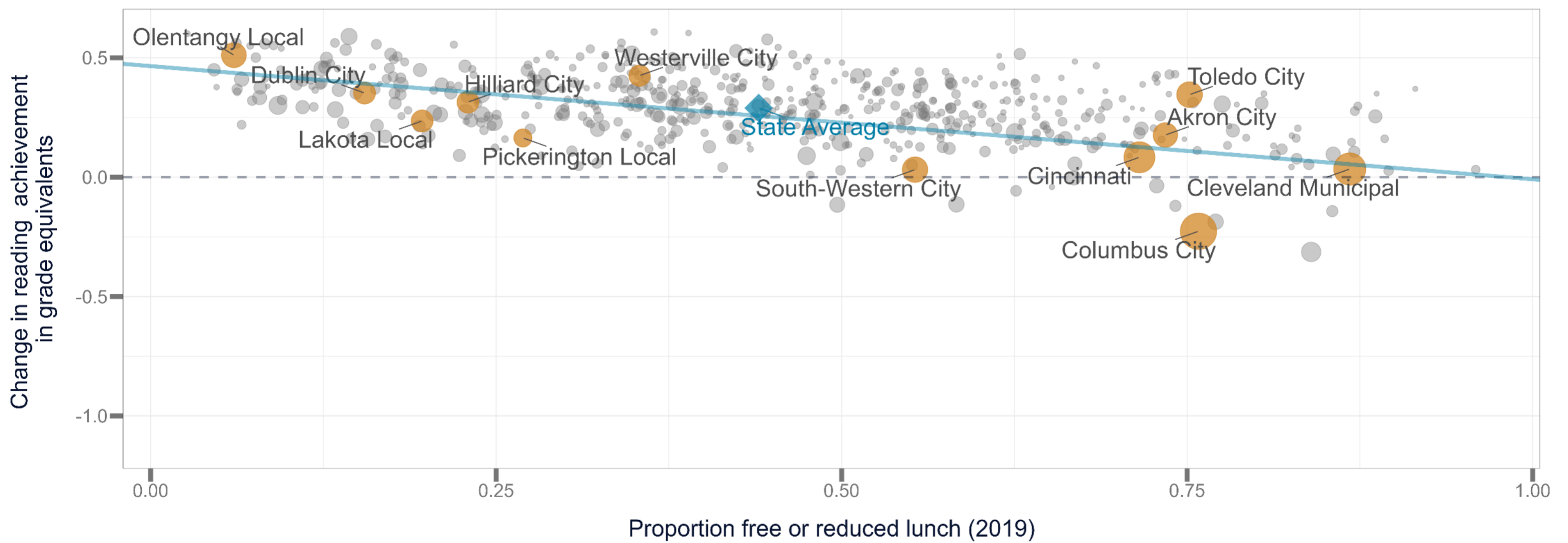
