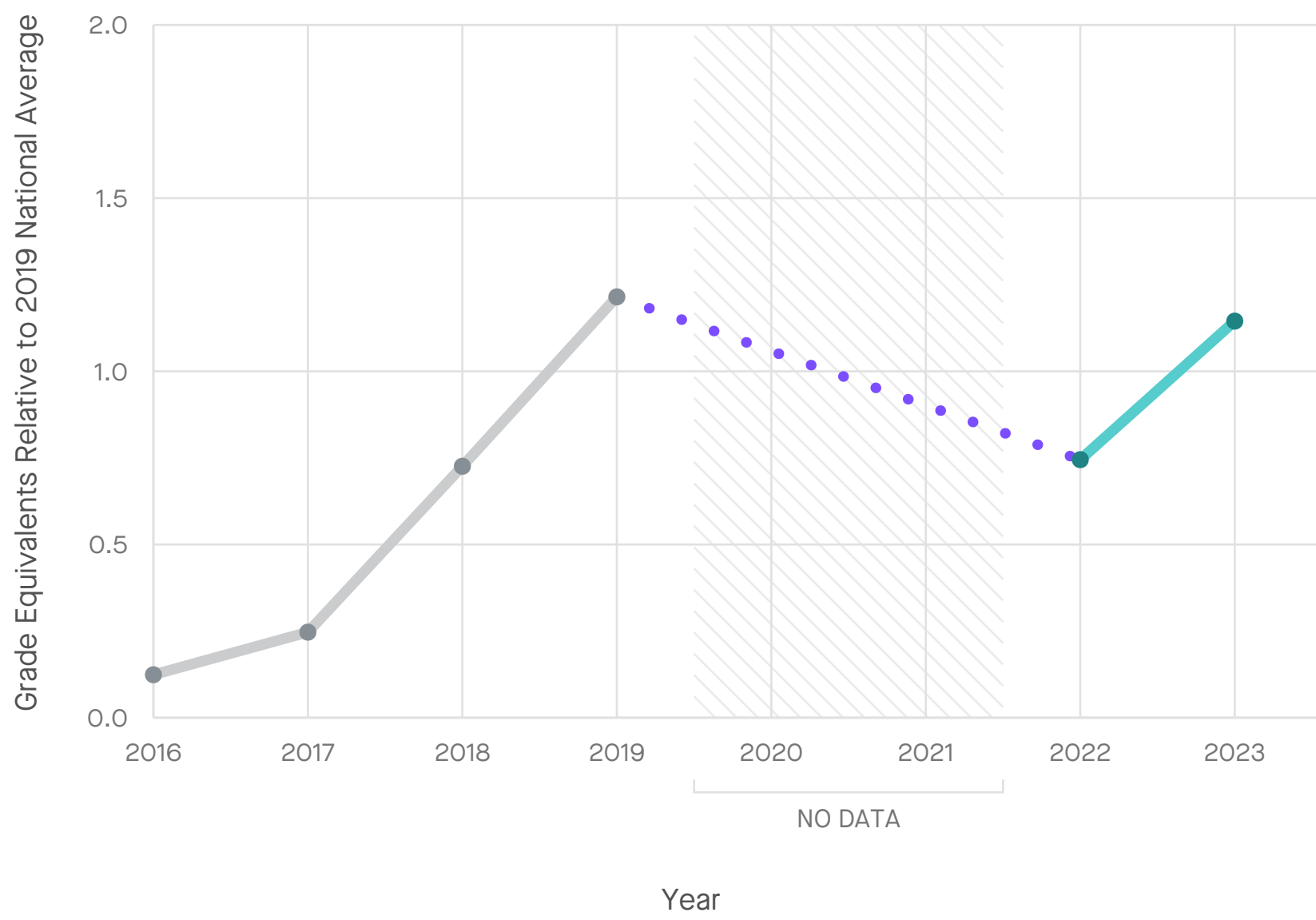

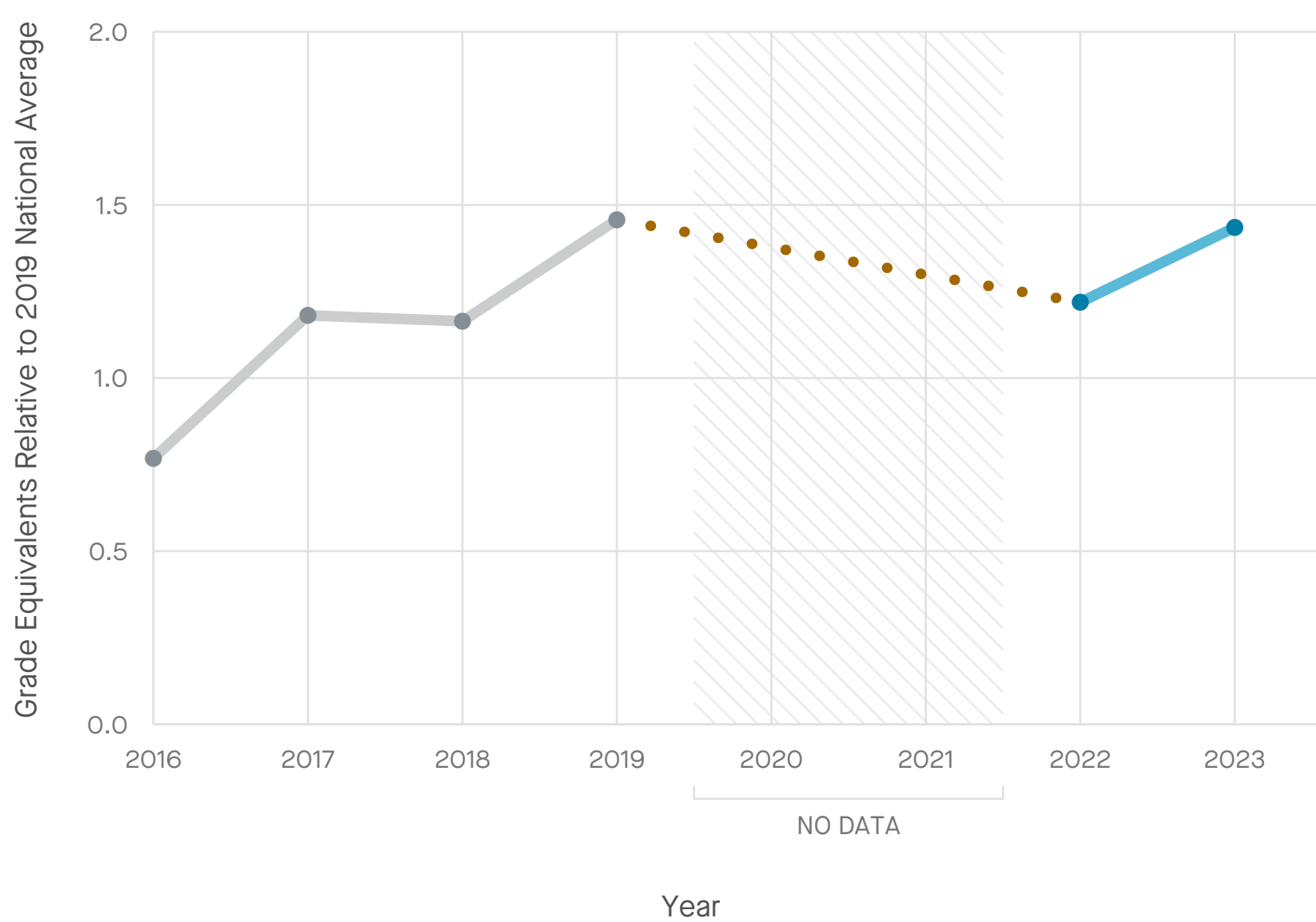

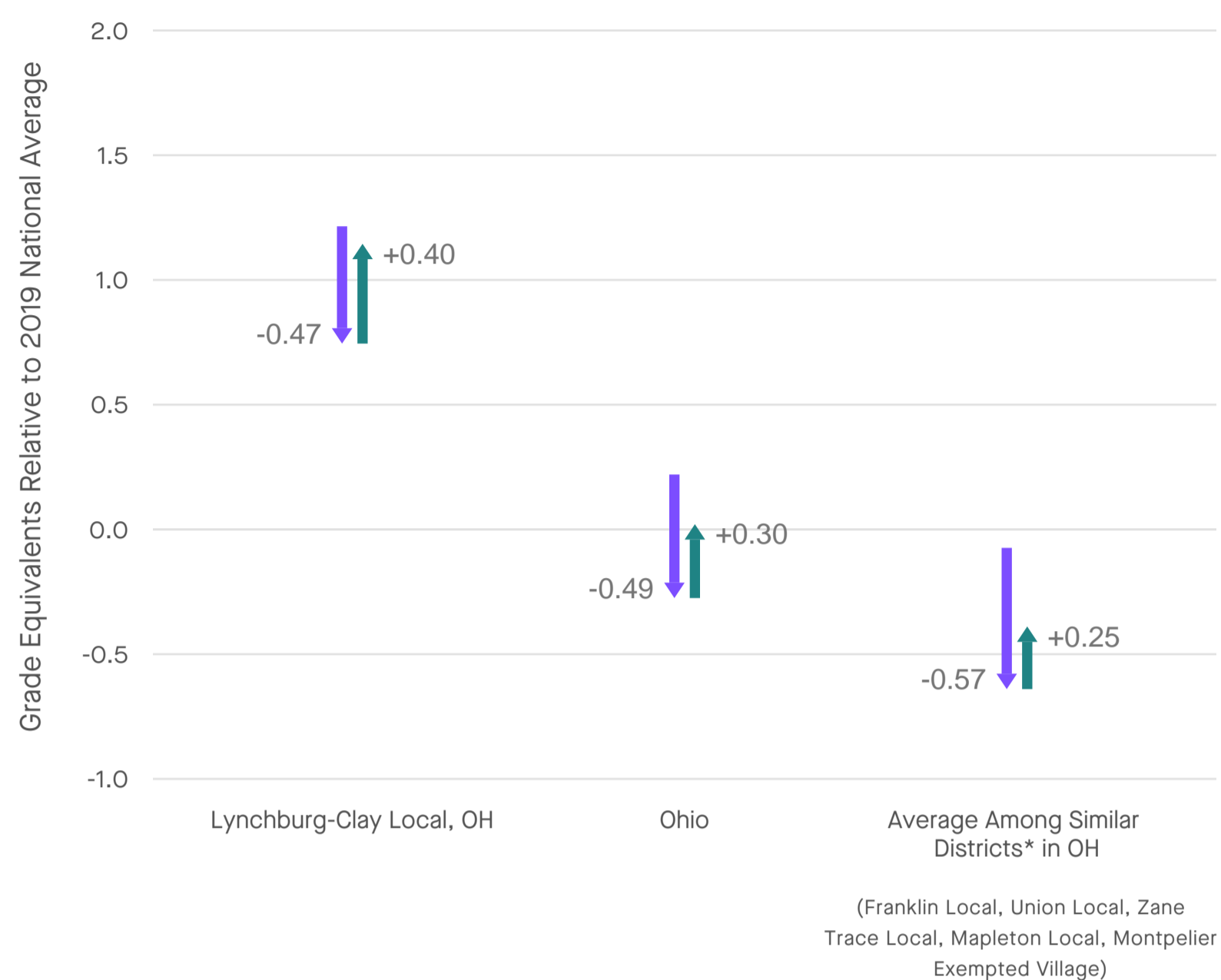

Math Performance in Lynchburg-Clay Local vs. Ohio and Similar Districts, Grades 3-8, 2019-2023



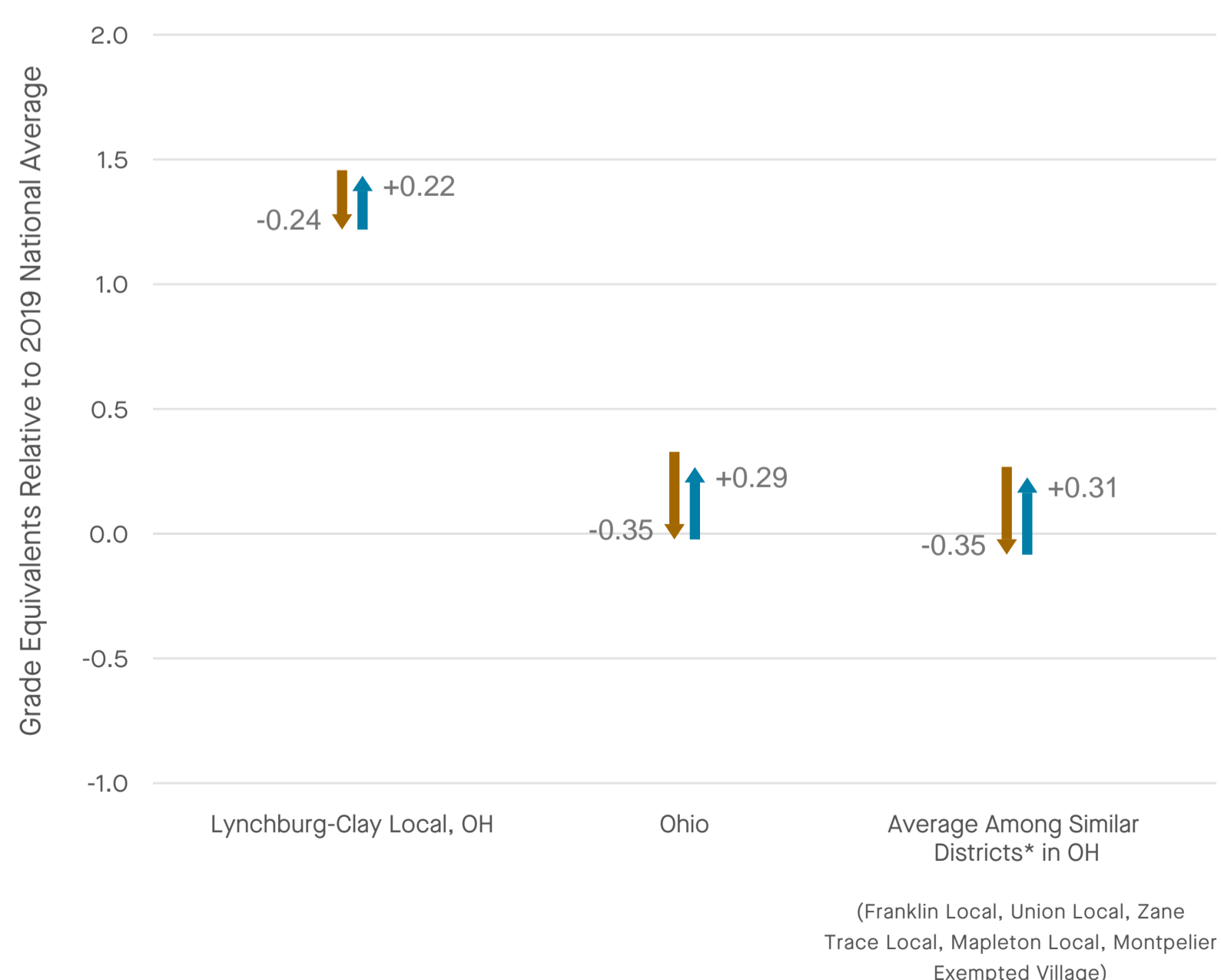

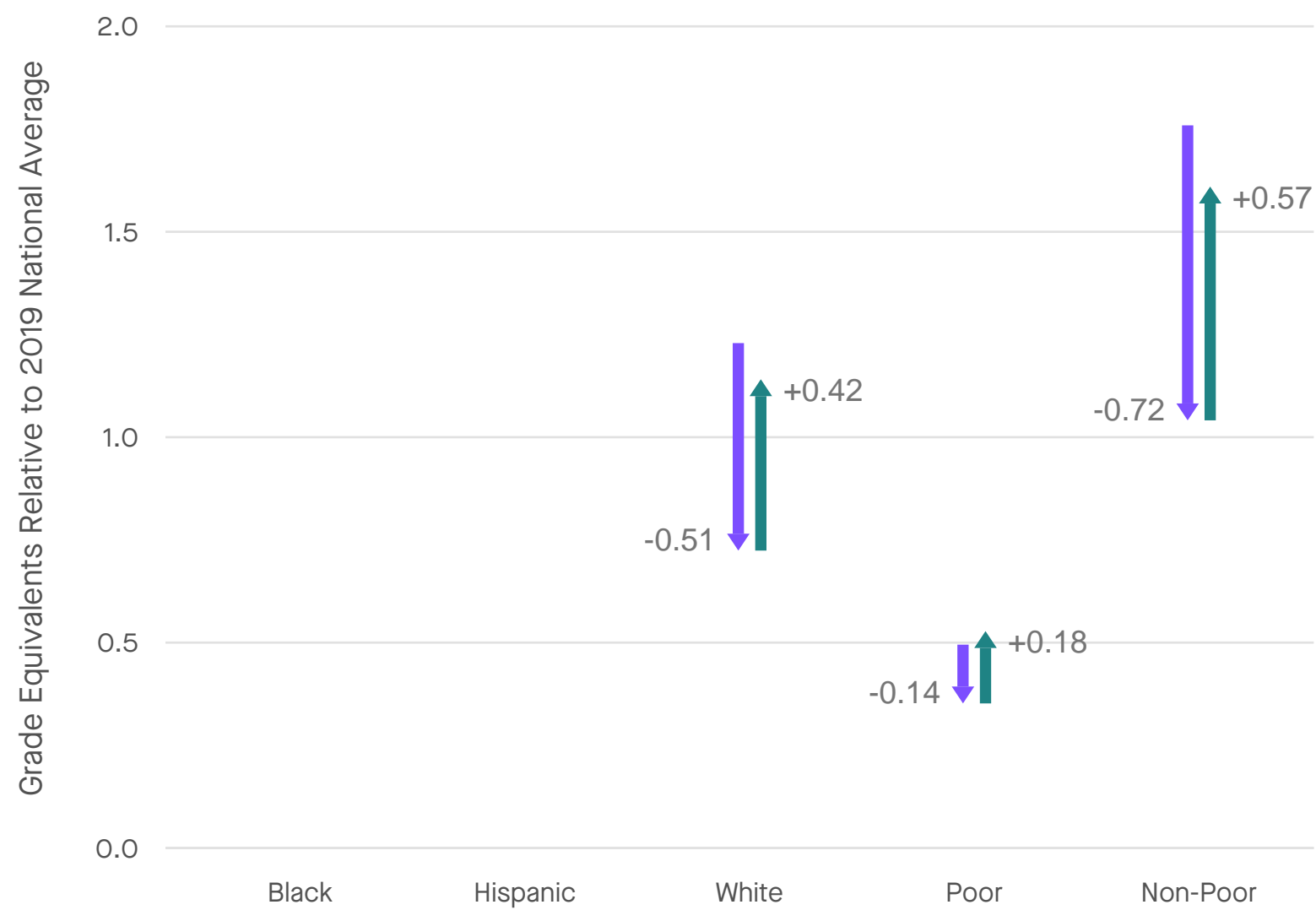

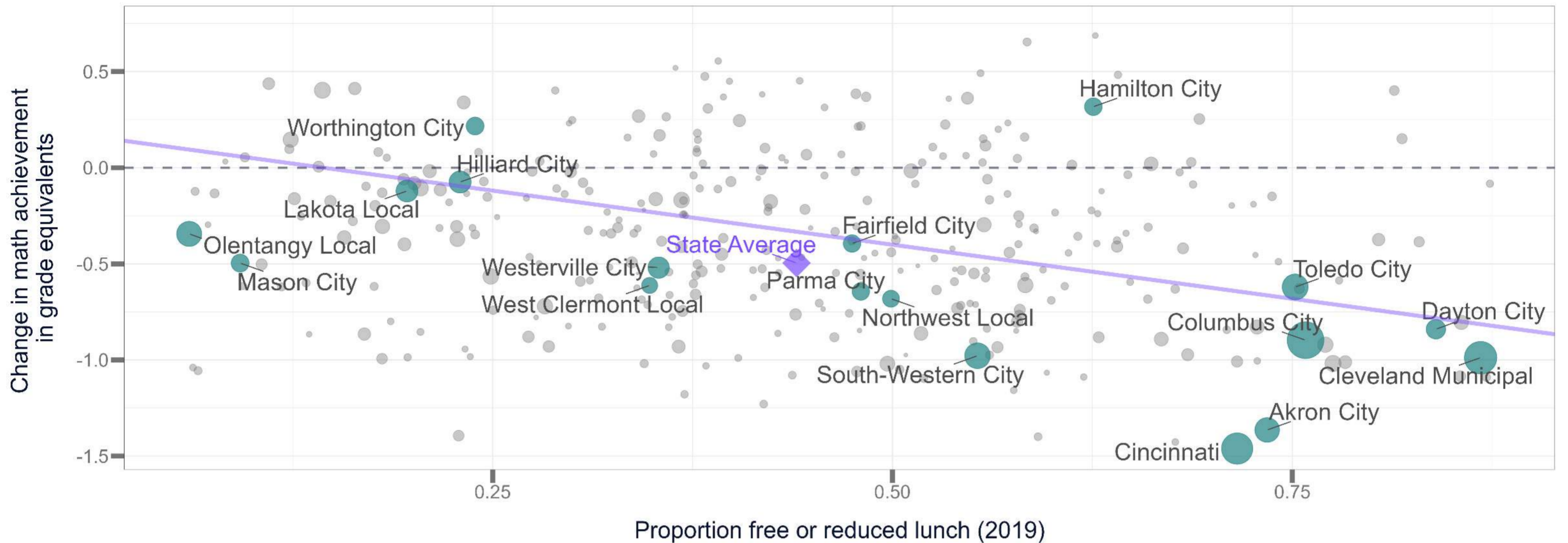

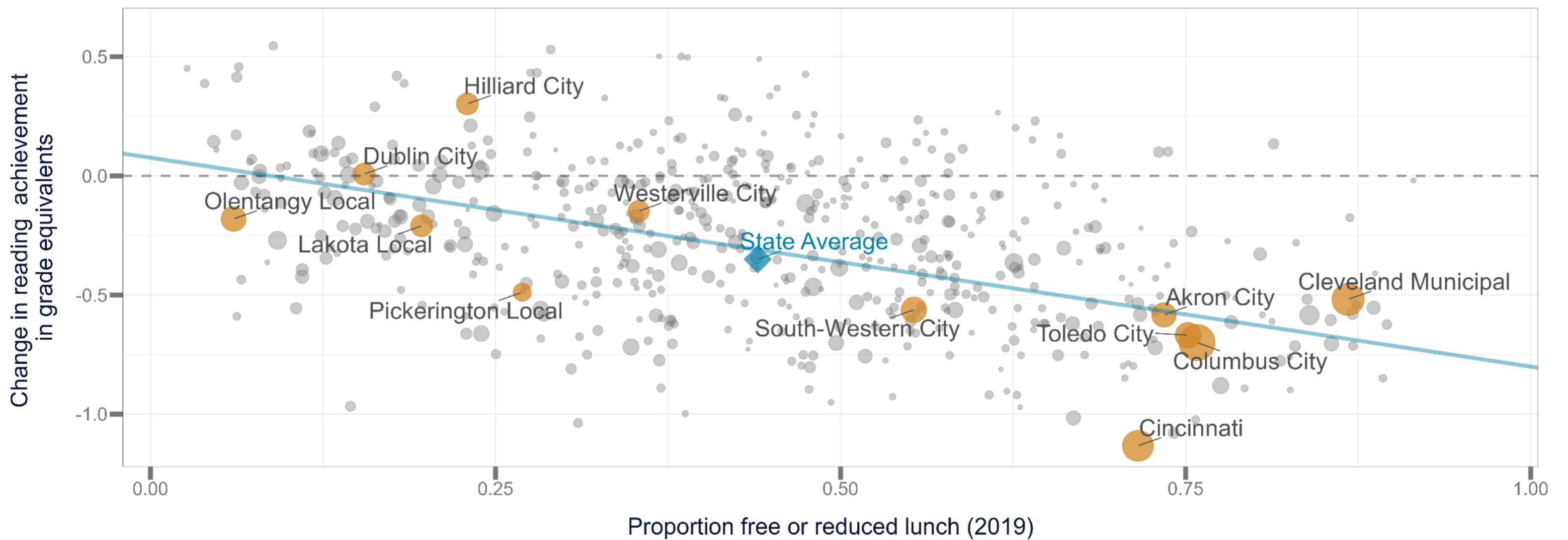
Change in Math Achievement 2019-2022 by proportion FRPL in Ohio districts

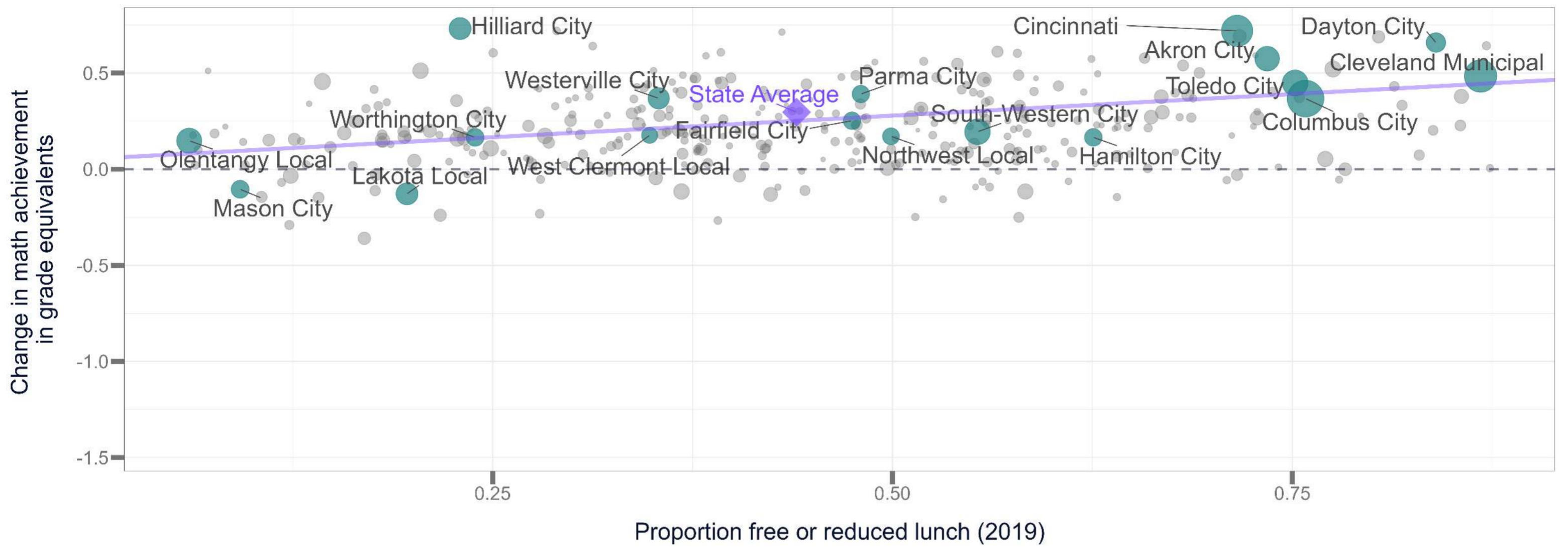
Change in Reading Achievement 2019-2022 by proportion FRPL in Ohio districts

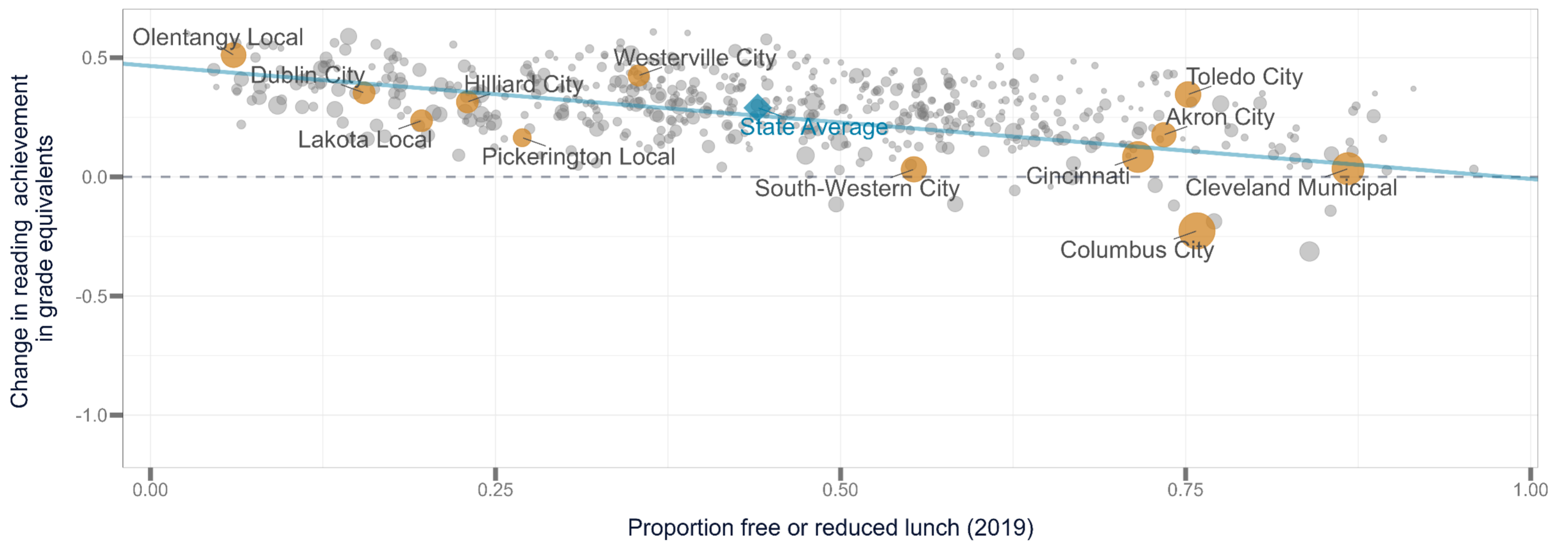

Change in Math Achievement 2022-2023 by proportion FRPL in Ohio districts



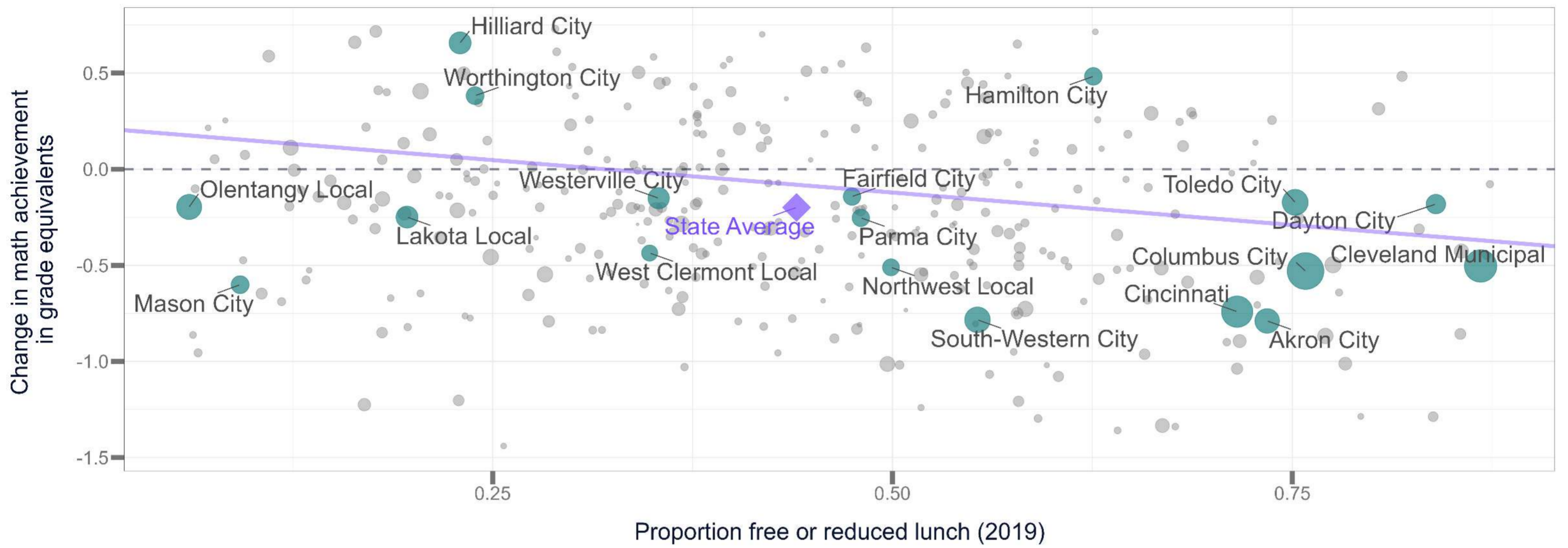

Change in Reading Achievement 2022-2023 by proportion FRPL in Ohio districts



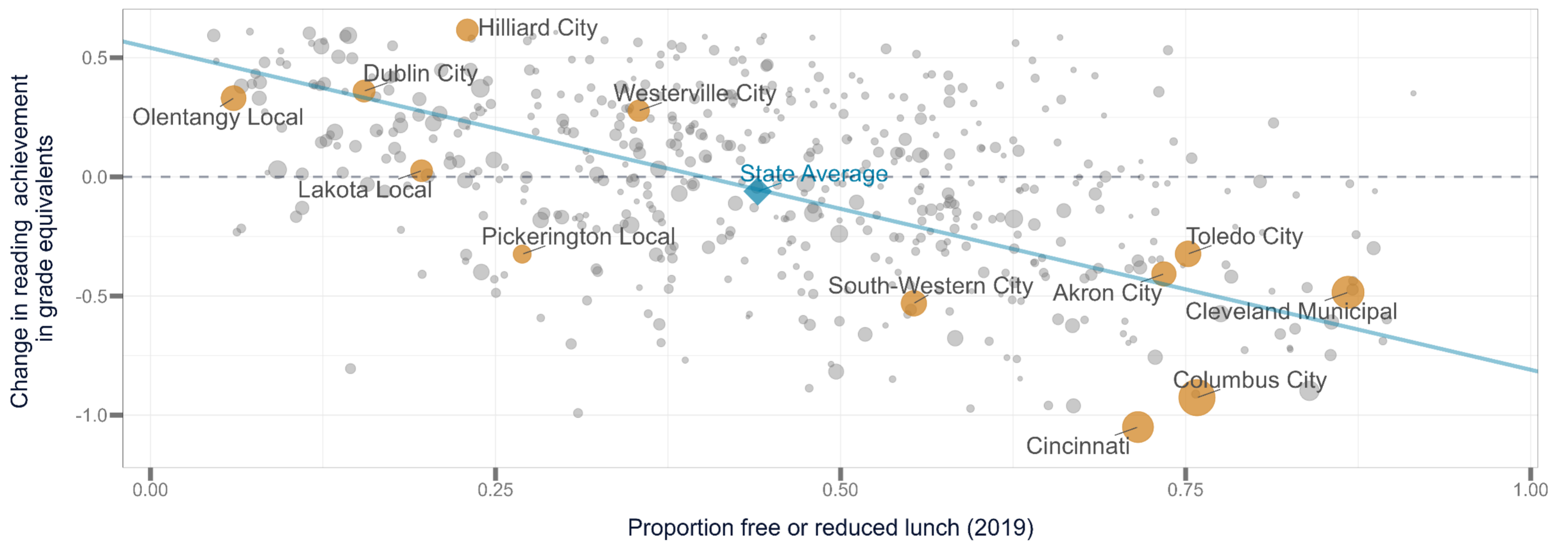

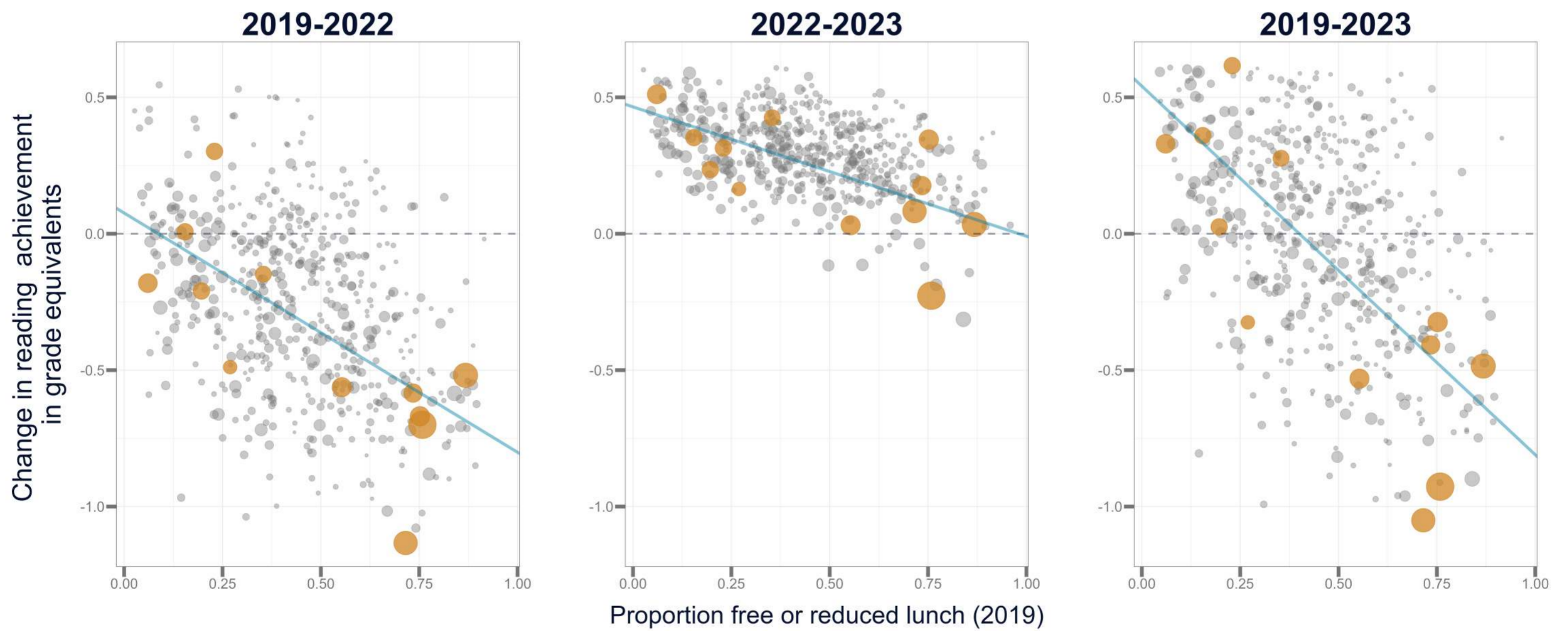

Change in Math Achievement by proportion FRPL in Ohio districts



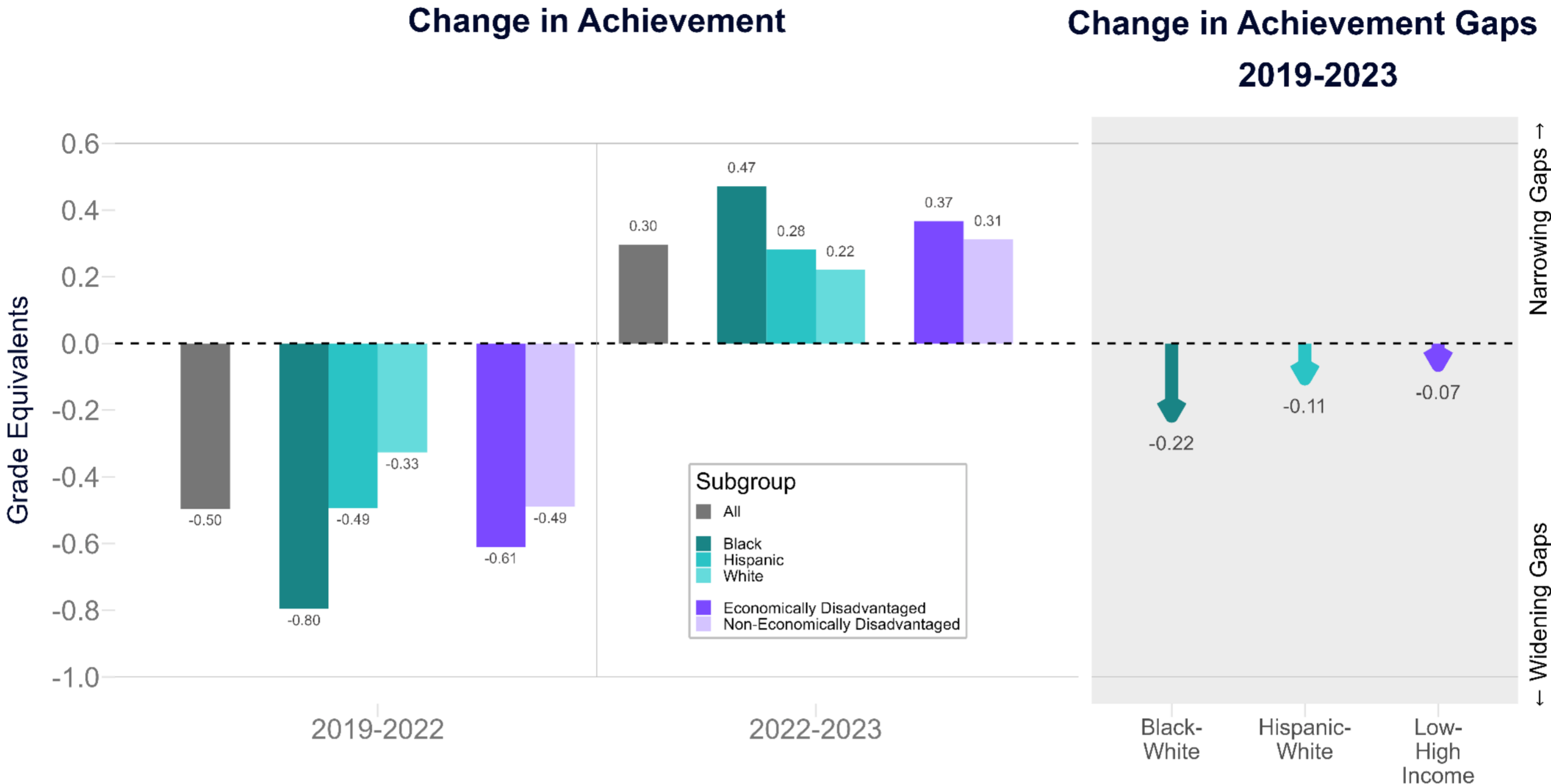

Change in Reading Achievement by proportion FRPL in Ohio districts



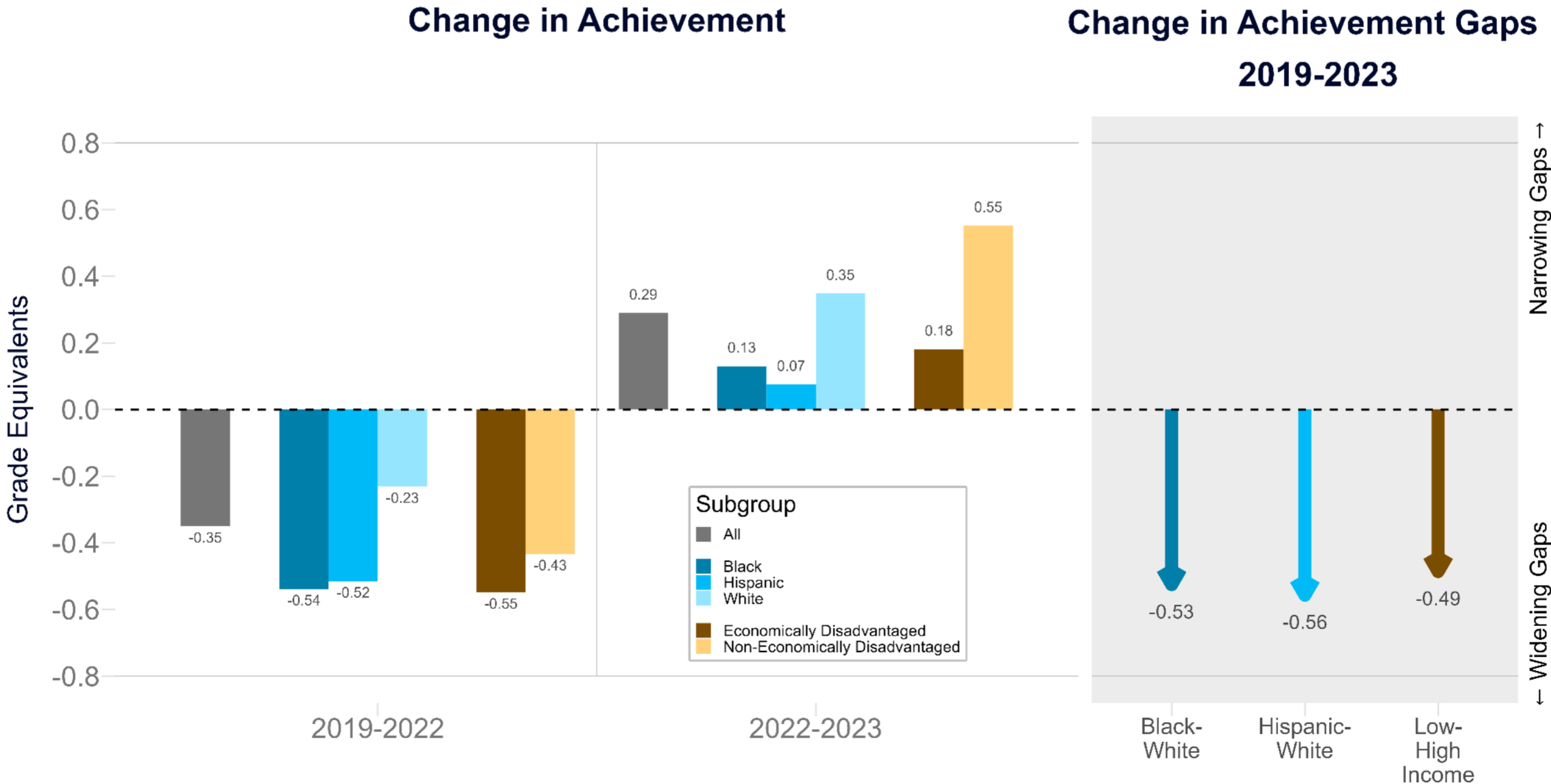
