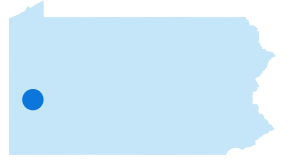
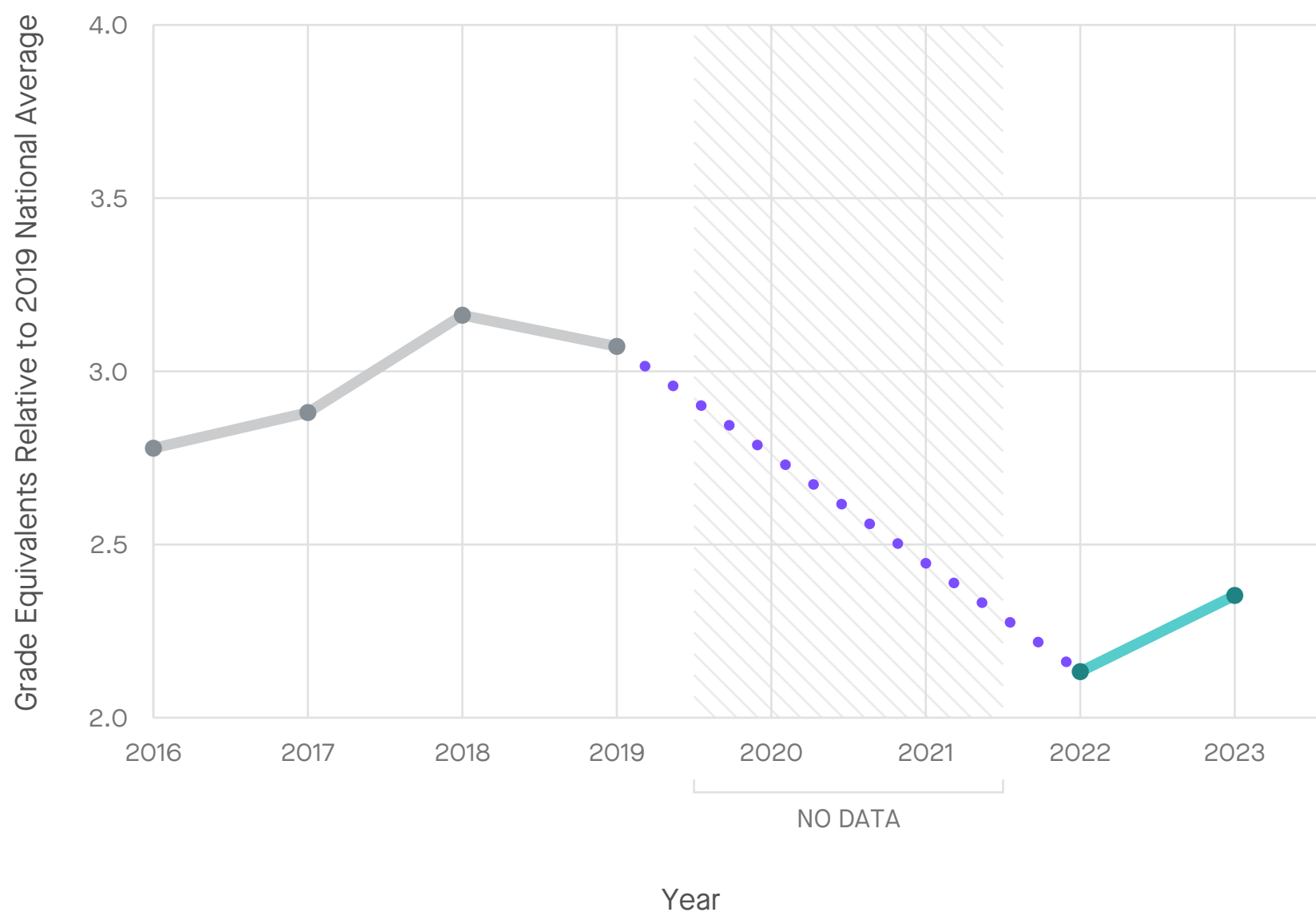

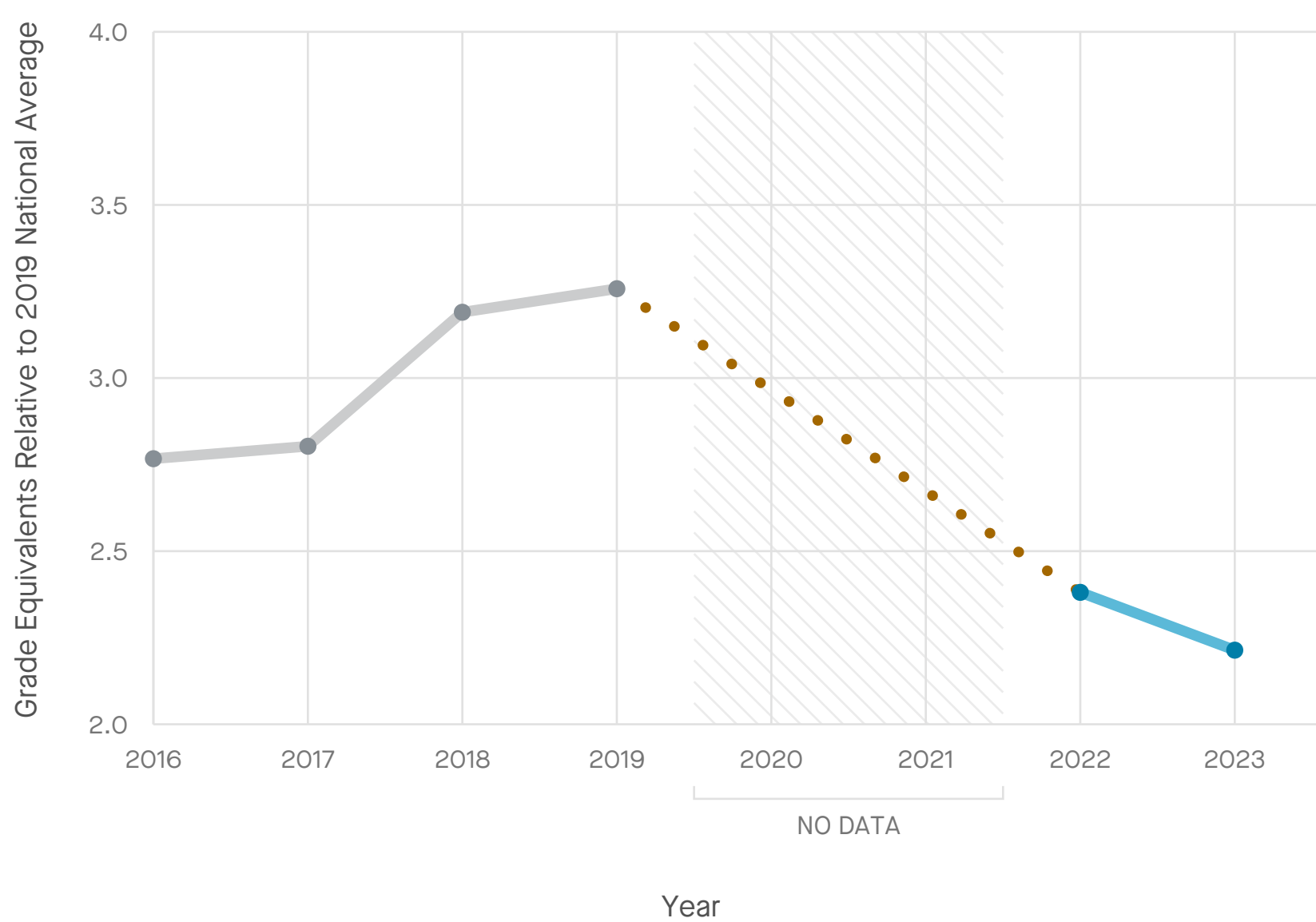

Reading Performance, Grades 3-8, 2016-2023



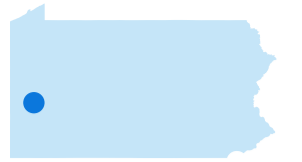

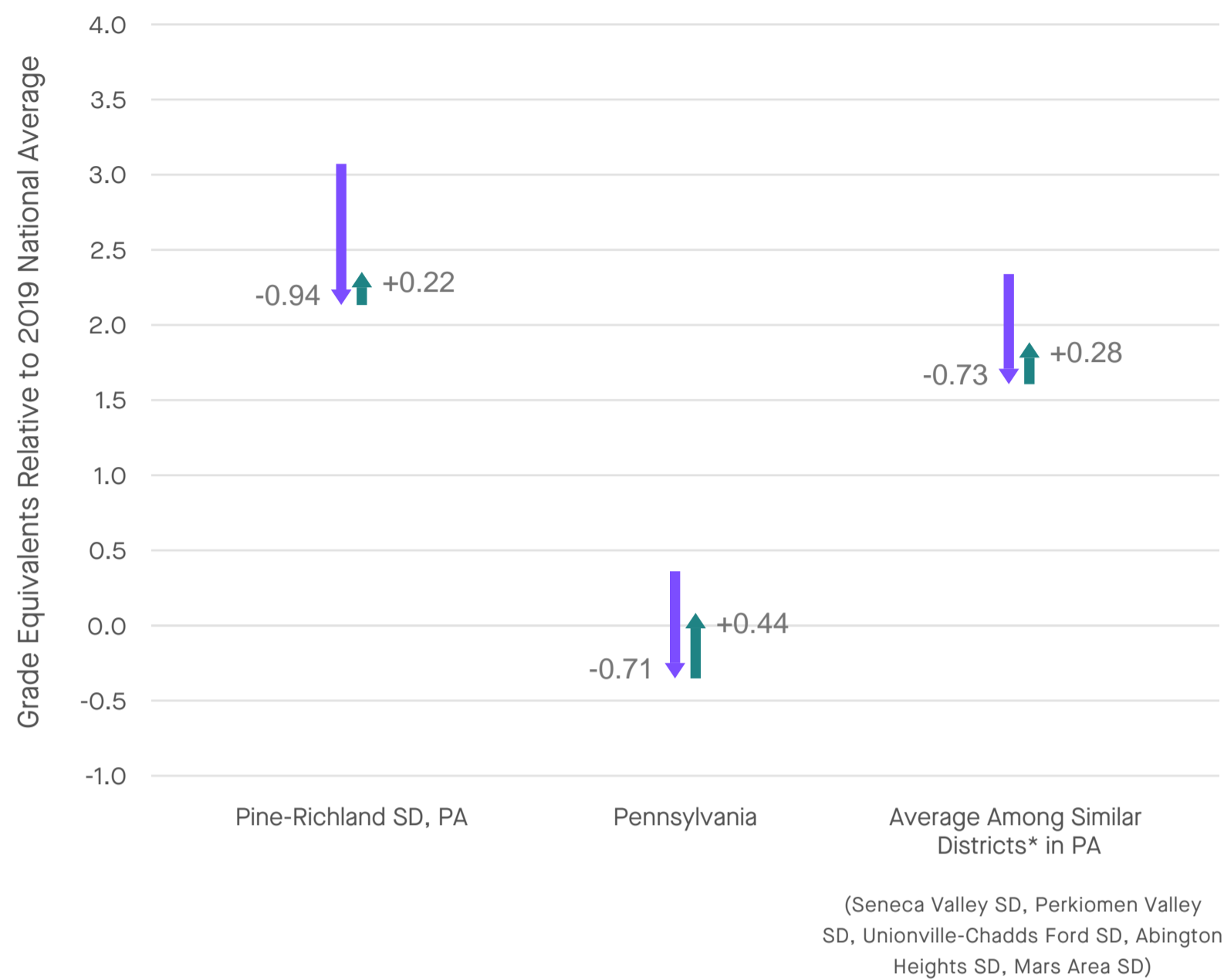

Math Performance in Pine-Richland SD vs. Pennsylvania and Similar Districts, Grades 3-8, 2019-2023



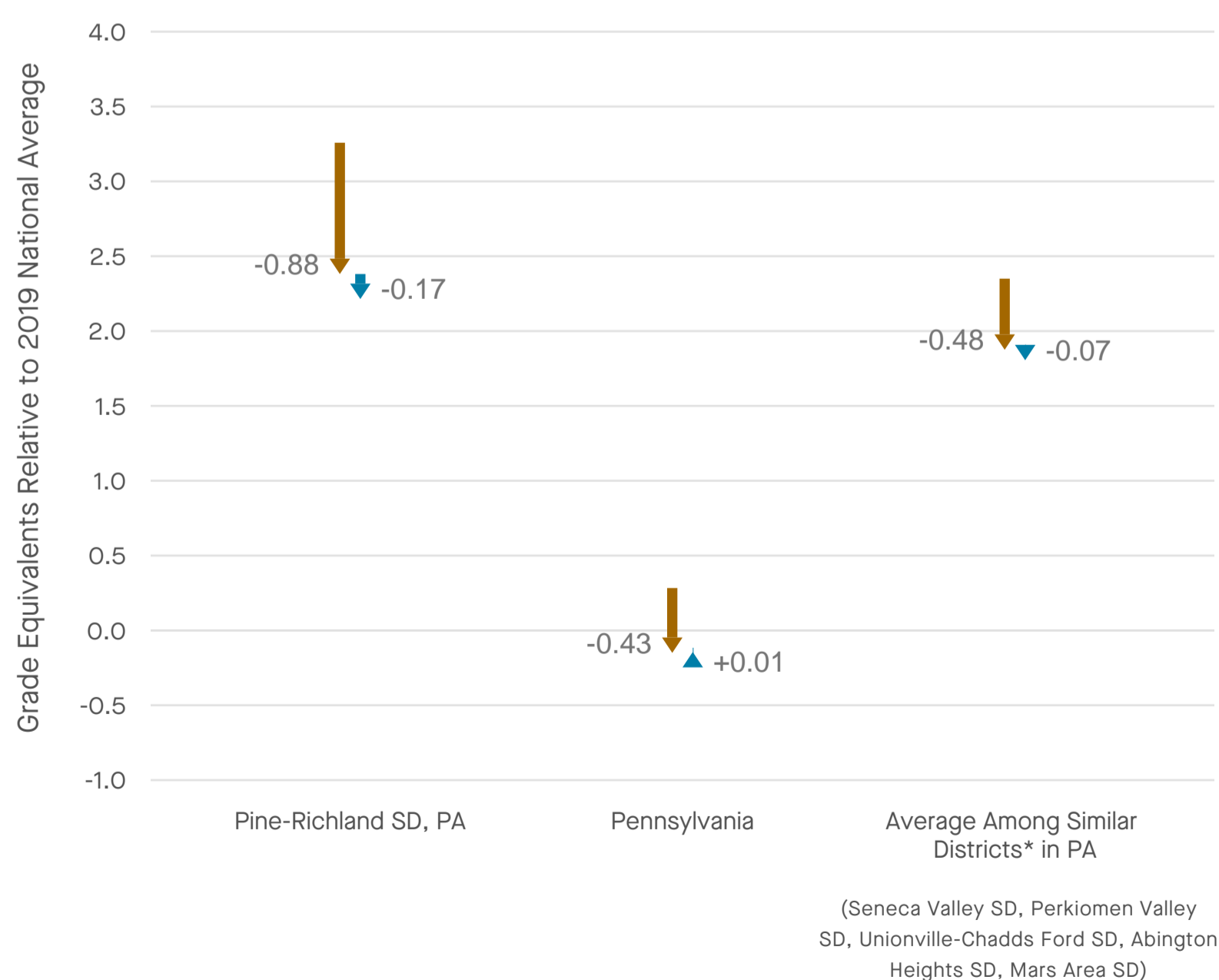
