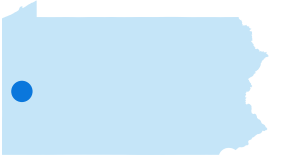
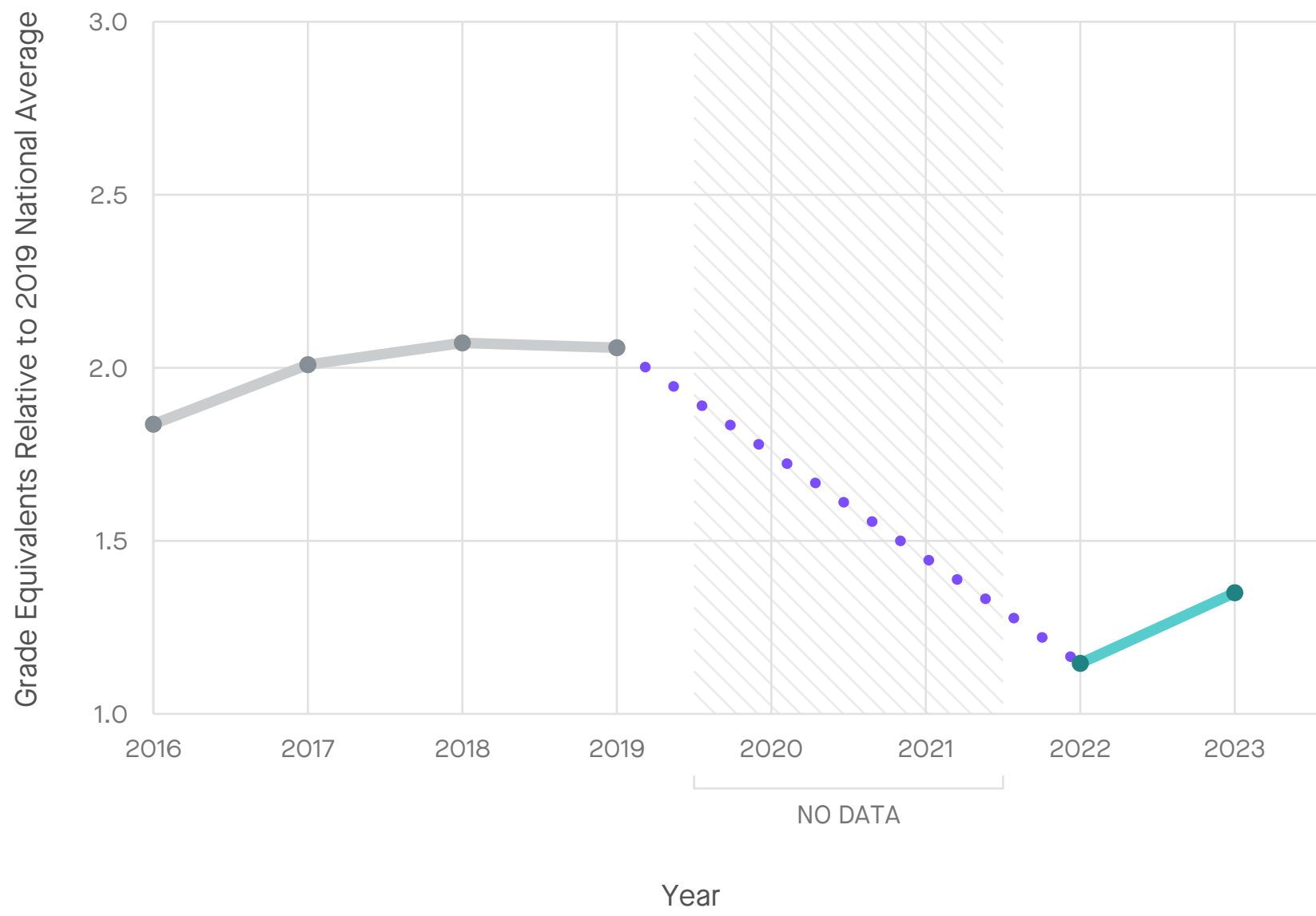

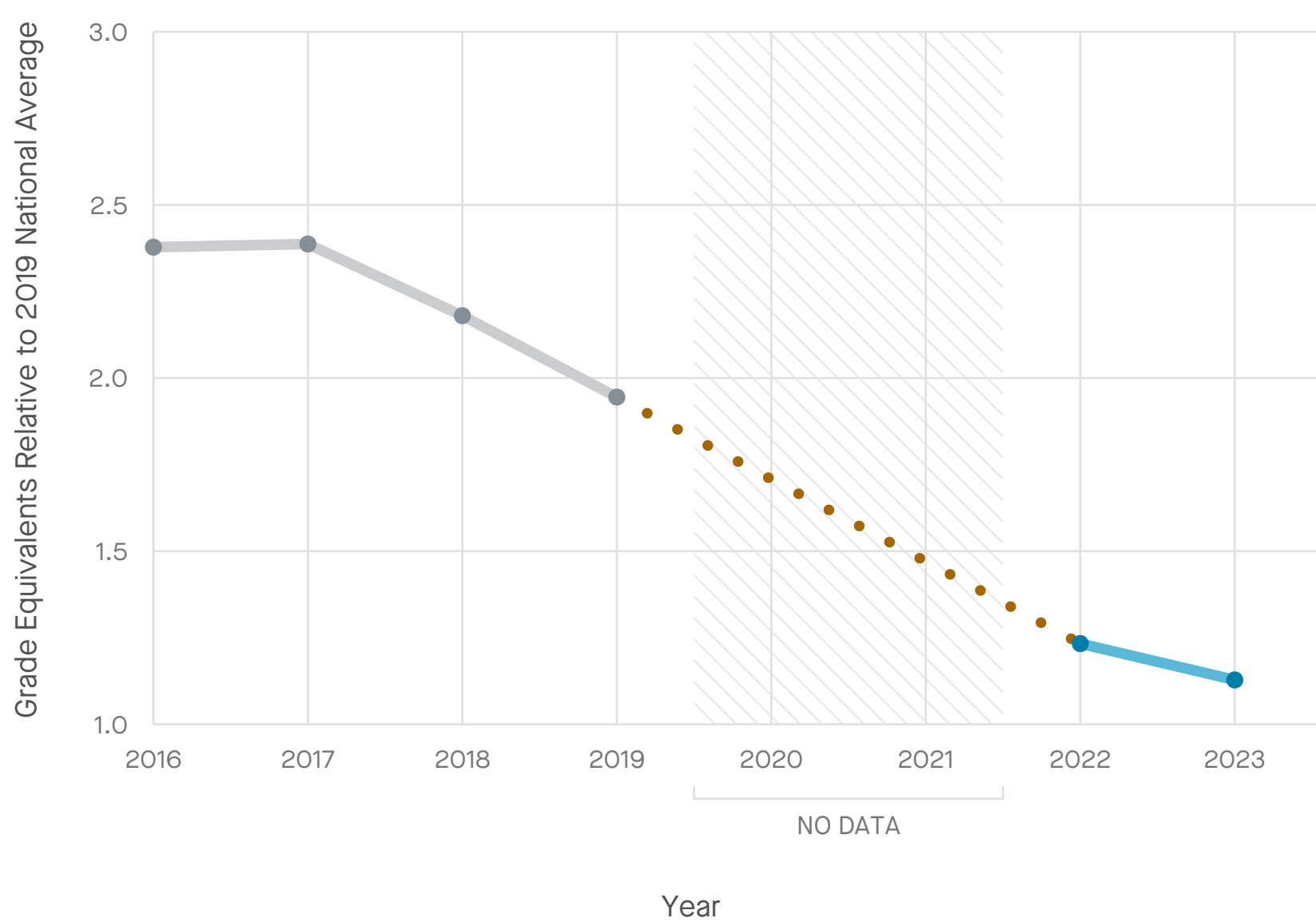

Reading Performance, Grades 3-8, 2016-2023



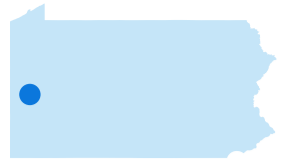

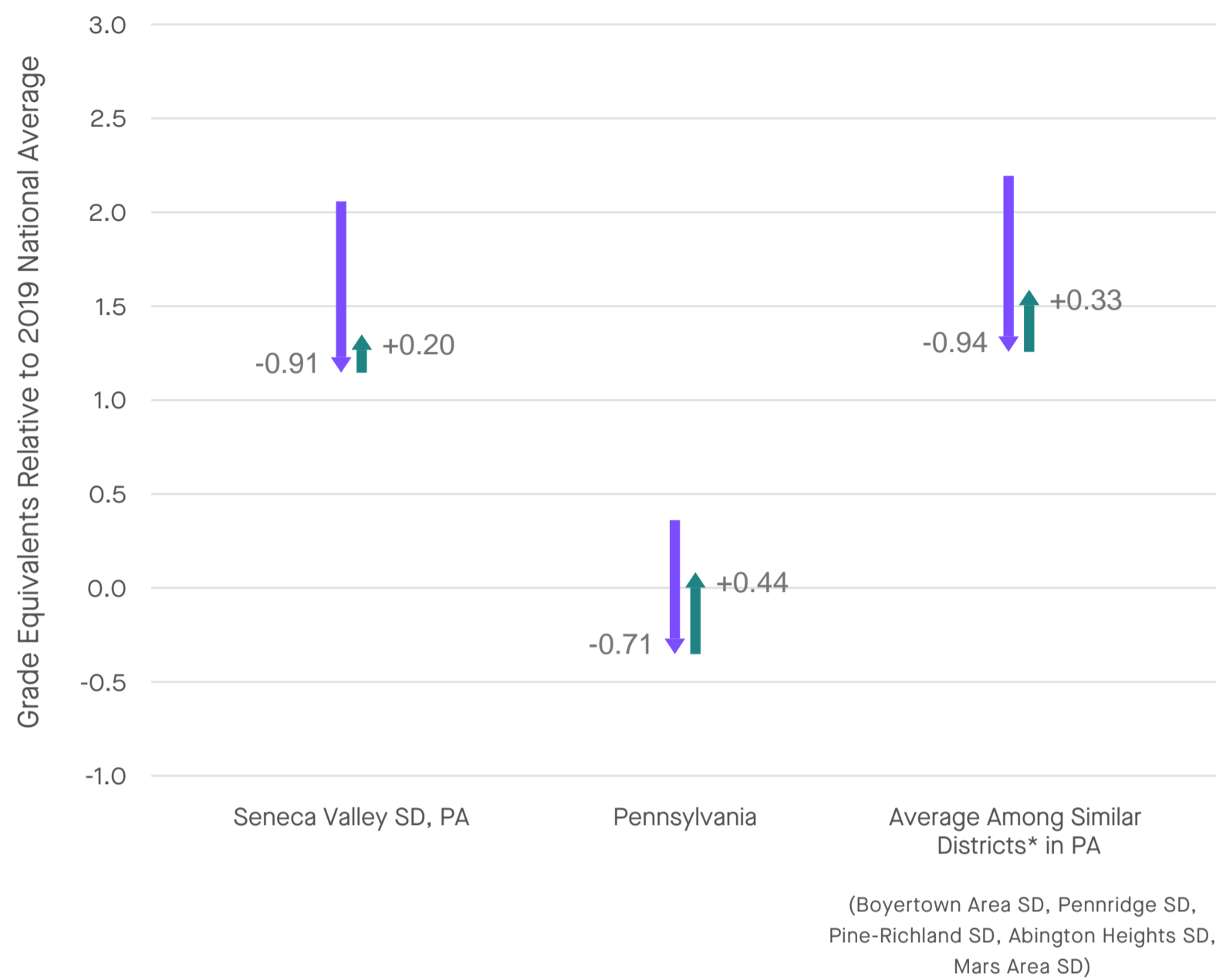

Math Performance in Seneca Valley SD vs. Pennsylvania and Similar Districts, Grades 3-8, 2019-2023



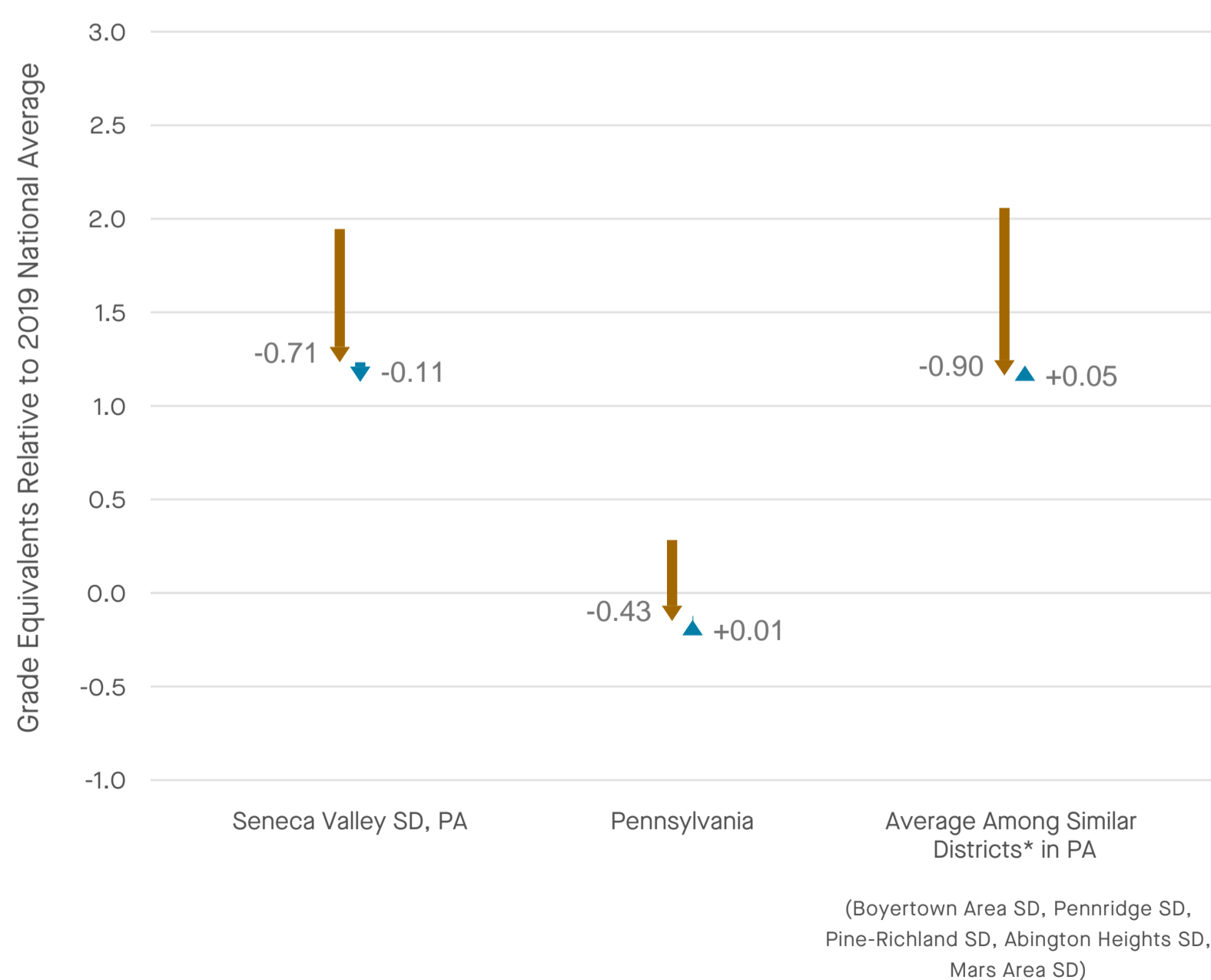

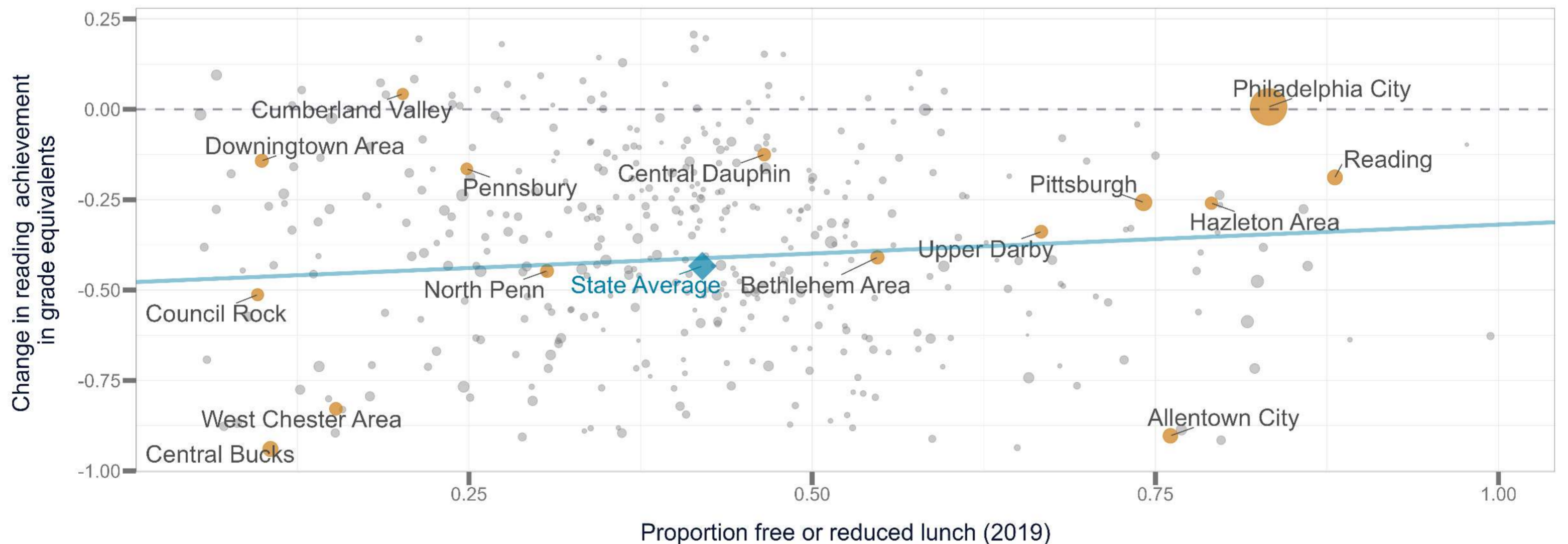
Change in Math Achievement 2019-2022 by proportion FRPL in Pennsylvania districts

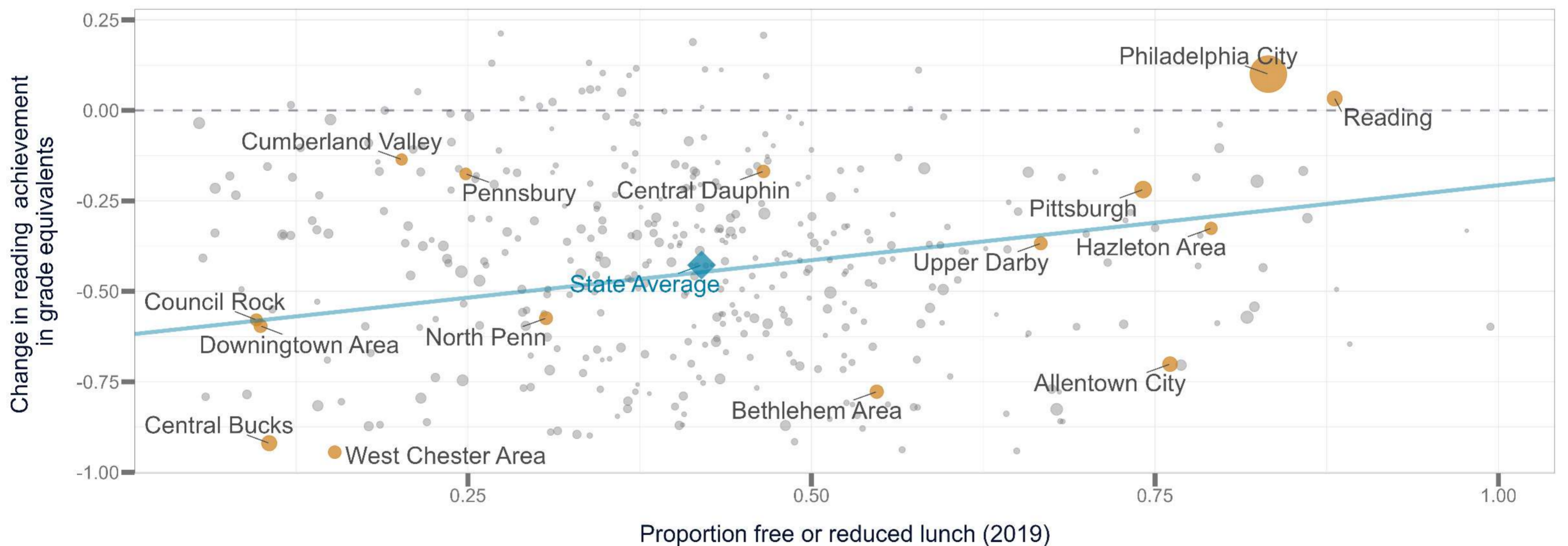
Change in Math Achievement 2019-2023 by proportion FRPL in Pennsylvania districts
