






Change in Math Achievement 2019-2022 by proportion FRPL in Virginia districts


### Change in Reading Achievement 2019-2022 by proportion FRPL in Virginia districts




#### Change in Math Achievement 2022-2023 by proportion FRPL in Virginia districts


### Change in Reading Achievement 2022-2023 by proportion FRPL in Virginia districts




### Change in Math Achievement 2019-2023 by proportion FRPL in Virginia districts




