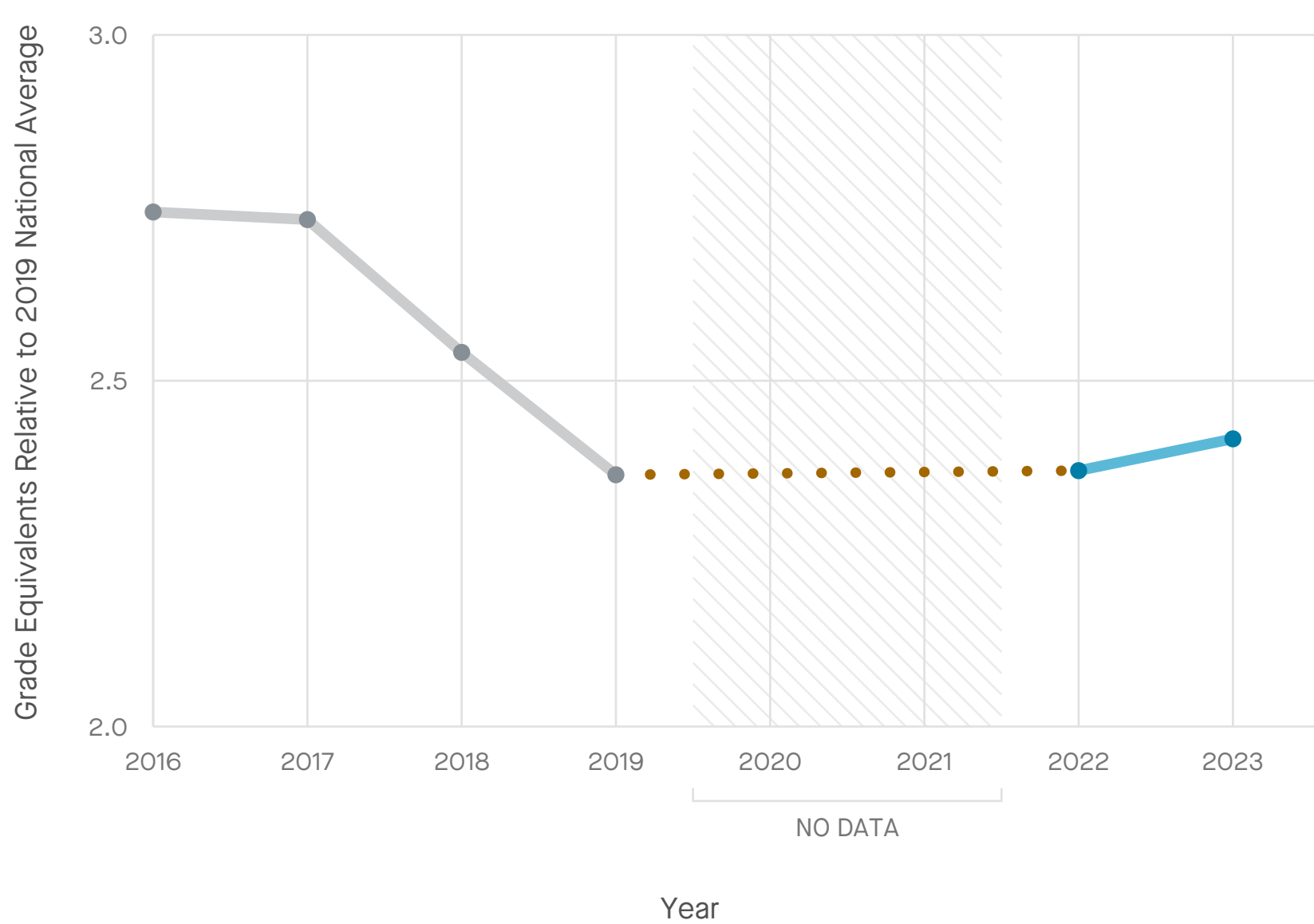

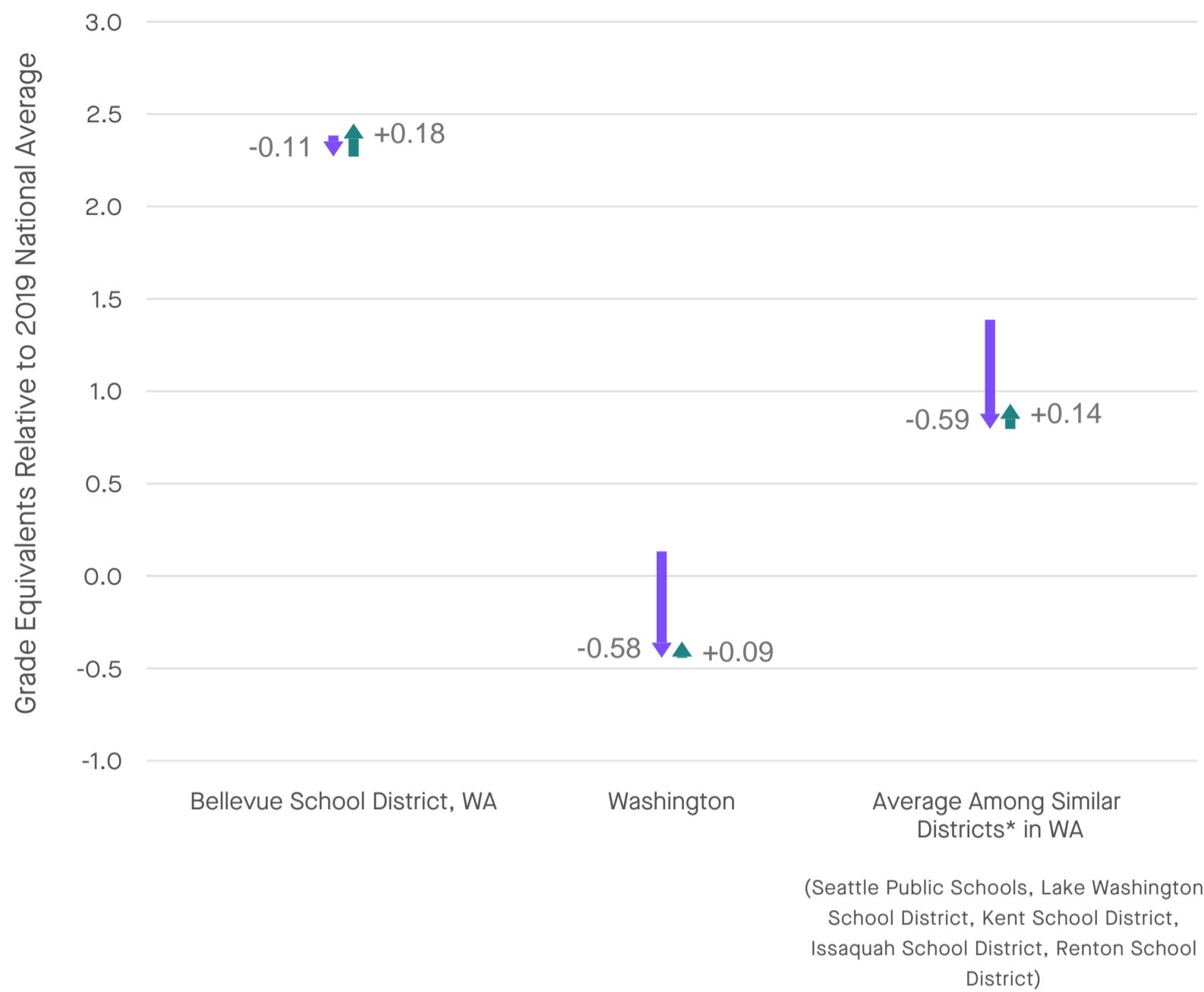

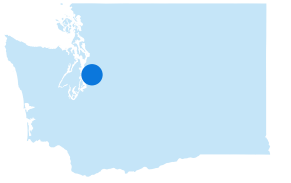

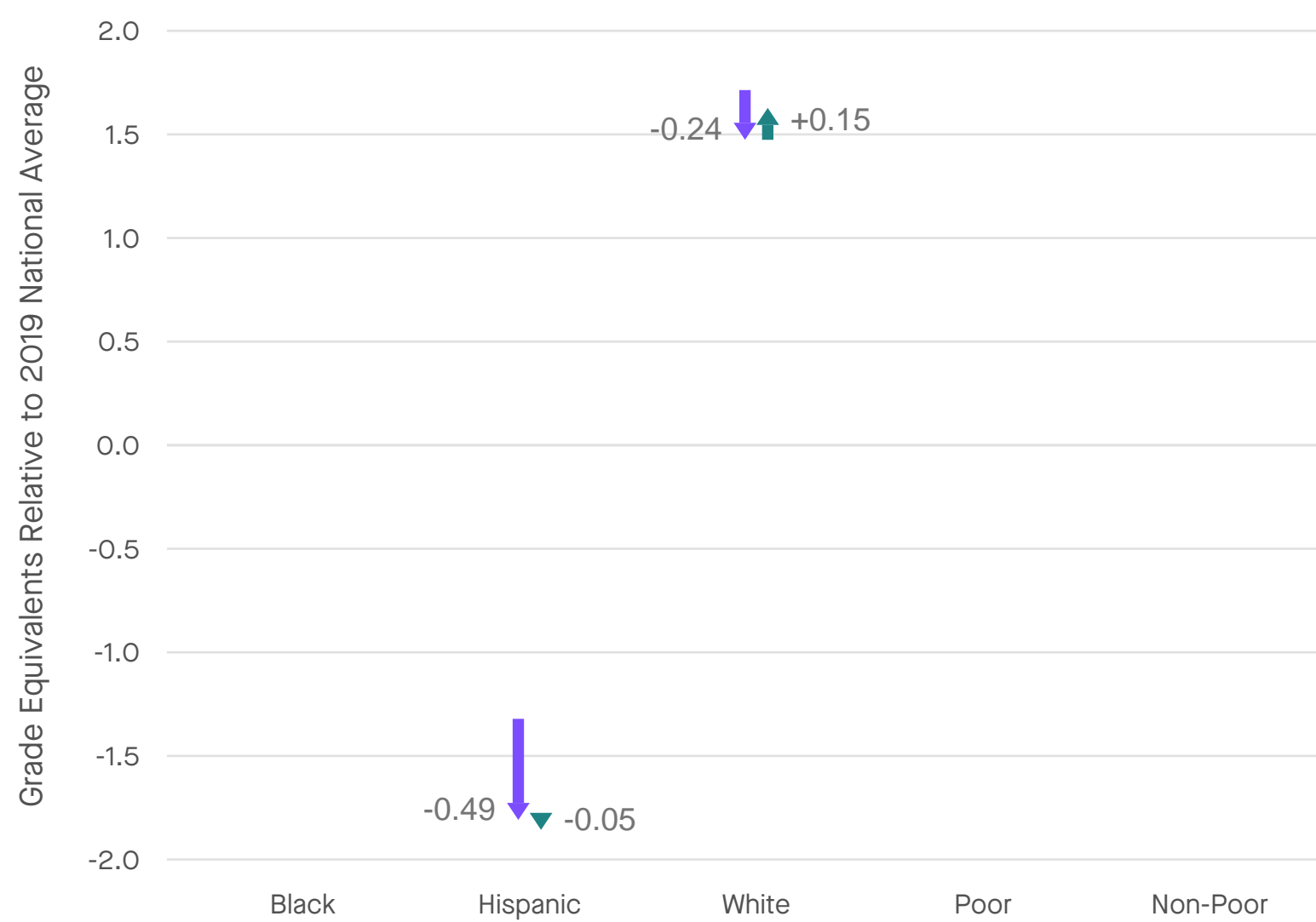

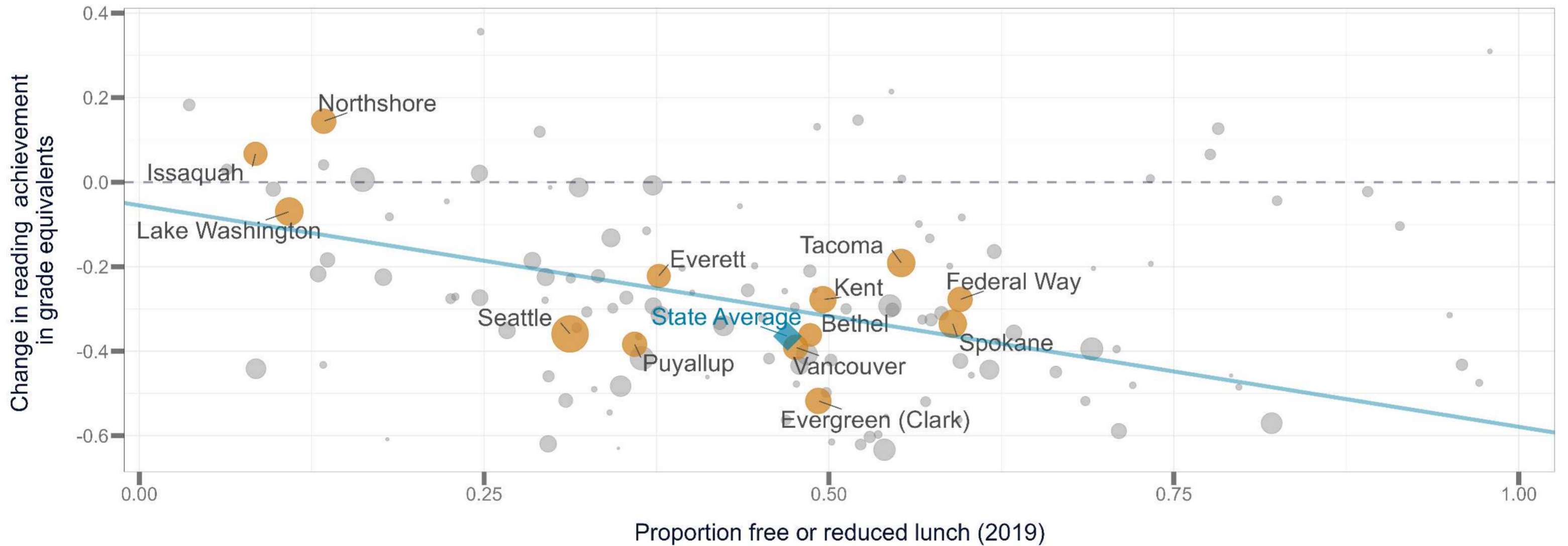

Change in Reading Achievement 2019-2022 by proportion FRPL in Washington districts



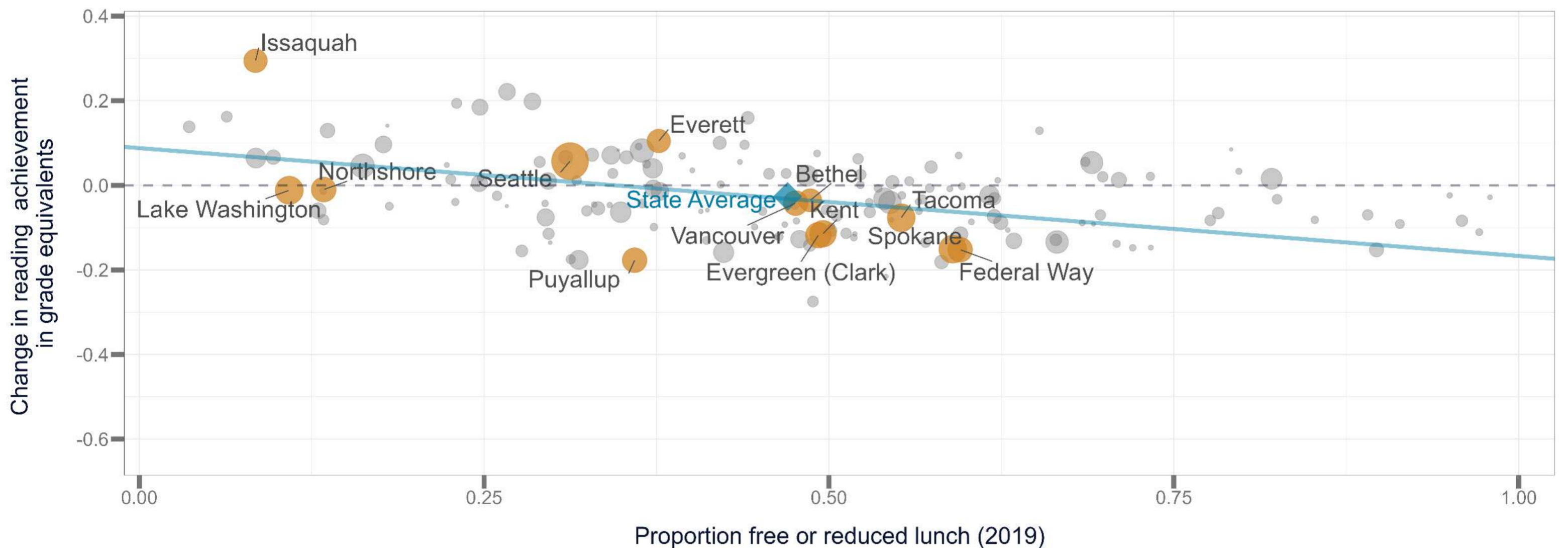

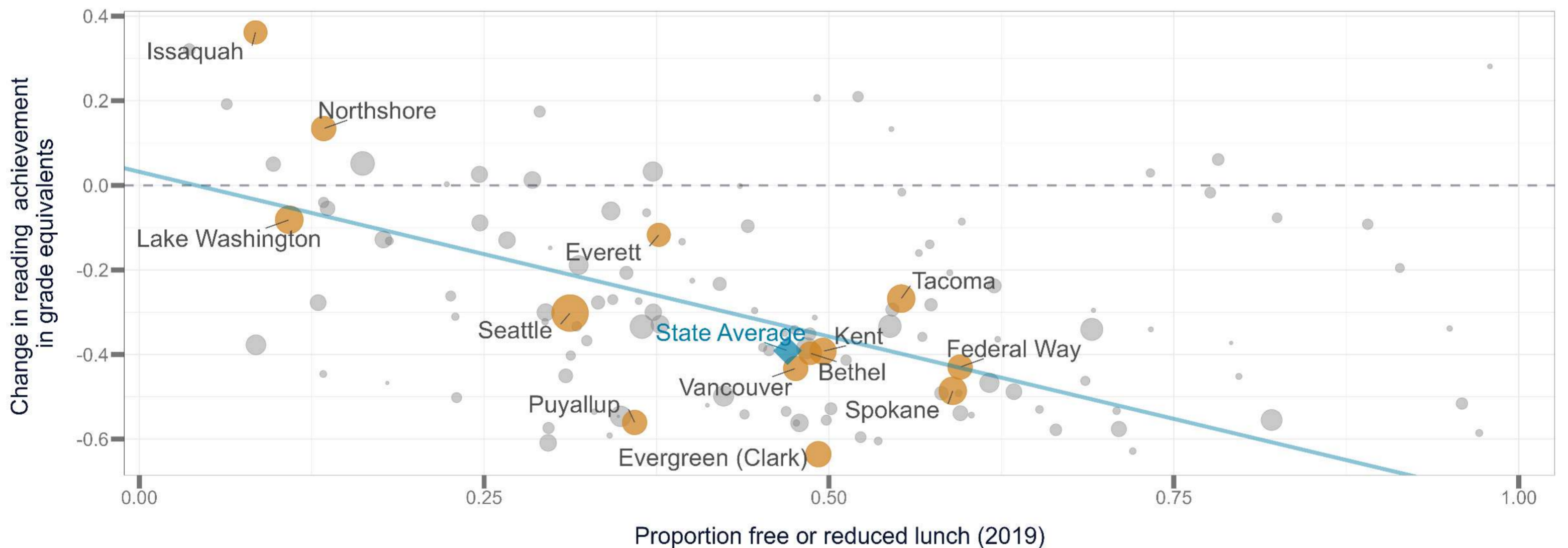

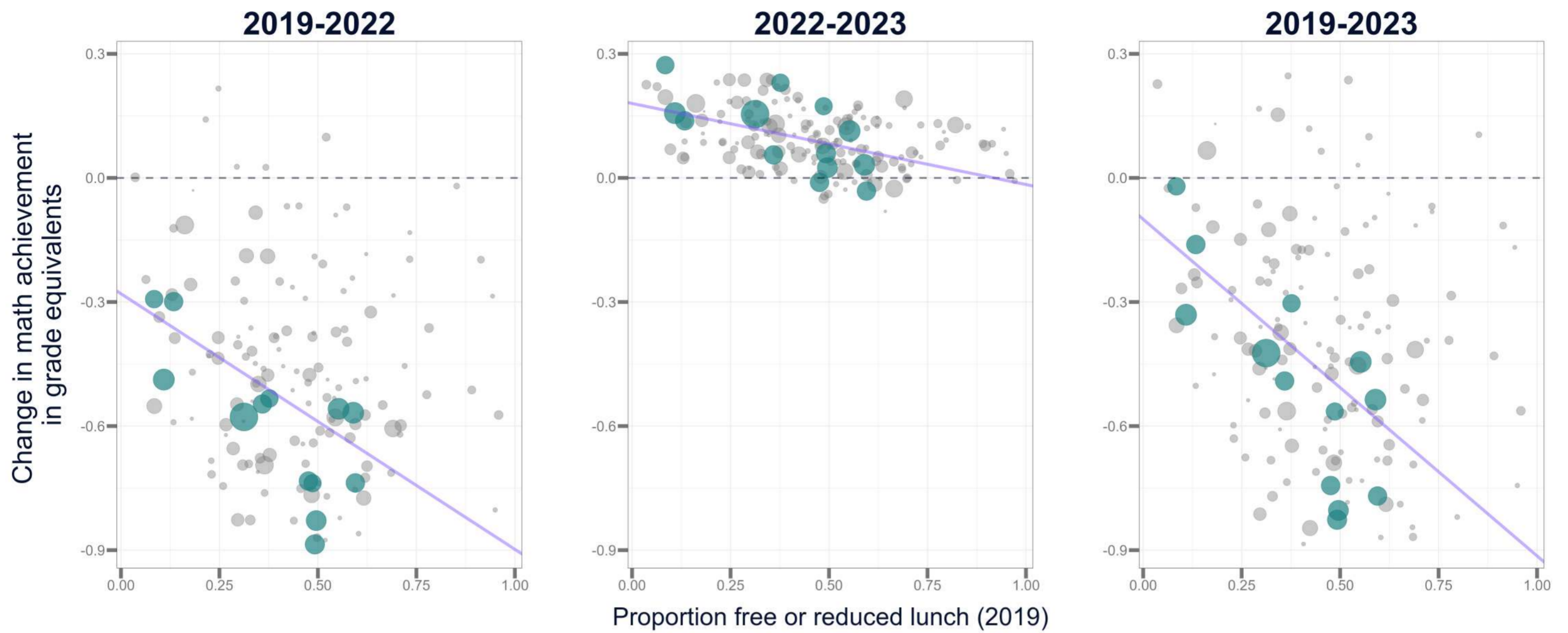

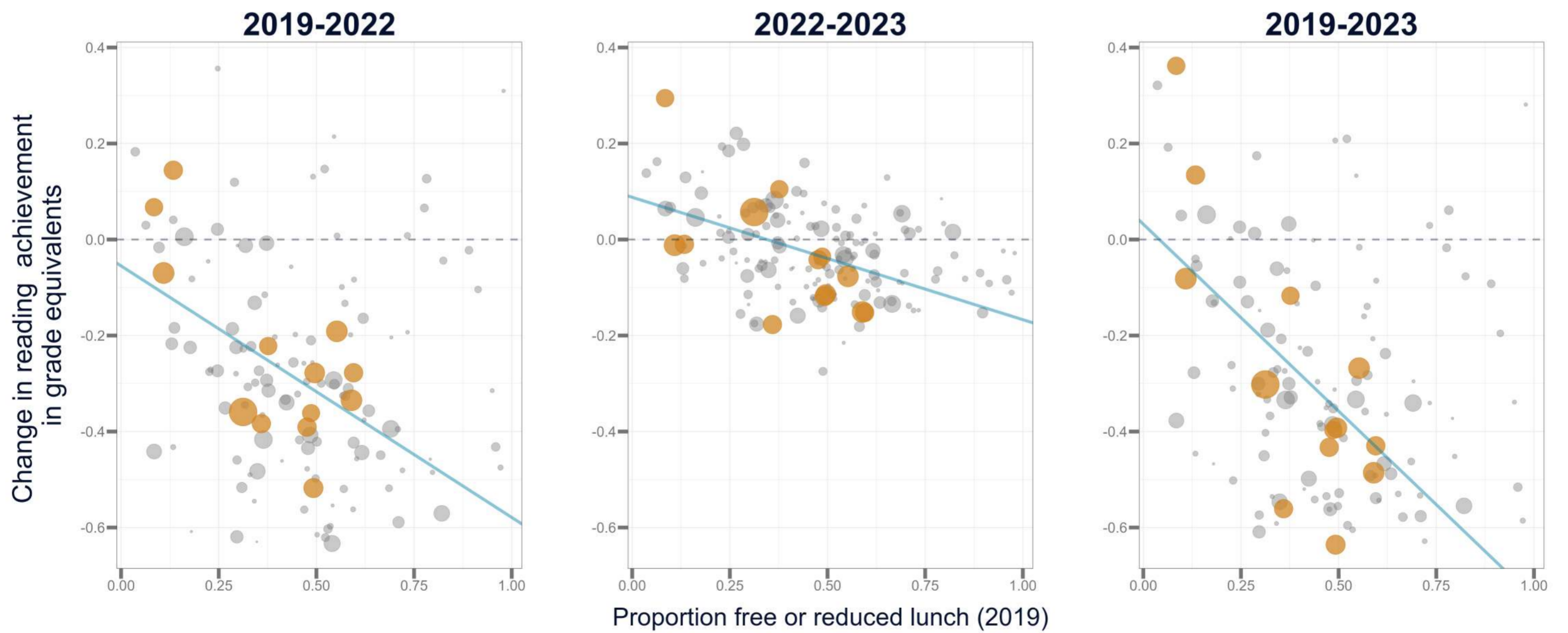

Change in Math Achievement by proportion FRPL in Washington districts



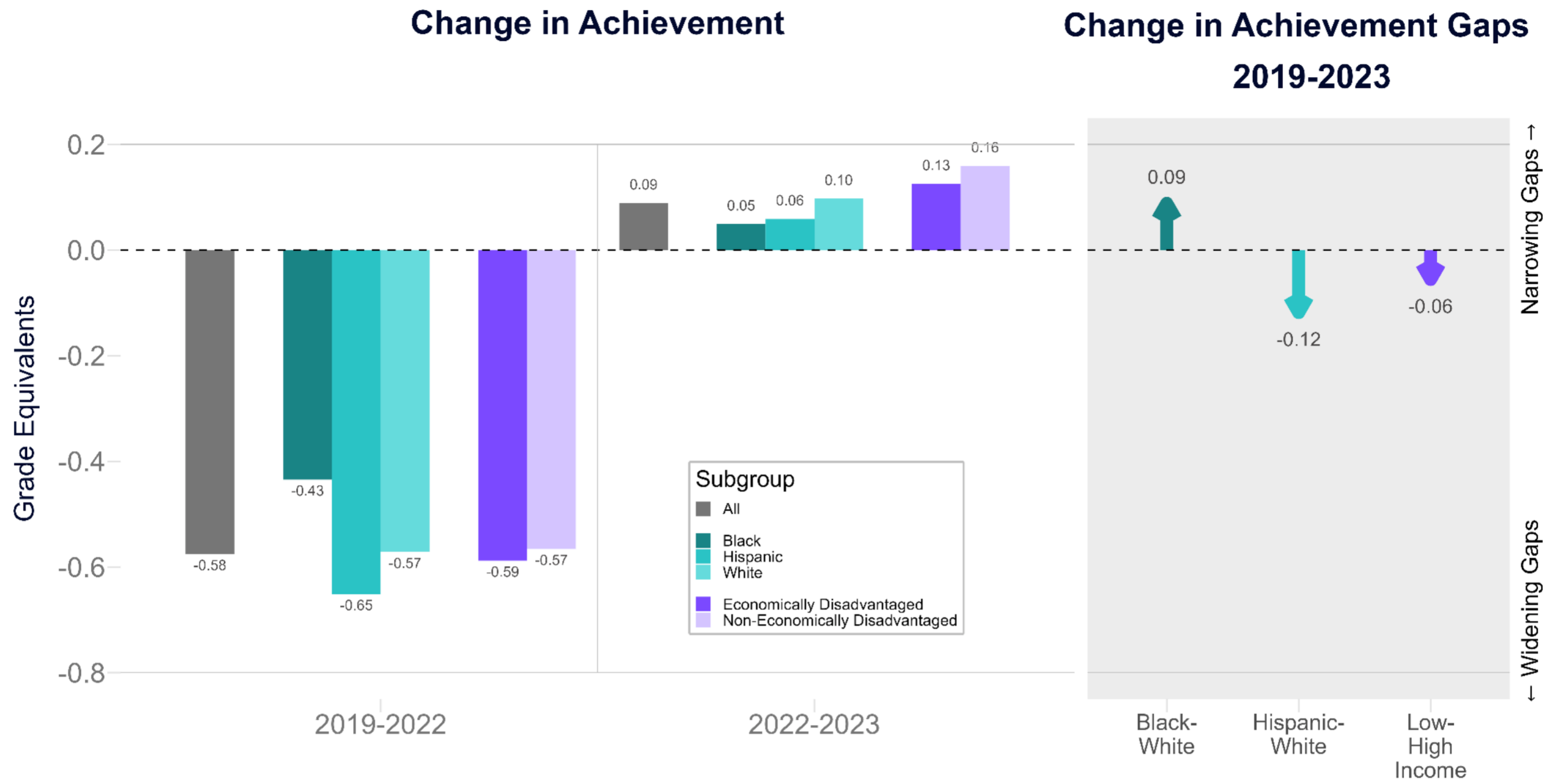

Change in Reading Achievement by proportion FRPL in Washington districts



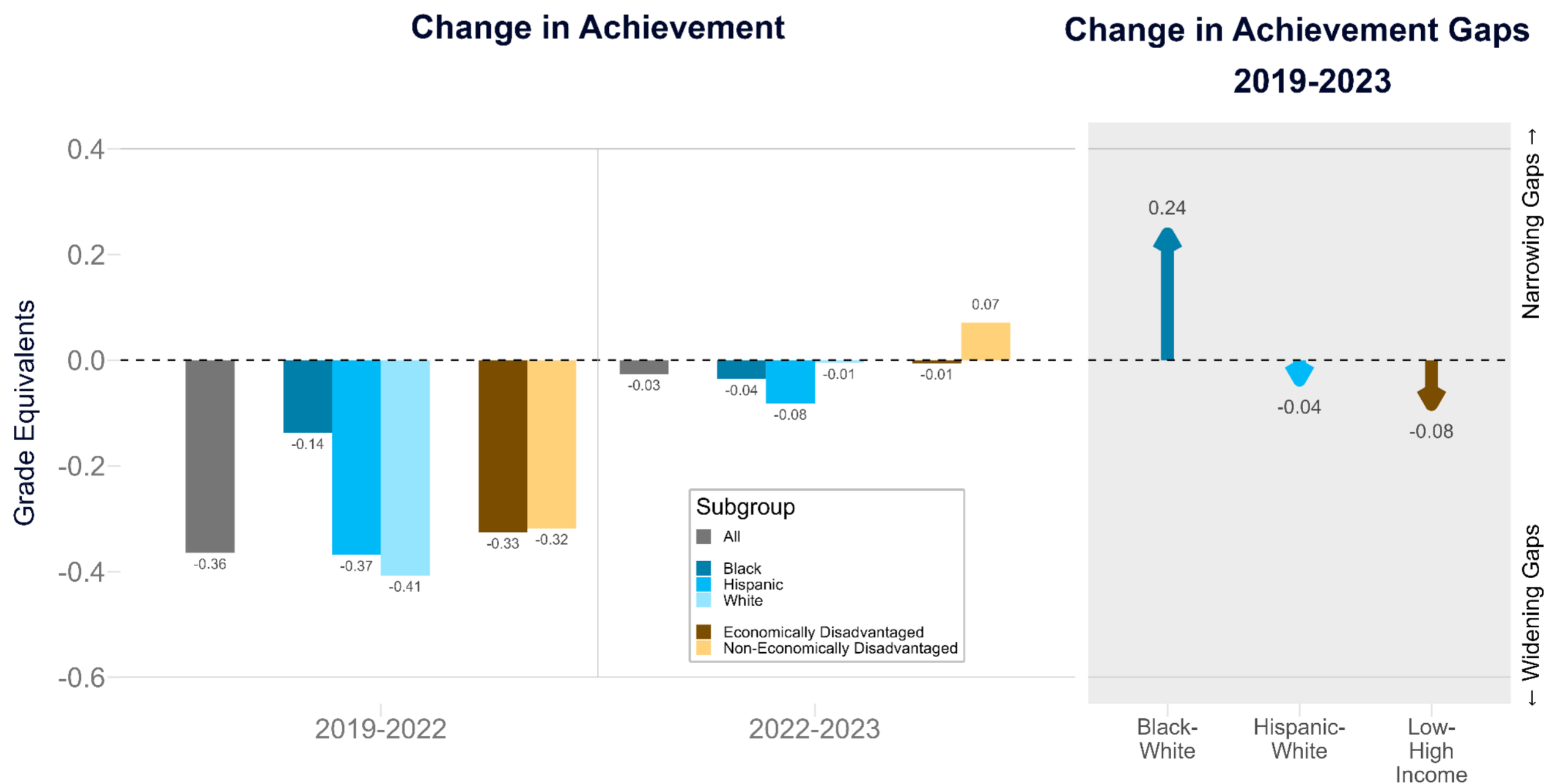
