





Math Performance in Freeman School District vs. Washington and Similar Districts, Grades 3-8, 2019-2023



Reading Performance in Freeman School District vs. Washington and Similar Districts, Grades 3-8, 2019-2023






Change in Math Achievement 2019-2022 by proportion FRPL in Washington districts




Change in Math Achievement 2022-2023 by proportion FRPL in Washington districts

Change in Reading Achievement 2022-2023 by proportion FRPL in Washington districts






Change in Math Achievement 2019-2023 by proportion FRPL in Washington districts



Change in Reading Achievement by proportion FRPL in Washington districts



Washington Math Achievement By Race and Economic Status




