












Change in Math Achievement 2019-2022 by proportion FRPL in Washington districts




#### Change in Math Achievement 2022-2023 by proportion FRPL in Washington districts







# Change in Reading Achievement by proportion FRPL in Washington districts



### Washington Math Achievement By Race and Economic Status




