





Math Performance in Pewaukee School District vs. Wisconsin and Similar Districts, Grades 3-8, 2019-2023









Math Performance by Subgroup, Grades 3-8, 2019-2023





Change in Math Achievement by proportion FRPL in Wisconsin districts





Change in Reading Achievement by proportion FRPL in Wisconsin districts




